Analysis

This resolution authorizes engineering studies and directs the Commissioner of Public Works to determine any benefits or damages which would result if the projects were to be constructed. After the Commissioner files his report, a Public Hearing will be held on those projects determined assessable. A resolution will be submitted after the Public Hearing authorizing construction. The City cost for engineering these projects is estimated to be \$885,000 with the total cost estimated to be \$10,459,000.

Body

Resolved, By the Common Council of the City of Milwaukee that it is necessary and in the public interest to do the following described work according to City specifications, and that such public improvements and resulting special assessments be made pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances:

1st Aldermanic District

N. 19th St. - W. Capitol Dr. to W. Olive St. (ST211120121): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$233,000. THIS AGREEMENT, By and between Marquette University, hereinafter known as MU and the City of Milwaukee, a municipal corporation, hereinafter known as "City";

WITNESSETH:

IN CONSIDERATION of the sum of One Dollar (\$1.00) to each party in hand paid by the other, receipt whereof is hereby acknowledged, and in further consideration of the covenants and agreements hereinafter contained.

WHEREAS, MU is constructing a new Marquette University Law School Building, and

WHEREAS, In conjunction with the building construction, MU is reconstructing the street abutting the new building, (location is more particularly described by Exhibit "A"; and

WHEREAS, A City of Milwaukee water main is located within the limits of the above mentioned street; and

WHEREAS, The proposed elevation of the street is significantly lower than current elevation which requires the water main to be lowered; and

WHEREAS, The cost of the relocation of the water main will be funded entirely by MU, cost to include construction costs, material costs, and engineering and inspections costs; and

NOW, THEREFORE, In consideration of these premises and the mutual benefits herein accruing and for other good and valuable considerations,

IT IS AGREED, By and between the parties hereto that:

1. Funding Obligation

MU agrees to provide all funds necessary for design, construction, and inspection of the new water main.

2. <u>Design Review</u>

City shall review the water main alterations necessitated by the streetscape project. The proposed alterations to the water main have been design by the MU civil engineering consultant, R.A. Smith National. R.A. Smith National is also the designer of the streetscape project; therefore, the design of the water main is accommodated within the streetscape design.

3. Construction Option

MU and the Commissioner of Public Works have agreed that MU will let and administer the construction contract for the water main relocation covered by this Agreement. This agreement formalizes MU intent to manage the construction activities as it relates to the relay of the water main. The City shall perform its normal inspections during the course of construction. In addition, MU agrees to make a good faith effort to comply with and administer on behalf of the City, all applicable City rules and requirements pertaining to Emerging Business Enterprise and local resident involvement in the construction contract. MU agrees to comply with the Wisconsin Prevailing Wages. MU will furnish the City with an affidavit confirming compliance with the Wisconsin Prevailing Wages.

MU shall not authorize any changes in improvement plans without the prior approval of the Commissioner of Public Works. All payments to contractors must be pre-approved by the Commissioner.

4. Water Main Improvements

The estimated cost for plan review for the new water main is \$2,900. The estimated costs to construct and inspect the sewer improvements are as follows:

Construction (includes all materials and fittings) \$65,125
Inspection (including as-built drawings) \$14,600
Attached is the bid proposal accepted by MU which shall be used as the basis for determining the cost of the work.

5. <u>Design Review and Inspection Fees</u>

MU shall provide the \$17,500 fee for the review of the water main design and all inspections required by the City in the form of a check made out to the City of Milwaukee prior to the commencement of any work on the water main.

6. Easements

If needed, MU agrees to provide, where necessary and at no cost to the City, all easements and other property rights required to construct, operate and maintain the public improvements described herein.

7. Funding Guarantee for Construction

MU shall submit an irrevocable Letter of Credit or other funding guarantee, satisfactory in format to the City Attorney, in an amount equal to the estimated construction contract cost and all materials and fittings (i.e. \$65,125) for the public infrastructure improvements that will be constructed by third party contractors prior to the award of any contracts, whether privately or publicly let. At the request of MU, the actual contract amount for the various improvements may be substituted for the estimated costs. In addition, the amount of the Letter of Credit may be reduced periodically to reflect payments made to contractors. Any such reductions shall be approved by the Commissioner of Public Works.

Any and all irrevocable Letters of Credit shall guarantee that MU's bank or savings and loan will provide the required funds to cover the contract cost of installing the applicable infrastructure improvements and will, upon simple request by the Commissioner of Public Works and the City Treasurer, release same to City as required, all such funds to be furnished interest free. The Letter of Credit or other funding guarantee shall be submitted to the City prior to the City or MU entering into any contracts for installation of public improvements.

8. Payments

In the event the City lets the public improvement construction contract, the contract costs for the public improvements will be billed to MU upon determination that such costs have been incurred by City. MU shall provide the City with funds to make contract payments. If such funds are not provided within 30 days of being requested, City may draw against the funding guarantee referenced in paragraph 10. It shall be further understood and agreed that where MU funded work covered under the terms of this Agreement does not proceed to the bid or contract stage, the City shall still retain a sufficient amount of the MU's design review and

inspection fee fund to cover expenses incurred by the City for plan review work commenced by the City at the MU's request.

9. Refunds

Upon completion of the pubic improvements and all associated City work, City shall return any unspent portions of MU cash deposits (i.e. the Engineering Design Deposit and the Construction Engineering Deposit).

10. <u>Inspections</u>

Both parties agree that all materials furnished and all work performed hereunder shall conform to all regulations and specifications of the City of Milwaukee and its Commissioner of Public Works and shall be subject to inspection by the Department of Pubic Works. All engineering and inspection costs incidental to the installation of the public improvements covered by this Agreement shall be subject to the terms of this Agreement, the cost of such service when furnished by City being established as the wages of the person or persons engaged in such work plus all costs of overhead.

11. Ownership of Public Improvements

It is understood and agreed by both parties hereto that upon satisfactory completion to the water main improvements installed under the terms of this Agreement, title to such improvements shall vest in the City of Milwaukee and that the City will accept the obligation of operation and maintenance in accordance with its standard practice.

12. <u>Termination of Existing Water Main Easement</u>

In connection with the water main improvements described in paragraph 4 above, an existing, recorded water main easement, a copy of which is attached hereto as Exhibit "B", will be vacated by the City and the section of water main located therein will be abandoned. The City shall record such termination of the easement upon execution of this agreement and upon provision by MU of the deposits and funding guarantees listed in paragraphs 9, 10, and 11.

13. City Ordinances and Regulations

City warrants that all work shall be undertaken in accord with City standard and customary public works contracting procedures unless such work is to be undertaken by City Forces or by MU per paragraph 3. It is further understood and agreed that this Agreement is subject to all City ordinances and regulations and nothing herein shall be deemed to waive or supersede such requirements.

THIS AGREEMENT, drafted by the City of Milwaukee, shall be binding upon MU and its successors and assigns, and upon the City, its successors and assigns.

PARKING, ACCESS AND MAINTENANCE AGREEMENT AND EASEMENT

(PALERMOS PROPERTIES PROJECT)

This NON-EXCLUSIVE PARKING, ACCESS AND MAINTENANCE AGREEMENT AND ESEMENT (this "Agreement") is entered into as of the ____ day of April, 2010 by and among the REDEVELOPMENT AUTHORITY OF THE CITY OF MILWAUKEE, a public body corporate and politic organized and existing under the laws of the State of Wisconsin ("RACM") the CITY OF MILWAUKEE, a Wisconsin municipal corporation ("CITY") and PALERMOS PROPERTIES, a Wisconsin limited liability company ("PALERMOS").

WITNESSETH

WHEREAS, PALERMOS is the owner of certain real property depicted in EXHIBIT A as Lot 1 (the "Palermos Parcel"); and

WHEREAS, PALERMOS is developing a manufacturing facility on the Palermos Parcel; and

WHEREAS, the west boundary of the Palermos Parcel abuts real property which is owned by RACM and a portion of which located immediately beneath the 35th Street viaduct over the Menomonee River Valley; and

WHEREAS, PALERMOS and RACM previously entered into a Non-Exclusive Parking and Maintenance Agreement and Easement (Palermos Parcel 1) dated as of the 30th Day of September, 2005, recorded with the Milwaukee County Register of Deeds on _______, 2005 as Document No. ______, (the "First Parking Easement"); and

WHEREAS, This Agreement encompasses the area subject to the First Parking Easement and additional areas necessary to allow PALERMOS to expand its existing parking

facilities in conjunction with the expansion of the existing manufacturing facilities on the Palermos Parcel; and

WHEREAS, This Agreement replaces and supersedes the First Parking Easement which is to be terminated and released by the execution and delivery of a Release of Easement s in substantially the form attached as EXHIBIT B; and

WHEREAS, PALERMOS requires non-exclusive certain rights and easements for the expansion, use and maintenance of surface parking facilities on the area immediately to the west of the Palermos Parcel as depicted on Certified Survey Map No. 2770 and legally described on EXHIBIT C (the "Parking Easement Area"); and

WHEREAS, RACM is the owner of certain real property depicted in EXHIBIT A as Lot 2 ("Lot 2") which is to be improved to create stormwater detention facilities to serve the Palermos Parcel and also incorporated into the overall stormwater facilities developed by RACM to serve the Menomonee Valley Industrial Center (the "Regional Stormwater Management Facilities"); and

WHEREAS, RACM requires certain non-exclusive rights and easements over the Palermos Parcel to provide ingress and egress to Lot 2 to allow for the improvement, use and maintenance of Lot 2 and the outfall depicted on EXHBIT A as part of the Regional Stormwater Management Facilities; and

WHEREAS, PALERMOS requires certain non-exclusive rights and easements over Lot 2 to allow construction of a stormwater detention basin and to permit the operation, use and maintenance of such stormwater detention basin; and

WHEREAS, RACM and CITY require certain non-exclusive rights and easements over the Palermos Parcel to provide ingress and egress to the Parking Easement Area to allow the improvement, use, maintenance and reconstruction of the 35th Street viaduct located above the Parking Easement Area; and

WHEREAS, The parties acknowledge and agree that the "31' wide access easement for Parcel 2" depicted on CSM #7707 and the "45' wide stormwater drainage easement" depicted on CSM #7701 will be replaced and superseded by this Agreement and are to be terminated and released by the execution and delivery of a Release of Easements in substantially the form attached as EXHIBIT B; and

WHEREAS, In conjunction with the expansion of the existing manufacturing facilities on the Palermos Parcel the driveway access to the Palermos Parcel from South 33rd Court is to be reconfigured and three new public parking spaces will be created and are to be located, in part, on the Palermos Parcel; and

whereas, CITY requires an easement over the Palermos Parcel for the area depicted on EXHIBIT _____ and legally described on EXHIBIT _____ to allow construction of the three new public parking spaces and to permit the improvement operation, use and maintenance of such parking spaces as part of the South 33rd Court right-of-way; and

NOW, THEREFORE, in consideration of terms, conditions and mutual covenants herein and for other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

I.

Grant of Parking Easement

RACM hereby grants to PALERMOS a perpetual, non-exclusive easement (the "Parking Easement") upon, in, over and under the Parking Easement Area. The Parking Easement is granted for vehicular parking and pedestrian and vehicular access to and from the Palermos

Parcel; for pedestrian and vehicular circulation within and between portions of the Palermos Parcel; for vehicular and pedestrian ingress and egress over, upon and across the Parking Easement Area to obtain access for the construction, operation, use, maintenance and repair (including reconstruction and restoration) of sidewalks, paving, landscaping and other facilities related to the operation of surface parking facilities serving the Palermos Parcel; and for the benefit of the Palermos Parcel. The Parking Easement is limited in height underneath the 35th Street viaduct and only extends to, but does not include, the bottom surface of the viaduct structure. In addition, the location of all improvements in the Parking Easement Area shall be subject to the prior approval of the City of Milwaukee's Commissioner of Pubic Works (the "Commissioner"), which approval shall not be reasonably conditioned, delayed or withheld.

II.

Conditions of Grant of the Parking Easement

The Parking Easement is granted to PALERMOS upon, and the parties shall be bound by, the following conditions:

- A. CITY's Department of Public Works will continue to have access to the Parking Easement Area for the improvement, maintenance, repair and reconstruction of the 35th Street viaduct, and PALERMOS' use of the land beneath the viaduct shall not unreasonably hinder access by the CITY's agents and employees for such purposes.
- B. PALERMOS shall not place any permanent structures in the Parking Easement Area other than pavement, landscaping, lighting and other facilities reasonably related to the maintenance and construction of surface parking facilities, and all as approved by the Commissioner.

- C. All construction performed and all improvements located in the Parking Easement Area shall conform with all applicable CITY standards, ordinances, building and zoning codes and all other applicable CITY regulations.
- D. In no event shall the construction or installation by PALERMOS of any improvement in the Parking Easement Area interfere with the public's or the CITY's use of the 35th Street viaduct or interfere with any CITY utilities, facilities or other items belonging to the CITY which are located within the Parking Easement Area.
- E. All landscaping, pavement, lighting, signs, or other items placed in the Parking Easement Area by PALERMOS shall be installed, maintained, and repaired by PALERMOS at its sole expense.
- F. No flammable or hazardous materials shall be stored by PALERMOS within the Parking Easement Area.
- G. Parking on the Parking Easement Area shall be available to PALERMOS at all times during which PALERMOS is operating its facility for business, and PALERMOS shall use its best efforts to ensure that parking is only made available to its employees, occupants, contractors, subcontractors, guests, invitees, or agents. CITY and RACM acknowledge that PALERMOS has the right to construct a fence within the Parking Easement to limit parking access as provided in the preceding sentence.
- H. CITY shall have the right to require removal of any materials, equipment, supplies, or improvements placed under the viaduct by PALERMOS if and when viaduct maintenance, repair or reconstruction activities so require. CITY shall save harmless PALERMOS from any loss, damage, injury or liability resulting from negligence on the part of CITY in connection with said work; provided that if such loss, damage, injury or liability results

from the joint negligence of CITY and PALERMOS, then the liability therefore shall be borne by them in proportion to their respective degree of negligence; provided further, however, that these provisions are subject to the legal defenses which under law CITY and PALERMOS are entitled to raise.

- I. PALERMOS will save and keep CITY and RACM clear and harmless from any claims for personal injuries or property damage asserted against it and caused by any negligence of PALERMOS or persons other than PALERMOS for whom PALERMOS has responsibility or legal liability, arising out the construction, installation or maintenance by PALERMOS of any item in the Parking Easement Area, and shall reimburse CITY for the full amount of such loss or damage.
- J. PALERMOS shall throughout the term of this Agreement carry, at its expense, insurance in the forms and with at least the coverages set forth on EXHIBIT "_____" hereto. RACM retains the right, at its sole discretion to adjust the foregoing coverage limits annually, effective on each January 1 of the term of this Agreement, to such insurance coverages and limits which are customarily provided at that time, by similar enterprises, and are commercially reasonable at that time. Said insurance shall be written by a reputable company licensed in the State of Wisconsin. PALERMOS shall furnish a Certificate of Insurance naming RACM and the CITY as additional named insureds. The Certificate shall provide that the insurance company will furnish RACM and the CITY with a sixty (60) day written notice of cancellation, nonrenewal or material change.
- K. After the location and installation of improvements in the Parking Easement Area have been approved by the Commissioner, CITY shall not unreasonably interfere with the use or operation of such improvements; provided, however, that CITY shall have the right to repair,

maintain, replace and/or reconstruct any CITY utility or improvement belonging to CITY. In the course of any such work, the City will in no case be responsible for replacing or paying for replacing any aesthetic plantings or improvements other than ordinary lawns or standard walks, roadways, driveways and parking lot surfacing which were required to be removed in the course of doing such work. However, CITY shall save harmless PALERMOS from any loss, damage, injury or liability resulting from negligence on the part of CTIY in connection with said work; provided that if above loss, damage, injury or liability results from the joint negligence of parties hereto, then the liability therefore shall be borne by them in proportion to their respective degree of negligence; provided further, however, that these provisions are subject to the legal defenses which under law CITY and PALERMOS are entitled to raise.

L. This Agreement, and the easement rights granted herein, may not be assigned or otherwise conveyed or sold to any person or entity that does not also own the Palermos Parcel without the written consent of RACM.

III.

Working Scheduling and Access

All construction or repair work by either PALERMOS or CITY in the Parking Easement Area shall be scheduled in advance by CITY and PALERMOS and coordinated with the Commissioner and PALERMOS or its agent responsible for scheduling such work, except in case of emergency when such notice and approval is not practical. PALERMOS and CITY will cooperate in good faith to ensure that CITY's access to the Parking Easement Area is reasonable and at such times and in such a manner that will avoid or minimize any disruption of or adverse impact on PALERMOS' property and operations (located on either on the Palermos Parcel or the Parking Easement Area). Without limiting the generality of the foregoing, CITY shall advise

PALERMOS from time to time of its expected needs for access to the Parking Easement Area for maintenance, repair or reconstruction of the 35th Street viaduct and PALERMOS and CITY shall endeavor to develop mutually agreeable schedules for such access. In all events, CITY shall give not less than ten (10) days' prior notice to PALERMOS each time that CITY will access the Parking Easement Area for construction or repair (except only in the case of emergency, provided that CITY shall in each such case give PALERMOS as much prior notice as is reasonably possible under the circumstances). Each such notice by CITY shall include the dates and times that such access will commence, the dates and times that such access will conclude, and the nature of the access and work (including without limitation the amount and type of equipment and the number of personnel to be included in such access).

IV.

Safety.

CITY and PALERMOS shall take all precautionary measures to protect the public from hazards related to their respective work on the Parking Easement Area and shall take all necessary steps to minimize impacts to PALERMOS' property and operations (including but not limited to PALERMOS' land, real property improvements, and all personal property). Without limiting the foregoing, in the event of emergency repair or access, CITY and PALERMOS shall work together to minimize disruption and impacts to PALERMOS' property and operations (including but not limited to PALERMOS land, real property, improvements, and all personal property.

V.

Insurance

Any and all private contractors engaged by CITY for work in the Parking Easement Area shall, prior to commencement of any construction work, furnish to PALERMOS a certificate of insurance evidencing the existence of public liability insurance naming PALERMOS as insured in amounts customary for CITY contracts. Any and all private contractors engaged by PALERMOS for work in the Parking Easement Area shall, prior to commencement of any construction work, furnish to CITY a certificate of insurance evidencing the existence of public liability insurance naming CITY as insured in such amount or amounts as CITY may reasonably require.

VI.

Remedies

In the event of any failure on the part of PALERMOS or CITY in the performance of any obligation hereunder relative to the Parking Easement Area, the party to whom such obligation is owed shall have the right to perform such obligation after first giving the failing party or parties not less than fifteen (15) days' notice of intention to do so, unless the failing party or parties shall within such fifteen (15) day period commence to perform such obligation and continue diligently therewith until such obligation be fully performed. Each party shall have a license to enter the Parking Easement Area to such extent as is necessary for the taking of such measures, and the failing party or parties shall pay to the performing party all costs incurred by the latter in accomplishing such performance. Any sum of money not paid when due shall bear interest until paid at the annual rate equal to the prime rate of interest in effect as the base rate on corporate loans at large U.S. money center commercial banks as published by the Wall Street Journal on the date of the described notice, adjusted with each change in such published rate, plus three percent (3%) or such other measure agreed to by the parties. All the rights granted to the parties

hereto by the provisions of this paragraph shall be in addition to all other rights which shall at such time be available by law. Enforcement of this Agreement may be by proceedings at law or in equity against any person or persons violating or attempting or threatening to violate any covenant herein, either to restrain or prevent such violation or to obtain any other relief. In the event a suit should be brought to enforce this Agreement, the prevailing party shall be entitled to recover its costs, including reasonable attorney's fees from the non-prevailing party.

VII.

Grant of Detention Basin Easement

RACM hereby grants to PALERMOS a perpetual, non-exclusive drainage easement upon, in, over and under Lot 2 (the "Detention Basin Easement"). The Detention Basin Easement is granted for the purpose of draining stormwater from the Palermos Parcel into a detention basin, to be constructed by PALERMOS on Lot 2, on a permanent basis. The location and design of all improvements on Lot 2 shall be subject to the prior approval of the Commissioner, which approval shall not be unreasonably conditioned, delayed or withheld.

VIII.

Conditions of Grant

- A. RACM shall retain ownership of Lot 2 and designate and include it as part of the Menomonee Valley Industrial Center Stormwater Management Facility. Lot 2 shall be made subject to that certain Menomonee Valley Industrial Center Drainage Easement and Stormwater Management Facility Maintenance Agreement dated as of _______, 2010 (the "Stormwater Facility Easement").
- B. Lot 2 shall be maintained and kept in good order by RACM or the party responsible for maintenance of the Regional Stormwater Management Facilities under the terms

of the Stormwater Facility Easement. Notwithstanding the foregoing, PALERMOS shall also have access to Lot 2 at all times for the improvement, operation, use and maintenance of Lot 2 for a stormwater detention basin to serve the Palermos Parcel.

- C. PALERMOS expressly agrees to indemnify and hold RACM harmless from and against any and all claims or demands for damages, costs, loss of use expenses, consequential damage, or any other thing whatsoever arising out of the construction of the detention basin, and the actions of PALERMOS in the operation, maintenance or use of Lot 2 for storm water detention.
 - D. No above grade structures other than fencing are permitted within Lot 2.

IX.

Grant of Public Maintenance Easement

PALERMOS hereby grants to RACM and CITY a perpetual, non-exclusive easement (the "Public Maintenance Easement") over the variable width access area depicted along the South line of the Palermos Parcel and the "15' wide storm sewer easement for the benefit of the City of Milwaukee" as each are depicted on Certified Survey Map No. 2770, (collectively the "Public maintenance Easement Area"). The Public Maintenance Easement is granted for ingress and egress to the Parking Easement Area and Lot 2 to allow RACM and CITY to improve, maintain, repair and reconstruct the Regional Stormwater Management Facilities, including the outfall depicted on EXHIBIT A and located within the 15' wide storm sewer easement for the benefit of the City of Milwaukee, and the 35th Street Viaduct.

X.

Conditions of Grant of the Public Maintenance Easement

The Public Maintenance Easement is granted to RACM and CITY upon, and the parties shall be bound by, the following conditions:

Grant of Public Parking Space Easement

PALERMOS hereby grants to CITY a perpetual easement (the "Public Parking Easement") over the area depicted on EXHIBIT ____ and legally described on EXHIBIT ____ (the "Public Parking Easement Area") to permit the improvement, operation and maintenance of three public parking spaces in conjunction with the southerly terminus of the South 33rd Court right-of-way.

XII.

Conditions of Grant of Public Parking Space Easement

XIII.

Miscellaneous

- A. <u>Binding Effect</u>. All the terms, conditions, covenants and other provisions contained in this Agreement, including the benefits and burdens, shall run with the land and shall inure to the benefit of, and be binding upon, the parties hereto and their respective successors and assigns, including, but without limitation, all subsequent owners of the Palermos Parcel, the Parking Easement Area, Lot 2 and the Public Parking Space Easement Area or any part thereof and all persons claiming under them. The rights and obligations granted hereunder shall be appurtenant to and encumber any sale of the Palermos Parcel.
- B. <u>Non-Use</u>. Non-use or limited use of the easement rights granted herein shall not prevent the benefiting party from later use of the same to the fullest extent authorized herein.
- C. <u>Severability</u>. If a term, covenant, or condition of this Agreement or the application thereof to any person or circumstance shall be deemed invalid or unenforceable, the remainder of this Agreement, or the application of such term, covenant or condition to persons or circumstances other than those to which it is held invalid or unenforceable shall not be affected thereby, and each term, covenant and condition shall be valid and enforceable to the fullest extent permitted by law.
- D. <u>Non-Waiver</u>. No delay or omission by any party in exercising any right or power accruing upon any default, non-compliance or failure of performance of any of the provisions of this Agreement shall be construed to be a waiver thereof. A waiver by a party of any of the obligations of another party shall not be construed to be a waiver of any subsequent obligation or breach of any other term, covenant or condition of this Agreement.
 - E. Non Dedication. Nothing contained herein shall be deemed to be a gift or

dedication of any portion of the easements granted hereunder to the general public or for any public purpose whatsoever.

F. <u>Notices</u>. All notices, demands, certificates, or other communications under this Agreement shall be in writing. They shall be deemed given (a) when hand delivered to the address below; (b) when transmitted by facsimile to the number below with electronic confirmation of receipt; or (c) two business days after being mailed by first-class mail, postage pre-paid, to the address below. Any party may, by written notice to the other parties, designate a change of address for these purposes.

Title

A substitute ordinance relating to storm water management regulations applicable to properties within the Milwaukee River greenway overlay zone.

Sections

120-7-1.5 cr

120-14 cr

Analysis

This ordinance creates storm water management regulations that apply only to properties within the Milwaukee River greenway overlay zone, a zoning district located along the Milwaukee River between the former North Avenue Dam and the city limits at Silver Spring Drive. These provisions are intended to supplement the city's existing storm water management regulations. When an overlay zone storm water management provision is in conflict with any other provision of the city's storm water management regulations, any other provision of the city code, or any applicable state or federal law, the more restrictive provision shall apply.

The new storm water management regulations include:

- 1. A storm water management plan shall be required if a development or redevelopment causes a land disturbing activity of one-half acre or more, causes the cumulative area of all land disturbing activities at a property to be one-half acre or more over a 3-year period or causes an increase of 0.5 acres or more of impervious area.
- 2. If the development or redevelopment causes an increase of 0.5 acres or more of impervious area, the release rate and requirements shall be governed by Milwaukee metropolitan sewerage district chapter 13 surface water and storm water rules.
- 3. Any development or redevelopment shall, by design, reduce to the maximum extent practicable the total suspended solids load by 80%, based on an average annual rainfall, as compared to no runoff management controls. This requirement applies whenever a storm water management plan is required in the separate storm sewer system or if storm water runoff from the development or redevelopment meets any of the criteria in item 1 and storm water runoff from that development or redevelopment discharges into waters of the state.

 Body

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

- Part 1. Section 120-7-1.5 of the code is created to read:
- 120-7. Control of Storm Water Discharge.
- 1.5. MILWAUKEE RIVER GREENWAY OVERLAY ZONE. This section shall not apply to any property located within the Milwaukee River greenway overlay zone, as shown on the city zoning map and established by common council file number 081568. Properties in the overlay zone shall be

subject to the storm water management regulations of s. 120-14.

Part 2. Section 120-14 of the code is created to read:

120-14. Control of Storm Water Discharge for the Milwaukee River Greenway Overlay Zone. 1. PURPOSE. The common council finds that the Milwaukee River corridor between the former North Avenue dam and the city limits at Silver Spring Drive contains native vegetation, wildlife habitat, natural bluffs, stream banks and waterways, and other valuable natural resources in need of protection. The regulations of this section are established to provide this protection by reducing the quantity of polluted storm water runoff, encouraging the planting of native vegetation, stabilizing stream banks and bluffs, mitigating flooding of the Milwaukee River and its tributaries, and reducing flows to the city's combined sewer system.

A substitute ordinance relating to storm water management regulations applicable to properties within the Milwaukee River greenway site plan review overlay zone.

..Sections

120-7-1.5 cr

120-14 cr

..Analysis

This ordinance creates storm water management regulations that apply only to properties within the Milwaukee River greenway site plan review overlay zone, a zoning district located along the Milwaukee River between the former North Avenue Dam and the city limits at Silver Spring Drive. These provisions are intended to supplement the city's existing storm water management regulations. When an overlay zone storm water management provision is in conflict with any other provision of the city's storm water management regulations, any other provision of the city code, or any applicable state or federal law, the more restrictive provision shall apply.

The new storm water management regulations include:

- 1. A storm water management plan shall be required if a development or redevelopment causes a land disturbing activity of one-half acre or more, causes the cumulative area of all land disturbing activities at a property to be one-half acre or more over a 3-year period or causes an increase of 0.5 acres or more of impervious area.
- 2. If the development or redevelopment causes an increase of 0.5 acres or more of impervious area, the release rate and requirements shall be governed by Milwaukee metropolitan sewerage district chapter 13 surface water and storm water rules.
- 3. Any development or redevelopment shall, by design, reduce to the maximum extent practicable the total suspended solids load by 80%, based on an average annual rainfall, as compared to no runoff management controls. This requirement applies whenever a storm water management plan is required in the separate storm sewer system or if storm water runoff from the development or redevelopment meets any of the criteria in item 1 and storm water runoff from that development or redevelopment discharges into waters of the state.

..Body

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 120-7-1.5 of the code is created to read:

120-7. Control of Storm Water Discharge.

- **1.5.** MILWAUKEE RIVER GREENWAY SITE PLAN REVIEW OVERLAY ZONE. This section shall not apply to any property located within the Milwaukee River greenway site plan review overlay zone, as shown on the city zoning map and established by common council file number 081568. Properties in the overlay zone shall be subject to the storm water management regulations of s. 120-14.
- Part 2. Section 120-14 of the code is created to read:
- **120-14.** Control of Storm Water Discharge for the Milwaukee River Greenway Site Plan Review Overlay Zone. 1. PURPOSE. The common council finds that the Milwaukee River corridor between the former North Avenue dam and the city limits at Silver Spring Drive contains native vegetation, wildlife habitat, natural bluffs, stream banks and waterways, and other valuable natural resources in need of protection. The regulations of this section are established to provide this protection by reducing the quantity of polluted storm water runoff, encouraging the planting of native vegetation, stabilizing stream banks and bluffs, mitigating flooding of the Milwaukee River and its tributaries, and reducing flows to the city's combined sewer system.
- **2.** APPLICABILITY. This section applies only to all properties within the Milwaukee River greenway site plan review overlay zone, as shown on the city zoning map and established by common council file number 081568.
- **3.** CONFLICTING REQUIREMENTS. The provisions of this section are intended to supplement, not replace, other provisions of this chapter. If any provision of this section conflicts with any other provision of this chapter, any other section of this code, or any applicable state or federal law, the more restrictive provision shall apply.
- **4.** DEVELOPMENT CRITERIA. A storm water management plan is required if any of the following criteria are met:
- a. The development or redevelopment causes a land disturbing activity of one-half acre or more.
- b. The development or redevelopment causes the cumulative area of all land disturbing activities at a property to be one-half acre or more over a 3-year period.
- c. The development or redevelopment occurring causes an increase of 0.5 acres or more of impervious area.
- **5.** RUNOFF RELEASE RATE. a. If the development or redevelopment occurring causes an increase of 0.5 acres or more of impervious area, the release rate and requirements shall be governed by Milwaukee metropolitan sewerage district ch. 13 surface water and storm water rules.

- **6.** RUNOFF DISCHARGE QUALITY CONTROL. a. Any development or redevelopment shall, by design, reduce to the maximum extent practicable the total suspended solids load by 80%, based on an average annual rainfall, as compared to no runoff management controls. No person shall be required to exceed an 80% total suspended solids reduction to meet the requirement of this paragraph.
- b. This subsection applies whenever a storm water management plan is required in the separate storm sewer system or if storm water runoff from the development or redevelopment meets any of the criteria of sub. 4 and storm water runoff from that development or redevelopment discharges into waters of the state.

Whereas, Wet detention ponds are one of the established and cost effective methods that can be implemented to remove sediments from large tributary areas and will aid the City in reaching the required TSS reduction goal; and

Whereas, The City is proposing to construct a wet detention pond at North 91st Street and West Calumet Avenue located within the municipal separate storm sewer system (MS4) portion of the city; and

Whereas, The wet detention pond will be sufficiently designed to treat storm water discharge from the entire 329 acre tributary area of storm sewer system number 2057; and

Whereas, The City Engineer will submit a signed Environmental Hazard Assessment form; and

Whereas, The operation of these grants begins on January 1, 2011 and ends on December 31, 2012; and

Whereas, The WDNR would provide a maximum cost share of 50% of eligible costs, with a total grantor share not exceed \$150,000 for the construction grant; and

Analysis

Current code places administrative responsibility for special privileges under the purview of the city clerk. These duties include the filing of applications and certificates of insurance, the issuance of permits, and the filing of amendment petitions. This ordinance transfers these responsibilities to the commissioner of public works.

Current code also requires the city clerk to monitor and enforce all provisions relating to special privileges, including written notification of non-compliance and penalty issuance. This ordinance transfers special privilege compliance and enforcement to the commissioner of public works, consistent with the enforcement powers granted to public works in s. 115-32-3.

In addition, this ordinance repeals code provisions relating to special privilege permits for the use of public ways by persons regularly engaged in the business of wholesale food distribution.

Body

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 115-35 of the code is repealed.

Part 2. Section 200-33-51.7 of the code is created to read:

200-33. Fees.

51.7. SPECIAL PRIVILEGE ENFORCEMENT FEE.

A monthly fee of \$25 may be charged for failure to comply with an order issued under s. 245-12.

Part 3. Section 245-12-2, 3-b and 5 of the code are amended to read:

245-12. Special Privileges.

2. FIXED COSTS. Any person, firm, association or corporation desiring such special privileges shall file with the [[city_clerk]]>>commissioner of public works<< a petition in writing on a form furnished for such purpose by the city engineer or the commissioner of city development, and shall pay to the city treasurer the fee as specified in s. 81-115, special privileges, for the purpose of defraying the cost of printing and other expenses which the city may incur in the consideration of such resolution for a special privilege, as regulated in s. 301-7.

PROVISIONS.

- b. The applicant shall file with the [[eity clerk]]>>commissioner of public works

Any sale, transfer or conveyance of ownership of a property with a special privilege requires the new ownership to file with the [[city clerk]]>>commissioner of public works<< a special privilege amendment petition in writing on a form furnished for this purpose by the city engineer or the commissioner of city development.





Analysis

This substitute resolution vacates the above alley in accordance with vacation proceedings under power granted to the City of Milwaukee by Section 62.73, Wisconsin Statutes, and Section 308-28, Milwaukee Code of Ordinances. This vacation was initiated by the City of Milwaukee, Department of Public Works, and will vacate an unimproved and landlocked alley with the property reverting to the properties along West Lakefield Drive.

Body

Whereas, It is proposed that the unimproved east-west alley in the block bounded by West Oklahoma Avenue, West Lakefield Drive, South 62nd Street and South 66th Street be vacated pursuant to the provisions of Section 62.73, Wisconsin Statutes; and

Whereas, The Department of Public Works has been directed to prepare a coordinated report estimating all costs and benefit assessments that will be incurred with said vacation; and

Whereas, That as provided by Section 62.73, Wisconsin Statutes, a lis pendens must be filed with the Milwaukee County Register of Deeds; and

Whereas, Said vacation has been reviewed in accordance with Section 308-28, Milwaukee Code of Ordinances; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that said alley as indicated by Exhibit A and bound and described by:

All of the east-west 20-foot wide alley as platted in Block 1 of Park Towne, a recorded subdivision, in the Northeast 1/4 of Section 15, Township 6 North, Range 21 East, described as follows: Commencing at the northwest corner of Lot 1 in said Block 1; thence Easterly, along the south line of said alley, 393.11 feet to the northeast corner of Lot 7 in said Block 1; thence Northerly, along the northerly extension of the east line of Lot 7 aforesaid, 20.0 feet to a point in the north line of said alley and the north line of said Park Towne; thence Westerly, along said north line, 393.09 feet to a point in the northerly extension of the west line of Lot 1; thence Southerly, along said northerly extension, 20.0 feet to the point of commencement, is vacated; and, be it
