



Dear Laura,

Thank you for inviting me to sit on the Brady Street BID Board. I am honored, as a fellow merchant and neighbor, to serve the greater good of the Brady Street Area. Here is a brief synopsis of my past experiences.

In 1984, I graduated with a Bachelors of Science from the University of Wisconsin – Stout. I majored in Clothing Textiles and Design with a minor in Business. My first post college job was in retail store management for the Limited Express. I began working for the Limited Express in Milwaukee, and transferred to Appleton in April of 1985 to open a new location in the Fox River Mall. After one year in Appleton, the Limited Express transferred me to Denver Colorado, where I managed all four locations in the Denver area. In September of 1987, I moved on to San Diego California and worked in retail store management at Banana Republic. In July of 1988, I moved back to the Milwaukee Area, answered a blind ad in the newspaper and began working for the Harley-Davidson Motor Company.

During the nine years I was employed at the Harley-Davidson Motor Company, I worked in three different departments. Initially I worked in Sales Administration, primarily calling dealers and soliciting orders via the telephone. After eighteen months, I was promoted to the Store Design Department. A new department with a total of three employees, we were responsible for helping dealers remodel their dealerships to become more retail friendly environments. My main duties included traveling to the dealerships after the remodeling was completed, and teaching the staff how to merchandise their dealership. After two years of extensive travel, I obtained the position of Product Development Coordinator in the Motor Clothes Department. There, I aided in developing private label products sold throughout the Harley-Davidson Dealer Network. After two years, I was promoted to Product Manager of Accessories, Riding Gear and Gifts.

In August of 1997, I left Harley-Davidson and went to work as a Product Manager for Amity / Rolf leather products. As the manager of men's small leather goods, I was responsible for the lion's share of the product line. I worked with the Sales Force in several

channels of distribution, including: Mass, Department Store and Outlets. When Amity / Rolf went bankrupt in the spring of 1998, I began to form a business plan for Miss Groove.

Realizing I had to have more money in the bank, I accepted a position with Seaquist Closures in Mukwonago, Wisconsin. Seaquist Closures make caps that fit on bottles and tubes. Seaquist Closures, is the leading supplier of caps to the Health and Beauty Aides Market in North America. As the Market Manager for Health and Beauty division, I was responsible for business to business marketing for North America and the marketing liaison for the European, South American and Asian subsidiaries. I left Seaquist Closures in March of 2000 to open Miss Groove.

Miss Groove was born out of wanting to stay in the fashion industry, yet remain in Milwaukee. Frustrated with Corporate America and hungry for a new challenge that utilized my past experience, I opened the doors of Miss Groove in May of 2000. Initially we sold only accessories and gifts. In response to market demand, we expanded our selection of merchandise to include apparel and lingerie. As a resident of the Brady Street Area one of my goals was to establish a store where people in the neighborhood could shop and buy gifts. Our merchandise mix has changed dramatically since the day we opened our doors, yet we continue to carry items under \$30 to serve our diverse neighborhood.

To grow the lingerie portion of our business and give the customer a distinct shopping experience, Miss Groove Intimate opened across the street from the first store in October of 2005. Miss Groove Intimate has received a multitude of positive press since its opening, adding to the allure of Brady Street.

In July of 2009, we combined Miss Groove Accessories and Apparel and Miss Groove Intimate and moved to 1330 East Brady Street. With the down turn of the economy, I needed to cut overhead and expenses. The importance of remaining on Brady Street cannot be understated.

After living in the Brady Street neighborhood for twenty years, I have a vested interest in the success of Brady Street. In 1995, I purchased my home on Astor Street. Miss Groove, Ltd employs four part time workers and supports my household. We are proud to be a part of the renaissance of Brady Street and hope to continue contributing to Brady Street's unique ambiance and diverse commerce. Thank you for your consideration.

Substitute resolution authorizing the creation and funding of the Central Business District Focus Retail Program and approving program eligibility requirements. Analysis

This substitute resolution authorizes the creation and funding of the Central Business District Focus Retail Program and approves program eligibility requirements. Specifically, the City Comptroller is directed to transfer \$75,000 from the Development Fund Parent Account to the Central Business District Focus Retail Program Project Account. By doing so, the City may assist property owners and businesses in the targeted Central Business District, leveraging substantial private investment and improvements to the exterior and interior of commercial buildings.

Body

Whereas, The Department of City Development has operated a number of business incentive programs for a number of years; and

Whereas, The City-wide Facade Grant Program and Retail Investment Fund have provided businesses with development incentives for visible reinvestment in downtown and neighborhood commercial areas; and

Whereas, The Common Council of the City of Milwaukee ("Common Council") created Business Improvement District No. 21 ("BID No. 21") via File No. 970900 on October 14, 1997, as authorized by Section 66.1109, Wisconsin Statutes, to provide a financing method to allow the Milwaukee Downtown business district to be self-sustaining; and

Whereas, BID No. 21 (Milwaukee Downtown) has committed \$25,000 for the Central Business District Focus Retail Program ("CBDFRP" or "Program"); and

Whereas, The CBDFRP is designed to provide two business incentives, which are white-box grants and retailer forgivable loans to commercial property owners; and

Whereas, It is recognized that the CBDFRP requires a set of program guidelines that will adhere to the Facade Grant Program Eligibility Requirements and to the established Design Guidelines; and

Whereas, The City of Milwaukee can leverage significant amounts of private investment and improvements to the commercial properties located in the targeted area in the Central Business District if the CBDFRP is available to assist property owners or businesses to upgrade their storefronts and building renovations; and

Whereas, This Program will provide a significant incentive to increase the vitality of the downtown retail environment; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the City Comptroller is directed to transfer \$75,000 from the Development Fund Parent Account No. 9990-UR03309000A to the Central Business District Focus Retail Program Project Account No. 1910-UR03398900; and, be it

Further Resolved, That these funds are designated for commercial building improvement activity in the target area under the guidelines established herein by the Common Council; and, be it

Central Business District Focus Retail Program

Program: Central Business District Focus Retail Program (CBDFRP)

Goal: Provide targeted financial incentives to increase the vitality of the downtown retail environment, to complement a variety of initiatives undertaken by Milwaukee Downtown BID #21 to stimulate retail activity.

Target area: The program will focus on businesses located within the area bounded by Wisconsin Avenue from Milwaukee Street west to N. Fourth Street. North-south blocks crossing East and West Wisconsin Avenue from Wells Street to Michigan Street are also included.

Business Incentives

The Central Business District Focus Retail Program will make available two new incentives within the target area. Businesses and property owners within the target area will continue to be eligible for façade and retail investment fund grants. However, as noted below, there are restrictions on using these programs in combination.

The City of Milwaukee and Milwaukee Downtown BID #21 will jointly fund the incentives described below. For every \$3 contributed by the City of Milwaukee, BID #21 will contribute \$1. Both the City of Milwaukee and Milwaukee Downtown BID #21 will be represented on the CBDFRP application review and awards committee.

White-box grants

This grant is designed to stimulate successful leasing of vacant first-floor retail space by assisting building owners to make interior improvements to upgrade the space and ready it for leasing.

- The grant will reimburse owners for costs related to bringing vacant space to "white-box" condition. Eligible costs include reusable base finish improvements such as ceilings, lighting, plumbing, interior walls, electrical outlets, concrete flooring, demising walls, restrooms and HVAC modifications.
- The white-box grant will offer reimbursable grant funds up to \$15 per sq/ft with a maximum grant amount of \$30,000. The grant may not exceed 75% of the total white-box project costs.
- The building must be in the targeted area and white-box grant funds may be used only for first-floor retail space with an active street presence.
- Property owners or retailers may qualify for white-box grants. However, owners
 and retailers who receive a white-box grant will NOT be eligible to receive a
 Façade or RIF grant for the same property.
- A retail unit may receive a maximum of one white-box grant. A property owner may receive a maximum of two white-box grants in a calendar year.

Central Business District Focus Retail Program

 Project applications will be accepted on a first-come, first-served basis beginning June 1, 2010, until current fiscal year funding is depleted.

Retail forgivable loans

This loan program is designed to assist property owners in downtown Milwaukee to attract targeted retailers by lending funds to the owner that can be provided to the tenant to subsidize rent, purchase inventory, install signage, and undertake marketing and advertising. Loan amounts are forgiven over a five-year period. Acceptance of a retail forgivable loan will cause a lien to be placed on the associated property.

- Retail forgivable loans are available to owners seeking to attract retail operations targeted by the Downtown Retail Strategy.
- Retailer must enter into a five-year lease for the space, and provide an acceptable business plan and five-year cash flow pro forma.
- Owner and retailer benefiting from the loan must present a spending plan that demonstrates that funds will be used in accordance with the purpose of the program.
- Retailer benefiting from the loan must demonstrate private sector leverage of at least 2 to 1 (i.e., at least \$2 of private financing for every dollar of forgivable loan).
- Retailer benefiting from the loan must provide at least 20% equity investment in the business.
- Retailer must occupy street-level space in the target area. A targeted retailer seeking to expand into an adjacent storefront or a second downtown location also is eligible for this assistance.
- Size of the loan is based on square footage occupied by the tenant.
- Property owners receiving a retail forgivable loan will be required to deposit monthly principal payments in an escrow account. Payment size will be based on a five-year amortization schedule with 0% interest. In order to be eligible for reimbursement of the loan, the borrower shall present receipts documenting the use of the funds by the tenant. Annually, the property owner will certify the continued operation of the retailer in order for 20% of the loan to be forgiven. In this manner, the loan will be forgiven at a rate of 20% per year for each year that the business remains in operation. In the event of default or closing of business, the remaining balance shall not be deemed "forgivable" and shall be subject to all legal collection efforts including enforcement of lien rights.
