OVERVIEW

Sweet Water Organics (SWO) seeks to build on Milwaukee's growing reputation as an international leader in community-based, sustainable agricultural production by establishing a **Model Production and Training Site** in the Bay View neighborhood. The Milwaukee Grow Zone (MGZ) project will expand production at the current SWO site through the construction of an outdoor growing area to better meet the burgeoning local demand for organic foods. This completed model site will serve as a stepping stone toward the development of **Sweet Water Village**—a "green industry park" that will grow green business partnerships, train and place 75 workers in "middle skills" jobs, and drive innovation in sustainable resource use.

The Milwaukee Grow Zone will result in:

- Immediate support of an expected **10 FTE jobs** to construct and operate an outdoor growing system that completes the SWO model site and increases vegetable and fish production by 400%;

investors from throughout the nation and world. In the last 3 months alone, SWO has hosted leaders from business, non-profits, government, and universities from over 20 states and 8 countries. With the completion of the SWO model site, interest in Milwaukee as a green jobs destination will only grow.

MGZ PROJECT TIMELINE

Stage One of the Milwaukee Grow Zone project will support the completion of the SWO model site by expanding the outdoor portion of the existing facility to include 7 covered hoop house structures. This stage will be initiated in May 2011 and will include the immediate employment of an **additional permanent 10 FTEs**—laborers, biologists, information systems analysts, etc.—in the construction and upkeep of the new outdoor 3- and 4- season growing area. Construction of this new growing area will be completed by December 2011, and will result in an increase in SWO's crop yield (an additional 12,000 vegetables and 15,000 fish), new varieties of crops (tomatoes, peppers, and cucumbers), and the piloting of a vertical growth approach that will enable more efficient use of space.

By the end of this first stage of the MGZ project, the model SWO production and training site will be completed, enabling a consistent, year-round yield to meet the demand of local buyers and demonstrating the model's viability for replication and broader investment.

Through *Stage Two* of the Milwaukee Grow Zone, SWO will engage businesses and investors in the development of a "green industry park," which will replicate the Model Production and Training Site in collaboration with like-minded businesses through coordinated use of organic food products, systems, and resources. SWO has already received a commitment from one company based in the Milwaukee metro area seeking to expand its production capacity and collaborate with SWO in designing integrated systems for production and energy use. SWO will leverage its existing planning partners—Milwaukee School of Engineering, University of Wisconsin-Milwaukee's WATER Institute, and others—in designing a new multi-business 5+ acre site that is planned to be developed within the Bay View neighborhood.

This stage of MGZ will result in an anticipated **65 additional, permanent FTE jobs by 2014** and will serve as the anchor of the "Sweet Water Village" concept, which envisions the eventual development of an integrated mini-community of service industry businesses (visitor accommodations, restaurants, markets), state-of-the-art research and learning facilities, and other green-focused industry.

INNOVATIVE TRAINING AND PROFESSIONAL SUPPORT

The Milwaukee Grow Zone will support workers in developing a broad set of technical skills and knowledge in a fast-growing, 21st century industry. While effective management of aquaponics systems requires proficiency in a diverse set of scientific disciplines (water chemistry, fish and plant biology, etc.), the SWO model provides entry-level workers with the opportunity to participate in each step of the food production process. Through one-to-one mentorship and hands-on learning experiences within this process, SWO workers will gain an increasingly advanced set of technical skills and knowledge.

As workers develop their expertise and production capacity is expanded, new positions will likely be created both within SWO and in related "spin-off" industries, enabling a career ladder of opportunities for participating workers. SWO will also offer an aquaponics credential program and professional learning community, in coordination with area educational institutions, to support workers and other interested community learners in developing urban agriculture expertise and sharing innovations.

HIGHLY LEVERAGED INVESTMENT FOR LONG TERM ECONOMIC IMPACT

In addition to creating 75 jobs and long-lasting worker skill development, re-purposing of unused city property, and increasing property tax revenue, the Milwaukee Grow Zone will leverage city investment

of \$250,000 through the attraction of new ideas, dollars, businesses, and residents who want to be a part of Milwaukee's green movement. A recently announced example is IBM's selection of Sweet Water Organics as one of 24 recipients worldwide of the Smarter Cities Challenge Grant, which provides \$400,000 worth of in-kind support to promote sustainable systems innovation. With City of Milwaukee support, Sweet Water Organics will be able to demonstrate the full potential of its model and continue to attract interest and millions of dollars of investment that will support Milwaukee's emergence as leader in the fast-growing green industries of sustainable food production and freshwater use.

With eighteen percent sales growth yearly we anticipate sales in excess of two million dollars in 2011 and three million in 2012. We now employ twenty five production staff and seven in sales, management and marketing. We intend to add sales and production staff this year and would expect to expand to over seventy five employees within the year following construction of a new facility in Bay View, WI.

The pet industry is growing rapidly even during the downward trend seen in other industries. It is expected that seven hundred thousand to one million dollars will be needed to complete our portion of the proposed eco-campus.

This will enhance our city's local economy and its growing identity in urban agricultural and water management acuity. Proposed Changes to Neighborhood Stabilization Program 2 Budget

The City of Milwaukee submitted a proposal for NSP 2 funding to HUD in September of 2009. The proposal included a budget which allocated \$25 million in funding among a number of different programmatic areas.

Based on actual experience with the NSP 1 program (which was fully obligated in September of 2010), and efforts in the NSP 2 program, several budget shifts are being proposed to more accurately reflect and respond to current market conditions and program demand.

The changes are itemized in the attachment and summarized below:

- A reduction is being made to the Homebuyer Assistance Program. Given that the NSP 2 target area is significantly smaller than the NSP 1 area, demand for the Homebuyer Assistance Program has diminished considerably. This is due to the relatively poorer condition of the foreclosed housing stock in the NSP 2 target area. These properties require higher levels of rehabilitation, making them more difficult and challenging – and less appealing – for prospective homeowners to purchase.
- Transfers are being made between the Rental Rehabilitation Program and the Large Rental Projects Program. Again, conditions of foreclosed properties in the NSP 2 target area are more challenging for small investors. However, there has been increased demand for the rehabilitation of foreclosed multi-family buildings, and the City has identified developers who have expressed a willingness to take on larger numbers of scattered site duplexes. The shift in funding between the Rental Rehabilitation and the Large Rental Projects categories reflect these changes in program demand.
- A reduction is being made in the Buy In Your Neighborhood Program. Despite continuing marketing and outreach efforts, there has not been demand for the program. Should conditions change, applications for the acquisition and rehabilitation of foreclosed properties by neighborhood owners will be funded under the Rental Rehabilitation Program, as the uses of funds are consistent.
- Funding for the Acquisition/Rehabilitation Program has been increased. The program has been very successful and there has been a demonstrated strong demand for houses developed under the program. As indicated above, given the condition of properties in the NSP 2 area, this is a viable alternative to developing and promoting homeownership opportunities in the NSP 2 target area.
- A reduction is being made to the land bank, due to increasing numbers of City foreclosed properties, which are being provided at nominal cost for the Neighborhood Stabilization
 Program for both homeownership opportunities and responsible rental property development.
- Vacant Land Reprogramming funds are being eliminated which were to be used for the improvement of vacant lots resulting from the demolition of foreclosed property. While the

City's NSP 2 application was approved with this program activity, HUD later determined that it was not an eligible use of NSP 2 funds. Funds from this category are being transferred to the Vacant Land Reuse (new construction) category.

- Demolition is being increased up to the maximum allowable amount (10% of the total NSP grant), to reflect increasing numbers of foreclosed properties that are blighting and economically infeasible to rehabilitate.
- A direct allocation of funds is being budgeted for the Housing Authority of the City of Milwaukee (HACM). HACM acquired and rehabilitated 2 properties under the NSP 1 Program to provide affordable rental opportunities. They will be utilizing NSP 2 funds for the acquisition and rehabilitation of foreclosed properties for homeownership. As HUD has indicated that Housing Authorities should be classified as "sub- recipients," a specific allocation of funds is being setaside in the revised NSP2 budget.
