#### Dear Honorable Members:

This letter is in reply to a notice dated February 7, 2010 regarding a request for an honorary street name on West Center Street.

Chapter 113-3 of the Milwaukee Code of Ordinances provides the guidelines to consider when reviewing honorary street name requests. The guidelines provided in the code have been reviewed and the following comments are offered.

Mattiebelle Woods passed away in 2005 at the age of 102 years. There is an exhibit on the life of Mattiebelle Woods at the Wisconsin Black Historical Society Museum located at 2620 West Center Street. The biography submitted on her behalf explains her community work within the Milwaukee area. Her volunteer work included involvement with the March of Dimes, The United Way, NAACP, and the Milwaukee Urban League. Mattiebelle Woods was the oldest living working journalist in America. She believed in helping people, especially the young with a positive attitude and strong spirit.

The request to honor Mattiebelle Woods with an honorary street name of "Mattiebelle Woods" includes 17 letters and spaces. There is not a limit to 13 letters/spaces as with an official street name change request, however, the letters will be a smaller size to fit the standard honorary street sign space.

One blue honorary street sign is required and will be mounted on the pedestrian triangle located at the intersection of West Center Street at West Fond Du Lac Ave. The sign will be mounted below the West Center Street sign in the east-west orientation at the location. The existing Official Street sign at the location will remain. The petitioner may choose to furnish the honorary street sign provided that it is fabricated to established City guidelines. The City

can fabricate the sign at \$50 each. In either case, the City will install the honorary street sign at a cost of \$50 per sign. The petitioner is to deposit \$50 to the City if they furnish the sign or \$100 if the City fabricates and installs the sign. If the sign needs to be replaced in the future, the City is to be notified of the missing or damaged sign and the petitioner is to cover the cost to fabricate and mount the sign as described above with the initial installation. The City's cost to fabricate and install future signs is subject to change.

Provided that the honorary street name request meets the established design criteria and that the Department of Public Works does not incur any costs as a result of this action, we can support this resolution.


Her infectious smile and signature dance routine, The Electric Slide, was a delight for everyone to see and participate in and she literally could not appear at a function without performing it.

# Concerns Regarding Valley Power Plant go to Public Works Committee

Alderman Bauman says utility hasn't delivered on promised changes at plant

Environmental concerns regarding the WE Energies Menomonee Valley Coal Plant and unfulfilled promises by the utility to convert the plant from coal to natural gas has prompted **Alderman Robert J. Bauman**, chair of the Common Council's Public Works Committee, to schedule a public hearing on a communication file to update council members and city residents on the environmental issues and the status of the plant.

The Public Works Committee will take up the valley coal power plant file when it meets at 9 a.m. tomorrow (Wednesday, September 28) in room 301-B at City Hall, 200 E. Wells St.

Alderman Bauman said recent reports indicate that the valley coal plant is the oldest (1960s) and most environmentally destructive plant operated by WE Energies, lacking modern pollution controls and providing a significant source of soot and smog which are linked to serious health problems like asthma attacks, heart attacks and strokes. He said more than 24,000 people, many of whom are his constituents, live within a mile of the plant and suffer the worst consequences of the plant's pollution.

According to Alderman Bauman, Milwaukee is consistently given failing grades for its air quality, and Milwaukee and its surrounding counties currently violate health standards for soot and smog.

Alderman Bauman indicated that these reports show that:

### Valley Coal Plant/ADD ONE

- The valley coal plant is a significant source of ozone (smog) and particulate pollution (soot) that can lead to serious respiratory illness, and on days when air pollution levels are high, the city sees more frequent, severe and deadly asthma attacks, heart attacks, and strokes.
- According to a report commissioned by the Clean Air Task Force, fine particulate
  pollution from the valley coal plant was estimated to cost \$280 million in health care
  related expenses.
- Milwaukee has been consistently named among the worst places to live with asthma by the Asthma and Allergy Foundation of America.
- The valley coal plant draws 110,800 gallons of water per minute from the Menomonee River, pulverizes fish and other aquatic life in the process, heats the water to high temperatures, and dumps the hot water - complete with pulverized fish - back into the river.
- In terms of global warming pollution, coal is the dirtiest fuel burned in power plants. The valley coal plant pumps almost 2 million tons of carbon dioxide into the city's air annually equal to the emissions of more than 300,000 cars.
- Milwaukee County was ranked among the dirtiest 10% of all counties in the U.S. for toxic chemicals released by power plants and industry, with the valley coal plant ranked as the top polluter in the city. (www.sourcewatch.org).

Dear Council Members:

In compliance with requirements of the Clean Air Act Amendment, the Wisconsin Department of Transportation is required to closely monitor traffic levels and changes in traffic patterns on the highway system in the Southeastern Wisconsin Ozone Non-attainment Area. To meet these requirements, WISDOT has requested to use City of Milwaukee traffic count data collected under our annual traffic counting program, and to expand the program as needed to meet the stricter data collection standards imposed on them. As part of their request, funding will be provided for all traffic counts beyond those normally collected by the City, as well as all necessary training for City employees involved in the traffic data collection. Similar grants have been provided to the City by WISDOT for this purpose on an annual basis since the inception of this program in 1993. Traffic volume counts to be completed in 2011 and 2012 include counts on roadways in the southern and central portions of the City.

The estimated cost of the expanded traffic count program for 2011 and 2012 is \$90,818 which will be funded by the Wisconsin Department of Transportation.

We have prepared and recommend adoption of the attached resolution, which authorizes the City Engineer to apply for and accept funding for the 2011 and 2012 Vehicle Miles of Travel Monitoring Grant, and to perform all work outlined in the Grant agreement. The resolution also authorizes and directs the City Comptroller to establish all necessary accounts, and to make appropriations to these accounts in the amounts set forth in the Grant agreement.

To meet the travel monitoring requirements included in the Federal Clean Air Act Amendments (CAAA) of 1990, the DEPARTMENT, the Wisconsin Department of Natural (DNR), Resources the Federal Administration (FHWA), and the Federal Environmental Protection Agency (EPA), noticed in 1993 that actual vehicle miles of travel (VMT) would be determined in the Southeastern Wisconsin Air Quality Non-Attainment Area, using the Department's established coverage traffic count program, enhanced with a sample of local function roads and an expanded control count program. This resulted in a 50% increase in counting effort by the DEPARTMENT's District 2, not including any counts within the City of Milwaukee.

Because the CITY had a long established traffic count program, the DEPARTMENT deemed it advisable to have the CITY expand its existing program to the enhanced program standards, rather than have the DEPARTMENT duplicate or replace the CITY's efforts.

It is the intent of this Agreement that the CITY provide the enhanced traffic counting services for roadways within jurisdictional boundaries of the City of Milwaukee. The scope of the 2011-12 enhanced traffic counting work to be performed by the CITY is indicated by the following estimates of traffic counting services and costs:

The City of Milwaukee, Department of Public Works, Infrastructure Services Division shall:

- 1. Perform 48-hour weekday traffic volume counts on all links of routes in the City of Milwaukee functionally classified as arterials and collectors. For purposes of this agreement, a link is defined as a segment of a functionally classified route between intersections with two other routes classified as arterials or collectors.
- 2. Perform 48-hour weekday traffic counts on a randomly selected sample of local function routes in the City of Milwaukee, with specific count locations to be defined by the DEPARTMENT.

- 3. Counts to be taken during calendar year 2011 will be in the southern, and counts to be taken during calendar year 2012 will be in the central portions of the City of Milwaukee.
- 4. Provide 7-day control counts during the four seasonal quarters of the year. Nine counts will be required for each functional classification of roadway (arterial, collector, and local). The City's "Key Count" program will be used as part of this control count program.
- 5. Provide the necessary vehicle for the transportation of personnel and equipment assigned to the 2011 count program.
- 6. Provide the DEPARTMENT, within 2 weeks of count completion, one copy of all count data sent by email, and send copies of Traffic COMP III Field Reports, for all counts.
- 7. The counts defined in items 1 and 2 above will be distributed over a 3-year cycle. This agreement is intended to cover work completed during the period October, 2011 through September 30, 2012.

The cost of these services, by billing period, are summarized as follows:

October 1 through December 31, 2011	\$25,948
January 1 through March 31, 2012	\$12,974
April 1 through June 30, 2012	\$25,948
July 1 through September 30, 2012	\$25,948

Work specified and eligible for reimbursement under this Agreement will commence on October 1, 2011. It is expected that all 2011 field data collection covered under this contract will be completed by November 30, 2011, with all data collected to be delivered to the District office by December 31, 2011. All 2012 field data collection covered under this contract will be completed by September 30, 2012 with all data collected to be delivered to the district office by October 31, 2012.

The DEPARTMENT will provide reimbursement of actual costs for services and items provided by the City for the enhanced traffic count program. However, total reimbursement to the CITY shall not exceed \$90,818 without prior agreement and approval of both parties for any additional services provided. Cost reimbursement shall be full compensation for all wages, fringe benefits, proratables and incidentals included in the work, and shall include training and training related travel for a maximum of 4 CITY workers in traffic data collection policies, procedures and recommended practices of the DEPARTMENT as necessary for successful project completion. The costs included in this contract reflect costs that exceed the CITY's normal traffic count program.

The DEPARTMENT will supplement, on a loan basis, the CITY's present 13 portable traffic count machines, to a combined total of 30 to 34 machines. The DEPARTMENT will be responsible for the repair of the supplemental machines. The DEPARTMENT will provide the peripheral equipment, hardware and software needed to operate the machines, and a compatible lap-top personal computer for the downloading of data.

The use of CITY forces is considered to be in the public interest because the CITY currently operates a traffic count program, is familiar with the conditions and characteristics of the area to be counted, and have trained staff available to perform all necessary work.

The City will charge actual costs incurred and attributable to the aforementioned services as follows:

### 1. Description of Grant Project/Program (Include Target Locations and Populations):

As required by the Clean Air Act Amendment, the Wisconsin Department of Transportation must monitor highway usage in the Southeastern Wisconsin Ozone Non-Attainment Area. As an indicator of reductions in vehicle usage needed to meet emission reduction goals, the DOT must monitor changes in traffic demand on the arterial roadway system in Southeastern Wisconsin. Traffic counts must therefore be taken on each arterial roadway segment, and on a sample of local roadways, to determine current roadway usage levels. To meet these requirements, Wisconsin DOT has requested to use traffic count data obtained by the City of Milwaukee under its annual traffic count program, and to expand the program as necessary to provide coverage of the entire City. Funding for all traffic counts beyond those normally completed by the City, as well as training for City employees involved in the collection of traffic count data, will be provided by Wisconsin DOT under this grant project.

### 2. Relationship to City-wide Strategic Goals and Departmental Objectives:

The program funds expansion of the City's traditional traffic count program to more closely monitor travel trends in the City of Milwaukee, which will allow a more complete, concise and timely evaluation of the impact of the City's effort to reduce single occupant vehicle use in the City.

### 3. Need for Grant Funds and Impact on Other Departmental Operations (Applies only to Programs):

The additional funding received under similar Grants provided by Wisconsin DOT during past years has allowed the City to nearly double the number of counts typically completed on an annual basis. While allowing the City and DOT to monitor the impact of vehicle emission reduction efforts, the expanded count program has also provided improvement to the City's traffic data base. Current traffic count data is more readily available for facility design and operational needs, and has consistently reduced the costs of many projects completed by eliminating data collection needs.

#### 4. Results Measurement/Progress Report (Applies only to Programs):

Not applicable.

### 5. Grant Period, Timetable and Program Phase-out Plan:

The Grant is to cover work beginning October 1, 2011, to be completed by September 30, 2012. Training of City staff in current traffic count procedures and technology will occur in fall of 2011 and in early April of 2012. Traffic count data collection will begin in October 1, 2011 with traffic counts scheduled to be taken in the central portions of the City, and at any remaining locations in the southern portion of the city not completed during the prior year's program. All 2011 counts are to be completed by late October/early November of that calendar year. All 2011 data reduction and analysis required is to be completed by December 31 of that calendar year. In spring of 2012 any traffic counts left from the 2011 season will be completed. Traffic counts had been completed under similar projects beginning in 1993. The traffic data collected in the central portions of the city will be compared by DOT with traffic counts taken in this area in 2009 to determine any changes in traffic patterns in the area. It is anticipated that grant funding will again be available for the Federal fiscal year, beginning in September, 2012.

### **Dear Committee Members:**

The following responds to your request for Department of City Development analysis of the Village of Greendale's Comprehensive Plan relative to reporting criteria C-1, C-2, and C-3 of Resolution File No. 080457.

C-1 — Whether the water can be used directly or indirectly to facilitate new residential, industrial, retail or commercial development in the community which has applied for water service, and the value of such development and the number of new jobs and residents that such development will generate.

The proposed water sale would not significantly influence the development of new residential, industrial, retail or commercial development within the Village because the Village of Greendale is currently served by water utility. In addition, land use trends in the Village have been fairly consistent over the last several years. The Village does not anticipate a significant change in land use over the next 20 years.

C-2 – Potential negative social and economic impacts on the City due to lost opportunities for attracting new businesses and jobs to Milwaukee, and the loss of businesses and jobs that exist in Milwaukee.

Based on the recommendations and projections outlined in the Village of Greendale's comprehensive plan, the sale of water to the Village does not seem to represent any negative social or economic impacts to the City of Milwaukee. The Village is currently fully developed and served by water utility and the Plan states the desire to preserve much of the existing neighborhood character and density.

C-3 – The current land use patterns in the community which has applied for water service and expected trends in land use if Milwaukee provides water to the community.

Land use trends in the Village have been fairly consistent over the last several years. Based on the most recent land use data from 2000, the primary land use within the Village was single family residential (41.7%). Commercial land use accounted for 3.9% (or 140 acres) of land within the Village and Industrial accounted for 1.4% (or 51 acres) Even though the Village has not retained its original focus on agriculture, there is still a significant emphasis on non-urban land uses in Greendale. Natural resource areas and open lands account for approximately 24% of the land area in the Village. As identified in the Village's Comprehensive Plan, based on the community's historic emphasis on maintaining significant open space and declining population projections provided by SEWRPC, the Village does not anticipate a major change in land uses over the next 20 years. Planned 2035 land uses are essentially unchanged from 2000 land use percentages.

Whereas, Downer Delaware LLC previously requested a special privilege to construct or to keep several encroachments into the public right-of-way for the premises at 2608-50 North Downer; and

Whereas, These encroachments include a building façade, fence, masonry planter, moveable planters, two stairways, display racks for merchandise, and excess door swings; and

Whereas, Permission for said items was granted in 2008 by adoption of Common Council Resolution File Number 060793; and

Whereas, Subsequently, several items have been removed from the public right-of-way and other items are now permitted

to occupy the public right-of-way per revisions to the Milwaukee Code of Ordinances; and

Whereas, The applicant is requesting permission to construct and maintain a bicycle corral in the east parking lane of North Downer Avenue; and

Whereas, A site visit revealed the presence of several dumpsters, recycling carts and a grease trap in the public right-of-way; and

Whereas, Said bicycle corral, dumpsters, recycling carts and grease trap may only legally encroach into the public right-of-way by granting of a special privilege resolution adopted by the Common Council; now, be it

Resolved, By the Common Council of the City of Milwaukee that Common Council Resolution File Number 060793 is hereby rescinded; and, be it;

Further Resolved, that Downer Delaware LLC, 788 North Jefferson Street, Suite 800, Milwaukee, Wisconsin 53202 is hereby, granted the following special privileges:

- 1. To construct and maintain a bicycle corral in the east, 8-foot wide parking lane of North Downer Avenue commencing at a point approximately 14 feet south of the intersection of the westline of North Hackett Avenue and the eastline of North Downer Avenue and extending 15 feet 4 inches to the south. Said bicycle corral consists of two multi-hoop bicycle racks, three bollards, and a rubber parking curb.
- 2. To install and maintain four dumpsters, two recycling carts and a grease trap in the west, 22-foot 6-inch wide sidewalk area of North Hackett Avenue. The area occupied by the dumpsters and grease trap projects 7 feet into the public way, commences at a point 67 feet northeast of the eastline of North Downer Avenue and extends southwest 21 feet.
- 3. To keep and maintain a fountain with appurtenant plumbing and electrical facilities in the public right-of-way between and adjacent to North Hackett Avenue and North Downer Avenue north of East Belleview Place. Said fountain is approximately 7 feet in diameter with the fountain basin being surrounded by a 6-inch wall.
- 4. To keep and maintain three wood benches with iron ends in the public right-of-way. Two benches are located in the east sidewalk area of North Downer Avenue and one bench is located in the west sidewalk area of North Hackett Avenue. The benches are 4 feet long and 1 foot 6 inches wide.
- 5. To keep and maintain fifteen moveable planters in the east, 15-foot wide sidewalk area of North Downer Avenue. Said planters are constructed of wood and measure 5 feet long, 1 foot wide and 1 foot 6 inches tall.
- 6. To keep and maintain a stairway projecting 7 feet into the west, 22-foot 6-inch wide sidewalk area of North Hackett Avenue which connects the sidewalk grade to the second floor. Said stairway, which consists of a double-back section with two platforms, commences at a point approximately 21 feet northeast of the eastline of North Downer Avenue and extends northeast 15 feet 4 inches, parallel to the westline of North Hackett Avenue.
- 7. To keep and maintain a stairway to the basement that projects 6 feet 6 inches into the west, 22-foot 6-inch wide sidewalk area of North Hackett Avenue. Said basement stairway commences approximately at the eastline of North Downer Avenue and extends 21 feet to the northeast, parallel to the westline of North Hackett Avenue.
- 8. To keep and maintain a stairway to the basement that projects 6 feet into the westerly 22-foot 6-inch wide sidewalk area of North Hackett Avenue. Said 4-foot 6-inch wide stairway is centered approximately 90 feet northeast of the eastline of North Downer Avenue.

grantee, Downer Delaware LLC, shall:

- 1. Become primarily liable for damages to persons or property by reason of the granting of this special privilege.
- 2. File with the Commissioner of Public Works a certificate of insurance indicating applicant holds a public liability policy in the sum of at least \$25,000 covering bodily injury to any one person and \$50,000 covering bodily injury to more than one person in any one accident and \$10,000 covering property damage to any one owner on the area or areas included within the special privilege and naming the City of Milwaukee as an insured. The insurance policy shall provide that it shall not be cancelled until after at least thirty days' notice in writing to the Commissioner of Public Works.
- 3. Pay to the City Treasurer an annual fee, which has an initial amount of \$1819.59. The subsequent annual fee is subject to change pursuant to the annual fee schedule in effect at the time of annual billing.
- 4. Whenever this special privilege is discontinued for any reason whatsoever, including public necessity whenever so ordered by resolution adopted by the Common Council not only remove all construction work executed pursuant to this special privilege, but shall also restore to its former condition and to the approval of the Commissioner of Public Works and curb, pavement or other public improvement which was removed, changed or disturbed by reason of the granting of this special privilege. Such grantee shall be entitled to no damages due to the alteration and/or removal for such purposes.

Returned herewith is Common Council Resolution File Number 101516, being a resolution to amend a special privilege to Downer Delaware LLC for addition of a bicycle corral, dumpsters, recycling carts and grease trap in the public right-of-way for the premises at 2608-50 North Downer Avenue.

The applicant is requesting permission to construct and maintain a bicycle corral in the east, 8-foot wide parking lane of North Downer Avenue. The bicycle corral, which occupies the entire 8-foot wide parking lane, commences at a point approximately 14 feet south of the intersection of the westline of North Hackett Avenue and the eastline of North Downer Avenue and extending 15 feet 4 inches to the south. Said bicycle corral consists of three yellow plastic bollards, which denote the limits of the corral; a rubber parking stop at the corral's south end; and two multi-hoop bicycle racks.

A site visit revealed the presence of dumpsters, recycling carts and a grease trap in the westerly, 22-foot 6-inch wide sidewalk area of North Hackett Avenue. The area occupied by these items projects 7 feet into the public way, commences at a point 67 feet northeast of the eastline of North Downer Avenue and extends southwest 21 feet. A total of four dumpsters, measuring 3 feet 4 inches by 6 feet 7 inches; two recycling carts, measuring 2 feet 1 inch by 3 feet; and one grease trap, measuring 3 feet by 5 feet occupy the aforementioned area.

Previously, the applicant had requested permission for a building façade, fence, masonry planter, moveable planters, two stairways, display racks for merchandise, and excess door swings. Permission for said items was granted in 2006 under Common Council Resolution File Number 060793. Subsequently, several of the aforementioned items were removed from the public right-of-way and the Milwaukee Code of Ordinances was revised so that some of the items are now permitted to occupy the public right-of-way without a special privilege. Items that have either been removed or are now permissible are not included in the attached resolution.

We are not aware that the presence of said items will have an adverse effect on the general use of the public right-of-way. We have, therefore, prepared the attached special privilege resolution, which, if adopted, will allow said bicycle corral, dumpsters, recycling carts and grease trap to occupy the public right-of-way.


