**10-YEAR PLAN TO END HOMELESSNESS** A coalition of more than 100 agencies and individuals worked throughout 2009 to develop a 10-Year Plan to End Homelessness in Milwaukee. The plan, expected to be released in early 2010, will include recommendations regarding preventing homelessness, emergency shelter, employment

strategies, behavioral health and support services, and development of permanent supportive housing units. The Milwaukee Continuum of Care, an organization of agencies that work to prevent homelessness and provide services to homeless individuals, sponsored the planning project.

# **2009 POINT IN TIME SURVEY**

As required by the U.S. Dept. of Housing and Urban Development, the Continuum of Care conducted a 24-hour count and survey of homeless individuals the weekend of January 28, 2009. The survey counted 1,660 adults and children who were homeless in Milwaukee. This number includes both sheltered and

unsheltered individuals, and does not include people who are doubling up or living in sub-standard housing units. A copy of the data collected during the survey is available at www.mkedcd.org/SupportiveHousing/ Resources/pdfs/ MilwaukeePointinTime2009.pdf.

# LOCAL, ILLINOIS STUDIES LINK SUPPORTIVE HOUSING TO COST SAVINGS AND IMPROVED QUALITY OF LIFE

Data released in 2009 regarding the experiences of residents at United House in Milwaukee and a larger study in Illinois provide insight into the impacts of supportive housing.

Our Space, Inc. provides recovery-oriented supportive services at United House, a 24-unit supportive apartment building at 2500 W. Center St. that opened in August 2008. According to outcome data compiled by Our Space for 2009, residents required minimal use of emergency mental health services, and most scored high on coping skills assessments, participated regularly in community activities offered at the building, and were compliant with medication needs. No residents of United House were arrested during the year. Most residents of United House are at risk of homelessness because of mental illness.

The Illinois study examined expenditures for Medicaid, mental health hospitals, substance abuse treatment, and corrections for 177 residents of supportive housing, comparing expenses for the two years before they entered supportive housing and the two years after. It found a 39 percent reduction in the total cost of services from pre- to post-supportive housing, with an average savings of \$2,414 per resident per year.

Other findings:

- Once in supportive housing, residents who had previously lived in more restrictive settings (i.e., nursing homes, mental health hospitals, and prisons) were unlikely to return.
- Residents shifted the type and volume of services they used, from a high reliance on expensive Inpatient/Acute services before supportive housing to less expensive Outpatient/Preventive services after supportive housing.
- Residents reported an increased quality of life after entry into supportive housing. Not only did their housing stabilize, but their health improved, and they experienced less stress.

Because the analysis did not include public costs related to homeless shelters, meal programs and free clinics, the study authors concluded the actual savings linked to supportive housing were even higher.

# Mission of the Commission

The enabling legislation established the following mission for the Commission on Supportive Housing:

"... serve as a community infrastructure with the institutional commitment and the financial resources necessary for providing safe, affordable and accessible housing options with supportive services for persons with mental illness or other special needs. The commission shall establish goals and benchmarks for the effort to address housing needs for persons with mental illness and other special needs in the community, and monitor progress and hold the community accountable for meeting those goals."

At the request of Mayor Tom Barrett and County Executive Scott Walker, the Milwaukee Common Council and the Milwaukee County Board both enacted legislation creating a City/County Commission on Supportive Housing in September and October, 2007. The commission held its inaugural meeting January 15, 2008.

The enabling legislation provided for appointees to the commission representing the philanthropic community, the Milwaukee Continuum of Care, mental health advocacy organizations, and mental health consumers, and citizen and business representatives. Two new members were appointed to fill vacancies on the Commission in 2009: Robert Berlan and Ken Schmidt. A list of the Commission's membership is contained in this report.

# **2009** ACTIVITIES

The Commission held quarterly meetings, on January 13, April 28, July 28 and October 15, 2009. Agendas and minutes of these meetings are available at www.supportivehousingmilwaukee.org Throughout 2009, Kenyatta Yamel chaired the Commission, and James Tarantino served as vice-chair.

The Commission received quarterly updates on the development of supportive housing units in Milwaukee County.

The Commission received ongoing updates regarding the 10-Year Plan to End Homelessness developed by the Milwaukee Continuum of Care.

The Commission engaged in advocacy on behalf of several supportive housing projects and related legislation.

- The Commission advocated for the continuation of 2009 levels of funding for supportive housing activity in the 2010 Milwaukee County budget. This effort was successful.
- The Commission advocated for proposed state legislation that requires that health insurance policies provide coverage for mental health services at a level comparable to coverage for physical health services. The legislation was pending at the end of 2009.

#### Message from the **County Executive**

The partnership between Milwaukee County and the City of Milwaukee through the Commission on Supportive Housing has quickly shown positive results for those with special needs in our community. Breaking ground on several developments and meeting the residents excited to move into the newly completed buildings has been heartwarming.

It is wonderful to see the steady progress being made on developing permanent supportive housing in Milwaukee County. The participation of city, county, and community organizations has created safe and affordable options for those who are at risk of homelessness. The seamless collaboration of agencies from both the public and private sectors shows what is possible when we are all focused and committed to a shared core mission.

Congratulations to all those involved in meeting a critical need. These first projects provide a successful model that will attract future partners. The Commission on Supportive Housing's role will continue to improve the quality and number of housing options in the community.

# **2009 SUPPORTIVE HOUSING DEVELOPMENT ACTIVITY**

Two new supportive housing developments opened their doors in 2009.

• Prairie Apartments, a 24-unit building at 1218 W. Highland Blvd., held a grand opening celebration April 3, 2009.



Guest House of Milwaukee and Heartland Alliance of Chicago teamed up to sponsor the development. The project provides 24 new one-bedroom and studio apartments with private baths and kitchens.



Other amenities include a fitness center, technology center, laundry facilities, and tenant storage. Rent subsidies are available for two-thirds of the units.

Prairie Apartments serves individuals at risk of homelessness because of mental health or other conditions. Supportive services are provided to tenants by Guest House of Milwaukee.



• Washington Park Apartments, a 24-unit building at 3940 W. Lisbon Ave., held a grand opening December 18, 2009. The project was developed by United Methodist Children's Services, and includes 12 apartments reserved for families in recovery from homelessness or mental illness.



The building includes new space for the UMCS Family Resource Center food and clothing bank. Washington Park Apartments was financed with Low Income Housing Tax Credits, and received additional assistance from the City and County Housing Trust Funds, Local Initiatives Support Corporation, and the Helen Bader, Greater Milwaukee, Jane Bradley Pettit, Elizabeth Brinn and Wells Fargo Foundations.

Construction was underway at year's end at Milwaukee's largest supportive housing development to date.

• Ground was broken May 28, 2009 for Johnston Center Residences, a 91-unit building at 1230 W. Grant St., Milwaukee.



The developer is Mercy Housing Lakefront, and supportive services will be provided by Hope House. The project involves renovation of the former Johnston

Community Health Clinic and construction of a new addition on the north side of the building. The City and County Housing Trust Funds have provided grants to the project, and the U.S. Department of Housing and Urban Development is

### 2. Approval of the minutes of the April 27, 2007 meeting

Mr. Durtka moved approval of the minutes, Ms. Cubias seconded. There were no objections.

# 3. Review and discussion on the following sister city relationship requests to determine if they should be invite to submit a formal application:

Ald. Davis said the committee has two sister city relationship requests on the agenda today, the first is for Manisa, Turkey (Exhibit 1) and the second is for uMhlathuze, South Africa (Exhibit 2).

Ald. Davis asked the representatives for Manisa, Turkey to come forward.

Ald. Witkowiak appeared and introduced Mr. Robert Miranda, Executive director of Esperanza Unida, Inc. and said Mr. Miranda will brief the committee on the background for this sister city relastionship request. Mr. Witkowiak also said that he is in full support of a sister city relationship between Manisa, Turkey and the City of Milwaukee.

*Mr.* Miranda introduced Dr. Fethullah Canpolat, the Program Director for Esperanza Unida, Inc. and said that he is the person that is organizing the efforts for a sister city relationship with Manisa, Turkey. Mr. Miranda gave a brief overview on the efforts being made to establish a sister city relationship with Manisa, Turkey.

Ms. Cubias asked what is the size of the city of Manisa?

*Mr. Miranda replied that the size is comparable to that of Milwaukee with a population of about 600,000. He said right now there is a lot of growth in businesses in Manisa.* 

*Mr.* Durtka said that it sounds like an economic kind of approach to the relationship and asked what other kinds of aspects do they see resulting from this relationship?

Mr. Miranda replied that they are focusing a lot on trade and building commerce, but they are also looking at educational, professional and cultural exchanges.

Mr. Durtka said he noticed that Mr. Miranda is taking the lead on this whole sister city relationship and asked if there is a Turkish community in the City of Milwaukee that is involved in this effort and, if yes, to what extent?

Dr. Fethullah replied in the affirmative.

Mr. Miranda replied that there is an ad hoc group of individuals who comes together every week and he and Dr. Fethullah have met with them and the group is very excited about being a part of the efforts to establish a sister city relationship with Manisa, Turkey.

Ms. Cubias said the MANISA ILIM VE KULTUR VAKFI is a non-profit group and asked what do they do?

Mr. Miranda replied that the MANISA ILIM VE KULTUR VAKFI group does similar work to that of Esperanza Unida. He said their operation is centered on student development.

A motion was made by Mr. Durtka and seconded by Mr. Vang to invite Manisa, Turkey to submit a formal Application.

Ald. Davis invited the representatives for UMhlathuze, South Africa to come forward.

Ald. Davis said that he received a call from Ms. Devon Turner with the Milwaukee Metropolitan Association of Commerce who sends her regrets that she is unable to make this meeting. He also said that the members should have a copy of the letter in their packets from Business Council (Exhibit 3) that is the non-profit organization who is spear heading the efforts to establish a sister city relationship between Umhlathuze, South Africa and the City of Milwaukee.

Mr. Macheil Van Nieker the Political Council for the South Africa Consulate General (Chicago) appeared. He gave a brief overview on the background and history of Umhlathuze, South Africa. He said that this sister city relationship can offer a lot to both Cities, including cultural and educational exchanges.

Mr. Durtka said that he is hesitant at this point to approve this sister city relationship, because of the fact that it looks like a business to business kind of relationship and that in order for a sister city relationship to work well there should be a local community organization involved. He asked if there is another connection other then the Municipal Government in Umhlathuze, South Africa, such as a local organization, cultural group or educational group that is also interested in being involved in the efforts to establish a sister city relationship with Milwaukee?

Mr. Fanika said that the Chambers of Business in South Africa is excited about being involved and will be quite active.

Ald. Davis said that there is an e-mail that is included in the member's packets (Exhibit 4) that explains that uMhlathuze, South Africa, Commerce of Business and the Milwaukee Chamber of Commerce will be the non-profit organizations that will spear head the efforts for this sister city relationship.

Mr. Durtka asked if there is any local organization in Milwaukee, besides the Milwaukee Chamber of Commerce that is going to participate in the efforts in establishing a sister city relationship with Umhlathuze, South Africa? Ald. Davis replied that he first has to disclose that he has been nominated as an honorary Counsel to the country of South Africa and he will have to abstain from voting on this item. He than said that he will be very much involved in the efforts for a sister city relationship between Umhlathuze, South Africa and the City of Milwaukee.

Ms. Cubias asked what is the population of uMhlathuze, South Africa?

*Mr.* Fanika replied that population is growing and right now there is about 1/2 million to 600,000 people.

A motion was made by Mr. Durtka and seconded by Ms. Cubias to invite uMhlathuze, South Africa to submit a formal application. The motion Prevailed. 3-1. (Ald. Davis sustained)

### 4. Review and approval of applications

Ald. Davis said that there is one application to review at this time and that is the renewal application for Galway, Ireland. He asked the representatives for Galway, Ireland to come forward.

The following appeared and introduced themselves: Ald. Murphy, 10th Aldermanic Dist., Jane Anderson, Executive Director, Irish Festivals, Inc. and Mr. Joe King, President of the Board of Directors for Irish Festivals, Inc.

Ald. Murphy thanked the committee for scheduling this item. He explained the similarities between Ireland and Milwaukee. He explained the reasons why they chose the City of Galway to have a sister city relationship with and gave some background on the relationship. He also gave a brief overview on past and present activities and on what activities are being planned for the future. He said that he is in full support of this sister city relationship with Galway, Ireland.

Ms. Anderson said that Ald. Murphy covered quite a bit. She said this will be the thirteenth year that representatives from Galway, Ireland will appeared in the City of Milwaukee for Irish Fest. She said while they are here they will meet with local organizations and officials, that she will facilitate. She said as Ald. Murphy pointed out, this year the Irish Fest will feature Galway, Ireland. She also said that about 3-4 media representatives will be broadcasting, during the Irish Festival, back to Galway, Ireland.

Mr. King said that Ald. Murphy and Ms. Anderson covered everything and he has nothing else to add. He said this is an excellent relationship and he is in full support of this sister city relationship.

Ald. Davis said that Irish Festival, Inc., sister city relationship with Galway, Ireland would be considered the standard or the norm as far as what a sister city relationship should be. He said that this sister city relationship is a good model that should be replicated.

Mr. King said that they would be happy to volunteer their time to work with other local organizations who have or is interested in establishing a sister city relationship.

Mr. Durtka asked if Irish Festivals, Inc. has some kind of annual report that could be use as a model for other sister city relationships?

Mr. King replied that they follow and work very closely with other Irish Festival organizations and several of them have come up with a brief 6-7 page report and they are

currently in the process of putting one of those together.

Mr. Durtka said the Sister Cities international will be meeting in Ireland in 2009.

Ald. Davis explained the benefits to being a member of Sister Cities International.

Ald. Davis said this is a five year agreement and this committee will expect an annual report from Irish Festival, Inc.

A motion was made by Mr. Durtka and seconded by Mr. Vang to approve the renewal application for the sister city relationship between Galway, Ireland and the City of Milwaukee. The motion prevailed. (4-0)

Mr. Cubias asked if the agreement signing cermony will take place as at Irish Fest?

Mr. King and Ms. Anderson said that would be an excellent idea.

Ald. Davis said that Ms. Anderson can start working with the Mayor's Office to make the arrangements for the official agreement signing ceremony.

#### Dear Alderman Davis

I have been asked to pass on thanks to you again for facilitating the video conference on January 13<sup>th</sup>, 2008. From the Consulate's perspective we thank you and acknowledge your role in fostering international ties for the City of Milwaukee.

For the sake of good order I would like to re-cap briefly on the discussion that occurred so that all parties are cognisant of what is required to realise the objectives of that discussion.

All parties involved, which included members of the Milwaukee Business Community, the Academia and local Government, mutually agreed:

- That a sister city agreement between uMhlathuze and Milwaukee is feasible and that it should be investigated
- > That we should agree on how best to begin the process

- Participate in a program with a real partner so all members of the community can feel they are contributing to international understanding in a direct personal way.
- Better understand their own community by interpreting their way of life to the people of another culture

Against this background I am pleased to inform you that Honourable Mayor Councillor Mnqayi has communicated his written intent to proceed as stated in the attached letter addressed to Honourable Mayor Barrett. In his letter he has re-iterated the areas of cooperation that were explored during the video conference in January 2008.

I wish to add that the Consulate General of South Africa on behalf of the Government of South Africa fully supports the initiative and would still fulfil a facilitative role.

### 1. Roll call

Ald. Davis welcomed Ms. Kathy Blair, the Commissioner of Health Bevan Baker's new designee who is replacing Dr. Vivian Chen.

Present 5 - Blair RN, Cubias, Davis, Durtka, Vang

Also present: Ronald Leonhardt-City Clerk and Amy Hefter-Legislation Reference Bureau

#### 2. Approval of the minutes of the February 25, 2008 meeting

Mr. Durtka moved approval of the minutes, Ms. Cubias seconded. There were no objections.

#### 3. Review and approval of applications

Ald. Davis said the two applications that will be reviewed today are Manisa, Turkey (Common Council File #071506) and uMhlathuze, South Africa (Common Council File #071584).

He asked if there were any questions by committee members on the applications.

*Ms.* Cubias said that there was a Turkish organization that appeared in Milwaukee last week and asked if any one had the chance to meet with the**m**?

Ald. Davis replied in the negative and said his office wasn't contacted by the organization, but he was advised that the Mayor's Office was contacted, but could not meet with the organization.

Ms. Cubias said that it was too short of a notice for the Mayor to meet with the organization, because they were coming to Milwaukee on March 17th through the 19th and the Mayor's Office received the request the Friday of the week before. She said she did contact the organization and informed them about this sister city relationship request. She said Mr. Miranda with Esperanza Unida, Inc. was also notified that the organization was coming to Milwaukee.

Ald. Davis asked Ms. MacDonald if the application that was submitted by Esperanza Unida, Inc. is a complete application?

Ms. MacDonald replied in the affirmative.

Mr. Durtka said that he is still confused on the relationship between Esperanza Unida, Inc., who proposed the sister city relationship between Milwaukee and Manisa, Turkey and the local Turkish community organization, as to whether or not it has been established.

Ald. Davis asked if it the pleasure of the committee to hold this application for further review?

A motion was made by Mr. Durtka and Ms. Cubias seconded, that the application be held for further review. The motion prevailed. (3-1). Ald. Davis objected.

Ald. Davis said that he is objecting because the application before them that was submitted by Esperanza Unida, Inc. is a complete application.

Ald. Davis said the next application before this committee for consideration is for uMhlathuze, South Africa.

Mr. Leonhardt appeared and said that at the time the application was distributed to the members and staff it was not complete and asked if it has been completed since then?

Ms. MacDonald replied that it has been completed. She said that the completed application is included in the member's packets that were given to them at start of the meeting.

Ald. Davis said he has a video for the committee members to see on the City of uMhlathuze. The members and staff viewed the video. (10 minute video)

Ald. Davis said the application that is before us is a complete application and asked for a motion to approve and forward it on to the Community and Economic Development Committee.

A motion was made by Mr. Durtka and Ms. Cubias seconded, to approve the uMhlathuze, South Africa application and to forward it on to the Community and Economic Development Committee. There were no objections. (Ald. Davis abstained)

Ald. Davis said that now that this committee approved the uMhlathuze, South Africa application he can announce that on April 29, 2008, there will be an event call South African freedom day that will be held at Discovery World. He said he will have invitations for each of the Sister Cities Committee members to attend. He also said that the agreement signing ceremony will take place on May 1, 2008.

#### 4. Review of current sister city relationships

Ald. Davis said a letter has been received from Ms. Wilma Giese regarding the sister city relationship with Schwerin, Germany (Exhibit 1). The letter states that the German-American Societies of Milwaukee met and voted to discontinue the Sister City Relationship between Milwaukee and Schwerin, Germany.

A motion was made by Mr. Durtka and Ms. Blair seconded, to terminate the sister city relationship with Schwerin, Germany at this time. There were no objections.

Ald. Davis asked Mr. Leonhardt tell the committee members about the e-mail that he received from a Mr. Soojin Choi with Seongnam, South Korea.

Mr. Leonhardt explained that Mr. Soojin Choi's e-mail requested the procedures on how to go about establishing sister city relationship with Milwaukee (Exhibit 2).

Ald. Davis said that the Consul General for Korea was here about two months ago at a formal event and told him that he is seeking a sister city relationship between Milwaukee and South Korea. Ald. Davis said he will be contacting the Consul General for Korea who is located in Chicago to brief him on the procedures and recommend that he send a formal letter requesting a sister city relationship.

Ald. Davis asked Ms. Cubias if she knows what is going on with the sister city relationship with Nuevitas, Cuba.

Ms. Cubias said that Mr. Raul Galvan said he doesn't want to move forward with a formal application at this time, because the USA government does not have a relationship with Cuba.

Ald. Davis asked Mr. Leonhardt if he has any suggestions in how to handle the relationship with Nuevitas, Cuba.

*Mr.* Leonhardt said the committee has several options on how to handle the sister city relationship with Nuevltas, Cuba; it can proceed to terminate the relationship, it can give Mr. Galvan time to contact Ald. Davis on what his intent is or it can just leave the relationship on the books for now.

Ald. Davis recommended that they hold Nuevitas, Cuba at this time and instruct the City Clerk's Staff to contact Mr. Galvan to get clarification from him on his intent for the sister city relationship with Nuevitas, Cuba.

A motion was made by Ms. Cubias and Mr. Durtka seconded, to hold Nuevitas, Cuba until the next Sister Cities Committee meeting, in order to give the City Clerk's Office staff time to contact Mr. Galvan to get clarification from him on his intent for the sister city relationship between Milwaukee and Nuevitas, Cuba. There were no objections.

#### 5. Review and approval of the Sister Cities Committee annual reports

Ald. Davis said that according to s. 320-47 of the Milwaukee Code of Ordinance, the Sister Cities Committee is required to submit an annual report. He said Ms. MacDonald has prepared the 2006 and 2007 annual reports. He said the members should have draft copies of the reports before them for their review. He asked if there are any questions or comments on the reports?

*Mr. Durtka asked that both reports be amended by inserting his full formal name. (Alexander Durtka, Jr.) There were no objections.* 

A motion was made by Mr. Durtka and Ms. Cubias seocnded, to approve the 2006 report and to refer it to the Community and Economic Development Committee for final approval.

A motion was made by Ms. Blair moved and Mr. Durtka seconded, to approve the 2007 report and to refer it to the Community and Economic Development Committee for final approval.

#### 6. Next meeting date and time

Ald. Davis said that due to the April elections, the next meeting will have to take place in May 2008. He said City Clerk's staff will contact the members to set the next meeting date.

#### 2. Approval of the minutes of the March 24, 2008 meeting

*Mr.* Durtka moved approval of the minutes, *Mr.* Vang seconded. There were no objections.

#### **3.** Review and approval of applications

Ald. Davis said there is one application that will be reviewed today and that is Manisa, Turkey's (Common Council File #071506). He said that application was held at the last Sister Cities Committee meeting, because there were concerns by some of the committee members regarding the connection between the Esperanza Unida, Inc. and the local Turkish community.

Ald. Davis asked the representative for Manisa, Turkey to come forward to give a brief overview.

Ald. Witkowiak, Mr. Robert Miranda, Executive Director for Esperanza Unida, Inc. and Dr. Fethullah Canpolat, the Program Director for Esperanza Unida, Inc. appeared.

*Mr. Miranda said that Esperanza Unida has been working closely with the local Turkish community for the past three years. He explained that Esperanza Unida, Inc. works to build relationships with all immigrants and provides job training and placement.* 

*Mr.* Miranda than gave an overview of Esperanza's relationship with the local Turkish community and what its intention are for this sister city relationship.

*Mr. Witkowiak said he supports this relationship between Manisa, Turkey and the City of Milwaukee 100%.* 

Dr. Canpolat said that he is originally from Turkey and has lived in the USA since 1966. He explained his connection to and how he became involved with Esperanza

#### Unida.

*Dr.* Canpolat said that the relationship with Manisa, Turkey will not only be a social relationship, but a business relationship as well.

*Dr*, Canpolat said that he is planning to visit Turkey in the near future along with Ald. Witkowiak and Mr. Miranda and they will be working to develop business connections.

Ald. Davis said that Dr. Canpolat brought some additional guests with him and asked him to introduce them. Dr. Canpolat said all of these people that came with him are members of the Turkish cultural who meet weekly on the near south side of Milwaukee.

Ald. Witkowiak said that before he became associated with this group and involved with this idea of a sister city relationship with Turkey, he traveled to Turkey twice and said that the Turkish communities are looking for products and business connections with western countries.

Ald. Davis said that the cultural and economic exchanges are an important part of a sister city relationship, but the diplomacy between the local governments in the two countries is also important.

Ald. Davis said that the local government input on a sister city relationship shows that the relationship will not be one that would exploit one another.

A motion was made by Mr. Durtka and Mr. Vang seconded, to approve the Manisa, Turkey application and to forward it on to the Community and Economic Development Committee for its consideration. There were no objections.

2. Approval of the minutes of the April 2, 2008 meeting

*Mr. Durtka moved approval of the minutes, Mr. Vang seconded. There were no objections.* 

3. Review and approval of the application for Carora, Venezuela (Common Council File #080769)

Ald. Davis asked Ms. Terry MacDonald the Staff Assistant if the application submitted by Peace Action Wisconsin is a complete application?

Ms. MacDonald replied in the affirmative.

Ald. Davis said, back in July of 2006, the Mayor of Carora, Venezuela, Mr. Julio Chavez appeared before this committee and met with Mayor Tom Barrett to talk about a sister city relationship between Carora, Venezuela and the City of Milwaukee.

Ald. Davis asked the requestors for the sister city relationship with Carora, Venezuela to come forward and give a presentation.

*Mr. Erik Sperling, member of the Board of Directors for Peace Action Wisconsin and Ms. Babette Grunow appeared on this matter.* 

*Mr.* Sperling said his intent for this sister city relationship with Carora, Venezuela is open to all kinds of connections, such as, exchanging of music, art, culture, business ventures, etc.

Ms. Grunow said they are also planning on having educational and healthcare

#### exchanges.

*Mr.* Sperling said the Mayor of Carora has established a program that offers free eye surgery for low-income citizens of Milwaukee and other US cities. Carora's government will also pay for the cost of transportation for the U.S. citizens to go to Carora for the eye surgery.

*Mr.* Sperling said another initiative that the Mayor of Carora has planned is to donate energy saving light bulbs to the City of Milwaukee.

*Mr.* Durtka asked *Mr.* Sperling what kind of activities have occurred since he submitted his initial sister city request to the City of Milwaukee in 2006?

*Mr.* Sperling replied that he has spent a good part of the past two years trying to find a local non-profit organization that has a 501c3 status to sponsor this sister city relationship.

*Mr.* Sperling said in the past two years there has been numerous educational events with Carora and on several occasions he had hosted visiting diplomats, including Consulate General Martin Zanchez (Chicago) and the Venezuelan ambassador.

Ald. Davis said he met with the Consulate General and other Venezuelan dignitaries here in Milwaukee at the United Community Center regarding this sister city relationship and they have renewed their commitment.

Ald. Davis said at the same meeting the dignitaries said they would like to work with the City of Milwaukee Health Commissioner on their eye surgery initiative.

*Mr.* Durtka asked if Peace Action Wisconsin is the sponsor of the sister city relationship or is it just the fiscal agent?

*Mr.* Sperling replied that there are a number of community organizations that are behind this sister city relationship, but Peace Action Wisconsin is the official sponsor because it has a 501c3 status.

Mr. Durtka asked if Peace Action Wisconsin will be the reporting entity?

*Mr.* Sperling replied, he is a Peace Action Wisconsin board member and he will be the one doing the annual reporting for this sister city relationship.

*Mr.* Durtka moved and *Mr.* Vang seconded to approve the Carora, Venezuela application and to forward it on to the Community and Economic Development Committee. There were no objections.

# 4. Discussion relating to the status of the City of Milwaukee's current sister city relationships

Ald. Davis asked Mr. Ronald Leonhardt to appear on this matter.

*Mr.* Leonhardt said the City Clerk's Office held an agreement signing ceremony with Galway, Ireland in August 2008.

*Mr.* Leonhardt indicated that his office received a call from *Mr.* Miranda regarding an agreement signing ceremony for the sister city relationship with Manisa Turkey. He said a date has not been set yet.

Ald. Davis asked what is the status of the sister city relationship with Nuevitas, Cuba?

Ms. MacDonald indicated that she send a letter to Mr. Raul Galvan the requestor for the sister city relationship with Nuevitas, Cuba in May 2008. She said she also sent an e-mail and contacted Mr. Galvan by phone and left a voice message last week. She said Mr. Galvan replied by phone that he is not interested in submitting an application for a sister city relationship with Milwaukee.

Ald. Davis indicated that he had also spoke with Mr. Galvan and Mr. Galvan said he was unhappy with the City of Milwaukee's current sister city process.

Ald. Davis recommended that the sister city relationship with Nuevitas, Cuba be terminated.

A motion was made by Mr. Vang and seconded by Mr. Durtka to terminate the sister city relationship with Nuevitas, Cuba. There were no objections.

# Accomplishments in 2008

At the February 25, 2008, Sister Cities Committee meeting, the committee reviewed the renewal application received for Galway, Ireland from Irish Festivals, Inc. After reviewing the application the committee moved to renew the relationship.

The committee also recommended moving forward with the requests to invite uMhlathuze, South Africa and Manisa, Turkey to submit formal applications for a sister city relationship with the City of Milwaukee.

At the March 18, 2008, the Common Council adopted File Number 071505 -Substitute resolution renewing the sister city relationship between Milwaukee and Galway, Ireland. On August 15, 2008, the City held a Sister City agreement signing ceremony between Milwaukee and Galway, Ireland.

At the March 24, 2008 Sister Cities Committee meeting, the committee reviewed the application received for uMhlathuze, South Africa from The Business Council, Inc. After reviewing the application the committee moved to enter into a sister city relationship with uMhlathuze, South Africa.

At the April 9, 2008, the Common Council adopted File Number 071584 -Substitute resolution establishing a sister city relationship with uMhlathuze, South Africa. On May 1, 2008, the City held a Sister City agreement signing ceremony between Milwaukee and uMhlathuze, KwaZulu Natal, South Africa.

At the April 2, 2008 Sister Cities Committee meeting, the committee reviewed the application received for Manisa, Turkey from Esperanza Unida, Inc. After reviewing the application the committee moved to enter into a sister city relationship with Manisa, Turkey.

At the April 9, 2008, the Common Council adopted File Number 071506 -Substitute resolution establishing a sister city relationship between Milwaukee and Manisa, Turkey. At the time this report was finalized, an agreement signing ceremony had not take place yet for Manisa, Turkey.

During 2008, the Sister Cities Committee determined that the sister city relationships with Schwerin, Germany and Nuevitas, Cuba be terminated due to lack of information on activities, reports, and documentation as required to meet the goals and guidelines set by Sister Cities International.

On May 20, 2008, the Common Council adopted File #071634 - Resolution relating to terminating the sister city relationship with Schwerin, Germany.

Resolution File #081547 to terminate the sister city relationship with Nuevitas, Cuba was introduced and approved by the Common Council in 2009.

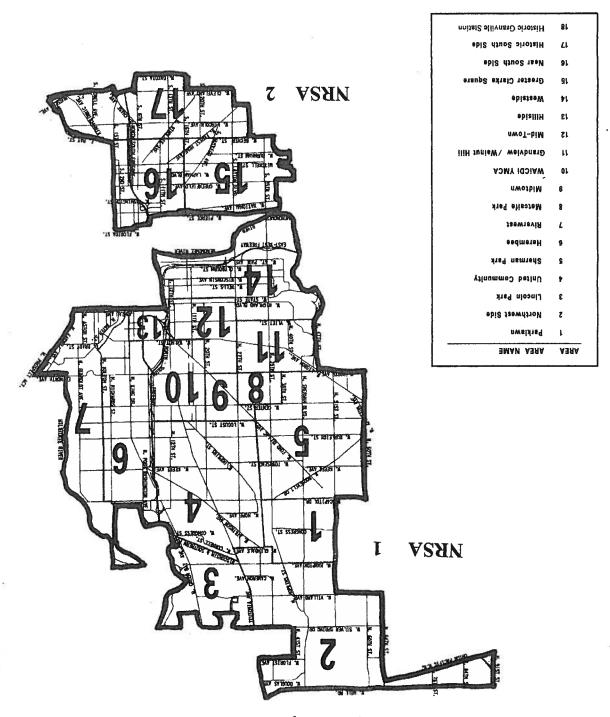

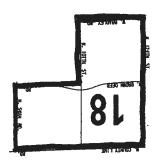
