This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 09/25/18 a 17 year old working in conjunction with the Milwaukee Police Department and WI WINS Tobacco initiative, was able to purchase a 2 pack of Grape Swisher Sweet Cigars at 1831 W. National Avenue, The sales clerk admitted to selling the item and the station was mailed a MARTS enrollment packet.
- 2. On 03/20/2019 officers were dispatched to the Citgo, 1831 W. National Av, for an aggressive panhandler. The officer spoke with the owner, Barkat ALI, who stated the subject was scaring customers away. The officer was not able to locate the subject.
 - 3. On 09/08/20 at 4:04pm, Milwaukee Police were dispatched to 1831 W. National Av, for an armed robbery complaint. Officers spoke with the victim who stated that he was robbed at gun point by two unknown suspects. The victim was pumping gas, and the suspects obtained his sunglasses that he was wearing. The suspects then fled the location in a silver van. Officers spoke with the gas station employees who stated that the suspects were in the sore prior to the incident. The employees provided officers a copy of the video that captured the incident.

- 4. On 02/04/21 at 5:55am, Milwaukee police were dispatched to 1831 W. National Av, for a vehicle theft complaint. Police spoke with the victim who stated that her vehicle was stolen while her boyfriend was getting gas. The victim does not know who may have taken her vehicle.
- 5. On 03/28/21at 5:09am, Milwaukee Police were dispatched to 1831 W. National Av, for a shooting complaint. The victim told police that he was walking in the area and an unknown suspect approached him. The suspect and the victim briefly spoke until the suspect pointed a gun at the victim. The victim then produced a bb gun in an effort to deter the suspect's actions of using his gun. The victim then attempted to flee and then was shot in his left leg. The victim entered the gas station and told the store clerk he was shot. The business was cooperative with the police investigation.
- 6. On 08/20/21 at 3:39am, Milwaukee Police were dispatched to 1831 W. National Av, for a fight complaint. Police spoke with the gas station employee who stated that an unknown suspect attempted to take items from the store. The employee attempted to stop the suspect and a fight occurred. The suspect then left the store without the items. The employee did not wish to prosecute and just wanted the police aware of the situation.
- 7. On 08/31/21 at 2:20am, Milwaukee Police were dispatched to 1831 W. National Av, for a trouble with subject complaint. The gas station employee called police regarding panhandlers outside the location.
- 8. On 10/21/21 at 3:30pm, Milwaukee Police conducted a meeting at District 2, regarding the business located at 1831 W. National Av. The meeting was regarding chronic loitering and panhandling related to the business during the hours of darkness. The agent stated that he has recently hired security in the last month that work from the hours of 5pm-1am. The agent has installed high output lighting inside and outside the store. The agent also has cameras that can be easily accessed and viewed by police when needed. The agent stated that he would continue to have an open line of communication with Milwaukee Police, and advise his newly hired security officer to do the same.

On Tuesday, September 8, 2020, at approximately 4:04pm, my squad partner (P.O. Thomas DANEK) and P.O. Elizabeth MCDARIS, while in full-duty Milwaukee Police Department uniform and equipped with Axon Body-Worn cameras, were dispatched to 1831 W. National Av. (which is located in the City and County of Milwaukee) for an Armed Robbery complaint. This location is the Citgo gas station.

Upon arrival, a Black male (who later verbally identified himself as Brandon M. PATTON, B/M, 09-24-87), stated that he was approached by Suspect #1 (a Black male, approximately 18 - 30 years old, approximately 5'08, thin build, dark complexion, short black curly hair, goatee, wearing a blue sleeveless t-shirt with a gold necklace, light blue jeans, and a black PAT belt) while PATTON was at Pump #1 at this location at approximately 3:08pm on Tuesday, September 8, 2020.

PATTON stated that Suspect #1 asked PATTON for a lighter. PATTON stated that as PATTON walked towards PATTON's vehicle to retrieve a lighter, Suspect #1 stated, "Those are some nice glasses" (referring to the Cartier sunglasses in which PATTON was wearing). PATTON stated that Suspect #1 then retrieved a black 9 mm handgun with an extended magazine from the front waistband of Suspect #1's pants and pointed this handgun at PATTON while stating, "This is me." PATTON stated that he threw the sunglasses onto the ground in front of Suspect #1 and then put both of his hands up in the air. PATTON stated that Suspect #1 then retrieved the sunglasses from the ground.

PATTON stated that Suspect #2 (Black male, approximately 18 - 30 years old, approximately 5'09, heavy build, medium complexion, medium length black curly hair, clean shaven, wearing a dark blue hooded sweatshirt with the word "Hustle" written in large white letters on the front of this sweatshirt and the word "Hustle" written in smaller white letters all over the rest of this sweatshirt, a white t-shirt, light blue jeans with a bright green stripe down the side of the pants legs, and black and white Nikes shoes) was also present but did not state anything.

PATTON stated that Suspect #2 entered the front passenger door of a silver van with tinted windows (unknown license plate), which was parked at the gas pump directly to the north of PATTON's vehicle.

PATTON stated that Suspect #1 also entered this vehicle. PATTON stated that Suspect #1 and Suspect #2 then fled from this location traveling southbound on S. 19th St.

PATTON stated that he had never seen neither Suspect #1 nor Suspect #2 prior to this incident.

PATTON stated that he purchased these Cartier sunglasses on September 7, 2020 for \$700. PATTON stated that he did not have a receipt, nor did he have the serial number for this property.

P.O. Elizabeth MCDARIS then entered the Citgo gas station at this location and spoke with both Citgo gas station employees (Maaz AHMAD, A/M, 12-12-97 and Adnan AHMAD, A/M, 06-15-91) who were on scene.

M. AHMAD stated that PATTON entered this location and was upset, yelling that PATTON was robbed because the gas pumps were not at this location. M. AHMAD stated that PATTON then went to the bathroom at this location. M. AHMAD stated that when PATTON exited this bathroom, he stated that he was robbed and his sunglasses were taken. M. AHMAD stated that he provided PATTON with the video of this incident that was captured by Citgo gas station surveillance video.

M. AHMAD stated that prior to PATTON entering this location and stating that he was robbed, Suspect #1 and Suspect #2 entered this location. M. AHMAD stated that Suspect #1 and Suspect #2 entered this location and got change (single dollar bills). M. AHMAD stated that Suspect #1 and Suspect #2 then exited this location. M. AHMAD stated that he never had seen Suspect #1 nor Suspect #2 prior to this incident. M. AHMAD stated that PATTON is a regular customer at this location.

A. AHMAD stated that had had never seen Suspect #1 nor Suspect #2 prior to this incident.

M. AHMAD then showed me the video of this incident captured by Citgo gas station video surveillance.

There were no witnesses on scene.

P.O. DANEK downloaded the video of this incident onto a USB memory stick. P.O. DANEK copied the video of this incident onto a DVD and inventoried this DVD as evidence (Inventory #20032882).

This report is being written by Police Officer Traves MARTIN assigned to District Two, Late Shift.

On Sunday, March 28th, 2021 at approximately 5:09 AM Squad 2321 (PO Tyler GNAS) were dispatched to a shooting at the address of 1831 W National Ave, in the City and County of Milwaukee. (Clark Gas Station)

The victim stated that he was walking near the area of S 18th St and W National Ave, when he was approached by an unknown subject, who was in possession of a some sort of bag. He continued to state that he and this subject were engaging in mutual conversation for a few moments, but he would not explain what the conversation was about. The victim then stated that the unknown subject then pulled a black semi-automatic firearm from the bag, and pointed it at him. He stated that this was when he produced his own "BB" (facsimile) firearm, and pointed it towards the armed suspect, in efforts to deter the armed suspect. He stated that he realized his counter efforts were not effective, so he attempted to flee from the armed suspect on foot. The victim stated that this was when he heard multiple gunshots, and then realized that he had been shot to his left leg.

An Interview was conducted of the gas station attendant that was on scene when the victim entered the business. Moazam SYED (w/m 1/19/1985) stated he observed the victim walk in and said he was shot. SYED observed the victim with a hand gun and observed him place it on top of the shelving units in the business. SYED said he observed blood on the victim's leg and the victim then laid on the ground.

All workers at the gas station were cooperative,

- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
