This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 09/13/2020 at 1:44am officers were dispatched to a Shotspotter call at 2307 N. 40th St. Responding officers observed a large crowd in front of Premier Sports Lounge, 4001 W. North Av, and located 3 vehicles parked in from that were struck by gunfire. The officers spoke with Deandre HARRIS who stated he was the owner of the business. HARRIS stated the business was closed and the officers could not enter. He did allow them inside but refused to show them the surveillance video.
- 2. On 10/12/20 at 11:30am, A call in meeting was held at the Third District Police Station with the applicant of 4001 W. North Avenue and members of the Milwaukee Police Department. During the meeting it was discussed how there was no cooperation between her employees and police, who wanted to obtain video surveillance, during a shots fired investigation. The applicant said the reports were incorrect and that all contacts would be documented. She also said that in the future she has no problem allowing police to view her cameras.
- 3. On 11/05/20 at 5:00pm, A person walked into the Third District Police Station to report a false imprisonment/armed robbery complaint which began at 4001 W. North Avenue. Investigation revealed that on 11/01/20 at 1:00am a subject was drinking at the tavern and later being in a vehicle with three females. The females drove the subject throughout the city punching,

stabbing, pistol whipping, and making her withdrawal money from an ATM. The subject was able to escape, flag down Milwaukee Police and received medical treatment.

- 4. On 03/07/21 at 1:09am, Milwaukee Police, along with the health department, conducted a license premise check at 4001 W. North Avenue. Upon arrival, officers and the health department workers attempted to open the front door but it was locked and a female answered the door by barely opening it not allowing anyone to see inside. The health department employee stated why they were there and the female closed the door and locked it without letting anyone inside. Officers then heard a female get on a microphone and tell patrons inside to "put on their masks" and the owner to talk with police. The front door was then unlocked and the applicant was reluctant to let officers and the health department inside. After the applicant allowed police and the heath department inside, they saw a lot of people inside the establishment and most were not wearing masks and social distancing. Officers also observed what appeared to be more people inside the location then capacity allows (80 persons). After leaving the location the heath department officials said that they would be issuing citations totaling around \$12,000.00.
- 5. On 05/27/21 at 1:09am, Milwaukee Police observed a large fight in front of 4001 W. North Avenue. Approximately 20 people were actively fighting, including tavern staff, which required 15 squads to disperse the crowd. After the crowd was dispersed, officers conducted a license premise check and found that most of the staff was uncooperative and argumentative regarding their investigation. The manager could not provide officers with any license information and there were no licenses posted. Investigation into the fight revealed that the manager had struck a female inside the establishment and the fight spilled out into the street. While talking outside with the victim/witness, multiple staff exited the business and began to fight with the victim a second time and the manager battered the victim a second time. The manager was arrested.
- 6. On 09/11/21 at 8:24pm, Milwaukee Police conducted a license premise check at 4001 W. North Avenue. Staff voiced an issue with the police department taking their security equipment on a different issue and requested that police keep driving around the area during tavern hours to keep vehicles secure and safe.

On Monday , October 12th , 2020, Squads 3272and 33274 (P.O Melvin FINKLEY and I) were in full Milwaukee Police Department uniforms with our badges and names affixed to our outermost garments,

On the aforementioned date at approximately 1:00PM (PO FINKLEY and I had a scheduled call in meeting at Milwaukee Police District with *Tabitha HARRIS (F/B 11/13/1973)* the owner of Premiere Sports Lounge

Attendance: Captain Steven JOHNSON, ADA Jesica Ballenger Tabitha HARRIS Deandre D HARRIS

During the call in meeting PO Finkley explained to HARRIS that there was a police report filed for a shots fired incident. During the incident there was reports that there was no cooperation with responding officers regarding viewing of the surveillance footage. HARRIS stated that the reports was inaccurate. HARRIS was informed that all contacts would be documented.

Captain Johnson also informed HARRIS that it is not our job to tell her how and what she should do with her business. HARRIS stated that she normally is there to run the business, when she is not there her workers manages the sports bar when she is not there.

HARRIS stated that in the future she has no problem with allowing Police in to view the cameras if they need to.

INITIAL INVESTIGATION

This report was written by PO Erica MARTINEZ, assigned to District 3, Early Shift.

On Thursday, November 5, 2020 at approximately 5:00 p.m., while working the front desk at District 3 (2333 N 49th St) I received a walk-in False Imprisonment/Armed Robbery complaint by verbally identified Jessica K LOHMEYER (F/W, 04/28/84) who was in the company of Benjamin J BERLOWSKI (M/W, 12/14/73).

LOHMEYER stated she was the victim of said incident on Sunday, November 1, 2020 between the hours of 1:00-4:00 a.m. LOHMEYER stated the incident began at Premier Sports Lounge bar, located at 4001 W North Avenue, which is located in the city and county of Milwaukee. LOHMEYER stated during the incident she was abducted and robbed by three unknown females, and that one of them was armed with a handgun. LOHMEYER stated she was also stabbed by a sharp object, pistol whipped on the head multiple times, and assaulted by the subjects to her head and body. LOHMEYER stated she managed to escape and eventually made contact with a police officer that night and was subsequently conveyed to Froedtert Hospital for medical treatment. LOHMEYER stated due to her injuries and condition, she followed up with the incident at a later time to make a statement. LOHMEYER stated during the incident approximately \$1,250 in cash was obtained, as well as her cell phone. LOHMEYER stated this was done intentionally and without consent, and wants to prosecute.

I observed LOHMEYER had stiches on her forehead, bruising to both of her eyes and right ear, and scratches to the right hand as well as several scabs on both of her hands. LOHMEYER stated there is additional bruising on her legs and puncture wounds on her head.

Squad 9261 (Detective Alexander AYALA) from CIB responded to the District and took over the investigation. The following is a copy of the report filed by Detective AYALA, which was obtained from Supplemental report 203100145.001.

Start of report

This report is being written by Det. Alexander AYALA, assigned to the Criminal Investigation Bureau, General Investigations Division, Early shift, Squad 9261.

On Thursday, November 5th, 2020, I was assigned to investigate a delayed reporting armed robbery/false imprisonment at the Police District #3, located at 2333 N. 49th St. I then spoke to P.O. Erica MARTINEZ who the desk P.O. and P.O. MARTINEZ stated that she had a victim by the name of Jessica K LOHMEYER (F/W, 04/28/84) who stated that she had been robbed at in Milwaukee and that she was at a bar at 4001 W. North Ave. I then proceeded to interview the victim regarding this incident.

On Sunday, November 1, 2020 at approximately 1:00 a.m., the victim, Jessica K LOHMEYER (F/W, 04/28/84) was at 4001 W North Avenue, which is located in the city and county of Milwaukee. LOHMEYER stated that after having some drinks at the bar she recalls being in a vehicle with three unknown females (unknown how she got inside). LOHMEYER stated one the females was armed with a handgun, and refused to let her exit the vehicle. LOHMEYER stated while in the vehicle the females forced LOHMEYER to show them her banking account balance from her cell phone and drove LOHMEYER to the Clarke Gas Station, located at 4950 W Lisbon Ave to withdraw approximately \$600 from the ATM. LOHMEYER stated the subjects were upset because the ATM did not allow them to continue to withdraw money and proceeded to driver her around the city. LOHMEYER stated at this time she was stabbed by a nail care instrument (possibly a cuticle scissor) in the head, pistol whipped on the head multiple times, and assaulted by the subjects to her head and body. LOHMEYER stated she was able to get away from the subjects and ran towards an MPD squad car located at 9550 W Brown Deer Rd. LOHMEYER stated at that time she did not have her shoes and cell phone and was suffering from her injuries. LOHMEYER stated she was conveyed to Froedtert Hospital that night for face and body contusions, and received 5-6 stitches on her forehead. LOHMEYER stated her cellphone and a total of \$1250 was taken from her that night (\$600 ATM, \$650 cash in her purse).

I observed LOHMEYER had stiches on her forehead, bruising to both of her eyes and right ear, and scratches to the right hand as well as several scabs on both of her arms. LOHMEYER stated there is additional bruising on her legs and puncture wounds on her head.

A Sick and Injured was filed by PO Andrew KELLER (IR 203060043) on 11/01/20. In the report LOHMEYER made similar statements but stated the incident occurred in Wauwatosa. Wauwatosa PD responded to the hospital and took over the investigation. LOHMEYER stated that night Wauwatosa PD took her clothing and some pictures but a report wasn't filed due to her injuries and condition. LOHMEYER stated she followed up with Wauwatosa PD today who advised her the incident is to be reported to the Milwaukee Police Department due to the incident location. Wauwatosa PD provided LOHMEYER report # 20-19630. A teletype was sent to Wauwatosa requesting any report copies.

She was not able to give a description of the suspects due to her state and she had no further information regarding this incident.

This report is written by P.O. Taylor ZUBE assigned to District 3, Late Power Shift.

On Saturday, March 7, 2021 at 1:12AM P.O. Kurt KEMNITZ (Squad 3465) conducted a tavern check on Premier Sports Lounge located at 4001 W. North Ave. due to the amount of cars parked outside the bar as well as the amount of people entering the bar. Mark STARKS and Tim STEIN from the Health Department were with us to conduct a walk through and check of their own.

As we approached the bar you could hear music coming from inside the bar. STARKS attempted to open the front door to the bar and the door was locked. A female answered the door barely opening the door not allowing us to see in. STARKS stated we were there to do a check and needed to come in. The female then closed the door locking it again and you could hear from inside the bar the female get on a microphone telling everyone in the bar to put their masks on and for the owner to come and talk to us. A male exited a rear door and then immediately went back into the bar through the back door.

The front door was unlocked and opened again and STARKS and STEIN as well as myself and P.O. KEMNITZ entered the establishment. Eventually, Tabitha A. HARRIS (b/f, 11-13-74) came to the front door, but was reluctant to let officers and STARKS and STEIN in at first. She eventually allowed us in to check and you could see that there were a lot of people inside the establishment and most were not wearing masks and were not following social distancing. I could also observe what appeared to be way more people inside the location than their capacity allows. Through the Lira system Premier Sports Lounge has a capacity of 80.

STARKS and STEIN finished talking to HARRIS and we left the location. HARRIS was issued a contact card with P.O. KEMNITZ and my information on it.

STARKS advised me once we got outside that the health department would be issuing citations for standing, masks, social distancing, and over capacity totaling around \$12,000.

This report is written by P.O. Kurt KEMNITZ, assigned to District 3 Late Power Shift.

On 05/27/2021 at approximately 2:00am Squad 3430, P.O. PETERSON and DAVIS, observed a large fight in the intersection of W North Ave, and N 40th St. This is directly in front of PREMIER SPORTS LOUNGE and no other businesses are operating at this time of night in the area.

Upon my arrival at the location I observed approximately 20 people in the intersection, including PREMIER staff fighting. This fight initiated multiple requests for additional squads which prompted a total of 15 squads to disperse the crowd. Once most of the crowd was dispersed and departed the scene due to Premier staff being involved I initiated a License Premise check.

Much of the staff inside the location was uncooperative and argumentative regarding the investigation. Staff did not cooperate when asked questions regarding the altercation and fight. It should be noted that NO licenses were posted and Deandre D HARRIS (b/m, 11/02/1975) who identified as the manager could not provide any licenses at the time of investigation.

After completing the investigation inside the business, I exited to speak with a female patron who stated she was battered by HARRIS. Alethia M TILFORD(b/f,07/11/1997) stated that she was battered by HARRIS which initiated the whole investigation. While investigating this battery complaint outside of the premises multiple staff exited the business and TILFORD and her party began to fight with staff for a second time. Police attempted to break up the fight of approximately 5-7 people in which HARRIS battered TILFORD again. HARRIS was arrested and the report is included at the end of this report.

Another male, Kentral RILEY -SAPP(b/m, 08/13/1992), (who was part of TILFORD's party) was arrested and cited for Disorderly conduct regarding his actions.

REPORT REGARDING HARRIS BATTERING TILFORD (IR211470018):

This report is written by P.O. Brandon BUELOW, assigned to District 3, Late Power Shift.

On Thursday, May 27th, 2021, at approximately 2:04AM, P.O. Kurt KEMNITZ and I (Squad 3465), were one of the backup squads that responded to a fight at 4001 W North Ave, in the City and County of Milwaukee.

Upon arrival to the aforementioned address, we observed an active physical altercation taking place between approximately 5-7 individuals, just outside the entrance of Premier Sports Lounge located on the southwest corner of N 40th St and W North Ave.

The individuals that were involved in the fight shouted to officer's on scene that the fight started inside the bar, then escalated outside before officer's arrived. Alethia M. TILFORD (B/F 07-11-1997) stated she was, intentionally and without consent, struck in the head approximately 3 times, causing her pain. TILFORD stated that while being escorted out at bar close she turned around and observed Deandre D. HARRIS (B/M 11-02-1975), in a colorful shirt and tanned shorts, behind her and that he was the one who punched her in the head. TILFORD stated that she was punched because a member in her group was missing their vehicle keys and she wanted to retrieve them from inside the bar.

Some time had passed and most of the individuals involved had dispersed and left the scene without further incident. TILFORD and HARRIS were among several individuals who remained on scene while officer's continued to conduct their investigation regarding a license premise check and the above mentioned battery.

At approximately 2:55AM, while several officer's were still on scene, another fight broke out just outside of the Premier Sports Lounge entrance involving approximately 5-7 individuals. Officer's quickly rushed over to the individuals involved in an attempt to break up the fight. While doing so, Sgt. Michael WASHINGTON observed Deandre D. HARRIS (B/M 11-02-1975), intentionally and without consent, with a closed right fist, strike Alethia M. TILFORD (B/F 07-11-1997), to the left side of her face. The actions of HARRIS caused TILFORD pain, as she fell to the ground immediately after she was struck.

HARRIS was taken into custody immediately by Sgt. WASHINGTON after he was observed striking TILFORD.

TILFORD declined medical attention.

While at District 3, in interview room 116, P.O. KEMNITZ attempted to conduct a Mirandized interview with HARRIS, after reading him his Constitutional Rights verbatim using the PM-2 (MPD Miranda Constitutional Rights Card), he declined to make a statement, all of which was recorded via Axon Camera System.
