There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-2.7-4, probative evidence concerning whether or not a new license should be granted may be presented on the following subjects: whether or not the applicant meets the municipal requirements, the appropriateness of the location and premises where the licensed premises is to be located and whether use of the premises for the purposes or activities permitted by the license would tend to facilitate a public or private nuisance or create undesirable neighborhood problems such as disorderly patrons, unreasonably loud noise, litter, and excessive traffic and parking congestion. Probative evidence relating to these matters may be taken from the plan of operation submitted with the license application, if any, but shall not include the content of any music. Evidence regarding the fitness of the location of the premises to be maintained as the principal place of business, including but not limited to whether there is an overconcentration of businesses of the type for which the license is sought; whether the proposal is consistent with any pertinent neighborhood business or development plans, or the location's proximity to areas where children are typically present. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should request an interpreter attend the meeting with you, at your expense, so that you can answer questions and participate in your hearing.

- 15. On 01/24/19 at 12:00am, Milwaukee Police were dispatched to 1341 W. Center Street for a property damage complaint. Upon arrival, officers interviewed the caller/employee who stated that a subject entered the establishment, shoved merchandise down his pants, and attempted to leave the store without paying for them. When the employee locked the front door and called police, the subject kicked the front door, damaging it. The subject then fled.

- 17. On 07/27/19 at 1:42am, Milwaukee Police were dispatched to 1341 W. Center Street for a theft complaint. Upon arrival, officers interviewed the caller/employee who stated that four subjects entered the establishment and stole 250 dollars' worth of groceries. The business was cooperative.
- 18. On 08/28/19 at 9:52am, Milwaukee Police were dispatched to 1341 W. Center Street. Upon arrival, officers interviewed the owner who stated that a subject entered the store, purchased a cigar, and started to roll it with a substance he believed to be marijuana. The area was searched for the subject, he was located, and arrested.

- 19. On 12/07/19 at 2:14am, Milwaukee Police were dispatched to 1341 W. Center Street for a ShotSpotter complaint. Investigation revealed that a vehicle entered the parking lot of the station, a subject exited the vehicle, he walked over to a dumpster, and fired 6 times in the air with a handgun. The vehicle then left the parking lot. The employee was cooperative and allowed officers access to the video surveillance system.
- 20. On 08/07/20 at 2:10pm, Milwaukee Police were dispatched to 1341 W. Center Street for a subject with a gun complaint. Investigation revealed that a subject fired a handgun at another subject who was sitting at N. Teutonia Avenue and W. Center Street waiting for the County Bus. A ShotSpotter did detect 8 rounds coming from the parking lot of the establishment location. Officers were able to obtain video surveillance of the incident from the establishment.

21. On 12/20/2020 at 12:18am officers were dispatched to a Shooting at 1341 W. Center St. The officers located a victim on the ground. The officers interviewed the clerk who stated there

was a fight inside the store and he kicked the subjects out. Once outside the clerk heard 3-4 shots fired. The clerk provided video of the incident. The video showed both the victim and suspect armed with firearms. The victim was shot as he attempted to enter an auto. The victim passed away due to his injuries.

- 22. On 01/05/2021 at 7:15am officers were dispatched to an Armed Robbery at 1341 W. Center St. The officers interviewed the victim who stated he came to the store to buy food for a subject he met outside. After buying the food they went behind the store and the subject displayed a knife and demanded the victim's money. After obtaining the money the suspect went back inside the store. The victim followed the suspect inside and they got into a physical confrontation. The victim was tackled by a security guard and the suspect got away. The security guard stated he did not see a knife and was just trying to stop a fight. The officers watched video of the incident inside the store but the system did not capture the robbery outside.
- 23. On 01/12/2021 a meeting was held at District 3 regarding recent incidents at 1341 W. Center St. At 12:00pm an officer spoke with the applicant by phone and he stated he was going to a funeral and would not be attending the meeting. The officers made numerous attempts to reschedule the meeting but the applicant never called back.
- 24. On 01/13/2021 at 6:38pm officers investigated a Strong Armed Robbery that occurred at 3:30pm at the N. Teutonia Av. and W. Center St. The victim stated he just purchased lottery tickets at the gas station at 1341 W. center St. and walked to the bus stop. The suspect was in the store buying gas. The suspect followed the victim to the bus stop with two additional suspects. One of the asked when the bus came. As the victim was answering the question the suspects knocked him to the ground. Once on the ground he was hit and kicked. When he got up he was missing his lottery tickets. The officers went to the business and recovered video. The business was cooperative with officers.
- 25. On 04/05/2021 officers went to the gas station at 1341 W. Center St. to check to see if they complied with their abatement plan, which was to be completed by 03/28/2021. The officers observed no loitering signs and cameras inside and out. The applicant was not on scene so the officer requested the clerk call the applicant by phone. The officer asked about the security company listed in the plan. The applicant stated he was still in the process of hiring a security company.
- 26. On 05/09/2021 at 5:34pm officers were dispatched to a Subject with Weapon at 1341 W. Center St. The investigation revealed two subject were fighting over who had the right to pump gas for customers. One of the subjects was armed with a machete. The officers interviewed the clerk and advised him to call police if he see subject attempting to pump gas for customers.
- 27. On 07/13/2021 a meeting was held at District 3 regarding 1341 W. Center St. The applicant was present with his attorney. The business was issued a nuisance letter in January 2021, they submitted an abatement plan in February and were sent a Failure to implement letter in April 2021. The attorney stated she wanted to appeal the nuisance designation. She stated the loitering issues seem to stem from the bathrooms because they had a door on the outside of the building. She stated that the problems have decreased since they closed the bathrooms for Covid-19. The applicant stated he did not hire security because the cost was too high. The applicant stated he would continue to try to hire security. The applicant was advised he also had no done an open records request as was stipulated in his abatement plan. He stated he

did not know how to make that request. was back open to in person requests.	The officers advised him that the opens record section

INITIAL INVESTIGATION

This report is being written by P.O. Randy BEAVER, assigned to District 3, Late shift.

On Tuesday, December 1st, 2020, at approximately 12:18 A.M. Squad 3340 (P.O. OBREGON) and I were dispatched to a shooting at the location of 1341 W Center St., which is located in the City and County of Milwaukee, State of Wisconsin. Upon arrival, we observed an unidentified B/M laying on the ground with a gunshot wound to his left chest. I spoke to the clerk who worked inside the gas station, Manjeed SINGH (W/M 07/15/1967) who stated he observed 5 B/M fighting inside his store, and after he kicked them out he heard 3-4 gunshots outside.

Surveillance video was able to be obtained, which showed a the victim attempt to steal a firearm from the suspect, which led to a fight inside the store. The fight continues outside. Both the victim and suspect are seen armed with firearms. The victim attempts to enter a vehicle and is shot by the suspect. The suspect flees the location. The victim is pushed out of the vehicle by the driver of the vehicle and is left on the ground by the doors of the business. The victim passed away because of his injuries.

CIB responded to the scene and conducted a homicide investigation.

On Tuesday, January 5th, 2021, at approximately 7:15 A.M. Squad 3340 (P.O. OBREGON) and I were dispatched to an armed robbery at the location of 1341 W Center St., which is located in the City and

County of Milwaukee, State of Wisconsin. Upon arrival, we made contact with the caller/victim, identified as Jonathan W MARWICK (W/M 05/03/1998), who stated that he was robbed at knife point, and that the suspect had fled the scene. Squad 3341 (P.O. Adam GONZALEZ and P.O. Matthew SCHLAX) also responded to the scene to assist with the investigation.

MARWICK stated that on todays date, he got off of the bus at the stop located at N 8th St and W North Ave and met with the suspect. MARWICK had agreed to purchase some food for the suspect, and they walked together to the Citgo gas station located at 1341 W Center St, and MARWICK purchased the food. They both left the store, and walked to an area behind the location. MARWICK stated that the suspect then brandished a knife and stated "give me all the money in your wallet". MARWICK proceeded to take out his wallet, and remove 15\$ dollars in US Currency and gave it to the suspect. The suspect then walks back into the store, and is followed by MARWICK. MARWICK continued that he asked for his money back, and he was attacked by the suspect. MARWICK stated the subject held a knife to his neck, and he attempted to defend himself before being tackled by the security guard. The suspect then fled the location on foot in an unknown direction. MARWICK sustained a small laceration on the hand during the fight.

I then spoke to the witness, identified as Reshun D BRAGGS (B/M 12-05-1995) who stated that he overheard the two parties arguing, and heard a commotion. BRAGGS then observed both parties physically fighting, before tackling MARWICK to try to break up the fight. BRAGGS stated he did not see the robbery take place, nor did he see the subject hold a knife to MARWICK's throat, he only observed the physical altercation.

We were able to view surveillance video from the gas station, which shows both MARWICK and the suspect enter the store, MARWICK purchases approximately 7\$ dollars worth of food from the subject, and then they both leave the location. A short while later, the suspect is seen entering the gas station, and is shortly followed by MARWICK. MARWICK and the suspect engage in non-confrontational conversation for a short time before MARWICK is seen attempting to strike the suspect. The suspect and MARWICK are shown physically fighting for a short time before MARWICK is tackled by security. The suspect is then shown leaving the location. The video does not show the robbery take place, as the location where MARWICK stated the robbery occurred is not covered by surveillance cameras. Follow up will be conducted to obtain a copy of the surveillance video.

We saturated the area but we were unsuccessful in locating the suspect.

MARWICK was issued a PV-17 and a community contact card.

This reports written by Police Officer Joseph DUNCAN, assigned to District 3, Early Shift.

On Wednesday, January 13, 2021 at about 6:38 p.m., P.O. Deja SLOAN and I, squad # 3231, responded to 8806 W Grantosa Dr. for a report of a strong armed robbery that had occurred at about 3:30 p.m. in the area of N Teutonia av and W Center st. The caller, Mark A YUNKER (W/M 4/17/60), reported that he was assaulted by 3 black males and had his lottery tickets taken.

Upon arrival, YUNKER met us outside. YUNKER told me that he was beaten and robbed of his lottery tickets at about 3:30 p.m., while waiting for the bus on the southeast corner of N Teutonia ave and W Center st. YUNKER had been working at Ashley's BBQ, 1501 W Center st. He stated that he left work at about 3:10 p.m. He walked to the gas station that is located on the southeast corner of N Teutonia ave and W Center st. There, he purchased \$32.50 worth of lottery tickets. He stated that the tickets were for the drawings of Super Cash, Badger 5, Mega Bucks, Pick 4, and Pick 3. He placed the tickets in his right side jacket pocket. YUNKER was not wearing his jacket when I spoke to him, but he showed me his tan color winter coat that he was wearing at the time. YUNKER stated that a black male came into the store and asked to buy \$1.00 in gas. YUNKER exited the store and went to the bus stop at the corner of the parking lot. The male who went in and asked for a dollar in gas also walked to the bus stop. Two other black males were with him. One of the subjects asked YUNKER when the bus was coming. YUNKER stated that he told him that he did not know, and that he just gets on the first one that shows up. He was then knocked to the ground. YUNKER did not know how he was knocked to the ground, but thinks he may have been hit in the head. All three of the black males that approached him then began to hit and kick him. He tried to get up, but could not. When the men stopped, YUNKER noticed that his lottery tickets were missing. He thinks that one of the subjects took them out of his pocket, but he was not sure if they reached into his pocket, or he dropped them.

YUNKER stated that one of the men was taller than the other two. One was shorter, and the third was between the other two in height. He thought the tallest was about his height, 5'07". He believed all three to be wearing hats. He could not describe the style of hats, or the color. He could provide no clothing description. I inquired as to whether one or more had a darker or lighter colored clothing, or any color that may have stuck out to him. He could not recall anything descriptive about any of the subjects, other than that they were slender.

YUNKER stated that after he was able to get up, he walked back to Ashley's BBQ. He told some co-workers what had happened. He stated that one was named Leon, but he forgot the name of his second co-worker. After some thought, he recalled that a third co-worker, Danny was also present. Danny drove YUNKER back to the bus stop and waited with him for his bus. YUNKER took the bus home. He noticed that his arm hurt when he reached for a cabinet, so he called Police to report the incident.

Officer BAUS requested additional assistance to recover video at a license premise where

several unknown subjects with the intent of steal used bodily forced on another human being and obtained property without consent with intent to permanently deprive him.

Upon arrival I spoke to employee, SINGH, who assisted law-enforcement retrieve several outdoor and indoor videos depicting suspects involvement. SINGH was cooperative during this investigation who passively knew a customer who was a victim of this robbery complaint stating the same male is a daily customer who buys coffee in the morning and frequently purchases lottery tickets in the afternoon.

On Monday April 5th, 2021 at approximately 2:35 pm squad 3271 (myself) and squad 3264 (P.O. Ordlyn Sanders) conducted follow up at the Citgo Gas Station located at 1341 W Center St., which is located in the City and County of Milwaukee.

We were conducting follow up to check the end of the gas stations abatement plan. The abatement plan was 45 days long and ended on March 28th, 2021. We did observe no loitering signs, four exterior cameras and 12 interior camera which were all listed in the abatement plan. We wanted to speak with the licensee identified as Harjinder SINGH (I/M, 07/20/1982) regarding security.

The abatement plan stated the gas station would be entering into a contract with a security company to provide armed security Wednesday through Sunday from 10:00 pm-3:00 am. The plan stated they intend to have an armed security guard onsite beginning the week of March 1st, 2021, but no later than April 5, 2021.

Upon arrival we spoke with an employee identified as Shardha SINGH (I/M, 08/01/1952) who stated that Harjinder SINGH was not at the location. I asked Shardha SINGH if he could contact Harjinder SINGH via phone.

I spoke with Harjinder SINGH via phone who stated he had left the location. I explained to Harjinder SINGH that we were attempting to check his abatement plan and were looking for information regarding the businesses' security. Harjinder SINGH stated he did not hire a security company and was still in the process of getting security.

I concluded the phone conversation with Harjinder SINGH.

This report is being submitted by P.O. Taylor CARLONI assigned to District Three - Early Power Shift, Community Prosecution Unit.

On Tuesday July 13th, 2021 at approximately 2:00pm a meeting was conducted with the licensee (Harjinder SINGH W/M, 07/20/1982) of Citgo Gas Station located at 1341 W Center Street and his attorney Samantha Huddleston.

The Citgo Gas Station located at 1341 W Center Street was put in a nuisance status in January of 2021, an abatement plan was accepted in February of 2021, they were sent a notice of failure to implement an accepted course of action in April of 2021 and went into billing April 2021. They are currently in billing for one year and received one bill thus far.

The meeting was scheduled by Attorney Samantha Huddleston to discuss the appeal and other nuisance issues. At the meeting was myself, Police officer Ordlyn SANDERS, Sergeant Troy JOHNSON, ACA Heather HOUGH, ADA Francesco MINEO, and Captain Steven JOHNSON.

Huddleston stated she wanted to discuss some of the issues the business is experiencing. Huddleston stated that SINGH was having issues with the outside bathroom at the business. HUDDLESTON stated she believed some of the loitering and other issues stemmed from the bathrooms. HUDDLESTON stated SINGH closed the bathrooms due to Covid-19 and has noticed a decrease in nuisance activity. The bathroom issue was not described in the submitted and accepted abatement plan. They were informed that District Three Community Prosecution Unit can help abate issues as they arise and were given contact information.

Huddleston also stated she wanted to discuss the appeal for the bill sent on May 19th, 2021. ADA Heather HOUGH explained that the appeal was submitted late on July 1st, 2021 and without the \$25.00. Huddleston and Singh are appealing the bill they received after they failed to implement the abatement plan. They failed to hire security as they stated they would in their abatement plan. Huddleston stated Singh was struggling to hire security due to the high cost and high demand. Singh stated he had tried to hire different people but was not able to get a security company. Singh also stated he was getting different prices from the same company decided not to hire due to the changing costs. Singh has not yet hired security and stated he is going to work on it.

Singh stated he is at the location daily and is typically there from 10:30am-2:30pm and sometimes stops in during the evening hours at about 9:00pm. When myself and partner P.O. Demetrious HUDSON made attempts to check the abatement plan we were unable to get in contact with Singh because he was at a

different business he owned. Singh did not meet us at the location either time.

I did mention to Singh that in his abatement plan he stated he would file an open records request for CADS at the location at least every 6 months. Singh failed to file an open records request for CADs during the 45 day abatement plan and had not made a request since 2019. Singh stated he did not know how to make a request through open records. ADA Heather Hough informed Singh that there is information within the nuisance designation letter explaining the process. I stated he could contact me if he needed information on how to make a request. Captain Johnson informed him our open records section is back open in person and is located on the second floor.

I gave Huddleston and Singh a contact guide and informed them they can contact me with any further questions or concerns.


