This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 12/03/20 at 7:58pm, Milwaukee Police conducted a license premise check at 2579 N. Teutonia Avenue. The reason for the check was because officers knew the establishment did not have a license and on 12/02/20 they observed a number of vehicles parked out front and the lights and televisions were on. Police were not able to perform a premise check on that date because they were flagged down for an assignment. When officers entered the establishment, they observed six people inside, multiple televisions on throughout the tavern, music playing, and a multi-colored strobe light functioning. Officers interviewed the owner who stated that he was open for business and when he was told that he did not have a license yet, he became uncooperative and defensive. The owner said that he was emailed the license and called the alderman requesting that he email them again. When advised that he needed a paper copy of the license, the owner became defensive and asked why he was being told he needed a license and what requirements he needed to be met. Officers told him he would have to contact the city licensing division to find out what requirements had to be met and the owner said that he will have a license next time they meet.
- 2. On 02/19/21 at 9:47pm, Milwaukee Police conducted a license premise check at 2579 N. Teutonia Avenue. Officers observed numerous vehicles, some illegally parked, and two lines outside the front door. Due to the large crowd, officers asked security outside, on two different occasions, if they could speak to the owner, but the owner did not come outside to speak with officers. Officers monitored the crowd and at tavern close, they roughly counted 519 people

- exiting the establishment using a hand-held counter (tavern capacity is 160). Due to a shooting in the area, officers were unable to make contact with the owner.
- 3. On 03/06/21 at 11:49pm, Milwaukee Police, along with the health department, conducted a license premise check at 2579 N. Teutonia Avenue. During the interaction, officers conducted a walkthrough and observed patrons not social distancing and not wearing masks. They interviewed security and ask how many patrons were inside and security told officers that they had counted 500 patrons (capacity of 160). After leaving the location, health department officials told officers that they would be issuing citations for standing, masks, social distancing, and over capacity totaling around \$12,000 (no citations could be found in the system).
- 4. On 03/15/21 at noon, a meeting was held at the Third District Police Station with the applicant of 2579 N. Teutonia Avenue. The meet was held because of the capacity issues and the owner of the business was not cooperating with police. The applicant said the manager of the establishment is named "Rob" (he does not know his real name and pays him through pay applications) and that the owner only owns the building, not the business inside, and should only be contacted when there is a maintence issue. The applicant was unsure of the security companies name but said that he has at least one security guard there at all times. When asked about the overcapacity, he said he was unaware of the issue but would make changes and would be at the location more often. The applicant was told he would be cited for the overcapacity on 02/20/21 (no citations could be found in the system).
- 5. On 03/18/21 at 9:48pm, Milwaukee Police conducted a license premise check at 2579 N. Teutonia Avenue. Upon arrival officers made contact with the front door employee who advised them who the manager was and they asked both of them the identity of manager "Rob". They told officers that the dayshift manager was named "Ron" and that he works sometime in the morning. The manager was asked if he knew the capacity of the tavern and he told officers that it was 260. When told that it was 160, the manager became defensive stating that it was "updated" today.
- 6. On 03/19/21 at 1:09pm, Milwaukee Police conducted follow-up regarding the manager named "Rob". The business appeared to be closed but a maintence worker answered the door and said that the only manager he knows is "Doug".
- 7. On 03/20/21 at 12:52am, officers observed a large number of vehicles, several illegally, parked on the street surrounding 2579 N. Teutonia Avenue. There were also 20-25 vehicles circling the area, blocking traffic, trying to find a place to park and 20 people standing outside the front entrance waiting to enter the tavern. While parking enforcement was handling the illegally parked vehicles, one officer, with the squad and body camera activated, started counting the patrons leaving the establishment and afterwards went inside to finish the count. While inside, the manager of the tavern refused to allow them to walk to the rear of the tavern to count the patrons still inside. The police left the tavern and ended up with a final count of 169 patrons (capacity 160).
- 8. On 03/21/21 at 1:53am, Milwaukee Police were dispatched to Mt. Sinai for a shooting victim. Investigation revealed that the victim was waiting in line to enter the tavern, located at 2579 N. Teutonia Avenue, when she got into a verbal argument with another subject. After finding out that the tavern was not letting anyone else inside, she walked back to her vehicle where she again was confronted by the suspect who shot her twice. Another squad was on scene and said the manager was cooperative with officers.

- 9. On 03/27/21 at 11:43pm, officers observed a large presence of vehicles parked, some illegally, outside the address of 2579 N. Teutonia Avenue. Parking enforcement was advised, security for the tavern was notified, and several patrons moved their vehicles. Several parking citations were issued.
- 10. On 04/25/21 at 12:30am, Officers observed approximately 200 vehicles parked surrounding 2579 N. Teutonia Avenue which is the only establishment open in the area. Officers also observed 10-15 people standing outside the tavern waiting to get in. Officers tried to enter the establishment but the front entrance was locked and security outside did not know why the door was locked. Someone eventually unlocked the door and when officers entered, there was a "smoky haze" inside which was later determined to be smoke emanating from cigarettes/cigars. While inside the tavern officers observed numerous 20oz empty bottles of Hennessy laying around, baggies of marijuana, cigarette buts, loose tobacco, and cigar wrappers on tables. The basement was checked and the breaker box for the building had wires exposed which could be a fire hazard and the only other exterior door to the tavern was locked and the courtyard it exited to, had a fence which was chained and padlocked. The applicant was contacted and told his establishment was 105 people over capacity.

- 11. On 05/01/21 at 1:41am, Milwaukee Police were dispatched to N. Teutonia Avenue and W. Clarke Street for a subject with gun complaint. Investigation revealed that the uncooperative caller said the incident happen inside the tavern located at 2579 N. Teutonia Avenue. Officers interviewed security who said that an altercation did happen inside the establishment and the female said the male had a firearm. Both subjects were escorted out, the male subject was searched, and no firearm was recovered. Security was cooperative.
- 12. On 05/13/21 at 4;20pm, Milwaukee Police, along with a Wisconsin Department of Revenue Agent and a DNS inspector, conducted a license premise check at 2579 N. Teutonia Avenue. Due to the tavern having two funeral events, the check was rescheduled but nine containers of shisha tobacco were confiscated because the tavern does not have a tobacco license.
- 13. On 05/14/21 at 2:00pm, a meeting was held at the Third District Police Station with the applicant of 2579 N. Teutonia Avenue. When asked what changes the applicant has made since last meeting, he replied that he has haired a new manager, has equipped security with a counter for capacity issues, and informed the building owner that he is not to be a part of day to day operations. The applicant was issued citations from item #10.
- 14. On 07/11/21 at 1:17am, Milwaukee Police were dispatched to 2579 N. Teutonia Avenue for a fight complaint. Investigation revealed that a large group of individual's left the tavern and engaged in a physical altercation outside which tavern security had to intervene.

This report is written by P.O. Taylor ZUBE assigned to District 3, Late Power Shift.

On Thursday, December 3, 2020 at 7:59PM, P.O. Ryan DOMBECK and I (Squad 3465) conducted a tavern check at Vibe Lounge located at 2579 N. Teutonia Ave. I know this tavern to have had a name change and the previous licensee gave up her license in August and the new owner/manager was in the process of going through the application process for a new license. With knowing this information I would drive by the location usually at least once a night to make sure they were abiding by not being open due to not having a license.

On December 2, 2020 at 11:14PM, P.O. Ryan DOMBECK and I (Squad 3465) were in the area driving by Vibe Lounge when we observed a number of cars outside the establishment as well as lights and TV's on inside. We conducted a tavern check (CAD#203372958) however as I was looking in the LIRA System to check if a license had been issued we were flagged down for another call for service and unable to make contact with the bar at the time which is why we went back out on 12-3-20.

A check of the LIRA System still shows that Vibe is still in the application process and have been approved by the City Council to get a licensee however they have requirements that need to be met first in order to have a license issued to them. With prior dealings with this establishment I know the owner to be slightly uncooperative so I requested a supervisor to come with us and Sgt. WASHINGTON (Squad 3413) responded to assist.

I observed 6 people inside the bar as we entered the bar; one behind the bar as a bartender, one sitting at the bar who appeared to be a patron, one who appeared security, one who appeared to be working in the kitchen, one who appeared to be cleaning up a back room, and the last person I knew to be Douglas L. GRAY (b/m, 11-19-70) who I know to be the owner/manager. Also as we entered the bar I observed there to be a multi-colored strobe light to be on in a back bar area, multiple TV's on through out the bar, and there was music playing.

I made contact with GRAY and asked him if he was open or just doing work on the place. GRAY stated he was open for business which I advised him he was not able to be due to him not having a license issued yet. GRAY became extremely uncooperative and defensive stating he was issued his license. GRAY stated he was emailed them and then he made a phone call to Alderman STAMPER requesting the email be sent to him again. I advised GRAY that he needed a paper copy of the license and it needed to be posted behind the bar and without that he could not be open. GRAY again became defensive and stated he wanted to know why he was being told he did not have a license. I advised GRAY that I was advised by the city clerk's office that he still had requirements that he needed to met in order to have the license issued and those had not been met yet. GRAY again became defensive asking what exactly the

requirements were which I advised him that he would need to as the city licensing division because I did not have that information. GRAY was told he needed to shut down for the night because he did not have a paper copy of the paperwork he was claiming to have which GRAY responded with "I'll have it the next time I see you".

This report is written by P.O. Taylor ZUBE assigned to District 3, Late Power Shift.

On Friday, February 19, 2021 at approximately 9:30PM I was notified by P.O. Jesus MERCED (Squad 3431) that Vibe Lounge located at 2579 N . Teutonia Ave. had numerous cars on the streets surrounding the bar as well as a 2 lines outside the front door of about 50 people each as well as were charging a cover fee of \$60 to get in. I notified Sgt. Kingston of the large crowd and he came to meet us.

At 9:47PM I put myself and P.O. Kurt KEMNITZ (Squad 3465), P.O.'s Jesus MERCED and Samuel KEHOSS (Squad 3431), and Sgt. KINGSTON (Squad 3412) on a Tavern Check to monitor the large number of cars and people. I know the capacity of this bar to be 160 and based on the large number of people and cars we stayed to monitor and attempt to speak to the owner/manager Douglas L. GRAY (b/m, 11-19-70) regarding the large crowd. I observed numerous cars illegally parked in bus stops and or covering crosswalks so P.O. MERCED and KEHOSS started issuing parking citations to cars that were illegally parked (9 total just in front of the bar).

At approximately 10:30PM Sgt. KINGSTON, P.O. KEMNITZ and myself attempted to speak to GRAY by asking security who was standing out front to have GRAY come outside the bar so we could speak to him. GRAY did not come outside to speak to us. At 10:32PM we heard 5 gunshots a block away in the intersection of N. 14th St. and W. Clarke St. Sgt. KINGSTON, P.O. KEMNITZ, and myself immediately went towards the gunfire to make sure no one was injured. Reference CAD#21-050-2492 and IR#21-050-0144 regarding the shotspotter.

At approximately 10:46PM we again attempted to speak to GRAY who again did not come out of the bar to speak to us. Sgt. KINGSTON advised us to stay and monitor the large crowd along with Squad 3431 and P.O.'s Brandon BUELOW and Daniel GOODCHILD (Squad 3440). I activated the squad camera in our squad and we parked on N. Teutonia Ave. facing southbound right across from the entrance to the bar so we could capture

everyone entering and exiting the bar.

While outside monitoring the crowd and traffic I overheard a few people in the crowd mention that the bar was charging \$100 for females to enter and \$150 for males to enter as well as they were charging \$1,000 a table. We were also advised that there was going to be a performer that would be arriving around 12:45AM.

At approximately 1:45AM a large number of gunshots were heard north of the bar near N. Teutonia Ave. and W. Center St. which caused the bar to close and everyone to start leaving. Sgt. Kingston advised me to try and get a count of the amount of people leaving the bar at this time. The squad camera was rolling and facing the front door of the bar while people were exiting. I counted with a hand held counter and ended with a rough count of 519 people that exited the bar. It should be noted that Vibe has a capacity of 160.

Do to the shots fired in the area turning into a shooting I was unable to try and make contact with GRAY again after the majority of the people had left.

On Saturday, March 6, 2021 at 11:50PM P.O. Kurt KEMNITZ (Squad 3465) conducted a tayern check on Vibe Lounge located at 2579 N. Teutonia Ave. due to the amount of cars parked outside the bar as well as the amount of people entering the bar.

At approximately 12:20AM on Sunday March 7, 2021 Mark STARKS and Tim STEIN from the Health Department came and met us to conduct a walk through and check of their own.

As we approached the bar there was a line of about 20 people standing outside of the bar waiting to get in. We made contact with one of the security officers who allowed us to enter the bar to make contact with the owner Douglas L. GRAY (b/m, 11-19-70). Both STARKS and STEIN did the majority of the talking to GRAY. P.O. KEMNITZ and I observed the bar as well as provided security for SARKS and STEIN while they conducting their check.

In the first room of the bar there was approximately 35-40 people standing and sitting at the bar as well as standing in the corner near what appeared to be the door to the kitchen. Not everyone was wearing masks and there was no social distancing being met. As we moved through the bar and into the back room there was probably another 200-250 people in close proximity on a dance floor and on a stage. I know Vibe to have a capacity of 160 people so based on observations alone there was more than 160 people in the building. I spoke to one of the security guards at the front of the bar and asked if he knew how many people were in the bar and he told me close to 500 he had counted. I advised him the capacity is only 160 and he appeared shocked.

STARKS and STEIN finished talking to GRAY and we left the location. GRAY was issued a contact card with mine and P.O. KEMNITZ information on it. STARKS advised me once we got outside that the health department would be issuing citations for standing, masks,

On Monday, March 15th, 2021 at approximately 12:00 PM, a meeting with the licensee of Vibe Lounge, identified as Reginald D. Butler (B/M 04/05/1958), was conducted to address issues with the establishment. This meeting was conducted at District 3 in the conference room. The parties who attended this meeting was Captain Steven Johnson, Sergeant Troy Johnson, Sergeant Chad Raden, Police Officer Ordlyn Sanders, Police Officer Taylor Zube, Police Officer Frank Williams, Assistant City Attorney Heather Hough, and Safe and Sound Coordinator Asia Carter.

We spoke with BUTLER who stated he was the registered licensee of Vibe Lounge and was unaware why we were conducting the meeting. Captain Johnson explained to BUTLER why we were having the meeting, due to over capacity issues and Douglas Gray, who says he is the owner of the establishment, not cooperating. BUTLER stated he understood and the meeting proceeded.

I asked BUTLER who is his manager and BUTLER responded with a guy by the name of "ROB." BUTLER stated he knew "ROB" wasn't the real name but wasn't sure what his actual name was. BUTLER stated, ROB was recommended to him through word of mouth by others he know, however didn't specify any more. BUTLER stated he pays "ROB" on payment apps and there is no written contract for him to be manager. BUTLER was asked what time "ROB" comes to Vibe lounge and BUTLER stated between the times of 5:30 PM -6:30 PM. BUTLER stated when he (BUTLER) is there ROB isn't and vice versa.

BUTLER was then asked who is Douglas GRAY, at which point, BUTLER stated that is the owner of the building; that "GRAY and his WIFE are the landlords of the building." BUTLER stated that GRAY is not the point of contact and should never be contacted unless there is a maintenance issue with the property. BUTLER stated he has known GRAY for approximately 20 years. We informed BUTLER that GRAY says he is the owner of the lounge and whenever police make contact with any representative of Vibe Lounge, GRAY acts as the point of contact.

BUTLER was asked who the security company hired for Vibe Lounge; BUTLER stated he believes it is Westly Walker Security but was unsure of their actual title. BUTLER stated he has security at certain times depending on the event at the establishment, however, he has at least 1 security guard there at all times.

BUTLER was informed of the over capacity issues and stated he wasn't aware of any issues. BUTLER stated neither "ROB" or Gray have told him there are issues at the establishment. GRAY stated he

understood what was occurring and he would make changes.

BUTLER stated he would change what is occurring by being at the location more and at different times. BUTLER stated he will need to replace ROB and get the information to the security company. BUTLER stated he will have a talk with GRAY regarding the statements that he is the owner and point of contact for the establishment.

BUTLER was then told by Captain Johnson that he will be issued a citation for over capacity for the night of February 20th, 2021 where his establishment was over capacity by 359 patrons. BUTLER also stated he was aware that his listed capacity is 160.

Clarke St. when I observed a large number of cars parked on the streets surrounding Vibe Lounge located at 2579 N. Teutonia Ave. I activated the front camera of Squad 517 as we circled the area and observed 127 cars parked on the streets surrounding the bar. I observed several illegally parked vehicles in the bus stops and blocking the crosswalks at the intersection of N. Teutonia Ave. and W. Clarke St. There were also approximately 20-25 cars circling the area blocking traffic trying to find a place to park to go into the bar. There was a line of about 20 people standing outside the bar as we drove past waiting to enter.

I notified Sgt. William KINGSTON of my observations and belief that the bar was probably over their listed capacity of 160 based on the number of cars and people standing outside. Sgt. KINGSTON advised me to call parking enforcement to see if they could send a few parking checkers out to issue tickets to the cars that were illegally parked around the bar (Complaint #C2111235). Around 1:45AM I noticed the exterior lights were shut off on the bar so I positioned our squad car on the Northeast corner of N. Teutonia Ave. and W. Clarke St. facing westbound and activated the front squad camera to capture everyone leaving the bar. I then stood outside of the Squad car with my body worn camera activated counting the number of people exiting the bar with a hand held clicker. Sgt. KINGSTON assisted Parking Enforcement while they issued parking citations while we waited for additional squads to come and help with traffic control. Squad 3451 (P.O.'s Jeremie GAINER and Devin WHITFIELD) and Squad 3441 (P.O.'s Joseph BINTER and Brandon BUELOW) arrived on scene to assist with traffic control and a walk through at the end.

Once the majority of patrons had exited the bar I was advised to conduct a walk through by Sgt. KINGSTON. I went in to the bar along with Squad 3441 and Squad 3451 to conduct a walk through and count the remaining people inside the bar. I made contact with the night manager Eddie J. PARR (b/m, 3-11-84) who stopped us from walking further into the

There was music still playing in the bar so I was unable to hear if PARR said anything to P.O. WHITFIELD because his face was turned away from me. One of the security guards Weasley T. To avoid any further confrontation or a fight with about 25-30 people that were inside the bar I made note of the number of people I saw inside the bar and we exited. I ended with a total count of 169 people which is 9 over their listed capacity of 160.

The victim was identified as Latrell S. WILLIAMS (b/f, 9-23-88). WILLIAMS stated she was in line outside of Vibe Lounge waiting to get into the bar when she observed the suspect waiting in line as well and a verbal argument ensued about issues from 2 years ago. WILLIAMS stated the bar was not letting anyone else in so she began walking back to her vehicle which was parked outside of 2535 N. Teutonia Ave. WILLIAMS stated the suspect followed her and a physical altercation ensued which then led to her being shot twice; once in the left pinky finger and once in the right thigh. WILLIAMS stated she was then driven to Mt. Sinai Hospital for treatment.

There was a shotspotter located at 2530 N. Teutonia Ave. for 1 round in the street (F81-559995) CAD#21-0800173). There was blood located in the street in front of 2527 N. Teutonia Ave.

I know Vibe to have at least 4 cameras covering the exterior of the bar that face southbound on N. Teutonia Ave. and westbound on W. Clarke St. as well as cameras that cover just inside the door. I have been told in the past by security at the bar that the cameras are just used to see what is going on outside of the bar and do not actually record.

Squad 3341 (P.O.'s John DAVIS and Keyandre CLAYTON) were on scene on N. Teutonia Ave. I was advised that P.O. DAVIS made contact with Eddie J. PARR (b/m, 3-11-84) who was cooperative with officers.

INITIAL OBSERVATIONS

On Sunday, April 25, 2021 at approximately 12:30AM while on routine patrol in the area of N. Teutonia Ave. and W. Clarke St. P.O. Kurt KEMNITZ and I (Squad 3465) observed approximately 200 vehicles parked on N. Teutonia Ave. and W. Clarke St. surrounding Vibe Lounge (2579 N. Teutonia Ave.) which is the only open establishment in this area at this time of night. I also observed a crowd of about 10-15 people standing outside waiting to get inside the establishment. Based on these observations and knowledge that Vibe Lounge has a listed capacity of 160. I contacted Sgt. William KINGSTON (Squad 3412) and advised him I wanted to conduct a count because I believed them to be over capacity.

Once all squads were on scene Squad 3450 blocked northbound traffic at N. Teutonia Ave. and W. Wright St. Squad 3431 blocked eastbound traffic at N. Teutonia Ave. and W. Clarke St. I activated my Axon Body Worn Camera as we approached the front door to the establishment and observed about 6 people standing outside the front door. P.O. LETTEER tried to open the front which was locked from the inside and we observed numerous patrons inside the establishment. Security outside the front door stated they did not know why the front door was locked. It took approximately 15 seconds for someone inside the bar to open the door. As we entered the bar there was a smoky haze inside. Due to the amount of smoke it was believed that a fog machine was on, however it was later determined that the smoke emanated from cigarettes/cigars. I asked who had control of a counter or knew how many patrons were inside the establishment at this time. P.O. MACRAE and P.O. LETTEER made contact with the bartenders advising them an announcement needed to be made that everyone needed to exit the establishment. I was directed to an individual who was standing behind a counter just inside the door. I was told by this individual that he had 165 patrons counted right now and I observed that number on his silver hand held clicker he was using.

While standing behind the bar as patrons exited the bar P.O. LETTEER observed two females exiting the bar with what appeared to be a large stack of single dollar bills each.

I then made contact with head security guard Wesley T. WALKER (b/m, 1-3-81) and advised him we were going to be conducting a count so the music needed to be turned off and an announcement made that all patrons needed to exit the establishment through the front door. It should be noted that as police entered the establishment numerous patrons exited upon seeing police enter. P.O. KEMNITZ and I stood at the front door of the establishment as patrons exited. I counted the number of patrons as they exited both out loud for my body camera to hear as well as on a hand held clicker. Per Vibe's occupancy license they have a **total capacity of 160** which includes their employees. Once all patrons had exited the establishment I entered to finish counting the employees left inside. I ended with a **total count of 265** patrons and employees which is **105 over their listed capacity**. It was decided by Sgt. KINGSTON that the establishment would be shut down for the night due to the occupancy violation.

P.O. MACRAE stated that upon entry he observed (3-4) patrons who were smoking cigarettes/cigars inside the rear of the establishment. P.O. MACRAE stated that he observed patrons who were "shoulder to shoulder" while standing in the rear dance floor area. The rear of the establishment is a large room that consists of a stage, dance floor, DJ area, an enclosed "VIP" lounge, a back drop for pictures to be taken, and a small bar which was being used to distribute Hookah equipment. P.O. LETTEER walked me to the rear where there were approximately 12 tables including a pool table with plastic coverings being used as a big table. In plain view on 2 of the tables inside the establishment there was abandoned plastic baggies with a green leafy substance suspected of being Marijuana which was recovered and placed on inventory at District 3 (Inventory #21014473). There was also loose Tobacco, cigar wrappers, and cigarette butts observed on the tables as well as cigarette and cigar butts located on the floor inside the establishment. I also observed numerous 20oz empty Hennessy laying on tables and on the dance floor.

While conducting a walk through behind the bar I observed loose bottles of liquor on the floor in one corner of the bar as well as numerous boxes of bottled liquor. The majority of the boxes had labels on them that were from Badger Distributing, however I observed two boxes to have different labels on them. One of the labels was half ripped off, but I could make out and address of 8948 W. Appleton Ave. which a check revealed it to be Westside Liquor. The other label had Hampton Liquor on it which a check revealed it to be located at 7410 W. Hampton Ave.

During our walk through there was a door open in the rear part of the establishment that opened to a common hallway that lead upstairs. While police were on scene the photographer that was in this area entered the back hallway and then came out. Upon checking this hallway boxes of liquor bottles were observed and it appeared the establishment was using this as a storage room. While P.O. MACRAE was checking the basement he observed the breaker box front panel was detached and laying on the ground. The breaker box wires were exposed which could be a potential fire hazard. P.O. MACRAE advised this needed to be replaced or repaired. At the top of the basement stairs there was an exterior door that lead to a court yard outside and appeared to be the only other exit besides the front door. This exit was locked and the fenced gate of the court yard was chained and padlocked shut making it seem like the only exit out of the building was through the front door.

On Sunday, April 25, 2021 at approximately 7:45PM P.O. MACRAE and I while at District 5 made contact via phone with the Licensee/Agent identified as Reginald D. BUTLER (b/m, 4 -5-58). BUTLER was advised of the incident and that police were at his establishment the night before. BUTLER was advised that the establishment was 105 people over capacity.

P.O. MACRAE advised of the observed patrons smoking inside his establishment, the recovered Marijuana, and the locked front door. P.O. MACRAE informed BUTLER that there were approximately 20 subjects claiming to be employees and could not provide what their duties were. P.O. MACRAE asked BUTLER about his security to which BUTLER responded that he employs 12 security persons. BUTLER was unable to inform P.O. MACRAE what roles his security perform at his tavern.

BUTLER advised P.O.MACRAE that he left the tavern at approximately 11:00PM and left the bartenders in charge. P.O. MACRAE informed BUTLER that Eddie PARR stated that he was in charge and a manager at the time of this inspection. BUTLER stated that PARR is not a manager and only an employee who does various tasks. P.O. MACRAE informed BUTLER that PARR should acquire a manager's licensee if he is to be left in charge.

P.O. MACRAE inquired where BUTLER purchases the tavern's alcohol to which BUTLER responded "Badger Wholesale". P.O. MACRAE asked if BUTLER would be able to provide distribution receipts if asked by the stated of Wisconsin for the past 6 months. BUTLER stated he has only been open since January and would be able to provide the past 4 months of receipts.

P.O. MACRAE and I informed BUTLER that he as the Licensee/Agent would be recieving a citation for over-capacity / smoking-prohibited (inside tavern), and locked-entry door. P.O MACRAE stated to BUTLER if he had any questions or needed assistance to contact him or myself regarding.

Upon arrival, I observed a large group of individuals fighting with one another in front of the location. I also observed a gray 4 door sedan with 3 black females inside arguing and attempted to break up the physical altercation that was taking place inside the vehicle. I later detained one female due to her being uncooperative and argumentative with the situation and placed her in the back of the wagon to separate her from the situation. She was later released and left the location without incident. I spoke to Sergeant Matthew THOMPSON who was first on scene who stated he also observed a large group of individuals leave the bar and engage in a physical altercation outside which bar security had to intervene.


