

# Downtown Masonic Center is to repurpose its stained glass windows as part of an apartment project. They instead could move to Sheboygan.

A downtown Milwaukee historic building that's being redeveloped might have its stained glass windows relocated to Sheboygan.

The 20 windows are now among the signature features at the former Humphrey Scottish Rite Masonic Center, 790 N. Van Buren St.

Northfield, Illinois-based Saxony Capital LLC is converting that building into 22 high-end apartments — a project that's received city <u>Historic Preservation Commission approvals.</u>

But that authorization came with a condition.

Saxony Capital can replace the windows in order to allow more light into the apartments.

But they must be reused as interior furnishings — perhaps going into future apartments as decorative items, according to the commission's March ruling.

Commission approval is needed for all exterior changes to the building because it's designated by the city as historic. Those rulings can be appealed to the Common Council.

Now, Saxony Capital is seeking commission approval to instead provide the windows to <u>the historic Sheboygan Masonic Lodge</u> for use at that facility.

That's according to a new filing with the commission.

"We are seeking approval for these windows to be preserved in an appropriate environment suitable for their subject matter at this location," according to the filing from Saxony Capital.

"If there are other options to be discussed we could seek approval for negotiation with HPC staff and the city attorney on the matter," it said.

Josh Mintzer, Saxony Capital principal, couldn't be immediately reached Wednesday for more information.

The condition of reusing the windows was imposed over the objection of the building's then-owner, an affiliate of Madison-based Ascendant Holdings Real Estate LLC.

Eric Nordeen, an Ascendant co-owner, told commission members in March that using the windows as interior furnishings might not go over well with prospective renters.

The designs reflect Masonic lore and symbols — which some people might find off-putting, Nordeen said.

He suggested instead finding others willing to take the windows, such as the Habitat for Humanity ReStore.

But commission members voted for keeping the windows for display at the property — which was suggested by Milwaukee Preservation Alliance Executive Director Jeremy Ebersole.

Ebersole joined Tim Askin, a city historic preservation planner, in opposing the removal of the windows.

Askin said the city's preservation guidelines consider the windows to be a significant part of the building.

The building was constructed as a church in 1889 and became a Masonic facility in 1912. It was extensively remodeled, with the windows installed from the 1920s until around 1950.

Scottish Rite sold the building to the Ascendant affiliate in 2017 for \$3.5 million because the fraternal organization's dwindling membership could no longer afford to maintain it.

Ascendant's planned conversion of the building to a hotel failed to obtain financing.
