This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 09/25/21 at 8:30pm, Milwaukee Police were dispatched to 2201 W. Orchard Street for a ShotSpotter complaint. Investigation revealed that none of the employees, one of which was standing outside and had an intoxicating odor on his breath, heard any shots fired. A casing was located on the ground in front of the store but the clerk inside did not have access to the video surveillance and told police to return the next day when the owner would be present. The video surveillance was never recovered because the business was closed on the days following the incident.

INITIAL INVESTIGATION

This report is typed by PO Oscar ESPITIA assigned to District Two, Late Power Shift and Squad 2484.

On Saturday September 25th, 2021 at approximately 8:30 PM my partner PO BECKETT and I responded to the address of 2201 W. Orchard St. (Orchard Food Market & Liquor), to investigate a shotspotter complaint (flex# 608-154065) for 8 rounds. Shall be noted that earlier in the day we observed an employee who was later identified as Jose L. FIGUEROA-RODRIGUEZ (W/M, 05/26/81) of Orchard Food Market & Liquor standing by a vehicle blocking traffic. This area is known for high volume for narcotics sales.

Upon walking up to the store I observed several individuals standing in front of the store along with FIGUEROA-RODRIGUEZ. All subject left the scene upon our arrival and FIGUEROA-RODRIGUEZ denied ever hearing seeing anyone shooting. I could smell the odor of alcohol coming from FIGUEROA-RODRIGUEZ's breath.

We located a casing on the ground in front of the store. We entered the store and spoke with Satinder P SING (A/M, 10//1/96), who also denied hearing any shots fired. The clerk stated he didn't have access to the surveillance and told us to return the following day when the owner was there.

My partner PO BECKETT will conduct follow up with the owner of Orchard Food Market & Liquor to retrieve surveillance footage of the incident. Please read PO BECKETT supplemental report regarding recovery of surveillance footage. Video not recovered due to the business being closed the following days.

Squad 2482 (PO SANCHEZ) filed a report regarding the ESBUDW.

The hearing before the Licenses Committee will take place virtually on 01/05/2022 at 09:20 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
