The Milwaukee Police Department's investigation regarding this application revealed the following:

 On 03/10/2017 officers were dispatched to La Caleta, 1801 S Muskego Av, for a theft complaint. A suspect grabbed an employee's phone and ran out of the business. The business was very cooperative with the police.

2. On 03/04/2018 officers were dispatched to a fight at La Caleta, 1801 S Muskego Av. The investigation revealed a fight on the dance floor between three subjects that security broke up using pepper spray. The officer observed that the posted licenses were expired. The applicant was on scene and stated the new licenses were at her home. The officers observed the video surveillance and issued a citation to one subject for Disorderly Conduct.

3. On 03/11/2018 officers were dispatched to a battery complaint at La Caleta, 1801 S Muskego Av. The officers interviewed an intoxicated subject who stated security had dragged him out of the bar and assaulted him. The officers interviewed security who stated the subject was attempting to fight other patrons and threatened to kill the security officer. When the security officers were escorting the subject out he hit one to the face. The security officer then hit the subject back. The subject was issued a citation for Disorderly Conduct and Battery. While checking the tavern the officers observed the posted license was expired. The applicant was issued a citation for Display of License- Posting required.

- 4. On 03/20/2018 officers were dispatched to a Trouble with Subject complaint at La Caleta, 1801 S. Muskego Av. The applicant was on scene and had called regarding a subject who had been banned from the tavern that was refusing to leave. The subject left prior to the officer arrival. No violations were observed.
- 5. On 09/08/2018 at 10:41pm officers were dispatched to a subject with gun complaint at 1801 S Muskego Av. The officers interviewed several patrons who stated they were sprayed in the face with O.C. Spray by a security guard for not reason. The security guard stated he sprayed them as they were charging toward him. The incident was advised on that night because the officers could not view the video surveillance. On 09/10/2018 the officers contacted the applicant and were able to view the video. The video did show the security guard spraying subjects by the door but did not show any of the confrontation outside. The video showed there were inconsistencies with the stories of all parties.
- 6. On 10/03/2018 officers were dispatched to a battery complaint at La Caleta bar, 1801 S Muskego Av. The officers interviewed the victim who stated she got into a verbal argument with a female that was talking with the victim's husband. The fight turned physical with the subject punching the victim to the face. The suspect then fled the scene. The officers spoke with the applicant who stated the suspect was a former employee but had none of the suspect's information.
- 7. Juana GASPAR-JERONIMO (33% Shareholder) has the following warrants with the City of Milwaukee Municipal Court.

8. On 05/13/2011 Omar MONREAL SALAS (50% shareholder) was cited for Operating while Intoxicated. He was convicted on 06/12/2011 and his license was revoked for 6 months. This item added as part of a change in ownership.

9. On 10/31/20 at 1:44am, Milwaukee Police were dispatched to an armed robbery which occurred near the address of 1801 S. Muskego Avenue. Investigation revealed that a patron left the tavern, was walking to his vehicle, and was beaten/robbed. When the victim walked back to the tavern to get help, security asked him to leave and they closed the door on him. Contact was made with the security guard outside the tavern and he stated that no incident(s) happened inside the tavern.

- 10. On 03/27/21 at 2:17am, Milwaukee Police were dispatched to 1801 S. Muskego Avenue for a fight compliant. Investigation revealed that two subjects were battered by a group of six subjects and one victim received sutures. The fight happened inside the tavern and the victims did not know why they were attacked.
- 11. On 04/02/21 at 11:32pm, Milwaukee Police were dispatched to 1801 W. Muskego Avenue for a shooting complaint. Investigation revealed that two groups of patrons inside the establishment engage in a verbal argument inside the bathroom. An employee entered the bathroom and told the patrons to disperse. While one of the groups were entering their vehicle, another vehicle approached and shot three people. The owner and bartender were cooperative with police and allowed them to review surveillance footage.
- 12. On 04/19/21 an 80-10 Nuisance Designation was drafted for nuisance activity at 1801 S. Muskego Avenue and the letter was mailed to the building owner.
- 13. On 05/04/21 at 8:00pm, Milwaukee Police, along with Wisconsin Department of Revenue Agents, conducted a license premise check at 1801 S. Muskego Avenue. When officers arrived, they observed an unlicensed bartender at the bar portion of the premise and the applicant in the restaurant portion. During the check, the applicant could not provide an invoice for any of the beer or liquor on the premise. The agents confiscated 62 liquor bottles and 65 boxes of beer.
- 14. On 05/18/21 at 10:00am, Members of the Milwaukee Police Department, City Attorney's Office, and a member of Safe and Sound, had a meeting with the members representing the business located at 1801 S. Muskego Avenue. The meeting was to discuss the Nuisance Designation put on the business and the abatement plan the business proposed. The abatement plan was denied because it did not address calling for police services, not training employees, not checking for weapons, and not preventing loitering outside the premise. The Captain of the Second District stated that a new plan would be considered if presented within ten business.

GNAS) were dispatched to an Armed Robbery at the address of 10059 W Arch Ave, in the City and County of Milwaukee

Prior to arrival, the caller stated her father was leaving La Caleta Bar and subjects pointed a gun at him, they stole \$700.00 from him and his phone. Caller stated that her father didn't feel safe and left the location to come home.

Upon arrival, we spoke to the victim who was identified as Juan F RUIZ VELAZCO CORNADO (w/m 10/23/1965). JUAN was observed with blood on his lip and bruises on his face. JUAN also appeared to have a lot of pain to his left side rib area whenever he would move. JUAN stated that he was at (La Caleta Bar) located at 1801 S Muskego Ave, and was walking to his vehicle to go home. When he crossed the street walking northbound, he was attacked from behind. JUAN was struck in the back of the head knocking him to the ground. JUAN stated he was attacked by two suspects unknown description aside from a both having black face masks covering their mouths. JUAN stated he believed they were Puerto Rican because of the dialect they were using to talk to each other. While JUAN was on the ground he was punched and kicked multiple times by both subjects. JUAN attempted multiple times to get up and run away and even fight back but was unable to. JUAN attempted to take his phone out of his pocket to call police, at which time one of the suspects snatched it out of his hand. JUAN stated a 3rd suspect (unknown description) approached from behind and JUAN felt an object touch the right side of his head and the subject stated in Spanish, "do you want to die today." JUAN believed it was a handgun pointed at his head. JUAN stated they took his black wallet containing \$600.00 (4x100 dollar bills and 10x20 dollar bills), red debit card (wells fargo), Mexican I.d, and a black Samsung Galaxy 9 cell phone. All suspects fled in unknown direction.

JUAN stated after he was assaulted and all the suspects fled the scene he went back to the bar to ask security for help they asked him to leave. JUAN informed security that he had been robbed and they closed the door on him. JUAN stated a random person had stopped and helped him by letting him call the Police.

This incident took place outside of the bar. Contact was not made with the tavern, only with the security guard standing outside. Security stated no incident(s) took place in the tavern.

This report is written by P.O. Radivoje PUPOVAC, assigned to District #2, Late Shift, Squad #2324 along with P.O. Murray HAYES. We were operating Milwaukee Police Department (MPD) marked vehicle # 529, which is equipped with Axon recording system. Both Officers were in full MPD issued uniforms with Axon body cameras.

On Saturday, March 27, 2021, at 2:17 a.m., P.O. HAYES and I were dispatched to 1801 S. Muskego Av. For a Fight Complaint. It was later determined that this is an Attempted Strong Armed Robbery and a Substantial Battery.

Initial Officer Observations/ Scene:

Upon arrival, P.O. HAYES and I entered 1801 S. Muskego Av., which is a bar called La CALETA. Upon entering, I observed a subject later identified as Nelson I. SANTIZO-BERRERA (M/W 04-03-1987). I Observed SANTIZO-BERRERA to be bleeding from left side of his head. It appeared that he had a cut above his left eye. SANTIZO-BERRERA appeared to be intoxicated. I also observed another male subject, who was later identified as Jesus SANTOS-MUNOZ (M/W 08-01-1987). I later learned that SANTOS-MUNOZ was a victim of an attempted Strong Armed Robbery.

This building is located on the Southwest corner of S. Muskego Av. And W. Maple street. Inside the bar, there is a large oval style bar. South portion of the bar is a dance/table area. Against west wall are male/female bathrooms and kitchen area. There are two doors on the east wall of the building, one is far north and second door are far south.

Squad # 2577 P.O. Jose RAMIREZ responded to the scene. P.O. RAMIREZ interpreted English Language into Spanish Language and vice versa.

Interview of SANTIZO-BERRERA:

The following is a brief summary of that interview and nota verbatim account. To fully understand the victim's statement, including the context in which it was made, please watch/listen to the recording of the interview in its entirety, which was captured using Officers Axon body camera.

SANTIZO-BERRERA stated that the incident took place at approximately 2:00 a.m., SANTIZO-BERRERA stated that he was seated at the bar when for no known reason to him he was jumped by six (6) Hispanic males. SANTIZO-BERRERA stated that he attempted to fight back but was unable because there was too many suspects hitting him. SANTIZO-BERRERA stated that he did see the suspects in the bar earlier in the night but he was not paying attention. SANTIZO-BERRERA was unable to provide me with a description other than about six (6) Hispanic Males, approximately thirty-five years old.

SANTIZO-BERRERA stated that the fight stopped when the women started screaming and yelling that they are calling the police.

SANTIZO-BERRERA stated that the same subjects who battered him bother other bar patriots and possibly were involved in another fight in the bathroom.

SANTIZO-BERRERA stated that this was done intentionally and without consent.

Ambulance, Curtis 313 responded to the scene. SANTIZO-BERRERA was later conveyed to ST' Francis Hospital Emergency Department, where we was admitted at 3:30 a.m., and see by DR. Yevgenia SHMELKOVA. SANTIZO-BERRERA did not have any broken bones but did need six (6) sutures above his left eye.

Interview of SANTOS-MUNOZ:

The following is a brief summary of that interview and nota verbatim account. To fully understand the victim's statement, including the context in which it was made, please watch/listen to the recording of the interview in its entirety, which was captured using Officers Axon body camera.

SANTOS-MUNOZ stated that he and SANTIZO-BERRERA arrived to the bar at approximately 1:00 a.m., SANTOS-MUNOZ stated that prior to the incident he did observe these same suspects bother other bar patriots. SANTOS-MUNOZ stated that they possibly involved in a fight with other bar patriots prior to fighting with him ad SANTIZO-BERRERA.

SANTOS-MUNOZ stated that he was seated at the bar when for no reason at all one of the suspects pushed him of off a bar stool, causing him to fall to the ground. SANTOS-MUNOZ stated that the suspects demanded money from him. SANTOS-MUNOZ stated that he did not want to give up his money and fought back. SANTOS-MUNOZ stated that the initial fight was between him and two suspects. SANTOS-MUNOZ stated that four more suspects joined the fight against him. SANTOS-MUNOZ stated that his friend SANTIZO-BERRERA attempted to help him defend against all six (6) suspects. SANTOS-MUNOZ stated that he was able to break away from the fight. SANTOS-MUNOZ stated that he went to the kitchen where he found a wooden stick that he wanted to use against the suspects. SANTOS-MUNOZ stated that when he returned to the bar he found SANTIZO-BERRERA battered.

SANTOS-MUNOZ stated that he believes that the suspects were Mexicans and from Chicago. SANTOS-MUNOZ stated that he knows how Mexicans look and that he heard them say that they are from Chicago.

SANTOS-MUNOZ stated that he did see the suspects earlier in the night but he was not paying attention to them. SANTOS-MUNOZ was only able to provide me with description of six (6) Mexican males approximately 35 to 38 years old.

SANTOS-MUNOZ stated that he did not sustain any injuries during the fight.

SANTOS-MUNOZ stated that this was done intentionally and without consent.

Squad 3390 P.O. WRIGHT responded to the scene and took photographs of the scene and victim's injuries. Please see supplementary report regarding.

On Friday, March 2, 2021, we were dispatched to 1801 S. Muskego Av. regarding a shooting call.

At approximately 11:32 PM, three patrons of the La Caleta Restaurant and Bar, 1801 S. Muskego Av. got shot at while entering their blue Dodge Ram, which was parked in front of the bar, 1801 S. Muskego Av., facing s/b. While the three patrons were entering the parked Ram, an unknown red SUV (possibly a Jeep Liberty) was driving e/b in the 2100 block of W. Maple St. The red SUV stopped in the intersection of S. Muskego Av. and W. Maple St. and approximately 23 rounds were discharged in the area (ShotSpotter ID# 608-124498) striking the three patrons. One patron was struck on the leg, Eduardo N. SEBASTIAN (W/M, 10-11-91) and another patron was struck on the buttocks, Gabriel RAMOS (W/M, 9-27 -90). Both patrons suffered non life threatening injuries. The third patron was struck by gun fire multiple times and died on scene, Julio C. RAMOS-GUTIERREZ (W/M, 9-19-94).

SEBASTIAN is believed to be a Mexican Posse gang member.

Witnesses stated that SEBASTIAN and other people of his group in the bar, and unknown Clanton "C14" gang member(s) got into an argument inside the bathroom prior to them leaving the establishment. The owner of La Caleta, Omar MONREAL (W/M, 1-30-82), went into the bathroom and told everyone in the bathroom to disperse. Everyone in the bathroom exited the bathroom when MONREAL told everyone to exit the bathroom.

The Clanton gang member(s) left the bar prior to SEBASTIAN, RAMOS, and RAMOS-GUTIERREZ leaving

the bar with the rest of their group.

Both MONREAL and BAROJAS-ISLAS stated there was no one fighting or arguing inside the bar prior to the incident in front of the bar. MONREAL stated he did observed a group of people inside the bathroom huddled up, and he told them they could not be inside the bathroom and told them to exit the bathroom.

ROMO-GUTIERREZ was shot to the left shoulder and left leg. MPD and MFD personnel attempted unsuccessful life saving measures on ROMO-GUTIERREZ and he was pronounced deceased at 12:03am. Dear Jose GONZALEZ:

This letter is notice to you that the Milwaukee Chief of Police, by the chief's designee, the district commander, has determined that the premises located at 1801 S Muskego Av Milwaukee, WI 53215 ("the premises") is a nuisance pursuant to Milwaukee Code of Ordinances ("MCO") § 80-10, Chronic Nuisance Premises.

The Milwaukee Police Department has responded to the following described nuisance activities at the premises on the corresponding dates, which qualify the premises as a nuisance:

- 1. On Saturday, October 31st, 2020, at or about 1:44am, police were dispatched to the premise for an Armed Robbery complaint. Upon arrival officers spoke with the victim, who stated that he exited the premise when two subjects approached him, produced a firearm and demanded the victim's money and cell phone. The victim then went back to the bar and asked security at the premise for help. Security refused to help and closed the door on the victim. This nuisance activity is contrary to MCO 80-10-2-c-1-L.
- 1. On Wednesday, March 10, 2021, at or about 8:05pm, police responded to a Shotspotter that occurred at the premise. Upon arrival, police observed one 9mm casing outside the front door at the premise. This nuisance activity is contrary to MCO 80-10-2-c-1-L.
- 1. On Saturday, March 27, 2021, at approximately 2:17am, police were dispatched to the premise for a Fight Complaint. Officer spoke with the victim who stated that six subjects intentionally battered him while inside the premise and demanded money from him. An audit of product purchases was conducted by Agents KING and WALDHERR. The audit revealed that the licensee could not provide an invoice for any of the beer or liquor at the premises as required. Agents KING and WALDHERR confiscated 62 sealed liquor bottles and 65 boxes of beer in various sizes. No contaminated bottles were found. I did observe any additional violations and no citations were issued.

SALAZAR, P.O. Matthew DIENER, ACA Heather HOUGH, Araceli ARVELLO of Safe and Sound, and I met with the agent Omar MONREAL and an employee/bartender Miguel HERNANDEZ-GASPAR of La Caleta, located at 1801 S Muskego Av, regarding the premises being designated as a nuisance property. The designation included a recent homicide, armed robbery, and other firearm related incidents.

The meeting started with a recap of the nuisance designation with HERNANDEZ-GASPAR stating that he had read and explained the letter to MONREAL and the two of them had come up with an abatement plan. MONRELA stated that the property owner had deferred drafting an abatement plan to him (MONREAL) but that the property owner was aware of the designation. The reasons for the denial of the plan were explained to MONREAL which included not addressing calling for police services, not training employees, not checking for weapons, and not preventing loitering outside of the premises.

MONREAL stated that the premises has armed and licensed security. Officers brought up the concern that there had been 6 shotspotter calls at the premises with only one incident where there was a corresponding 911 call and only one incident where casings were located. MONREAL stated that he did not believe his armed security were involved in these incidents but instead stated the tenants in the apartment above were. MONREAL stated that he has brought concerns about the tenants to the property owner but the issues have not been resolved. MONREAL did not deny that the location is frequented by various gang members but that the problem patrons are not repeat customers.

MONREAL was unable to explain why his employees have not called for police when violent crimes or firearm incidents have occurred within the premises or directly around it.

Officers explained that security at the location would need to do a better job with preventing loitering outside of the premises and preventing incidents before they occur. Officers also noted that bartenders need to ensure that they are not over-serving patrons.

Captain SALAZAR stated that a new plan would be considered if presented within 10 business days and that the owner of the premises needs to submit the abatement plan. Suggestions were made regarding a new plan; however, the licensee was reminded that the drafting of an abatement plan is ultimately the responsibility of the property owner and licensee.
