This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- On 07/14/2018 officers on Code Red deployment observed a subject loitering at 1125 N. Old World Third St. The subject was intoxicated and found to be under 21 years of age. He told the officers that he had been in The Pub Club, 1103 W. Old World Third St. He stated he got in without showing an ID. He stated in the past he used fake ID's until he became a regular. The officer spoke with security at the Pub Club, who confirmed they allowed the subject in without checking his ID. The officer advised them the subject was underage and to not allow him inside.
- 2. On 09/23/2018 officers observed an argument in front of The Pub Club, 1103 N. Old World Third St. They spoke with a citizen who stated he was trying to get back inside The Pub Club to be with his friends but security would not let him in. Security then pushed him to the ground and punched him. The citizen did not want to prosecute but did describe the bouncer and stated he was wearing a Pub Club red security shirt. The officer spoke with the manager who did not see anything but did hear an altercation outside. The officer could not locate the described security officer and the cameras were not working because of a recent fire.
- 3. On 11/29/2018 officers conducted underage tavern enforcement in District 1. An underage Police Aid attempted to gain entry to The Pub Club, 1103 N. Old World Third St. the Police Aid was allowed entry and did purchase a Miller Lite beer for \$4.00. The bartender was identified and the manager was advised the business failed the check.

4. On 03/18/2019 at 11:30pm an officer conducted a walkthrough of The Pub Club and observed about 100 patrons and only one security guard. The security guard was positioned at the door checking ID's and was not able to observe the entire bar. Due to a lack of security personnel other bars on the block sent their security to help. A fight did break out inside on the dance floor which required additional squads to respond to restore order.

- 8. On 02/19/2015 Milwaukee police conducted a licensed premise check at 1103 North Old World Third Street (Pub Club) and provided an employee, Steven Mick, with a packet of tavern related ordinances.
- 9. On 02/26/2015 a Milwaukee police aide, working in conjunction with Milwaukee police, was able to gain entry to 1103 North Old World Third Street (Pub Club). The police aide was then able to purchase a can of Pabst brand beer from the bartender. The applicant received citations for Allow Underage Person on Premises and Sale of Alcohol to Underage Person. Neither citation can be located in the city of Milwaukee Municipal Court Query System.

- 10. On 05/24/2015 officers were flagged down by staff of The Pub Club, 1103 N. Old World Third St, for a subject down inside the business. The officer found an intoxicated subject sitting on the dance floor. The officer called for medical attention. MFD responded and stated the subject was highly intoxicated but uninjured. The investigation revealed the subject had been harassing females on the dance floor and one of their boyfriends punched him. The subject refused to prosecute and was taken home by his friends. The staff of the Pub Club was cooperative with the investigation.
- 11. On 08/08/2015 District One officers conducted underage tavern enforcement. An underage police aid attempted entry to the Pub Club, 1103 N. Old World Third St, but was denied entry at the door when she couldn't provide identification.
- 12. On 12/23/2015 officer were flagged down by staff at The Pub Club, 1103 N. Old World Third St for a subject who fell and hit his head. The officers found Michael GOLDEN inside the tavern with a 2" laceration to his head. He stated he was hit in the head by a subject with a bottle. The officers checked the video and found the GOLDEN was talking with someone who pushed GOLDEN causing him to lose his balance and hit his head on a wood bench. It appeared from the video that GOLDEN and the subject were from the same group of friends. GOLDEN was highly intoxicated and refused to cooperate with the police investigation and refused medical attention.
- 13. On 02/20/016 officers observed the rear door of The Pub Club, 1103 N. Old World Third St, standing open and unattended. The manager, Michael ALBANESE, was contacted and he stated these doors were left open to vent the location. He apologized and secured the door.
- 14. On 04/22/2016 officers conducted a tavern check of The Pub Club, 1103 N. Old World Third St. Officers observed numerous patrons attempting to leave the tavern upon their entry. One of the subjects with a youthful appearance was stopped and found to be under 21 years of age with a second ID used to gain entry. A group of female patrons was observed entering the restroom. A female officer was called. While waiting outside the restroom the male officer observed a female open the restroom door, see him and close the door without exiting. The female officer arrived and located 5 under age patrons in the restroom. Two of the subjects stated they walked in with a group that knew the doorman and was not carded. The other three had fake ID's they used to gain entry. A sixth female from the bathroom, who was 21, was arrested for Resisting or Obstructing an Officer. The six subject were cited for Presence of Minor at Licensed Premise.
- 15. On 06/17/2016 officers responded to 1103 N. Old World Third St for a shots fired complaint. The officers interviewed James HERNANDEZ, manager of the bar, who stated there was a subject who was attempting to get in the bar after closing time. The subject was denied several times and was upset. He made a statement that he had a gun and "would shoot up the place". The subject walked off toward the rear of the bar when HERNANDEZ heard shots fired. He did not see who fired the shots. Milwaukee Police Department IR# 16-1639-0015.

- 16. On 10/15/2016 officers responded to The Pub Club, 1103 N. Old World Third St, for a fight. The investigation revealed security was escorting out a subject who refused orders to stay out of areas closed to the public. Security got the subject outside but refused to leave the property. When security attempted to escort him off the property he punched the security guard. The guard responded with one punch back and the subject was held for the police. The subject was cited and the security guard was fired by the tavern for violation their "No Striking" policy. A check of the security cameras revealed they were not functioning.
- 17. On 11/27/2016 officers were flagged down for a battery at The Pub Club, 1103 N. Old World Third St. Security officers were escorting a combative subject out of the tavern. During the altercation two employees were bitten by the subject breaking the skin and causing them to bleed. The subject was still on scene and was arrested. Milwaukee Police Department IR# 16-332-0134.

18. On 12/02/17 at 12:25 am, Milwaukee police were flagged down at 1103 N Old World Third Street outside of the Pub Club for a sexual assault. Police spoke with the victim who stated that he was inside the Pub Club seated at the bar when a female came up to him and that they were face to face when she turned around and started dancing. The female then reached inside his pants and underwear and grabbed his penis. The victim stated he told the woman he could not flirt with her and that he has a girlfriend with the female responding, "She's not here". The victim stated she walked away but came back a few minutes later and reached again into his pants and grabbed his penis, with the victim stating, "No, you can't do that". The victim stated he flagged down a bouncer and pointed out the female to him and she was kicked out of the bar. The victim stated he had about 5 drinks total over 6 hours. The victim further stated that the girl did not talk to him, nor were they drinking together. Police spoke with the bouncer, identified as Rico J Contreras, who stated that the victim told him that a girl assaulted him and pointed the woman out to him. Contreras then stated he escorted the suspect out of the bar. Officers viewed video surveillance from 11:30 pm to 1 am, but were unable to locate the incident taking place. Further follow up will be conducted with the bar manager, Samantha Belmarez, in attempts to view further video surveillance to try and locate the incident.

Michael informed me that in the southwest corner of the property there are plans to construct a stage that will house two pianos. Centered on the south wall a bar will be erected and table seating throughout the center of the property. There is a small walled area near the front entrance at Old World Third Street that will be used as a manager's office and house a safe.

There are no plans to have cameras in the business. Security will be employed by the business with plans to have two people inside and two outside of the front door. This ends the CPTED.






