The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 08/08/2010 the applicant was cited in the City of Milwaukee at 788 N. Jackson St for Sale of Alcohol to Underaged Person.

 On 12/18/20 at 1:44am, Milwaukee Police were flagged down for a trouble with subject at 1125 N. MLK Drive. The manager told officers that there were four individuals who were being rude and refusing to leave the tavern. Officers approached the subjects, asked them to leave, and they left without incident.

3. On 01/03/21 at 2:05am, Milwaukee Police were flagged down for a trouble with subject at 1125 N. MLK Drive. Investigation revealed that at tavern closing time, a patron tried to leave the establishment with an alcoholic drink. When told by employees she could not leave with a drink, the patron became verbally abusive with staff and approach one in an aggressive manner. The staff member then pushed the female in order to create distance between herself

and the abusive patron causing the patron to trip and fall. The patron was not injured and left the location. The employees were cooperative with officers during the investigation and provided all requested information.

- 4. On 03/02/21 at 9:08pm, Milwaukee Police conducted a license premise check at 1125 N. MLK Drive. The tavern was in compliance and cooperative.
- 5. On 08/15/21 at 10:39pm, Milwaukee Police were dispatched to 1125 N. MLK Drive for a battery complaint. Investigation revealed that a patron was disorderly inside the establishment and the manager was trying to remove him from the premise. The patron grabbed the managers shirt and both subjects fell causing the patron to hit his head on the hostess stand. The patron was conveyed to a hospital and received stiches.

On Friday, December 18, 2020 at approximately 1:44 A.M (while in full duty uniform equipped with an AXON body-worn Camera Activated and in a marked squad) I Sqd-1431 along with P.O. Robert WATTS PS#018677 was Flagged down by the Uncle Bucks staff member (located at 1125 N Old World 3rd St Milwaukee, WI 53203; which is in the City and County of Milwaukee and state of Wisconsin). who was later identified as Lawrence E STARKS (B/M 03-15-73).

Upon arrival the Uncle Bucks staff member was later identified as Lawrence E STARKS (B/M 03-15-73) Manger of the Uncle Bucks bar. Manager Lawrence stated that (4) four individuals was inside of the bar acting in a rude manner and refused to leave after he asked several times for them to leave. LAWRENCE stated that he just needed police assistance in getting them to leave.

I then approached the subjects and explained to them that the Manger wanted them to leave immediately because of their behavior. At that time all (4) four individuals got out of their seats and exit the main doors of the bar without any confrontation.

Manager on scene, Lawrence E STARKS was notified that a tavern report regarding this incident would be filed. Staff and the manager on scene were cooperative with the police.

This report is written by PO Joshua Doering assigned to District One Late Power Shift.

On Sunday, January 03, 2021 while on a Park and Walk in the area of 1100 N. Old World Third St, located in the City and County of Milwaukee, Squad 1421 (PO Kevin ZAVADIL and I in full MPD uniform and operating a marked MPD squad) was approached by a citizen regarding a trouble with subject complaint at 1125 N. Old World Third St. (Uncle Bucks).

A female stated she was assaulted by a bar employee.

I spoke with the bar staff who stated at the end of business hours when customers were leaving they observed a female attempting to leave with a drink. Bar staff informed her that drinks were not allowed to be taken outside of the bar and staff took the drink from her so she could leave. Bar staff stated that another female in the group became upset that they were not allowed to leave with a drink and became verbally aggressive, swearing and being loud, with staff. The female then approached a staff member in an aggressive manner and got "in her face" while continuing to swear and be loud. The staff member stated she pushed the female away from her in order to make distance between herself and the aggressive customer. The customer, being intoxicated along with the weather conditions making the entrance area slippery, tripped and fell. The customer was not injured. The aggressive customer then left the location and approached our squad.

The business did not request any action be taken in regards to the customer causing a disturbance at the location.

While speaking with bar staff I observed the female customer who was being aggressive with staff and her group of friends outside the bar yelling and gesturing towards the bar staff through the front windows.

The bar staff, Katrina L. WRIGHT (b/f, 09-24-88), and manager, Lawrence E. STARKS Jr. (b/m, 03-15-73), were all cooperative with Officers during the investigation and provided all requested information.

No citations were issued due to the females claim of being assaulted was unfounded.

INITIAL INVESTIGATION

This report was written by PO Bradley ORLANDO, assigned to District 1 Early Shift, Squad 1241.

On Sunday, August 15, 2021 at 10:39pm I was Dispatched to 1125 N. Old World 3rd St.(Uncle Bucks Bar) for a Battery complaint along with squad 1240, PO Zachariah WILBER and squad 1410, Sgt. David GRANDSARD.

Upon arrival at 10:47pm I observed a H/M who was later identified as Jesus G CABRERA (H/M 11/28/76) who was walking out of the bar to Bell Ambulance #403 with his head wrapped in gauze. CABRERA was transported to St Mary's Hospital and was followed by PO WILBER. Milwaukee Fire Department (MFD) Engine 2 was also on scene.

While on scene I spoke to Manager on Duty, Christian R ROELS (W/M 3/16/98) who stated he was punched one time to the chest by CABRERA, but it didn't really hurt and did not want to press charges. After this ROELS stated he tried to remove CABRERA when they both fell over and CABRERA hit his head on the front hostess stand.

Witness Interviews

Ryan A KURUDZA (W/M 6/2/95)

KURUDZA stated he observed CABRERA harassing customers and observed him grab ROELS. Both ROELS and CABRERA did a "circle" and CABRERA fell into the hostess stand.

Kimberly V SCHNELL (W/F 5/20/86)

SCHNELL stated she was sitting in the second chair at the bar when CABRERA came over and touched her friend on the shoulder. SCHNELL then observed ROELS walk over to CABRERA and CABRERA grabbed his shirt. They then tangled and CABRERA fell into the hostess stand.

I then spoke with Ricardo A RAMOS (H/M 4/19/74) who is the Director of Operations at Uncle Buck's. RAMOS was not on scene during the incident but returned after he heard what occurred. I asked RAMOS if he was able to get video footage of the incident but was not able to pull it up on his phone while on scene. RAMOS stated he would get back to me regarding footage. RAMOS emailed me on AUGUST 21, 2021 and stated they did not have footage of the incident as it was down from July 22, 2021- August 15, 2021.

PO WILBER attempted to speak to CABRERA regarding this incident but did not want to talk and did not want anything done.

CABRERA was admitted to St. Mary's Hospital at 11:16pm and was treated by Dr. Ryan EICHE. He had a cut on the middle of his forehead and nose and received 5 stitches.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 1/5/2022 at 10:25 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
