There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to attend this meeting may result in the denial of your license. Individual applicants and partnership applicants must attend or attend by an attorney. The agent or attorney for corporate or limited liability applicants must attend. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should request an interpreter attend the meeting with you, at your expense, so that you can answer questions and participate in your hearing.



To whom it may concern:

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 01/05/2022 at 10:35 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.

We were in full MPD uniforms with badges and nameplates affixed to our outermost garments. We were equipped with body worn cameras, which were activated and captured this incident.

At approximately 10:30 PM while doing Traffic Control on N Old World Third St. and E Juneau Ave ,i responded to a fight at the White Tail Bar located at 1110 N Old World Third St Milwaukee WI 53203 (which is in the City and County and State of Wisconsin). Upon arrival I observed that other Milwaukee Police Officers had broken up the fight and had made (1) arrest of a subject who was identified as Demetris MARTIN (B/M 01-17-99) During the investigation I had spoken with the White Tail Manager who identified himself as Alberto VALIE (W/M 09-26-90).

INTERVIEW of Alberto VALIE: MANAGER

At approximately 11:00 PM I spoke to Alberto VALIE (W/M 9-26-90) who stated at approximately 10:20 he observed a MARTIN who sitting at the east end of the bar arguing with another patron. VALIE stated the other patron was sitting next to MARTIN. VALIE stated MARTIN began arguing with the other patron about accidentally bumping into him. INITIAL INVESTIGATION

This report is written by P.O. Lafayette TURMAN, assigned to District One, Late Power Shift.

On Wednesday, July 15th, 2021, I was assigned to Squad 1431 along with PO Robert WATTS. We were operating a marked black and white Milwaukee Police Department Chevrolet Tahoe (Car 567) equipped with red/blue emergency lights and audible siren. We were in full MPD uniforms with badges and nameplates affixed to our outermost garments. We were equipped with body worn cameras, which were activated and captured this incident.

At approximately 1:12 AM (while doing monitoring the Old World Third St. Bar District) I was asked to investigate a fight by Sgt. Debbie Allen that occurred at the White Tail Bar located at 1110 N Old World Third St Milwaukee WI 53203 (which is in the City and County and State of Wisconsin). Upon arrival I observed that other Milwaukee Police Officers PO Alexander REED (PS# 022567) and PO. Emmons JORDAN (PS#3018992) was speaking to a male subject who was identified as Mohamed Fathy Ibrahim ELKADY (W/M 02-13-1986).

During the investigation I had spoken with the White Tail Manager who identified himself as Alberto VALIE (W/M 09-26-90). VALIE stated that at approximately 1:30 he was informed by his Security staff that his Security Employee who was later identified as Robert SMITH (B/M 11-25-71) had escorted ELKADY out of the bar because he was acting disorderly.

INTERVIEW of Alberto VALIE: MANAGER

At approximately 2:00 during the investigation I had spoken with the White Tail Manager who identified himself as Alberto VALIE (W/M 09-26-90). VALIE stated that at approximately 1:30 he was informed by his Security staff that his Security Employee who was later identified as Robert SMITH (B/M 11-25-71) had escorted ELKADY out of the bar because he was acting disorderly.

appeared to be agitated. VALIE stated that when SMITH got ELKADY out of the bar ELKADY then began using racial slurs and spat on SMITH. VALIE stated that he did not observe the incident and that it was only reported to him.

INTERVIEW OF ROBERT MARTIN: SECURITY

At approximately 2:10 AM I spoke to Robert SMITH (B/M 11-25-71) SMITH stated that he observed ELKADY in areas of the bar that was used for White Tail Staff only. SMITH stated that he approached ELKADY and ELKADY began to become agitated and began to become disorderly. SMITH stated at that time he asked ELKADY to leave the bar. SMITH stated ELKADY did walk out the bar but then called him a "Nigga" and spat on him. SMITH stated that he then shoved ELKADY and punched him and closed the front entrance door.

Manager on scene, of Alberto VALIE was informed that a tavern report regarding this incident would be filed. Staff and the manager on scene were cooperative with the police.

This report is being submitted by Police Officer Lorenzo HERNANDEZ, Squad 1240, in full duty uniform, wearing a body worn camera. I am assigned to District One, early shift. I was partnered with Police Officer Joseph LASPISA.

On 7/21/21 at approximately 4:35 PM P.O. LASPISA and I were dispatched to 9355 W Arch Av to investigate a Battery call for service that occured at 1110 N MLK. These locations are in the City and County of Milwaukee, Wisconsin.

P.O. LASPISA and I went to 9355 W Arch Av to speak with an employee of Whitetail MKE (1110 N Old World Third St, tavern.)

I spoke with the caller identified as Tylan L CANADY (b/m, 11/11/69.) CANADY is a bouncer at Whitetail MKE. CANADY stated on 7/21/21 at approximately 1:50 AM the manager informed staff that he wanted all people out of the bar. CANADY stated RAMIREZ was verbally arguing with him along with other bouncers named Tim, Chris, and Cody about not wanting to leave. CANADY stated RAMIREZ was being loud and boisterous. CANADY stated RAMIREZ was eventually ushered to the north doors of the establishment. CANADY stated RAMIREZ was near the exit then rushed the doorway and RAMIREZ was swinging. CANADY stated to RAMIREZ, "Your hitting me, Your hitting me." CANADY stated RAMIREZ's people grabbed her. CANADY stated he was then able closed the doors. During this incident CANADY stated he was struck in his right eye that caused him pain. CANADY stated RAMIREZ struck him with her right hand intentionally without consent.

Observation of CANADY

I did not observe any bruising or swelling to CANADY's facial area consistent with being struck in the face.

CANADY provided me with the owners name of Edward. I spoke with Edward C DESHAZER (b/m, 2/23/83.) DESHAZER provided me with video surveillance of the incident. After speaking with DESHAZER, he stated he does not wish to be a victim

of a crime. Further stating he does not want his information out there.

Statement from RAMIREZ

On 8/14/21 at approximately 5:00PM I spoke with Aaliyah A RAMIREZ (b/f, 1/19/95) via phone.

RAMIREZ stated on 7/21/21 at approximately bar close time she was at Whitetail with her boyfriend. RAMIREZ stated she and her boyfriend purchased beverages and the establishment closed early. RAMIREZ stated she and her boyfriend left the location. RAMIREZ stated shortly after they left she realized her boyfriend left his debit card at the tavern. RAMIREZ stated the two returned to the tavern. RAMIREZ stated the bouncers at the location would not let her in and that upset her. RAMIREZ stated due to the intoxication level of her boyfriend she wanted to help her boyfriend make the payment of drinks. RAMIREZ stated she feared her boyfriend would not be able to rationally pay for the drinks. RAMIREZ stated bouncer let her boyfriend in but would not let her in. RAMIREZ stated bouncers were very rude to her and mocking her while she stood outside of the tavern. RAMIREZ stated when the door open she tried to enter the tavern and began to swing her arms. RAMIREZ stated she believed her leg was caught in the door. The video depicts a male believed to be her boyfriend stepping between RAMIREZ and a bouncer she was swinging at in attempts to defuse the situation. RAMIREZ continued to swing her arms and eventually fell to the ground clear of the tavern doors. CANADY was able to close the door. RAMIREZ continued to hit the glass doors. RAMIREZ eventually walked away from the tavern. RAMIREZ stated she tried to flag down Officers nearby but Officers informed her they were tied up on assignments.

Video Depiction:

At approximately 1:47 AM, the video depicts RAMIREZ on the exterior of the tavern with the B/M subject possibly her boyfriend. Bouncers allow the male subject within the tavern. RAMIREZ is observed to stand at the exterior of the tavern door. RAMIREZ appears to be highly upset and pointing at bouncers within the tavern. CANADY opens the north door to allow the male subject out of the tavern and RAMIREZ attempts to enter the tavern and begins to swing her arms at a bouncer. The bouncer moves backwords in attempts to dodge the strike. The male subject steps between RAMIREZ and the bouncers to defuse the situation. RAMIREZ falls to the ground clear of the tavern door. CANADY is observed securing the tavern doors.
