The hearing before the Licenses Committee will take place virtually on 01/05/2022 ay 11:20 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.

This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 03/07/2021 officers were dispatched to a Shot Spotter call at Gas N. Go, 1909 W. Hopkins St. The officers located a victim, who stated he was punched to the face several times and hit in the head with a pistol. The officers spoke with the clerk, who stated he heard two pops and saw someone running. The officers watched video surveillance, which did capture the incident. The video showed the suspect hit the victim and run off, pulling a gun and shooting at the victim two times. The victim was not hit by the shots fired.
- 2. On 03/22/2021 officers conducted a license premise check at Gas N. Go, 1909 W. Hopkins St. The officers spoke with the applicant regarding the Standing Complaint Form Program. The applicant did agree to participate in the program and signed the form.
- 3. On 04/12/2021 at 9:09pm officers conducted a license premise check at Singh Gas & Food), 1909 W. Hopkins St. The clerk was cooperative and provided all requested licenses.

This license premise report is written by PO David LETTEER, assigned to District 5, Late Power Shift, Sq. 5468 with PO Russell MACRAE.

On 03-07-21 at 9:46 p.m., officers were dispatched to the Gas N Go Gas Station, located at 1909 W. Hopkins St., which is a licensed premise in the city of Milwaukee. The call was for a shotspotter of two rounds fired at the location, then the call was updated to a shooting.

Upon arrival, officers determined that there was no shooting, but that there was a victim sitting on the sidewalk in the gas station parking lot, with an individual who was punched in the face several times, as well as struck in the head with a pistol. The suspect in this incident is unknown and did not demand anything from the victim.

As the investigating officers were conducting the initial investigation, PO MACRAE began reviewing the video and located at the time of 9:47 p.m., the victim exits the store, buying milk. The victim is walking back to his vehicle, when a black male wearing a dark colored clothing, with fur around the hood, dark colored pants with a white face mask, with a design on it. The black male walks up to the victim, punches him in the face and strikes him with a handgun. As the suspect does this, the victim falls to the ground and the suspect then runs east out of the parking lot.

As the suspect is exiting the parking lot, the suspect retrieves a dark colored handgun from his right jacket pocket and fires the handgun in the direction of the victim, striking the sidewalk and a cardboard sign. The victim was not shot during this incident.

While PO MACRAE was reviewing the video, I spoke to the clerk Sandhu A. SINGH (w/m 04-11-67), who stated he began work at 9:15 p.m. tonight. He stated he had customers in the store and was checking them out, when he heard pops and looked out the gas station window, when someone was running east out of the lot. He could not describe the person and did not see what happened. It should be noted, upon the arrival of the police, SINGH was able to show us two spent casings, which were resting on the sidewalk, just to the east of the gas station.

While marking the casings, I located copper jacketing from a bullet near the spent casings.

PO MACRAE was able to retrieve the video, which was ultimately saved to a DVD disk and inventoried.

PO MACRAE contacted the listed agent and informed him of this incident and the filing of this report.
