This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 05/10/09 at 5:31am, officers were dispatched to 3033 W. Lisbon Ave. (Lisbon Gas & Food) for a subject with a weapon. When officers arrived the suspect surrendered and told the officers where the knife was that he used to threaten the clerk. That knife was found in his back pocket and another knife was found in his coat pocket. The clerk stated to officers that he recognized the suspect as a person who shoplifted at the store a few days earlier, so when he observed the suspect pick up some items today he locked the door. The suspect did attempt to leave the store without paying and when he couldn't, he reached into his pants pocket and pulled out a knife pointing it at the clerk.
- 2. On 07/13/09 the applicant was cited by the Milwaukee Police Department at 408 W. North Ave. for:

3. On 06/11/11 a Milwaukee Police Officer was working the WI Wins Tobacco Initiative with an underage (15 year old) checking area vendors for compliance on tobacco purchases. At about 1:08pm, the 15 year old was able to purchase 2 Grape Swisher Sweet Cigars and 2 Black and Mild Cigars from the cashier at the US Gas Stop at 408 W. North Ave. The cashier thought the girl was over 18. The officer also observed that the agent's tobacco license was expired in April of 2010. The agent was cited for:

5. On 08/21/13 officers investigated a Stabbing that occurred at 1:15am in the parking lot of Lisbon Gas and Food at 3033 W. Lisbon Ave. Officers spoke to the on duty security guard regarding the incident. The security guard stated the stabbing did occur at this location. He further stated he already cleaned up the blood and no one called the police because the victim drove away.

The officer spoke to the on duty clerk who stated he did observe an altercation inside of the location, but once the subjects left the store he didn't see or hear anything else until his security told him what happened outside. The clerk stated he told the security guard to clean up the blood.

A detective did view the surveillance video, which captured the incident. An altercation began inside the store and spilled outside where the stabbing occurred. The detective also spoke with the security guard who stated he did observed the stabbing.

- 7. On 10/18/17 a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a property damage complaint. Officer's interviewed an employee who said that the employee on another shift called in the complaint and that employee stated that a black male and black female entered the parking lot of the establishment in a white four door sedan. The female entered the store and attempted to take an item without paying. The employee locked the front door of the establishment so the female was unable to leave the store with the merchandise. The black male then rammed the front door of the establishment with his vehicle causing the door frame to bend and allow the female to escape. The employee was unable to retrieve a registration plate number and could not operate the surveillance system. No suspects were taken into custody and an Incident Report was filed (172910170).
- 8. On 01/13/18 at 12:53am, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a trouble with subject (panhandler). Upon Squad's arrival, the subject left the location and no incident report was filed.
- 9. On 01/21/18 at 12:42am, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a trouble with subject (panhandler) Upon Squad's arrival, the subject left the location and no incident report was filed.
- 10. On 01/31/18 at 2:00pm, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a trouble with subject (panhandler). Upon Squad's arrival, they interviewed the employee/caller who said that a black female entered the store begging for money. The subject left the location before squad arrival and no incident report was filed.
- 11. On 02/16/18 at 10:03pm, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a trouble with subject (panhandlers) complaint. Upon Squad's arrival, the subject left the location and no incident report was filed.
- 12. On 03/04/18 at 5:37pm, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a trouble with subject complaint. Upon Squad's arrival, the officer's interviewed the employee/caller who stated that a black male was loitering on the property, doing drugs, and refusing to leave. The subject left the location before squad arrival and no incident report was filed.
- 13. On 03/06/18 at 5:15pm, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for an injured/sick person call. Upon Squad's arrival, the officer's found a subject, outside the establishment trembling and shaking. The subject was unable to comprehend the officer's questions, so one of the officers entered the establishment and talked with the clerk who said he has observed the subject before and has seen his body shake in the past. While one officer was talking with the store employee the subject told the other officer that he was feeling suicidal and wanted to go to a Milwaukee County Mental Health Facility. Officer's conveyed the subject to the facility but while waiting to enter, the subject's health worsened and one of the officers called for medical attention. Wauwatosa Fire Department arrived on scene and conveyed the subject to Froedtert Hospital.

^{14.} On 05/04/19 a 16-year-old working in conjunction with Milwaukee Police Department and WI WINS Tobacco initiative, was able to purchase a 2 pack of Swisher Sweet Cigars at 3033 W.

Lisbon Av. The sales clerk admitted to selling the item. A citation of Sale of Cigarettes to minor/underage was issued.

- 15. On 07/27/19 officers were flagged down by citizens regarding a fight complaint outside the location of 3033 W. Lisbon Av. Officers stopped the juveniles who were then transported to their homes.
- 16. On 12/07/19 at 2:44am, Milwaukee Police were dispatched to 3033 W. Lisbon Avenue for a theft complaint. Investigation revealed that a subject entered the store and took product without paying for them. Officers were given a description, checked the area, and found the subject still in possession of the product. The subject was issued a citation and the product was returned.

- 17. On 06/13/20 at 5:21am, Milwaukee Police were dispatched to 3303 W. Lisbon Avenue for a ShotSpotter complaint. Investigation revealed that a group of about 15 people were in the lot when there was an argument between two of them. One of the persons had a handgun and was sitting in his vehicle when he fired one shot at the person he was arguing with. Everyone fled the scene and on casing and one fired bullet was recovered. The employee was able to provide video surveillance.
- 18. On 07/01/20 at 12:53am, Milwaukee Police conducted a license premise check at 3033 W. Lisbon Avenue. When officers entered the lot, they observed large numbers of vehicles and groups of people "hanging out". While officers were walking up the group entered their vehicles and left the premise. Officers interviewed the employee who stated that this is an ongoing problem with people in the lot and building. Officers left the premise to assist another officer just north of the location and when they returned, there was another large group of people and vehicles gathered inside the lot. Officers then entered the lot with their squad vehicles and, again, the vehicles and people left. The employee said this is an ongoing problem but he never calls police.
- 19. On 07/03/20 at 12:27am, Milwaukee Police conducted two license premise checks at 3033 W. Lisbon Avenue. The reason for the checks was because of the large amount of vehicles/people in the lot loitering throughout the nights. The first check lasted about twenty minutes and there were no problems observed or reported. During the second premise check there was a firework lit off in the parking lot and about 18 vehicles with 15 people loitering on the premise. The filling station employees have been advised numerous times to call the police when there are people loitering on the property but there were no calls for service from that location.
- 20. On 07/04/20 at 3:22am, Milwaukee Police, while on patrol, observed the filling station located at 3033 W. Lisbon Avenue had no lights on and about 20-25 vehicles in the lot with about 20 people loitering. Officers entered the lot and parked causing the vehicles/ loiterers to leave and the lights to the establishment came back on. There were no calls from the establishment for people and vehicles loitering.

21. On 09/25/20 at 2:41am, Milwaukee Police were dispatched to 3033 W. Lisbon Avenue for a Shot Spotter complaint. Investigation revealed that a subject was standing next to pump number 5 pulled out a firearm and fired shots toward a black sedan located next to pump number 8.

- 22. On 09/29/2020 at 11:38am officers were dispatched to a Reckless Use of Weapon at 3033 W. Lisbon Av. The officer interviewed the clerk, who stated a subject came into the store and pointed a firearm at him. The subject did not steal anything. The clerk was cooperative and showed the officers video of the incident.
- 23. On 10/31/2020 at 12:16am officers were dispatched to a Theft at 3033 W. Lisbon Av. The officers could not locate the caller, who was attempting to report his bicycle stolen from the lot.
- 24. On 11/11/2020 at 12:17am officers were dispatched to a Shotspotter at 3033 W. Lisbon Av. The officers interviewed the clerk, who spoke limited English. The clerk pointed to the north when the officer asked about shots fired. A customer stated she did not see shots fired on the property but heard some from across the street. There were no cameras that could have captured the incident.
- 25. On 11/15/2020 at 9:51am officers were dispatched to a Robbery complaint at 3033 W. Lisbon Av. The officers interviewed the victim, who stated she was handing money to the cashier when a subject came up behind her and grabbed the money from her hand. The suspect grabbed her hair and pushed her to the ground. The officers interviewed the clerk, who was cooperative. The clerk provided officers with video of the incident and stated he recognizes the suspect because she frequents the area.
- 26. On 11/15/2020 at 6:05pm officers were dispatched to a Subject wanted at 3033 W. Lisbon Av. The officers did not locate the described suspect and could not contact the caller. No contact was made with the business.
- 27. On 11/16/2020 at 12:33am officers were dispatched to a Trouble with Subject at 3033 W. Lisbon Av. The officers interviewed the clerk, who stated there was a group of females that had been on scene panhandling and about to fight. The group left prior to the arrival of police. An unrelated subject on the scene was provided medical attention.
- 28. On 11/17/2020 at 6:29pm officers were dispatched to a Trouble with Subject at Express Pantry, 3033 W. Lisbon Av. When the officers arrived an employee exited the store and stated the call was made in error and no police service was required.
- 29. On 11/18/2020 at 8:03am officers were dispatched to an Injured Person call at 3033 W. Lisbon Av. The call was for a subject on the floor in the bathroom. When the officer arrived they located a female outside the main entrance in a wheelchair. The female stated she was waiting for a ride to take her home.
- 30. On 11/28/2021 at 12:13am officers were dispatched to a Robbery at 3033 W. Lisbon Av. The officers interviewed the victim, who stated he was at the station when someone attempted to take his keys and vehicle. The business did not have anyone to operate the video system but did provide it at a later time. The business was cooperative with the investigation.

- 31. On 01/10/2021 at 10:04pm officers were dispatched to a Trouble with Subject at Express Gas, 3033 W. Lisbon Av. The caller stated there were 20 cars parked in the lot for 20 minutes. When the officers arrived they observed 12 cars on the lot. The officers parked on the lot to monitor the area. The autos left within a few minutes and the officers cleared the area.
- 32. On 01/26/2021 at 1:17pm officers were flagged down for a parking trouble. The clerk stated there was a car has been blocking the pumps for 30 minutes and the drivers refused to leave when asked. The officers spoke with the driver and he left the area.
- 33. On 03/06/2021 at 2:44am officers were dispatched to a Shot Spotter call at 3033 W. Lisbon Av. The officers located four casings in the front of the gas station property. The officers spoke with the clerk, who stated he observed a subject shooting from the corner of N. 30th St. and W. Lisbon Av. The officers watched surveillance video, which showed two subjects in an argument. As one of the subjects was leaving, the other subject ducked behind a car and fired shots at the first subject. Both subjects then fled the scene.
- 34. On 03/07/2021 at 4:04am officers were dispatched to a Shot Spotter call at 3033 W. Lisbon Av. The officers checked the area and did not locate any casings on the ground. The officers interviewed the gas station clerk, who showed officers video of the incident. The video showed a car parked at the pumps and another man firing shots at the auto. The auto flees eastbound on W. Lisbon Av. and the suspect continues to fire at the car.
- 35. On 05/11/2021 at 7:03pm officers were dispatched to a Fraud complaint at Lisbon Gas 7 Food, 3033 W. Lisbon Av. The officer interviewed the clerk, who stated on 05/10/2021 a subject came into the store and demanded \$40 or he would break the stores credit card machine. When the clerk refused the subject broke the machine and again demanded money or he would break the other machine. The clerk then gave the subject the money. On 05/11/2021 the subject returned and demanded \$60. The clerk gave the money to avoid further damage. The officer spoke with the applicant and he stated he would like to prosecute. The applicant was not present for the incidents but did view them on surveillance video.
- 36. On 06/19/2021 at 3:20am officers were dispatched to a Shooting at Express Gas, 3033 W. Lisbon Av. The investigation revealed a shooting did occur inside the business and was the result of a theft of firearm. The employees were cooperative and closed the business during the investigation.
- 37. On 08/07/2021 officers were dispatched to a Robbery at 3033 W. Lisbon Av. The officers interviewed the caller, who stated he was at the gas station when an unknown actor grabbed him from behind. They fell to the ground and the suspect took money from the caller's pocket. The officers watched the video, which did not match what the caller said happened. The video showed the caller being on the lot for 20 minutes, interacting with the suspect. The officers confronted the caller about the video and he then stated the suspect was continuously asking for money.
- 38. On 08/09/2021 at 5:51am officers were dispatched to a Shooting at 3033 W. Lisbon Av. The officers were advised that the victim was transported the St. Joseph's Hospital. The officers interviewed the victim, who stated she was at the gas station at 3033 W. Lisbon Av. when she was shot in the abdomen by an unknown actor. Officers went to the scene and located 2 casings at 3231 W. Lisbon Av. at the location pinpointed by Shot Spotter.

- 39. On 09/22/2021 at 9:08pm officers were dispatched to a Shot Spotter call at 3033 W. Lisbon Av. The investigation revealed a shooting occurred at the gas station by the air pump. The clerk was cooperative and provided video of the incident. The video showed the victim was the air pump and appeared to argue with a subject in a car. The car drove of but returned and the driver shot the victim to the chest. The victim was taken to the hospital by a witness, where he was pronounced dead.
- 40. On 10/14/2021 at 11:30am a meeting was held at District 3 regarding Lisbon Gas and Food, 3033 W. Lisbon Av. The applicant was present, along Guilty with the property owner and an attorney. The applicant stated he has no loitering signs posted, adequate lighting, and security cameras. The applicant stated one of the shootings was his armed security guard but he no longer has armed security at the location. He stated he has been turning off the interior building lights and locking the doors to the store between 2:00am and 5:00am to help prevent recent problems. It was suggested the applicant attend neighborhood meetings to become involved with the surrounding community. The applicant was advised to call the police to report loitering and other problems in the area to help prevent further incidents.

This report was submitted by P.O. Scott WIETING, assigned to District 3, day shift.

On Monday, September 29, 2020, I was assigned to Squad 3131, along with P.O. Eric ROM. At approximately 11:38 A.M., we were dispatched to 3033 W Lisbon Av, Milwaukee, WI, (Express Convenience Centers), regarding a reckless use of a weapon.

3033 W Lisbon Av was a gas station that was on the south side of W Lisbon Av, in between N 30th St and N 31st St. The gas station has a total of eight gas pumps, on either side of four stations. The store building is south of the pumps. The customer door for the store is northbound facing.

Upon our arrival, we viewed video footage from the store, showing at 11:08 A.M., on Monday, September 29, 2020, an unknown black male, as he was leaving the store, retrieve a black firearm from his front right pants pocket, and then point the firearm, with his right hand, towards the cashier at the store. The cashier stated the male did not steal anything, but that the gun had been pointed at him.

The video footage also showed at 11:09 A.M., the suspect walk up the cashier window from the exterior of the building, and knock on the window with the gun, which was in his left hand.

The suspect walked over to a vehicle parked at pump three. Pump three was the pump furthest to the southeast, and row which was closest to the building.

The vehicle was eastbound facing. The rear plate was AJF2737. Vehicle Information:

At 11:10 A.M., in the video, the vehicle can be observed driving northwest on W Lisbon Av from the gas station.

P.O. ROM and I checked the area for the suspect vehicle, but did not locate it.

On Sunday, November 15th, 2020, at approximately 9:51 A.M., P.O. Andres CABRAL and I (Squad 3131), along with P.O. Charles SEELOW (Squad 3140), while in full duty uniform equipped with an Axon body worn camera and in a marked squad, were dispatched to a robbery complaint at 3033 W. Lisbon Ave, in the city and county of Milwaukee.

Upon arrival, I observed the location to be Express Gas Station & Food Mart (3033 W. Lisbon Ave). Upon entry into the gas station, I observed the cashier register to the right. I observed the cashier behind the safety glass pointing to the door located to the right of the safety glass. I observed a female standing in the doorway.

During my investigation, I spoke to Alejandra E. VELOZ (W/F 10-05-1993), who stated that on 11/15/2020, at approximately 9:45 A.M., at 3033 W. Lisbon Ave, in the city and county of Milwaukee, an unknown suspect, intentionally and without consent, grabbed her by the hair, threw her onto the ground and stole \$60.00 cash from her. VELOZ stated she walked into the gas station (3033 W. Lisbon Ave) to pay for gas for her vehicle. VELOZ stated she was standing in line at the cashier's register with her hands in her front hoodie pocket. VELOZ stated she had \$60.00 cash in her hands. VELOZ stated she removed her hands from her hoodie pocket with the \$60.00 in hand. VELOZ stated while attempting to hand the cashier money to pay for gas, an unknown suspect, intentionally and without consent, walked up from behind her and snatched the \$60.00 from her hands. VELOZ stated the suspect then grabbed her hair and threw her onto the ground. VELOZ stated she tried fighting back as best as she could but the suspect overpowered her. VELOZ stated while on the ground, the suspect punched her in the face a couple of times and dragged her by her hair. VELOZ stated the suspect then left the gas station with the \$60.00 and fled eastbound on foot from the location. VELOZ stated she was certain she would be able to recognize the suspect in a photo array if necessary.

I observed VELOZ to be crying and shaking. I observed VELOZ to be very upset. I did not observe any visible injuries on VELOZ. VELOZ declined medical attention.

VELOZ provided a description of the suspect as a B/F, approximately 503', thin/skinny build, with black hair, wearing a black hat, white v-neck t-shirt with a blue jean button up coat, and black pants.

The cashier, Kulwinder SINGH (W/M 03-25-1992), who witnessed the incident, showed me a picture of the suspect on his phone. I observed the picture to match the suspect description provided by VELOZ. SINGH stated he recognized the suspect and stated that she is in the area frequently.

I completed a broadcast of the suspect's description. P.O. SEELOW (Squad 3140) checked the

While at District 3, I viewed a copy of the surveillance video from the incident. In the video, I observed the unknown suspect, matching the description above, standing outside the safety glass in front of the cashier desk. I observe VELOZ walk into the gas station at approximately 9:46 A.M. I observed the suspect to stare at VELOZ. I observed VELOZ walk up to the cashier counter at approximately 9:47 A.M. with cash in her hand. I observed the suspect walk up to VELOZ from her left side and proceeded to push VELOZ and grab her cash from her hands. I observed the suspect grab VELOZ's hair and drag her to the ground. I observed VELOZ attempted to fight back but was overpowered. I observed VELOZ pulling the suspects shirt in an attempt to keep the suspect from leaving. I observed the suspect punch VELOZ in her face approximately 2 times and kick VELOZ in her chest. I observed the suspect was able to break away from VELOZ and VELOZ laying on the ground. I observed the suspect attempt to leave the gas station but the doors were locked. I observed the suspect to take off her coat and yell at the cashier. I observed VELOZ get up from the ground and walk over to the door to the left of the cashier counter. I observed the suspect to exit the gas station at approximately 9:49 A.M. and flee eastbound from the gas station.

SINGH stated he refused to give the suspect the cash. SINGH stated the suspect grabbed the debit card scanner and ripped it off of the countertop. SINGH stated he did not want any further damage to the gas station store and gave the suspect \$40.00 in cash. This incident occurred on May 10, 2021 at 7:09 p.m. SINGH stated the suspect was wearing a blue jean jacket with dark pants.

SINGH then stated the same subject came into the store today, May 11, 2021 at 6:11 p.m., and demanded \$60.00 in cash or he was going to break the other debit machine. SINGH stated he did not want the suspect to damage the only other debit card scanner so he gave the suspect \$60.00 in cash.

SINGH indicated if the suspect comes back in to the store tomorrow he is going to lock him in the store and call the Police.

Interview with Business Agent

I spoke with the store owner via phone, who identified himself as **Simranjeet BENIPAL (A/M, 12-28-1979)**. BENIPAL explained that he wishes to press charges against the suspect, who was caught on camera on two (2) separate occasions, demanding money by holding store property as leverage.

BENIPAL was not present for either incident, but has remote access to the store security system, and has viewed the surveillance footage from both incidents.

BENIPAL explained the suspect, who frequents the store, walks inside and demands the cashier hand him (the suspect) money. If/when the cashier refuses, the suspect then takes the digital pen pad (hooked up to the cash register) and refuse to return the property until the cashier gives the suspect money.

The first incident occurred the previous day (05/10/2021) at approximately 7:09 PM, wherein the suspect physically pulled the pen pad from the wall, breaking it.

During the second incident, (05/10/2021) the suspect verbally threatened to take the pen pad again. The suspect obtained \$40 USD the first day, and \$60 USD the second day, in unknown denominations.

Upon arrival, we spoke with Marsey D. HOBSON (B/M 01/11/1982) who stated on 8/7/2021, at approximately 6:50 A.M., he arrived at the Lisbon Gas & Food Station, located at 3033 W. Lisbon Ave., in the City and County of Milwaukee. HOBSON stated he parked his red pick up at pump 5 and exited his vehicle. HOBSON stated as he walked around the rear of his vehicle and an unknown subject grabbed him from behind. HOBSON stated he struggled with the subject and fell to the ground as he continued to struggle. HOBSON stated he was in possession of \$3000 in his rear left pocket which the subject was able to remove while they were struggling. HOBSON stated he was on top of the subject, however, he felt his arms being pulled away. The unknown subject then fled in an unknown vehicle.

I entered 3033 W. Lisbon Ave., in the City and County of Milwaukee, to check for video. I was allowed to view cameras by staff. I observed HOBSON arrive at 3033 W. Lisbon Ave, on 8/7/2021, at approximately 6:27 A.M., in a red pick up and park at gas pump 5. I observed approximately 10 people throughout the gas station lot. I observed HOBSON exit his vehicle and appeared to speak with a black male subject wearing all black. I then observed HOBSON walk into the gas station and after approximately two minutes exit the gas station and speak with multiple other subjects. HOBSON remained in the gas station parking lot for approximately 20 minutes getting in and out of his vehicle and appeared to continuously interact with the black male wearing all black. While watching the video, I observed a female enter HOBSON's vehicle from his front passenger door. HOBSON appeared to also be in the front driver seat of the vehicle. The female was observed getting out of the passenger door and appeared to look towards to the rear of the red pick up. I then observed HOBSON and the black male wearing all black pushing and pulling each other. My view was obstructed by the gas station overhead and the red pick up. HOBSON and the black male separate and HOBSON enters his vehicle and conducts a u turn in the parking lot. I observed the black male walk towards a white Nissan 4 door and entered the front passenger seat of the vehicle. On Thursday October 14th, 2021 at approximately 11:30am a meeting was conducted with the licensee identified as Simranjeet S BENIPAL (U/M, 12/28/1979) of Lisbon Gas and Food located at 3303 W Lisbon Avenue along the property owner identified as Gurinder S NAGRA (U/M, 07/30/1970) and their Attorney Samantha Huddleston.

The meeting was scheduled by the CPU team due to the recent shooting incidents and armed robbery incident. At the meeting was myself, Sergeant Jerome BATTLES, Safe and Sound Coordinator Asia CARTER, ACA Heather HOUGH, ADA Kelly O'NEIL, Sergeant Guadalupe VELASQUEZ and Captain Herb GLIDEWELL.

During the meeting we discussed some of the incidents that had recently occurred at the location. BENIPAL outlined his plan for the businesses. BENIPAL explained he has security cameras, sufficient lighting, no loitering signs posted and stated he is willing to work with the department. I asked BENIPAL if he was aware of the incidents and he stated yes and provided some information. BENIPAL stated their armed security guard was involved in one of the shooting incidents on the property. BENIPAL stated their security guard was licensed and armed but they no longer have a licensed or armed security guard at the location. NAGRA stated they had more problems than usual with the business recently due to another gas station nearby being closed. NAGRA stated they have been turning the lights off and locking the doors between the hours of 2:00am and 5:00am to help prevent some of their recent problems with loitering.

Asia CARTER explained that the surrounding neighbors complain about the loitering and possible drug dealing at the location. Asia CARTER asked BENIPAL and NAGRA if they attend neighborhood meetings or have contacts in the neighborhood. BENIPAL and NAGRA stated they can start attending community meetings and District Three's Crime and Safety meeting to get more involved with the surrounding community.

Attorney Samantha HUDDLESTON stated that BENIPAL and NAGRA intend to watch for repeat problem subjects and file for restraining orders when necessary. HUDDLESTON stated they will continue to close their doors and turn the lights off between the hours of 2:00am and 5:00am. HUDDLESTON inquired about when the business should be calling police and reporting. ACA Heather HOUGH explained that reporting loitering and other problems to police is important and can help prevent further incidents.

I provided BENIPAL, NAGRA, and HUDDLESTON with a District Three Contact Guide, open records information, Crime and Safety dates, and informed them they can contact the team for any assistance.

Captain Glidewell made the decision not to give BENIPAL a nuisance designation letter. Captain Glidewell agreed to monitor the location and work with BENIPAL. We agreed to schedule another meeting at a later date to reassess the matter. In the meantime the team will be in contact with BENIPAL and monitoring the location.

You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
