There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to attend this meeting may result in the denial of your license. Individual applicants and partnership applicants must attend or attend by an attorney. The agent or attorney for corporate or limited liability applicants must attend. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should request an interpreter attend the meeting with you, at your expense, so that you can answer questions and participate in your hearing.

This report is typed by P.O. Margaret BOYD assigned to District #7, late power shift. Sunday March 21st, 2021. I while assigned to Squad 7431 along with my partner P.O. Blake KASBERGER was dispatched to 4750 N Hopkins St for a complaint of a theft.

Upon arrival we were met at the licensed premise by the caller, Bryan H CLAYTON M/B 08/10/1990. CLAYTON stated that the prior evening around 2:15 a.m., after the tavern was closed, approximately 1,600.00 dollars in U.S. currency was stolen from him. CLAYTON stated that he was counting money that belonged to the tavern after close. CLAYTON stated that he was seated on a couch when he was doing this. He stated that a female friend that he only knows as "Cookie" was seated to his right. Clayton stated that "Cookie" is not an employee of the tavern. He stated that "Cookie" also had another friend, who is also not an employee, seated to her right. CLAYTON stated he set large amount of U.S. currency on his lap. This amount of money was wrapped in a rubber band. CLAYTON stated that he believes the amount was around 1,800.00. CLAYTON stated that as he was counting other money and putting it in a bag "Cookie" reached across his lap and took the roll of money. CLAYTON realized the money was missing after "Cookie" left. CLAYTON reviewed the video and saw that "Cookie" had taken the money and pushed it into her wig before leaving. CLAYTON called to report the incident. CLAYTON stated that the bar owner is making him personally pay 1,600.00 dollars back to the bar. CLAYTON then led us down to the basement to show us the security surveillance. I first observed during the video that there was at least ten people in the bar. CLAYTON stated that all of the people are employees except for "Cookie" and her friend. I then observed that the time registered on the camera was 4:15 a.m. CLAYTON again stated that the times are just off on the cameras. I then noticed that there was a older larger set male wearing a hooded sweatshirt and a baseball cap behind the bar. This male had in his hands what appeared to be a black and possibly tan rifle in his hands. He appeared to be playing with the firearm. He pointed it at the walls and the ceiling as well as other people in the bar. I recorded the video with my body worn camera. CLAYTON stated that there was no one present who could operate the video to make a copy. The theft incident is pending identification of the suspect.
