There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-2.7-4, probative evidence concerning whether or not a new license should be granted may be presented on the following subjects: whether or not the applicant meets the municipal requirements, the appropriateness of the location and premises where the licensed premises is to be located and whether use of the premises for the purposes or activities permitted by the license would tend to facilitate a public or private nuisance or create undesirable neighborhood problems such as disorderly patrons, unreasonably loud noise, litter, and excessive traffic and parking congestion. Probative evidence relating to these matters may be taken from the plan of operation submitted with the license application, if any, but shall not include the content of any music. Evidence regarding the fitness of the location of the premises to be maintained as the principal place of business, including but not limited to whether there is an overconcentration of businesses of the type for which the license is sought; whether the proposal is consistent with any pertinent neighborhood business or development plans, or the location's proximity to areas where children are typically present. The applicant's record in operating similarly licensed premises; and whether or not the applicant has been charged with or convicted of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the activity to be permitted by the license being applied for or any other factor which reasonably relates to the public health, safety or welfare may also be considered. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to attend this meeting may result in the denial of your license. Individual applicants and partnership applicants must attend or attend by an attorney. The agent or attorney for corporate or limited liability applicants must attend. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should request an interpreter attend the meeting with you, at your expense, so that you can answer questions and participate in your hearing.

PLEASE NOTE: Upon reasonable notice, efforts will be made to accommodate the needs of disabled individuals through sign language interpreters or other auxiliary aids. 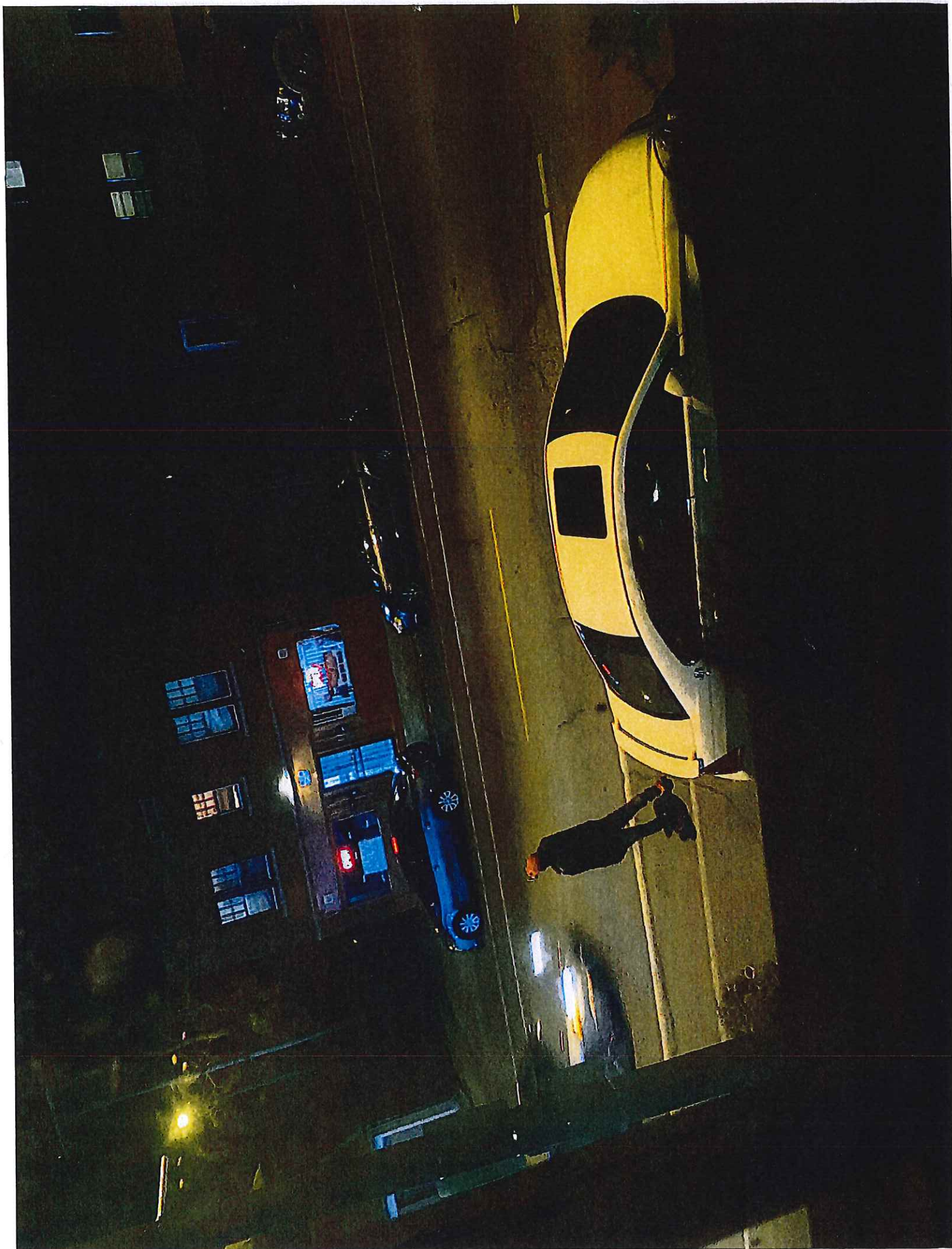
Afternoon and evenings ill parking and alcohol open in cars

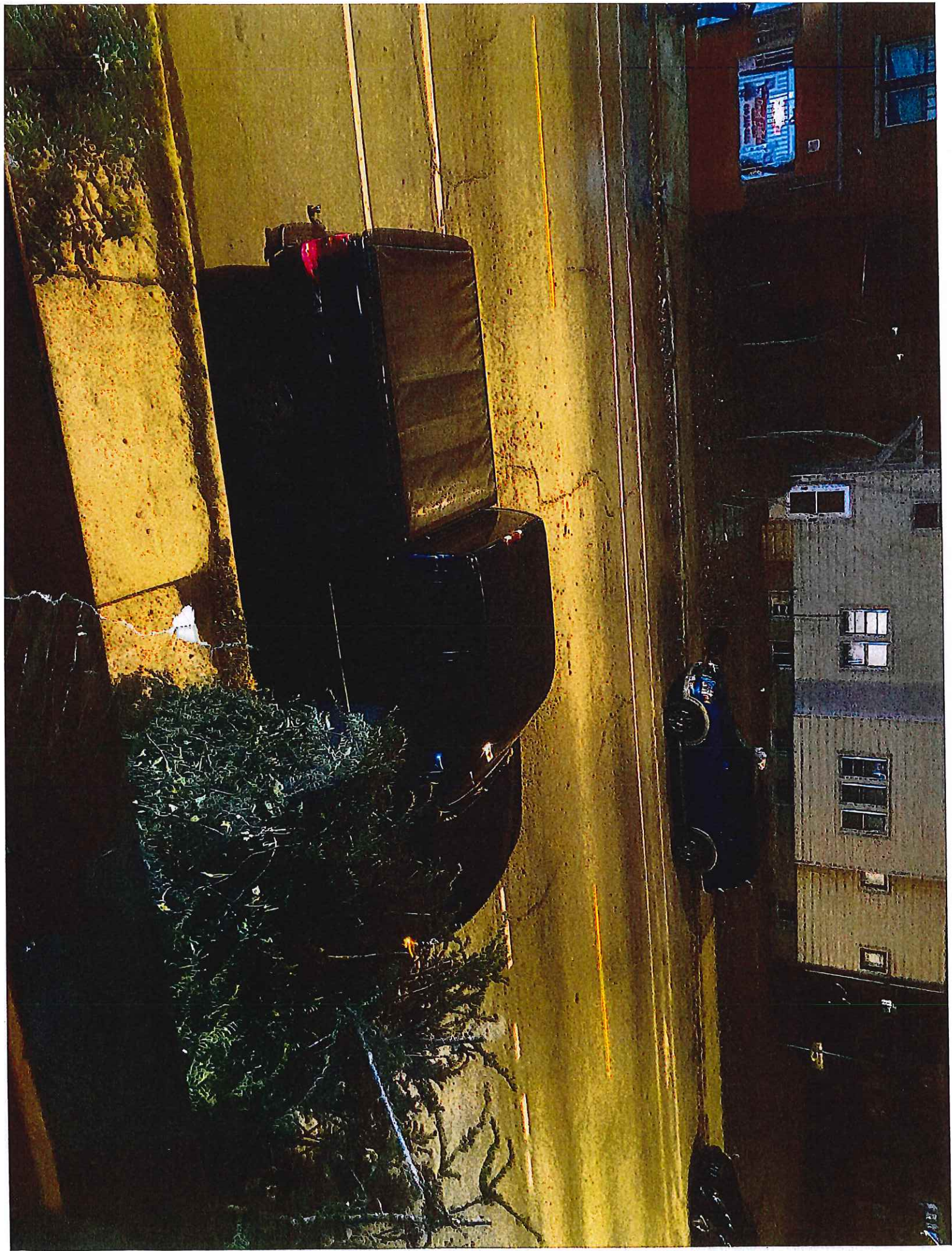
They park next to my garage entrance and drink waiting for customers from the stores to come out. I pick up bottles of alcohol every day.

Last Friday afternoon, 10/22, at the time school was getting out, 3:25pm an individual was shot at 44th and Center street. The shooter may have been just east of the store. At 3:20 Adel delivered my hummus from the store. Adel manages the store Jay's Grocery Store. My Friday order. At 3:25 I heard a gunshot from the area of the store. Called Adel immediately since he just left. He was not at the store still in his car. After talking to him went out to check out what happened the police were already there tapping off the streets. No casing found no person at that point. Turns out the person shot found his way to the hospital. People from the area came to me complaining about no security from the stores. No working cameras. I found that odd. So I talked with an officer and he said the guy in the store was blasting the music so loud he could not hear his own thoughts. I asked about the cameras, none were working.

So here is the set of coincidences:

No one called in shot fired

Security system not working

Person attending the store Jay's blasting music so they could not hear the shot.

Security seems to be disappearing, not improving.

So did they know this was going to go down and turned off their cameras?

Did the shooter know they had no security system working that day and felt they could shoot someone in broad daylight?

None of these businesses are taking the security for the area, school neighbors, kids at the candy shop seriously.

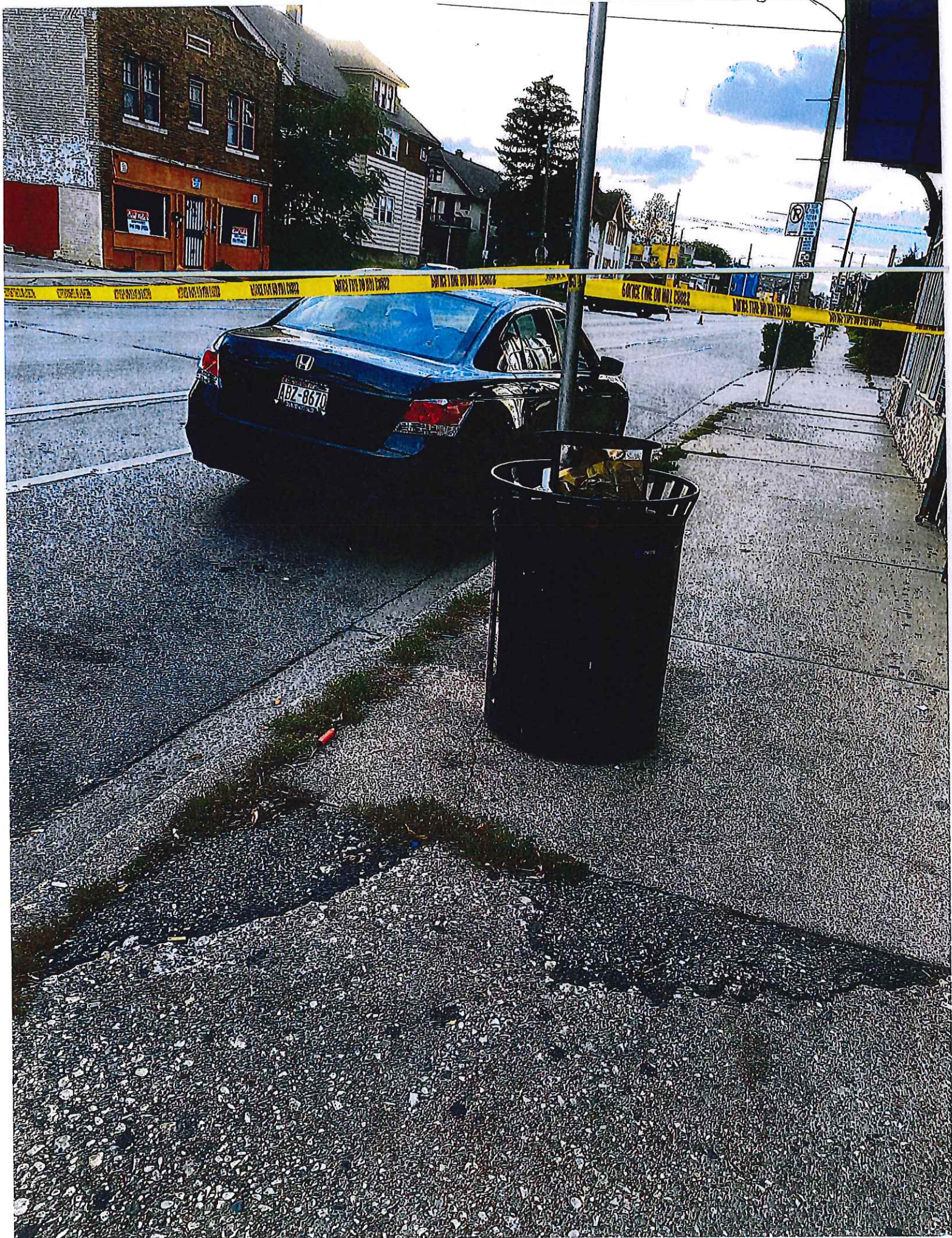
Again no working cameras, no lights in the back, gate not locked.

All the stores are connected physically and monitally. (4402, 4410, 4412 W. Center Street)

Alderman Rainey you were lucky that it was not a student or students. A weekday, Friday, school let out time, 3:20 pm.

This could have been bad, some people told me some guys go into these stores with shot guns slung around their necks. The guns being carried and teens carrying them into these stores are situations building into violence.

Attached is a pic of the tape but most importantly the black Honda owned by Sam Metro Cell. He parks his car for 8 hours in front of the metro store in the customer parking area. I tried to talk to Sam but he was rude and I also asked Adel to talk with him but apparently he does not care even though the parking is two hours in front of the store adding to the parking situation here. Nothing will happen at this building complex unless everyone works together with the safety of this building.

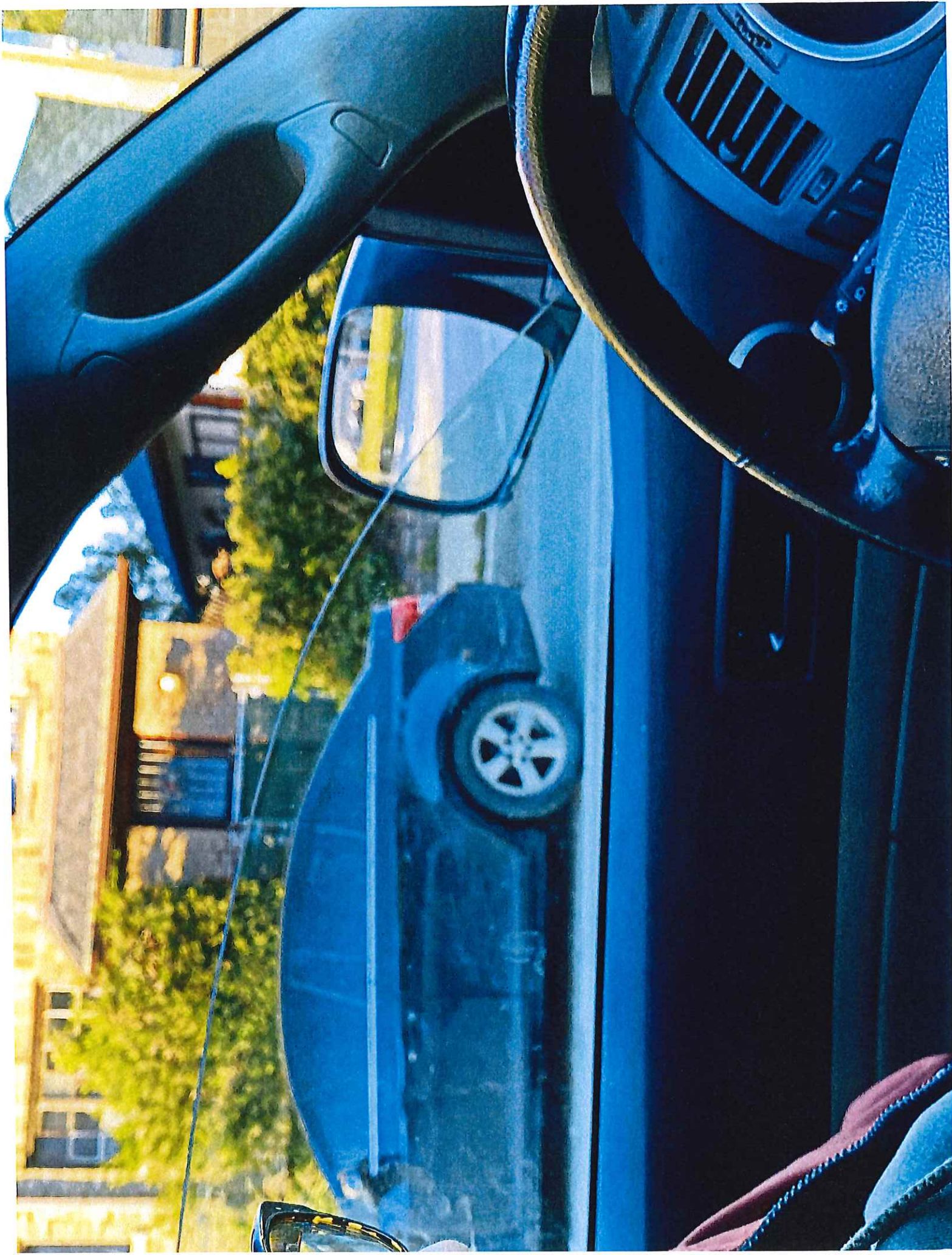

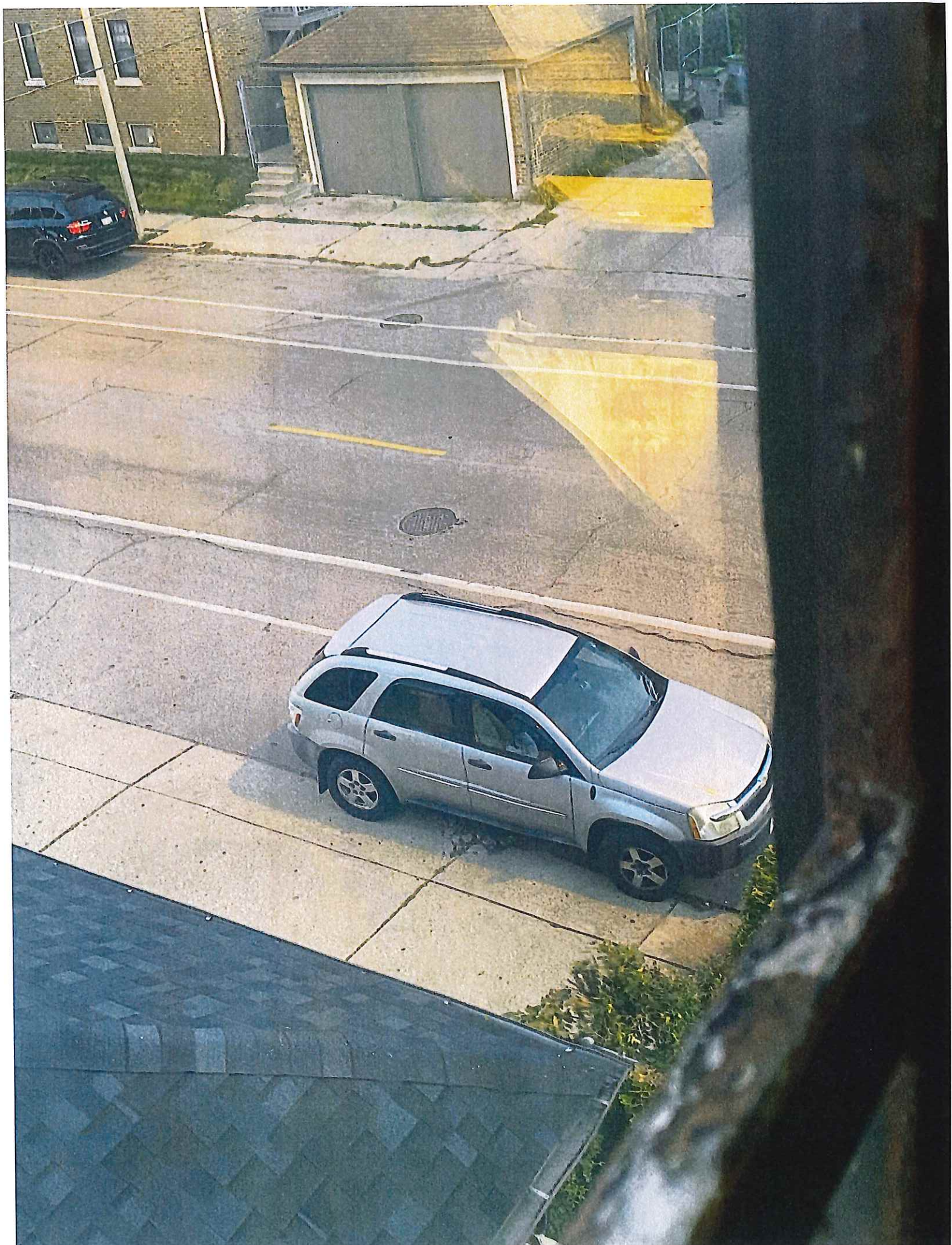

Last friday afternoon, 10/22, at the time school was getting out, 3:25pm an individual was shot at 44th and Center street. The shooter may have been just east of the store.
At 3:20 Adel delivered my hummus from the store. Adel manages the store Jay's Grocery Store. My Friday order. At 3:25 heard a gunshot from the area of the store. Called Adel immediately since he just left. He was not at the store still in his car. After talking to him went out to check out what happened the police were already there tapping off the streets. No casing found no person at that point. Turns out the person shot found his way to the hospital. People from the area came to me complaining about no security from the stores. No working cameras. I found that odd. So I talked with an officer and he said the guy in the store was blasting the music so loud he could not hear his own thoughts. I asked about the cameras, none were working.

So here is the set of coincidences:

No one called in shot fired

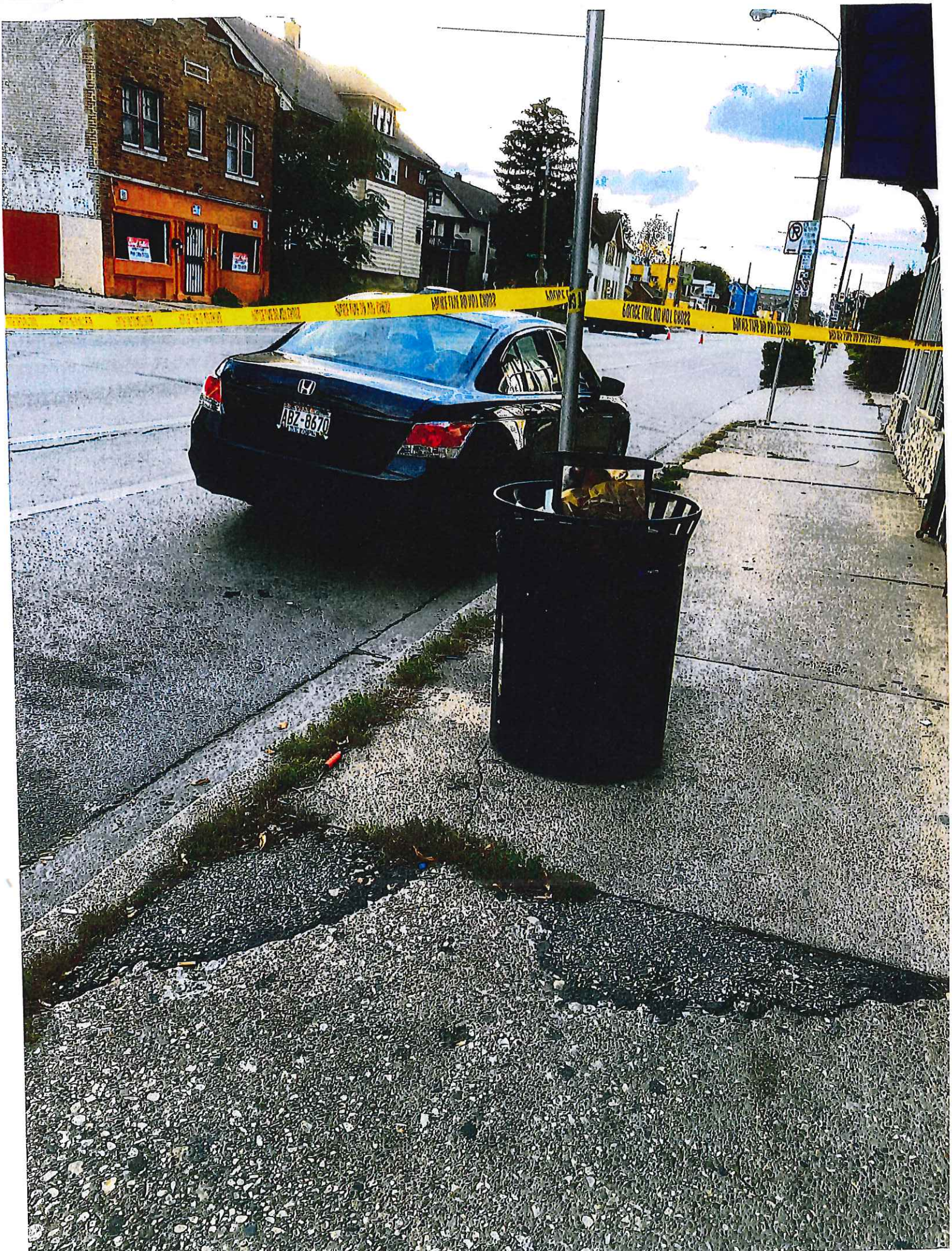
Security system not working

Person attending the store Jay's blasting music so they could not hear the shot.

Security seems to be disappearing, not improving.

So did they know this was going to go down and turned off their cameras?
Did the shooter know they had no security system working that day and felt they could shoot someone in broad daylight?
None of these businesses are taking the security for the area, school neighbors, kids at the candy shop seriously.
Again no working cameras, no lights in the back, gate not locked.
All the stores are connected physically and monitally. (4402, 4410, 4412 W. Center Street)

Alderman Rainey you were lucky that it was not a student or students. A weekday, Friday, school let out time, 3:20 pm.
This could have been bad, some people told me some guys go into these stores with shot guns slung around their necks. The guns being carried and teens carrying them into these stores are situations building into violence.
Attached is a pic of the tape but most importantly the black Honda owned by Sam Metro Cell. He parks his car for 8 hours in front of the metro store in the customer parking area. I tried to talk to Sam but he was rude and I also asked Adel to talk with him but apparently he does not care even though the parking is two hours in front of the store adding to the parking situation here. Nothing will happen at this building complex unless everyone works together with the safety of this building.
