Added to this PP Piercings' BMW is also being parked in front of the stores taking up valuable customer space. yesterday one car blocking my garage was from pPPiercings Plus (customers) Called it in and this time parking people in the area were able to give three tickets to that car.

Also Metro cell 's black honda has been parked in front also taking up valuable parking space for 8

hours daily.

Since the customers will not park in a legal spot my house becomes their territory. They like to up the music and throw out trash bags full of trash and this is done in retaliation.

The hangout continues behind one of the stores employees' cars, near the boundary of the store and

4407 W. 44th street the store 4402 W.Center.

These guys carry guns, and were recently caught in car theft - tearing apart a truck/van shooting in daylight guns. (I can not show any pictures under investigation.)

They continue to hang out and carry guns, these are individuals shooting at night and during the daylight, lucky no one has been killed so far.

Security lights in the back of the store is a must and so must that cage be locked up with a padlock. The latter would take a 10.00 pad lock so why is this not done?

All in all the car situation continues, my getting in and out during the afternoon and evening is chanchy.

The situation has been compounded with PP Piercings Plus and Metro Cell parking in the customer parking recently see attached.

Yesterday two cars were recovered in the process of. The truck was just stolen and parked directly behind the building complex owned by Rabie 4402 4410 4412 W. Center Street. None of the stores called in the shot fired directly behind their business. One or multiple young adults fired a gun aiming it down the alley. This is a crew of about 30 people, most are teens, some as young as 10 years of age. Due to the hangout at and around this store most of the people got away.

ALDERMAN RAINEY THE BACK CAGE HAS NO PADLOCK ON IT AND NO WORKING SECURITY LIGHTS IN THE BACK.

There was a smaller older crew of young men tearing out the insides of this vehicle.

ALDERMEN WHERE ARE THOSE CAMERAS ON THIS BUILDING AND WHY ARE THESE STORES NOT CALLING IN CRIMES WITH GUNS AT THERE BACK DOORS? THESE INDIVIDUALS ARE NOT CONCERNED WITH WHAT THEIR CUSTOMERS HARBOR AND THE NEIGHBORHOOD SUFFERS FOR IT. THIS CREW ALL HAD GUNS AND THEY ARE ALL AT THE STORE'S PROPERTY AND IN AND OUT WITH GUNS!

WHOSE CAREER WILL SUFFER IF THAT SCHOOL BECOMES A VICTIM TO THE GUNS DIRECTLY ACROSS FROM IT. WHY ARE GUNS ALLOWED SO CLOSE TO THE SCHOOL AND YOUNG TEENS CARRING 45 OR 9MM GUNS INTO THE STORE? TWO DAYS AGO I WAS APPROACHED BY SOMEONE WHO LOOKED LIKE SOMEONE INVOLVED WITH THE STORE BUT IT WAS DARK AND HE WAS IN A CAR SO COULD NOT GET A REAL CLOSE LOOK AT HIM.

HE TOLD ME IF I CALLED THE POLICE ONE MORE TIME ON THE STORE HE WOULD GET ME. MY NEIGHBOR WAS WITH ME SO HAVE

THIS STORE IS STILL REFUSING TO INSTALL SECURITY LIGHTS AT THE BACK OF THE BUILDING, TO LOCK THE PADLOCK GATE, AND INSTALL WORKING CAMERAS BEHIND THE BUILDING AND ALLEY WAY.

GUNSHOTS HEARD BUT NOT RESPONDED TOO. YOU WOULD THINK THEY WOULD DO EVERY POSSIBLE TO ENSURE THE AREA IS SAFE FOR EVERYONE.





Hey, good afternoon, Alderman Rainey,

I am a resident in your district and was present at the licensing hearing this week. I want to express my concerns over the store that is on the corner of 44 and Center and the issuing of a new business license.

I believe that a business must be good for the neighborhood and support the neighborhood. I do not see this business as good for the neighborhood.

While I am not saying that this business can't be successful, I am saying, I have little hope after hearing the new owner speak at the meeting. In his comments he padded his commitment to making changes to the store by saying things like I can't control what goes on outside the store. He says he has been running the store for a month and as a resident, I can attest to the fact that issues surrounding that store have just gotten worse.

I am sure you are aware there are numerous police complaints and issues with the store. The lawyer himself said there was a 2inch stack of reports and issues. That is a lot of drama for a family neighborhood to absorb. If this was on the eastside, it would not be tolerated. It shouldn't be tolerated either.

There are two physical schools near this store, and it is commonly known as place where kids are congregating and major issues involving guns are unfolding. You often cannot walk by that store without someone harassing you, or making you feel unsafe based on the yelling and screaming that occurs among the kids that are fighting.

Given the owners own statements, it seems very clear this is a business shell transfer. The new owner initially was not seeking a new or independent license, showing the connection between him and the previous owners, Ravi and Jason. The frustration with this is it just takes a bad business and puts someone else in charge without addressing the bad business.

Any good business knows who his customers are and targets them in the way they run their business. This store needs to redefine their customer base and take steps to change its image at its roots, not just superciliously to obtain a license.

More specifically, while I can't speak for others, I have many shared concerns with the other neighbors which revolve around:

- safety and criminal activity
- traffic that cruises the neighborhood circling the store, blocking drives and alleys
- the permissiveness for large underage crowds to hang out in and around the store
- the loud music that can be disruptive
- the shell transfer of the store to another owner without addressing the business model
- the lack of understanding of who is his customer and who he is catering to.
- Redundancy in tobacco and convenience stores on the same street, in the same neighborhood.
- The exorbitant amount of trash that comes from that store and litters the surrounding neighborhood

Personally, I would like to see another style business in this area.

Perhaps an urban roots style café that attracts black startup businesses, entrepreneurship and networking, or a community kitchen for startup businesses that need rental kitchen space.

What about creating a STEM center, and using that to support the Science and Technology programs in the local Schools?

There are many great options that could really give back to the neighborhood and schools as opposed to propitiate the safety issues that this business model does. At the end of the day, I would just like to see something better for our neighborhood.

Greetings:

I am writing to object to the license for the business and the applicant for the following reasons:

- 1. As the former
 frequently observed, before the Covid-19 lockdown, interactions between people hanging out at the business and students from the Washington High School campus that undermines the mission of the school district, such as the use of illegal drugs during school hours and students being intercepted on their way to school as well as gambling activities, such as throwing dice. With students about to return to school in person, these concerns are especially pressing.
- 2. As a resident, I have observed and endured taunting and threats from younger adults and teenagers who hang out in the store's parking lot (which is not observable from a store window on the east side of the building) and in the alley adjacent to the businesses on the southeastern side of the street. This taunting is especially disturbing since there has been a rise in crime and violence after the onset of measures designed to curb the Covid-19 pandemic. Firearms have recently been spotted in the possession of young adults in this area, which is frightening for residents.
- 3. As a resident, I have observed the proliferation of trash and litter around the store and especially in the alley during the operating hours of the business. My neighbors and I are frequently compelled to collect the trash and litter to preserve the beauty of our neighborhood.
- 4. As a resident, I have occasionally been unable to enter or exit the southern entrance to the alley between 44th and 45th Street because of illegally parked cars that obstruct the entrance and exit to the alley.
- 5. As a resident, I have frequently been disturbed by loud music emanating from vehicles parked by and around the business.

If the business were to employ security that could and would effectively monitor the presence of students, enforce nuisance regulations regarding trash, parking, and noise, and prevent illegal activities such as gambling, drug use, and human trafficking, then I and my neighbors would have less reason to object to the licensing of this business.

Thank you for considering the above-stated objections.

As the former Board President of the Milwaukee Board of School Directors, I have frequently observed, before the Covid-19 lockdown, interactions between people hanging out at the business and students from the Washington High School campus that undermines the mission of the school district, such as the use of illegal drugs during school hours and students being intercepted on their way to school as well as gambling activities, such as throwing dice. With students about to return to school in person, these concerns are especially pressing.
- 2. As a resident, I have observed and endured taunting and threats from younger adults and teenagers who hang out in the store's parking lot (which is not observable from a store window on the east side of the building) and in the alley adjacent to the businesses on the southeastern side of the street. This taunting is especially disturbing since there has been a rise in crime and violence after the onset of measures designed to curb the Covid-19 pandemic. Firearms have recently been spotted in the possession of young adults in this area, which is frightening for residents.
- 3. As a resident, I have observed the proliferation of trash and litter around the store and especially in the alley during the operating hours of the business. My neighbors and I are frequently compelled to collect the trash and litter to preserve the beauty of our neighborhood.
- 4. As a resident, I have occasionally been unable to enter or exit the southern entrance to the alley between 44th and 45th Street because of illegally parked cars that obstruct the entrance and exit to the alley.
- 5. As a resident, I have frequently been disturbed by loud music emanating from vehicles parked by and around the business.

If the business were to employ security that could and would effectively monitor the presence of students, enforce nuisance regulations regarding trash, parking, and noise, and prevent illegal activities such as gambling, drug use, and human trafficking, then I and my neighbors would have less reason to object to the licensing of this business.
