In response to the incident which occurred on March 7th, 2021


Gas N Go Enterprises, Inc took the following actions:

- On the night of the incident, a call went out to the police from the business telephone to inform of the shots fired. Please reference the attached picture showing the call history on the business telephone.
- On the night of the incident, the trained employee who was working at that time cooperated with police by showing them the bullet casings found on the ground and promptly showed the CCTV recording of the incident.
- Since the night of the incident, lighting was drastically increased around the perimeter of the building. Please reference the attached images showing the lighting. This project was unprescribed and was done to deter something like this from happening again and to keep the business lot and the area around the business much safer.
- On March 22nd 2021, I signed the Standing Compliant Form with the District 5 Milwaukee Police Department to empower local police officers to take any needed action upon any suspicious criminal activity without the need for someone to call for a dispatch. 




