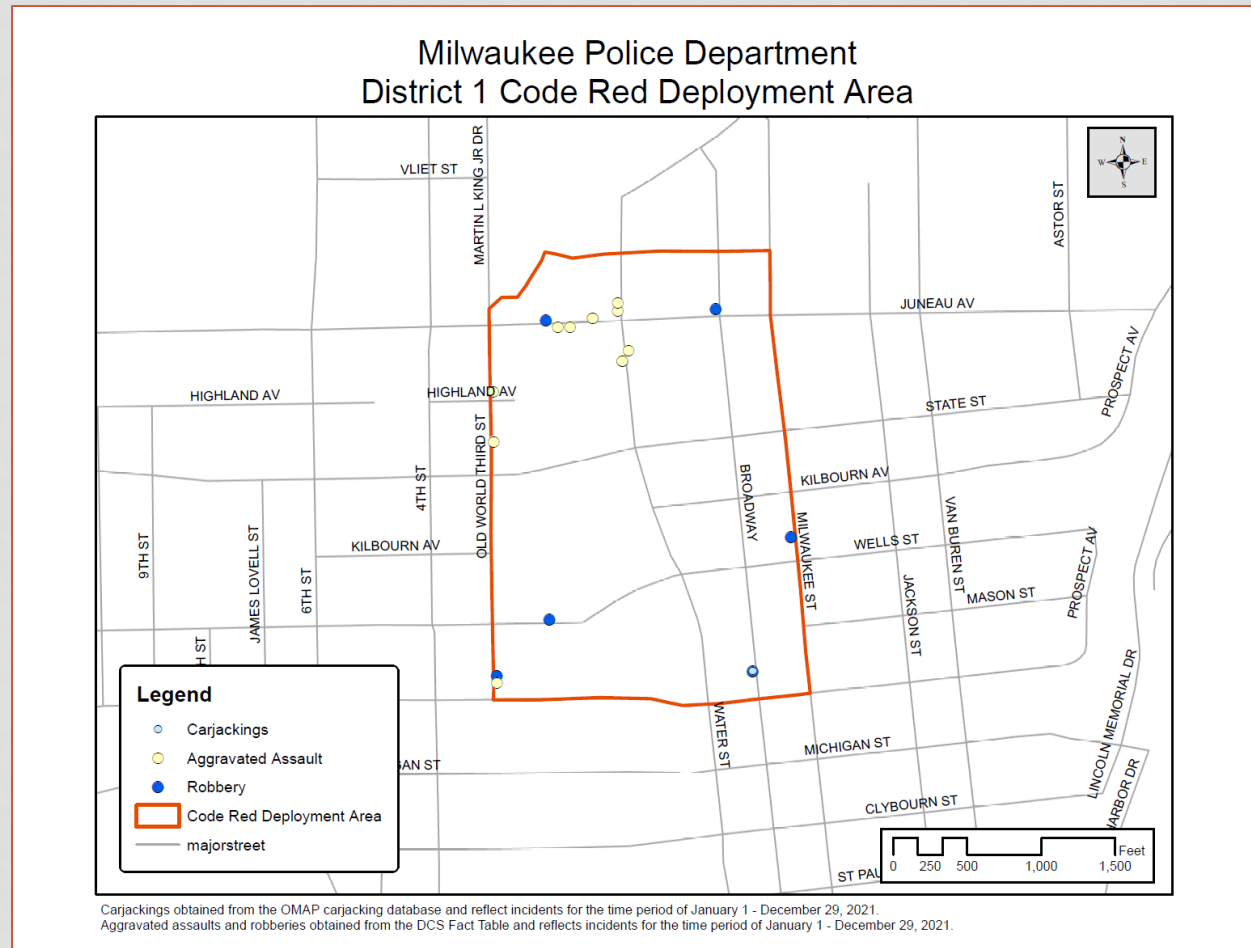

Excludes training units and training calls, Priority 5, misdials, cancelled calls, proactive activity and calls with a disposition type of MFD, MCSO, and DRU. Call data only includes Fridays and Saturdays from 7:00PM to 3:00AM. Call type final is sorted by the cumulative total.

Part I Crime data obtained from the DCS Fact Table based on the from date for the time period of January 1 – December 29, 2017-2021. Crime data only includes Fridays and Saturdays from 7:00PM to 3:00AM. Homicide, rape, aggravated assault, non-fatal shootings and human trafficking are counted by victims; robbery, burglary, theft, auto theft, arson and carjackings are counted by incidents. Non-fatal shootings and carjackings are listed below since they are already encompassed in Part I Crime totals.

*Paid overtime data for 2021 is through PP 25, estimated year end total is \$395,246. As of PP 25, MPD was **5.5% under budget** for overtime.

ADDITIONAL NOTES

- MPD's "policies and procedures" related to Code Red are documented through **operation plans**.
- Code Red is not designed to provide security for the businesses, but to provide a safe environment for the **patrons**.
- Last summer, MPD met with downtown stakeholders, elected officials and city departments **multiple times** to address issues in the entertainment district.

ADDITIONAL NOTES

- Ongoing working relationship with Responsible Hospitality Institute and comparable law enforcement agencies to develop **best practices**.
- Actively partner with other **city departments** (e.g., DPW, City Attorney's Office, Health Department) to provide a safe downtown.
- Continue to work with **businesses and stakeholders** in the entertainment district to collaboratively address issues.
