I. <u>PURPOSE</u>

To establish and provide guidelines for a specialized unit of the Milwaukee Police Department to be known as the Honor Guard. No greater tribute is paid to a member for his or her service to the Milwaukee Police Department, and the citizens of Milwaukee, than to be honored by the department's Honor Guard. The Milwaukee Police Department Honor Guard represents the members of the department at police funerals (both active and retired members) and at a variety of ceremonial occasions. The Honor Guard provides professional and dignified services to those who devoted their careers to the Milwaukee Police Department and to the community they served. The members of the Milwaukee Police Department Honor Guard maintain exceptionally high standards of appearance, conduct, and promote honor, integrity, and professionalism at all times. They hold the department's core values to the highest degree. The purpose of this standard operating instruction is to establish policy regarding the Milwaukee Police Department Honor Guard and its duties and responsibilities.

II. <u>POLICY</u>

It shall be the policy of the Milwaukee Police Department to train, maintain and support an Honor Guard to represent the department at funerals, civic functions and other venues or events.

III. <u>PROCEDURE</u>

A. SELECTION

- 1. To participate in the Milwaukee Police Department Honor Guard, members must submit an application for assignment in response to a vacancy announcement. Members must include a *Department Memorandum* (form PM-9E) of support from their commanding officer.
- 2. Employee participation is voluntary and members selected must pass the prerequisite training course to become members of the Milwaukee Police Honor Guard. Selected members will be evaluated for a period of six months prior to final assignment and uniform order.
- 3. The selection process will include an oral interview by the Honor Guard commander, unit training coordinator, and one other Honor Guard member. Applicants will also be evaluated on the following:

C. TRAINING

Minimum of (4) hours per month and attendance at the biannual in-service shall be utilized for the purpose of rifle movements, color presentation/posting/retrieval, casket watch, casket team and flag folding. All training is mandatory unless duly excused by the Honor Guard commander.

D. ACTIVATION

- 1. The Honor Guard commander, or his/her designee, shall cause the activation of the Honor Guard Unit. Once activated, members shall fall under the authority of the Honor Guard commander.
- 2. All Honor Guard members shall notify their immediate supervisor when they are requested to participate in an event. On duty personnel shall be utilized if possible and overtime may be authorized, when applicable. On duty members will immediately return to their assigned duties upon completion of the event.
- 3. The Honor Guard commander, or designee, shall:
 - a. Be responsible for the operation, selection, and training of the Honor Guard.
 - b. Organize and direct meetings, drill practice, and attendance at ceremonies.
 - c. Maintain the training records, death of member forms, and records of the Honor Guard Unit.
- 4. Each request for the use of the Honor Guard shall be directed to the Honor Guard commander, who will coordinate and facilitate the appearance of the Honor Guard Unit.

E. EQUIPMENT

The following issued Honor Guard uniform/equipment will be subject to inspection by the Honor Guard commander or unit coordinator. The Honor Guard full dress uniform is as follows:

- 1. Uniform campaign cover
- 2. Campaign cover-cap shield
 - a. Officer cover will have Honor Guard insignia affixed to the cover
 - b. Supervisor cover will have rank insignia affixed to the cover
- 3. Tailored Honor Guard standing collar dress blouse
- 4. Dress pants with yellow (blue) stripe on outer seams

B. OUTSIDE AGENCIES - FUNERAL SERVICE

When an officer is killed in the line of duty within a reasonable driving distance from the City of Milwaukee, the Honor Guard commander, or designee, shall ascertain the date, time, and location of the funeral and internment services. This information will be forwarded to the Chief of Police, or designee, for approval.

C. The Chief of Police may, at his/her discretion, authorize the Honor Guard members to travel and represent the Milwaukee Police Department at said outside department funerals in different states.

V. <u>EXPENSES</u>

The department will make a marked unit available to the Honor Guard for each authorized Honor Guard event. The department will reimburse actual gas expenditures, but prior authorization is required for any additional expenses (e.g., lodging). The department will not pay for meal expenses.

VI. LINE-OF-DUTY DEATH FUNERAL PROTOCOLS

- A. A Line-of-Duty Death is any action which claims the life of a Milwaukee Police Department (MPD) employee while performing work related functions, within the scope of their employment, either on or off-duty.
- B. The three main components denoting a full honors funeral are a flag-draped casket, a rifle salute, and the playing of Taps. These traditional elements should be reserved for a Line-of-Duty Death. There are several ceremonious or traditional elements that could, at the discretion of the Chief of Police, be included in funeral events, however, the main components shall be reserved for Line-of-Duty Death funeral events.
- C. In the case of a Line-of-Duty Death the Milwaukee Police Honor Guard will follow the below listed protocols.
 - 1. Upon notification of an event that has, or may result in the death of an active department member, the Honor Guard commander, or designee, will cause the activation of the Honor Guard Unit. Unit members will immediately dress in full uniform (if possible) and report to the hospital where the member is located.
 - 2. Honor Guard member(s) will retrieve a U.S. Flag from the Specialized Patrol Division Honor Guard closet or from the rear of the Honor Guard commander's departmental vehicle to be used to drape the member. It should be noted that this flag will remain with the member and will not be changed or exchanged at any time. This will be the primary flag that will later be presented to the family of the deceased. No Honor Guard member is authorized to promise or issue any additional flags without the permission of the Honor Guard commander.
 - 3. Honor Guard members, as soon as practicable, will arrange for the member's department vehicle or replica to be draped at the members work location with the thin blue flag and blue lights located in the Specialized Patrol Division Honor Guard closet. The vehicle shall be draped in a professional manner and this memorial should stay in place until sunset of the memorial of the member. As soon as practicable, Honor Guard members will respectfully remove the memorial and return the vehicle back to service. Honor Guard members should attempt to save any items from the memorial and turn them over to the family liaison for disposition.

VII. CATEGORY I "FULL HONORS"

A. Upon notification of a line-of-duty death, the Milwaukee Police Department will implement the incident command system. The Wisconsin Honor Guard Association (WHGA) should be notified immediately to serve as a resource to assist in honoring our fallen brothers

VIII. CATEGORY II FUNERALS

- A. Honor Guard members will be involved in Category II Funerals on a routine basis as they are associated with the death of a retiree or active sworn member in "good standing," who is not on-duty. The phrase "good standing" refers to a death that is not associated with:
 - 1. A criminal act, or;
 - 2. An attempt to avoid prosecution of a criminal act, or;
 - 3. Any other equally dishonorable action.
- B. The Chief of Police will determine whether or not funeral honors will be afforded and to what extent.
- C. Retired members of the Honor Guard in good standing may be utilized for Category II funerals or as directed by the Honor Guard commander.

D. SUICIDE

- 1. When the Milwaukee Police Department needs to address the funeral arrangements surrounding a suicide by an on-duty, off-duty, or retired law enforcement officer, it is important to proceed cautiously, so as to avoid passing judgment as to the reason(s) for the officer's suicide. The Milwaukee Police Department Honor Guard holds that the ceremonious activities surrounding a law enforcement officer's funeral are to honor the way in which the officer served, and therefore, should not be impacted by the circumstances of his or her death by suicide (with notable exceptions being previously addressed).
- 2. The death of a law enforcement officer by suicide does not rise to the level of a Category I funeral. However, the Chief of Police, or designee, may authorize a Category II funeral for the death of an office by suicide.

E. PLANNING AND COORDINATION OF CATEGORY II FUNERALS

- 1. A Category II funeral will usually be smaller in scope and complexity than its Category I counterpart. Considerable planning is nonetheless essential for the proper delivery of ceremonious honors, and for the effective use of Honor Guard and department personnel.
- In most circumstances, the Honor Guard Unit will be able to handle all the duties associated with a Category II funeral; however, we must be mindful not to overburden our Honor Guard Unit (or its personnel), particularly when a large response of law enforcement is expected.
- 3. Consideration must be employed to ensure that the following assignments are properly addressed and staffed (ICS considerations) as determined by the Honor Guard commander, or designee:

G. RIFLE SALUTE, PLAYING OF TAPS, FLY OVER, AND SIX MEMBER FLAG FOLD

Some ceremonious honors must be reserved for those law enforcement officers who die in the line-of-duty. Consequently, a Rifle Salute (3 volleys), six member flag fold, fly over, and the playing of Taps should be reserved only for Category I law enforcement funerals (please note that in some instances the decedent member may be an armed forces veteran, and their branch of service may provide them with a rifle volley as a part of their military honors, but the Milwaukee Police Department does not).

H. OTHER CEREMONIOUS FUNCTIONS

- 1. Ultimately, it is incumbent upon the Honor Guard commander, or designee, to determine what law enforcement honors will be afforded during Category II funerals. This determination should be minimally based upon the following considerations:
 - The wishes of the family/survivors of the decedent;
 - The needs of the department;
 - The needs of the community;
 - The agency's ability to deliver certain components.
- 2. Some ceremonious elements that can be considered are as follows:
 - a. Casket / Urn Watch

Two officers at the head and foot, or a single officer posted at the head of the casket, with periodic guard change.

b. Shrouded Squad

Cleaned and polished agency squad with a black-shrouded light bar, displayed at a prominent location. (Category I)

c. Stand of Colors

National and State Flags appropriately displayed at the casket/urn.

d. Ceremonial Pillow

Color-coordinated pillow with agency patch/emblem, placed in a prominent location, with fallen officer's cover/hat.

e. Rifle posting

Rifle(s) ceremoniously posted outside the venue.

f. Cordon of Honor

Other attending officers positioned outside venue during casket movements, brought to Attention, and salute as casket passes by.

The Milwaukee Police Department Honor Guard holds that the ceremonious activities surrounding the non-sworn member's funeral are not to rise to the level of a Category I or a Category II funeral. However, the Chief of Police, or designee, may authorize a Category II funeral for a non-sworn member based upon other circumstances surrounding the death of the non-sworn member. Those special circumstances involve factors such as whether the member was on-duty, and/or acting in an official capacity.

2. Category II funeral services shall be followed if the Chief of Police, or designee, authorizes a Category II funeral. Members shall follow normal civilian protocols (no salutes of the un-draped casket, rifle volleys, vehicle processions or honors otherwise reserved for military and law enforcement personnel). Department members can attend, come to attention at the passing of such a member's coffin/Urn, and/or stand guard for a non-sworn member's funeral.
