Hi, Nik,

Just an update on street's quest to get some peace at night.

This weekend there were people out partying in their cars again. Drinking in their cars, blasting their music for 30+ minutes (around midnight), idling in their cars before racing.

', just being a nuisance. One car in particular parked, went to Mangos for an hour, came back to their car to party for 30 minutes, and then returned to Mangos. I think they were avoiding spending money in the bar by drinking in their car.

a conversation with the owner a couple weeks ago about what his patrons are doing to residents' peace and quiet. He assured—it bothered him, and he wanted to work with us to fix it. He told—could call him anytime when this was happening, and he would make sure they were turned away at the door to discourage this from happening. called him this weekend, as he'd requested, but got no answer—left a message and never heard back. He said he'd make sure security had a presence further down the block, but—haven't noticed that, either. People just hang out and party on—street with no intervention.

also contacted the police non-emergency line when it was happening. on hold for 15 minutes. By the time the police showed up, the people had long since moved on. This has been the theme any time try to get help with this nuisance from the police. understand they're busy -- but do want to recognize the fact that they're often mentioned as a solution, when they aren't able to address this problem.

So it seems like can't get help from the police, and can't get help from the bar's owner. My choices seem to either be direct confrontation (which I'm not comfortable with), or just tolerating people treating like a nightclub.

Please tell me this bar's license won't be renewed. The owner says he wants to work with neighbors, but hasn't followed through. And the police aren't available to enforce peace and quiet either. just don't know of any way to keep the bar's presence peaceful and fair

Good morning,

I write to you today to urge closure (or at least a refusal to renew their business license) of Mangos East Cafe on Van Buren. Every night there are broken bottles left in the street by their patrons. Fights break out there constantly. Reckless driving by those who intoxicate themselves at this bar and leave hammered, putting everyone around them at risk while doing burnouts and donuts in the street. Here is a sequence of events from last night alone that all involve patrons we witnessed leaving Mangos East Cafe:

- A group of 5 women began blasting music from their car with all the doors open while twerking in the street for an hour.
- Two men arguing up and down the street, becoming belligerent toward each other and chasing each other
- Man in a white Audi (license plate ACW 1501) driving recklessly, blaring music, and backfiring car multiple times a night, multiple nights a week

These are just a few events are from ONE night; things like this happen every night, and they are always folks coming from Mangos East Cafe.

I don't normally write these types of emails but less and less fond of the neighborhood, solely because of Mangos East Cafe.

I can say I am feeling

I have received several letters from neighbors urging me to join their coalition of reporting and communicating dangerous behavior related to this bar, and this is my first step toward trying to be part of the solution.

I appreciate your time and I will continue to reach out to anyone else who can help make our community feel safer.

Learn why this is important

Hey, just reaching out to let you know we're still experiencing issues with the Mango's crowd.

Last night there was a loud, aggressive verbal fight outside that lasted nearly 30 minutes around 9:30pm, with a group coming from the direction of Mango's. , and would have called the police if it turned physical, but in light of police violence against people of color thought it best not to call otherwise.) They showed up around 7:45, went to the bar, and then had their argument in the street afterwards. The occupants of the vehicle dumped all their trash around the side of the vehicle, leaving a mess. As things wound down, a couple of people went back in the direction of Mango's:

At 1:50 am, another group came from that direction --- maybe Mango's, maybe Casablanca -- and hung out in the street, dancing and shouting in a group, playing chicken with traffic. (Short video here: https://video.nest.com/clip/100a124316fa46fca411e212b845190f.mp4.) The video is only a minute or two long, but this went on for about 15 minutes, in the wee hours of the morning, surrounded by houses.

Additional security outside these bars — if it's still in effect — isn't helping their patrons' behavior in the neighborhood. It's still a problem. The bars need to do more to communicate to their patrons that the neighboring houses are full of sleeping people who won't tolerate fights, raucous behavior, etc. especially when they're sleeping. Or, the bars need to relocate to a neighborhood that fits this behavior better.

- 8. On 03/30/2017 officers conducted underage tavern enforcement in District 1. An underage Police Aid attempted to gain entry to Mango's Café East, 1682 N. Van Buren St. There was no security at the door and the Police Aid was able to order a Miller Lite from the bar for \$3.00.
- 9. On 05/15/2017 officers were dispatched to a shots fired complaint at 1638 N. Van Buren St. The investigation revealed the subject involved had been inside Mango's, 1682 N. Van Buren St. He exited and was denied re-entry by security. As he was walking away he pulled out a gun and fired shots into the air. The tavern does not have working video surveillance system and had no ID scanner.

11. On 04/17/2018 at 1:41am officers were dispatched to Mango's Café East, 1682 N. Van Buren St, for a Noise Nuisance complaint. The officer attempted to contact the caller but received no answer. On 04/17/2018 at 1:00pm an officer contacted the caller who stated there were two groups of people that left Mango's and were yelling very loudly at each other and began playing loud music. No employees of Mango's were observed outside to help manage the crowd. The officer cited the agent for Excessive Noise.

12. On 11/29/2018 an underage compliance check was conducted at Mango's, 1682 N. Van Buren St. Mango's passed the compliance check.

13. On 03/26/2019 at 1:00am officers were flagged down by security at Mango's Bar for a disorderly subject that security had removed from the bar. The subject was issued a Disorderly Conduct citation. While on scene security again flagged the officers down for subjects removed for fighting inside. One of the subjects was issued an Assault and Battery citation.

- 14. On 04/16/2019 at 1:27am officers were dispatched to 1682 N. Van Buren St for a battery complaint. The officers spoke with security who stated an altercation occurred between two females sitting at the bar. Security broke up the fight and escorted one of the subjects out. The officers spoke with the owner, Greg KIECKBUSCH, who was cooperative and provided surveillance video of the incident.
- 15. On 12/02/2019 officers conducted a licensed premise check at Mango's Café East, 1682 N. Van Buren St., believing the tavern was over capacity. The officer spoke with the manager, Jeffrey PARR, asking if he knew what the capacity was and he stated "about 93". The officers asked to see the issued capacity sign and PARR could not locate it. The security at the door estimated there were 60-70 people in the tavern but could not give an accurate count because his "clicker" was broken. PARR was advised to have the capacity posted in view of the public. The officers determined the bar was not over capacity.
- 16. On 12/10/2019 officers along with agents from the Wisconsin Department of Revenue, conducted a licensed premise check at 1682 N. Van Buren St. The officers spoke with the manager, Jeffrey PARR, who showed the officers the license and capacity posted in public view. PARR then assisted the Department of Revenue agents in their inspection.

- 17. On 03/17/21 at 11:21pm, Milwaukee Police were dispatched to 1682 N. Van Buren Street for a subject with gun complaint. Investigation revealed that there was a fight inside the tavern which was broken up and nobody had a firearm. The owner told officers that the tavern was now closed for the evening, but the officer did observe numerous patrons, inside the tavern, consuming beverages and eating food. The tavern license was observed which was posted inside a small room just off the southern end of the bar.
- 18. On 08/11/21 at 2:20am, Milwaukee Police were dispatched to 1682 N. Van Buren Street for a subject with gun complaint. Investigation revealed that there was a fight inside the establishment and when an employee tried to break up the fight, a subject produced a handgun and started waving it around. The subject then fled in a vehicle. While officers were interviewing the employee, the vehicle that the subject fled in returned and officers found a firearm inside the vehicle. The subject was arrested.
- 19. On 10/04/21 Milwaukee Police conducted follow-up at 1682 N. Van Buren Street on a shots fired complaint which occurred on 10/03/21 at 1627 N. Van Buren Street. Pole camera video, which is located at the intersection of E. Brady Street and N. Van Buren Street, revealed that the shooter and vehicle used in the incident were captured lingering in front of 1682 N. Van Buren Street immediately before the incident. Officers made contact with the General Manager who appeared nervous and evasive in his answers to questions asked of him. He told officers that he did not know the full names of his employees and that they subcontract security. The owner arrived at the tavern and told officers he does not subcontract security and that he was unaware of a shots fired incident but agreed to allow officer's to view video

- surveillance. Officers found that the outside surveillance cameras were not functional and were able to get a better description of a person involved in the incident from the surveillance cameras posted on the inside of the establishment.
- 20. On 11/11/21 at 2:16pm, Milwaukee Police conducted follow-up at 1682 N. Van Buren Street. Officers met the owner and informed him of the recent complaints from neighbors regarding his business. The owner said he was aware of the complaints and was in contact with the Alderman's office regarding these complaints. The officers and the owner agreed to set up a meeting to try and resolve some of these complaints.
- 21. On 12/10/21 at 11:30am, a meeting was held at the First District Police Station between representatives of the City of Milwaukee and the owners of 1682 N. Van Buren Street. The reason for the meeting was to discuss numerous complaints that have come to the attention of the police department and alderman's office. The applicant told officials that he has implemented the following changes; he has provided his personal cell phone number to neighbors, has increased his security staff levels, added eight cameras, pat down and metal detector searches on weekends or when they have a DJ, and instructed door security to deny entry to people who appear intoxicated. The police offered fake identification training for security if they thought it would help them succeed.

This report is written by P.O. Daniel O'CONNELL assigned to District 1, Late Shift.

On Wednesday March 17, 2021 while assigned to Squad 1331, I was dispatched at approximately 11:25 PM to Mango's Cafe along with Squad 1321, P.O. Shahriar SOLATI, to Mango's Cafe at 1682 N Van Buren Street, which is located in the City and County of Milwaukee, regarding a subject with gun complaint. The initial information provided by the caller stated that there was a black male in his mid 30s wearing a lime green hooded sweatshirt causing a disturbance. During this disturbance the male wearing the lime green sweatshirt produced a handgun and pointed it at a bouncer and threatened to shoot the bouncer, according to the information provided by the caller.

Upon my arrival, I located a subject matching the description of a black male in his 30s wearing a lime green sweatshirt, standing a few feet north of the entrance to the bar. The staff of the bar did not flag me down or appear as if someone had just pointed a firearm at them. The subject later identified as Darnell J DOUWDY (B/M, 08-25-91), stated that there had been an altercation inside the bar that he was trying to break up and that he did not have a firearm on his person. I asked if anyone at the bar had called regarding a subject with a gun but they all stated that there was a fight that had broken up but no one had a gun with them during this time.

I was met by Gregory A KIECKBUSCH (W/M, 06-25-80) who identified himself as the owner of Mango's Cafe. KEICKBUSCH retold the story about the fight that occurred and that no one had a firearm during this time. He then mentioned that the bar was now closed for the evening. As he said this I observed numerous patrons still consuming beverages and eating food while the bar was supposedly closed. He allowed me to view the license which was posted inside of a small room just off the southern end of the bar.

The following report was written by P.O. Jacob BACZEK regarding this incident resulting in the summary arrest of the suspect that was a patron at Mangos Cafe East.

On Wednesday, August 11th, 2021, while working on squad 1420, P. O. Rick MICHALAK and myself were dispatched to a subject with gun complaint at MANGO's Bar located 1682 North Van Buren Street at 2:20 a.m.

Upon arrival, I spoke to the victim, Rex A CRUZ (H/M 03-31-82) who stated that he was breaking up a fight at his bar (MANGO's) when a hispanic female got involved in the fight and began to wave a black semi automatic handgun and threaten him with the gun causing him to fear for his safety. CRUZ stated the subject then fled the scene in a white HUMMER H3, and stated they had just left when we arrived. While interviewing CRUZ, the white HUMMER H3 pulled up and then drove off southbound on Van Buren Street from MANGO's, at this time P.O. MICHALAK and myself initiated a traffic stop on the white HUMMER H3, at 1530 North Jackson Street in the City and County of Milwaukee.

Upon approaching the vehicle, A White 2006 Hummer H3, bearing Wisconsin registration plate AFT-9885, VIN#5GTDN136368190632, I observed the subject described to P.O. Ryan BALLOGH by CRUZ who finished interviewing CRUZ while myself and P.O. MICHALAK conducted the traffic stop. CRUZ described the suspect waiving the gun as a hispanic female wearing a red dress with braces. I observed the driver, later identified as Janessa L. RODRIGUEZ (H/F 07-22-2000) wearing a red dress and having braces on her teeth. In the front passenger seat was Damanique A. MCADORY-WATSON (H/F 12-24-96) and in the rear driver's side passenger seat was Emerald P. MOORE-GARNER (H/F 08-06-99). I began to ask the occupants of the vehicle if they had a firearm in there possession, both passengers seemed heavily intoxicated and neither of them had braces on their teeth. RODRIGUEZ became uncooperative at which time she was asked to exit the vehicle. During a search of the vehicle, a firearm was located under the front passenger seat. The firearm, a SCCY CPX-2 9 milimeter, semi automatic pistol, black in color, serial number C037838 was assigned MPD Gun Tag#100556, and placed on MPD inventory#21030565. The firearm was not loaded and had no cartridges in the magazine.

This report is being written by P.O. Joseph LACROIX, assigned to District One Early Power Shift Squad 1246.

On Monday October 4, 2021 D1 Lt Robert THIEL asked my partner, P.O. Tanya ROSALES and I to conduct additional investigation into a shots fired incident that occurred at 1627 N Van Buren St at approximately 2:00am on Sunday October 3, 2021.

During the course of this investigation, filed under Milwaukee Police Department Incident Number 212760028, it was discovered that the shooter and the vehicle used by the shooter were captured lingering in front of Mangos Cafe, located at 1682 N Van Buren St, by Milwaukee Police Department Pole cameras located at the intersection of E Brady St and N Van Buren St.

In the Pole camera video, one can observe a disturbance occurring in front of Mangos involving the shooter, the shooter vehicle, an unknown black female wearing a tube top and red pants, several additional unknown subjects, and what appears to be a member of Mangos' Security staff, who can be seen waving a flashlight around in what appears to be an attempt to disperse the various involved subjects.

It should be noted that this occurred immediately before the shots fired incident.

P.O. ROSALES and I are aware that there is a surveillance camera on the exterior of the building that should have captured video of the disturbance, and a check of Mangos most

recent liquor license application indicated that there are two exterior cameras as well as additional interior cameras at the location.

It should be noted that P.O. ROSALES and I, over the past several months, have been in contact with multiple residents in the area that have expressed concerns and complaints regarding the activities and behaviors of the clientele of Mango's, that according to said residents, include reckless driving, noise nuisances, littering, fights, shots fired, public consumption of alcoholic beverages on the street and within parked vehicles, entry to auto and auto theft.

It should be noted that while it seems unanimous that residents in the neighborhood feel that a large percentage of the crimes and ordinance violation incidents in the neighborhood are directly attributable to the clientele of Mangos Cafe, most are unwilling to file complaints due to fear of retaliation, and have asked P.O. ROSALES and I what they can do outside of filing reports. P.O. ROSALES and I advised that neighborhood residents were welcome to share their concerns at the next Liquor License review hearing, which should be in January of 2022 and should be open to the public for comment. A large number of neighborhood residents told us that they would be going to the hearing.

INVESTIGATION AT MANGO'S CAFE

On Tuesday October 5, 2021 P.O. ROSALES and I arrived at Mango's Cafe to check for video regarding the shots fired incident that occurred 10-03-2021. It should be noted that the exterior camera at Mango's was broken and did not capture any video on 10-03-2021.

We made contact with the General Manager, Rex A CRUZ(M/W, 03-31-1982), it should be noted he appeared nervous and evasive in his answers to our questions, some of which made no sense, and at one point, interrupted the interview to ask if he needed a lawyer. CRUZ exhibited multiple deceptive behaviors, including barrier posture, evasive answers, changing answers, increasing nervousness, withheld names, erratic and rapid posture changes, and rapid rate of speech pitch and volume changes.

CRUZ told us that he was working the night of Saturday October 2, 2021 and he locked up at approximately 3:00am on Sunday October 3, 2021. CRUZ told us that at one point during the night he heard people arguing "down the block", screaming and talking loudly, and that he "heard there was a fight outside" that occurred "down the block". CRUZ told us that he checked outside when he heard the fight, which was at approximately 2:10-2:15am, but there was no one in front of the bar. CRUZ told us there were three bouncers working Saturday night whom he knew only as "Nik", "Chip" and "someone else". CRUZ stated the bouncers were subcontracted by an unknown security company.

CRUZ also told us that there are three other managers that work at Mangos, "T-Rel", "Lance", and "Jeff". CRUZ told us that he didn't know the other managers, or the bouncers' full names.

Prior to the start of our interview, CRUZ contacted "Greg" who he stated was the owner of Mangos.

Gregory A KIECKBUSCH(M/W, 06-25-1980), arrived on scene and met with P.O. ROSALES and I next.

KIECKBUSCH confirmed that CRUZ was the General Manager and he was the licensed food service manager and owner, though the licensed agent is "Francisco". A records check identified "Francisco" as Francisco SANDINO-ESCOBAR(M/W, 09-15-1951) as this agent.

KIECKBUSCH told me that Mangos does not use subcontracted bouncers, and all of the bouncers are employees of Mangos.

KIECKBUSCH told us that he was unaware of the shots fired incident, and agreed to take us downstairs to his business office to check for video captured by the surveillance cameras. Unfortunately, the exterior camera was not functional.

KIECKBUSCH was able to show us video of the interior of the bar from approximately 1:45am until just after 2:00am on 10-03-2021. In the video, one can observe can a clearer image of the unknown thinly built female wearing the tube top and red pants who was observed in the pole cam video hugging on the shooter and entering the suspect vehicle and exiting the suspect vehicle and entering the parked Toyota in JEROW's video. The female can be seen on video engaging in a heated argument with an unknown black male near the front door of the bar. The female can be seen pushing and slapping the unknown male.

On Friday, December 10, 2021 I along with PO Carlos FELIX, Sgt. Adam ZIEGER, LT Robert THIEL, Sgt. Guadalupe VELASQUEZ, ADA Keliy HEDGE, City Attorney Meighan ANGER, and Alderman Nik KOVAC met with the staff and owners of Mangos Cafe. In attendance for Mangos was Francisco SANDINO-BADILLO Jr, Gregory KIECKBUSCH, Nicholas GRADY, and their attorney Vincent BOBOT.

The meeting was to discuss numerous complaints that have come to the attention of the Police Department and the Alderman's Office regarding Mangos Cafe. This meeting was to strategize ways to improve security measures and cut back on the amount of complaints that are being received. Francisco informed us that he recently made some changes with his staff and the way that patrons who are being a problem are handled. Francisco stated he has provided his personal phone number to neighbors in the area so they can call him when something is wrong (loud music, cars racing, disorderly patrons down the block). Francisco stated he has two or three security guards working at all times to ensure the safety of his patrons. Francisco also informed us that he has instructed his door security to deny entry to any patrons who appear intoxicated or approach the entrance with an open intoxicant. There has been an additional eight cameras added to the establishment and Francisco has immediate access to them. Francisco has his security staff conduct pat downs on weekend or when they have a DJ, the staff also uses a metal detector to wand over patrons before they enter. Francisco feels that some of these new changes will help cut down on the amount of complaints his establishment is receiving.

We offered Fake ID training and a meeting with security for the establishment if Francisco felt it would help them succeed.
