There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-2.7-4, probative evidence concerning whether or not a new license should be granted may be presented on the following subjects: whether or not the applicant meets the municipal requirements, the appropriateness of the location and premises where the licensed premises is to be located and whether use of the premises for the purposes or activities permitted by the license would tend to facilitate a public or private nuisance or create undesirable neighborhood problems such as disorderly patrons, unreasonably loud noise, litter, and excessive traffic and parking congestion. Probative evidence relating to these matters may be taken from the plan of operation submitted with the license application, if any, but shall not include the content of any music. Evidence regarding the fitness of the location of the premises to be maintained as the principal place of business, including but not limited to whether there is an overconcentration of businesses of the type for which the license is sought; whether the proposal is consistent with any pertinent neighborhood business or development plans, or the location's proximity to areas where children are typically present. The applicant's record in operating similarly licensed premises; and whether or not the applicant has been charged with or convicted of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the activity to be permitted by the license being applied for or any other factor which reasonably relates to the public health, safety or welfare may also be considered. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to attend this meeting may result in the denial of your license. Individual applicants and partnership applicants must attend or attend by an attorney. The agent or attorney for corporate or limited liability applicants must attend. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should request an interpreter attend the meeting with you, at your expense, so that you can answer questions and participate in your hearing.

Alderman-

District Six and LIU within MPD have been investigating this location,

Our Sensitive Crimes Unit also was involved and did a work up on the phone number and the location first week of October. We were able to establish that there were advertisements on adultlook website using the businesses phone number 414-737-4420- as recent as October 8, 2020.

On October 19, 2020 Sensitive Crimes Division brought this information to a Federal Task Force meeting and DCI and at that time there was no evidence that trafficking was taking place.

LIU was also involved and ticketed and shut the business down due to insufficient licensing. The business was issued there license once they completed what was required with DNS's inspection.

District Six personnel have been attempting to monitor and make traffic stops and business checks, which we are continuing to do as staffing allows. We are also working with our Sensitive Crimes Unit in an attempt to set up surveillance.

Please advise any and all neighbors that if they are seeing them open after hours to call the non-emergency number and report these issues. At this time we have NO calls for service.

Do not know this kind of business but it was "sold " to me as providing services like massage using warm stones on back, deep-tissue massages and rehab for athletes. Please note that the District has a couple of other Massage businesses that are very legit! It was also. Strictly mentioned by myself that I would not tolerate "hankypanky." So, Mr. Schmit your email to me on Monday (28th) was the first I have heard about them since they have been in business. And yes, I am "ticked off" that I may have been bamboozled, but I wanted to see for myself and check. At this time, I am giving them the "benefit of doubt' as they denied the allegations and stated an angry/vindictive customer has used social media against them. I was also put on the phone with the female owner and again, went over what is legit. The Milwaukee Police Department's investigation regarding this application revealed the following:

The employee spoke limited English and the officers used an over the phone translator. The officers advised the employee the business had no license and had to cease operations. The officers spoke with the applicant by phone and he stated he attempted to resolve the license issue in person but was not able to do so because of Covid regulations.

- 2. On 02/08/2021 officers conducted a license premise check at Charm Spa, 5726 W. Oklahoma Av. The officers spoke with the manager, who provided the officers with the current licenses.
- 3. On 02/09/2021 officers conducted a license premise check at Charm Spa, 5726 W. Oklahoma Av. The officers spoke with the employee through a phone translator. The officers advised they were concerned of underage girls working at the location. She stated they work with an advertising company and she stated the officers could talk with them about the advertisements. The officers also advised of complaints of sexual acts being performed. The

employee stated she has been asked to perform sexual acts but has always refused. She then showed the officer messages the business has received requesting sexual acts and the business responses that they only performed massages. She stated she welcomed the officer's help to address these issues.

- 4. On 02/13/2021 at 8:09pm officers conducted a license premise check at Charm spa, 5726 W. Oklahoma Av. The officers spoke with the employee, who provided the current licenses.
- 5. On 02/18/2021 at 7:30pm officers conducted a license premise check at Charm Spa, 5726 W. Oklahoma Av. The officer observed no customers in the business. The employee called the translator on the phone because of her limited English. The employee stated she was concerned the neighbors would think there was a problem because of the amount of police visits. The officer stated he was just instructed to check the licenses.

### INITIAL INVESTIGATION

Benitez, Xavier J 012992

01/28/2021

This report is being submitted by PO Xavier Benitez assigned to the License Investigation Unit.

On Thursday January 28th, 2020 at 10:00am PO Penny MONREAL and I conducted a license business check at 5726 W. Oklahoma Ave (Charm Spa) I was equipped with an Axon worn body camera at the time of the premise check. To view the interaction in it's entirely please review Axon camera footage.

Upon exiting my police vehicle I observed that the open sign of the business was illuminated and flashing "Open" Officers entered the business with no employees in the front. Officers were then greeted by an employee later identified as Zhirong WANG (f/a 08/21/81) who had difficulty speaking English due to a language barrier. Ms. WANG stated she speaks Chinese and her English was limited. Officers were attempting to use google translate when Ms. WANG used her telephone, to contact a live person translator. The translator on the phone identified himself as Christopher GAN (m/a 01/27/72) who stated that he translates for the business, English to Chinese.

Ms. WANG with Mr. GAN translating was informed the business does not have a valid massage license to run the business. Ms. WANG showed officers a occupancy permit for the location, but was informed that the City of Milwaukee never granted the massage license from January of 2020. Ms. WANG was informed the license was held up due to the city inspector never being allowed on premise to finish a final inspection. Ms. WANG was informed that business was not allowed to operate, cease all in person services, until the massage license is approved from the city. Mr. GAN stated that he informed Ms. WANG, and she acknowledged that she would comply.

Mr. GAN stated that he will inform the business agent, Mr. GUO of the information. I informed Mr. GAN that I will also call the agent to verify that he understands regarding the interaction and that a citation would be issued regarding the operation without an approved massage license.

I received a call from Mr. GAN with the business agent on the phone, who stated that they attempted to resolve the license issue in person. However they were not able to do so, due to the City of Milwaukee Covid -19 restrictions. Mr. Gan stated that at city hall there is no in person business currently conducted, the business is done by phone and email. Mr. GAN stated that they did leave a message with the City of Milwaukee License Division, regarding the issue, and hope to have an update soon.
