The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 03/14/2019 a meeting was held at the District with the applicant regarding the McDonald's at 2520 W. National Av. The officers met with the applicant regarding prior problems at this location under the old owners. The applicant stated he has hired security and has meet with the Alderman. The applicant stated his main concern was loiters being disruptive. The applicant was given information on trespassing citations and restraining order.
- 2. On 11/12/2019 a meeting was held at the District regarding an increase in nuisance related calls at McDonald's, 2520 W. National Av. The applicant was advised of measures the previous owner took to alleviate problems; including improved outdoor lighting and hiring off-duty Milwaukee Police Department officers. The applicant was also advised of Operation Impact cameras he could install at the business; which officers could view in real time to see problem while they were occurring.
- 3. On 02/25/21 at 1:07 am, Milwaukee Police were dispatched to 2520 W. National Av, for a battery complaint. Police spoke with the manager who stated that a burgundy vehicle, with several subjects ordered through the drive thru window. The vehicle with subjects came around again complaining about the food. The main subject argued and made threats to the workers at the drive thru window. One of employees threw the bag of food back into the

vehicle, and closed the window thinking the vehicle would leave. The main subject exited the vehicle and started to damage the drive thru window. The main subject then attempted to enter through the window. During the altercation, the soda machine was damaged. One of the workers during the incident stated he believed the subjects were attempting to enter the location to rob the business. That worker exited the store and retrieved a shotgun from his personal vehicle. The worker then returned and pointed the shotgun at the main subject who was partially in the location. All the subjects entered the vehicle and left the location. Police reviewed the video, which showed the incident described take place. The vehicle with the main subject returned to the location during the course of the investigation. Police arrested the main subject who damaged the drive thru windows and the soda machine. Police also arrested the worker who pointed the shotgun. The manager and employees were cooperative with police during the investigation.

#### LICENSE PREMISE REPORT

Gnas, Tyler D 026046

This report is written by P.O. Tyler GNAS assigned to District Two Late Shift.

On Thursday February 25, 2021 at approximately 1:07AM my partner P.O. Traves MARTIN and I were dispatched to a battery call for service at the address of 2520 W National ave which is a McDonalds Restaurant. Upon arrival we were met by a worker who later identified himself as Tornell T THOMAS (M/B, 07/14/1987) who yelled for a manager to let them know that Police have arrived. I was then met by the manager who identified himself as David I BROWN (M/B, 07/14/1988) and as one of the managers of the McDonalds Restaurant. BROWN stated that multiple subjects had came through the drive through and damaged the drive through windows. I observed the west side drive through window which was broken off of the sliding rail. The south pane of the window was also shattered with a hole in the center of the window pane. I also observed a broken Coca-Cola soda machine just beside the broken window along with an unknown liquid covering the floor beside the window pane on the inside of the McDonalds. I also observed the second broken drive through window which was located on the northwest side of the business. The window was broken off of the sliding rail and I could see the chain that controls the sliding mechanism hanging along the side of the window. I then conducted a detailed interview of the incident with BROWN.

#### INTERVIEW OF DAVID BROWN

BROWN stated that a Burgundy Chrysler PT-Cruiser containing multiple black male subjects drove through the drive thru and ordered food. BROWN stated that upon giving the subject's their food, they demanded that their food be made fresh. BROWN stated that he asked the subjects to pull around and they would bring their food out to them. BROWN had their food made and gave the food to his coworker who is identified as Joel E AVILA (W/M, 10/15/1984) to give to the subjects. pulled back around to the west side drive thru window claiming that they were missing food that they had ordered. BROWN and his co-worker who was identified as Daveon A JONES (B/M, 11/25/1996) then engaged in a verbal confrontation with the subject's inside of the PT-Cruiser. BROWN stated that the subject's yelled to himself and his workers that they would "come in and get on yawl" and "take all of their shit". JONES then took the bag of food from BROWN and threw the bag of food through the drive thru window and into the PT-Cruiser through the driver side front window. The driver of the vehicle who was later identified as Edward J LEWIS (M/B, 01/05/1999) then exited the vehicle. A passenger of the PT-Cruiser who is later identified as Jalen M PRIMER (M/B, 12/25/2003) exits the PT-Cruiser and punches the drive-thru window multiple times, then pushes the drive-thru window until the window breaks and falls off of the sliding track. BROWN then calls for the police using the McDonalds phone. BROWN stated that the damage to the drive-thru windows is estimated to a total of approximately \$1000 per window for a total of \$2000 worth of damage to the drive thru windows. BROWN stated that the Coca-Cola Beverage Dispenser was also broken and would cost approximately \$600 to repair. The total damage to the windows and the Coca-Cola machine is approximately \$2600. BROWN does not know the insurance that covers the McDonalds business. BROWN also stated that he was able to provide video of the incident.

#### INTERVIEW OF DAVEON JONES

JONES stated that he had heard several subjects outside of the drive-thru window stating that they did not receive all of the food that they had ordered. JONES and BROWN then engaged in a verbal confrontation with the subjects inside of the PT-Cruiser regarding their food order. The subjects inside of the PT-Cruiser then began threatening JONES and BROWN. JONES then took the bag of food from BROWN and threw the bag of food through the drive-thru window and into the driver side window of the PT-Cruiser. JONES then closed the drive-thru window and thought that the subjects were going to leave. LEWIS and PRIMER then exited the vehicle and PRIMER began damaging the drive-thru window. JONES stated that he believed that LEWIS and PRIMER were trying to break into the McDonalds and rob the business. JONES stated that he then exited the McDonald's through the east door and ran to his personal vehicle which is identified as a Green 1997 Honda Accord bearing a temporary license plate 84479FE and removed a shotgun from the vehicle. JONES then ran back into the McDonalds and pointed the shotgun out of the west drive-thru window and at LEWIS. JONES then struck LEWIS in the left side of the neck with the barrel of the shotgun. LEWIS and PRIMER then entered the PT-Cruiser and fled the scene. JONES then walked into the women's bathroom and placed his shotgun into a trash bin that was located inside of the one of the stalls of the women's bathroom. JONES stated that he placed the shotgun into the bathroom because he did not want to walk around with a shotgun in hand while customers were still pulling through the drive-thru and because the police arrived before he was able to place it into his vehicle.

#### INTERVIEW OF JOEL AVILA

AVILA stated that he was on his break eating food in the middle of the restaurant when he heard a verbal argument coming from the drive-thru window. AVILA stated that he then observed a subject breaking the drive-thru window and attempting to enter the business. AVILA then grabbed a broom and yelled to

them that if they came in he would strike them with the broom. AVILA stated that his managers, JONES and BROWN, were arguing with the male subjects prior to the subjects damaging the drive-thru window. AVILA did not have any further information.

#### INTERVIEW OF TORNELL T THOMAS

THOMAS stated that he was on a break smoking a cigarette on the east side of the building and he did not hear or see any of the incident. TORNELL greeted police upon their arrival and observed the damage to the windows. THOMAS did not have any further information.

#### CAMERA FOOTAGE

I observed the camera footage of the incident which captures two separate angles of the incident. I observed a camera facing the west side drive-thru window from the inside of the McDonalds. The angle captures the window, the outside of the window, and several feet inside of the kitchen area to the east of the window. At approximately 1:00AM a red PT-Cruiser pulls up to the drive-thru window. JONES and BROWN are seen opening the window and taking a McDonalds bag from the driver of the PT-Cruiser. JONES and BROWN then appear to begin arguing with the subject's inside of the PT-Cruiser. JONES then takes the bag and throws the bag through the drive-thru window and at the PT-Cruiser. JONES then exits the frame. A black male subject wearing a red sweater then exits the driver seat side of the PT-Cruiser and walks northbound out of frame. A black male subject wearing a black sweater, with black and blonde dreads, who is later identified as PRIMER then walks to the drive thru window and punches the window with a closed fist multiple times. PRIMER then pushes the window multiple times breaking the window and removing the drive thru window from the sliding track. PRIMER then reaches the top portion of his body into the business and grabs a Coca-Cola machine. PRIMER throws the Coca-Cola machine onto the floor, causing it to break and leak liquid all over the floor in front of the drive thru window. PRIMER then walks out of frame. JONES then walks back into frame carrying a black long gun, which JONES had identified as a 12 gauge shotgun, and pointed the shotgun out of the drive thru window. JONES then points the shotgun at a subject and strikes the subject with the tip of the barrel.

I then observed a camera angle that captures the outside of the northwestern drive-thru window. At approximately 1:04AM a black male subject with black and blonde dreads, wearing a black sweater, and black pants, later identified as PRIMER, enters the frame. PRIMER then kicks the drive-thru window. PRIMER then walks backwards and runs up to the window and kicks the window once again. PRIMER repeats this two more times causing the drive-thru window to break off of the sliding track.

While investigating the incident we were met by LEWIS and PRIMER who identified themselves after arriving on scene. LEWIS is interviewed by P.O. MARTIN regarding the incident.

#### INTERVIEW OF LEWIS

LEWIS stated he came to the McDonald's at the address of 2520 W National Ave to pickup food. LEWIS stated that after he was given the food that he had ordered, he noticed that some of the food that he

ordered was missing from the bag. LEWIS then drove back through the drive-thru to the drive-thru window and told the worker who was identified as JONES that food was missing from his bag. JONES then began giving LEWIS attitude. JONES then threw the bag of food back at LEWIS which caused the food to spill all over LEWIS. LEWIS then felt disrespected by JONES so LEWIS exited his vehicle and started yelling at JONES. LEWIS stated that his brother, PRIMER, then strike the drive-thru window which caused the glass to crack. LEWIS stated that JONES then came out of the drive-thru window and pointed a "big gun" at LEWIS. JONES then shoved the firearm into LEWIS' neck. LEWIS was checked out by Curtis 316 and stated that his mother would take him to the hospital to get checked out at a later time. I and P.O. MARTIN observed a small superficial laceration to the left side of LEWIS' neck just below his ear. P.O. MARTIN also observed a circle mark which is consistent with the tip of a barrel of a long gun.

It was determined that PRIMER had caused approximately \$2600 worth of damage to the McDonalds restaurant and was arrested on scene. JONES was determined to have pointed a firearm at and struck LEWIS with a firearm. JONES was arrested on scene. JONES and PRIMER were conveyed to the District Two Station for booking and processing.

P.O. MARTIN and I retrieved the shotgun which was located inside of a garbage bin inside of the women's bathroom. The shotgun is identified as a Black Mossberg Master Mag 12 Gauge pump-action Shotgun model CC660 bearing Ser#J007745. We measured the barrel of the shotgun which measured 16.25inches in length. The shotgun was found to be shorter than 18inches in length. The shotgun had one 12 gauge shell inside the chamber and 3 12 gauge shotgun shells inside of the magazine tube.

While booking PRIMER in I observed abrasions on PRIMER's right knuckles which are consistent with punching a hard surface.

PV-17 was issued. I conducted CST which consisted of the damage to the McDonalds, injuries to PRIMER's knuckles and the recovered shotgun. I took 35 digital photographs at approximately 3:55AM. I have attached the photographs to this report. I was assisted by Squad 1927 (Forensic Investigator Angela GONZALEZ) to retrieve video of the incident.

P.O. MARTIN placed the shotgun on inventory under inventory#21006538.

It should be noted all the employee's that were working during this incident were very cooperative with Officer's and assisted us in retrieving video footage for this incident.

You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.
