INITIAL INVESTIGATION

This report was submitted by Police Officer Austin GRABOWSKI. I am currently assigned to District Four, Late Shift, Squad 4320, with P.O. Alfred HERRMANN.

On Sunday, December 5, 2021, at approximately 7:22am, P.O. HERRMANN and I were dispatched to 9091 N 76th St regarding a "property damage" complaint. This address is located in the City and County of Milwaukee WI.

Upon arrival, P.O. HERRMANN and I spoke to the caller (Laurie A. DONNELL, w/f, 8-11-62) who is the manager. DONNELL stated a black male, 5'03", light build wearing a red winter hat and a black jacket came into the store on Sunday, December 5, 2021, at approximately 7:15am and started saying he's crazy and knocked over the ice machine off the counter. DONNELL stated she told the unknown male that he needed to leave. DONNELL stated at this time he knocked over the coffee machine and started pushing the computer monitors over the counter and started throwing random items in the store. DONNELL stated the credit card reader had its cords pulled out as well.

DONNELL stated the unknown male left the store and she locked both doors and the unknown male fled the scene in an unknown direction.

DONNELL stated the ice machine is worth approximately \$1000 dollars and the coffee machine is work approximately \$1500 dollars. DONNELL stated the monitor is about \$300 dollars. DONNELL stated about another \$2000 in other misc. items. DONNELL stated the credit card reader is approximately \$2000 dollars. DONNELL stated approximately \$6800 dollars in all damage

DONNELL stated they are self insured.

P.O. HERRMANN and I spoke to the other two employees on scene (Jody L. CARROLL w/f, 11-33-77) and (Kendrea O. LAYAYETTE b/f, 8-18-99). CARROLL stated the unknown black male stated he was depressed and no one loves him and started knocking items off the counter and at that time DONNELL told the unknown male he had to go. CARROLL stated the unknown male also took the fire extinguisher off the wall and tried to use it before he started knocking more stuff off the counter tops with it. LAYAYETTE stated an unknown black male started knocking items off the counter and started throwing items throughout the store.

DONNELL was issued a PV-17.

The hearing before the Licenses Committee will take place virtually on 01/25/2022 at 02:00 PM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
