Per MCO 85-2.7-4, probative evidence concerning whether or not a new license should be granted may be presented on the following subjects: whether or not the applicant meets the municipal requirements, the appropriateness of the location and premises where the licensed premises is to be located and whether use of the premises for the purposes or activities permitted by the license would tend to facilitate a public or private nuisance or create undesirable neighborhood problems such as disorderly patrons, unreasonably loud noise, litter, and excessive traffic and parking congestion. Probative evidence relating to these matters may be taken from the plan of operation submitted with the license application, if any, but shall not include the content of any music. Evidence regarding the fitness of the location of the premises to be maintained as the principal place of business, including but not limited to whether there is an overconcentration of businesses of the type for which the license is sought; whether the proposal is consistent with any pertinent neighborhood business or development plans, or the location's proximity to areas where children are typically present. The applicant's record in operating similarly licensed premises; and whether or not the applicant has been charged with or convicted of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the activity to be permitted by the license being applied for or any other factor which reasonably relates to the public health, safety or welfare may also be considered. This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 09/27/2018 at 12:15pm officers, along with Agent William GRAY from the WI Department of Revenue, conducted a license premise check at 6901 W. Brown Deer Rd. The officer found the sole employee, Cheree PERRYMAN, in the kitchen area. The officers observed the establishments licenses were not posted and found several items for smoking Hookah. The officers observed several open containers of liquor with a large funnel next to them. They also observed several boxes of liquor with labels from Express Liquor Store. The applicant arrived on scene and stated she has not displayed he licenses. Her son, Larry WILLIAMS, could not find invoices for the liquor and stated he has bought liquor from the store on occasion because the distributor was closed or has a poor selection. He stated he did not know this was illegal. The officers seized 271 bottles of liquor and a package of hookah tobacco. The applicant was issued citations for not having a bartender on the premise and failure to display licenses.

2. On 06/27/2020 at 1:44am officers were dispatched to 6901 W. Brown Deer Rd for a possible shots fired complaint. The officer met Brown Deer Police, who had been dispatched to Wal-Mart at 6300 W. Brown Deer Rd. When they arrived at Wal-Mart, witnesses stated there was a shooting at Retox Martini Lounge. Brown Deer Police responded to that location and observed numerous cars fleeing the parking lot. They spoke with the bartender, who stated there was no problem and they would need a warrant to look around. Milwaukee Police Department officers searched the parking lot and found 11 casings. The officers spoke with a citizen, who stated her nephew was shot in the leg but they were unable to locate a victim.

- 3. On 07/10/2020 a meeting was held at District Four regarding the shooting at Retox on 06/27/2020. The officer asked the applicant why the officers were denied entry. The applicant's son, Larry WILLIAMS, stated he did not deny Milwaukee Police Department access but did tell the Brown Deer Police that they did not have jurisdiction. WILLIAMS stated they have ID Scanners, wands, and security. He stated the cameras are not working because of water damage. The applicant stated she will work with the police because she wants a safe establishment. She stated she would invest in parking lot security and have the cameras fixed soon.
- 4. On 10/30/2020 at 9:21pm officers conducted a license premise check at Retox Martini Lounge, 6901 W. Brown Deer Rd. The officers observed security staff patrolling the parking lot as well as the interior of the building. They spoke with the manager, Larry WILLIAMS, who presented his plan that was approved by the Health Department for safe operation. He stated the dance floor would be closed off and all patrons wearing masks. At 1:26am the officers returned and saw security in the parking lot directing traffic to assist vehicles exiting in a timely manner. The officers did not observe any violations.
- 5. On 11/30/2020 at 12:53am officers were dispatched to a shots fired at 6901 W. Brown Deer Rd. The officers spoke with Larry WILLIAMs, who stated he is the owner's son. He stated there was a fight in the main bar area but no shots were fired. He stated it's hard to pull up the security footage so he would only show the officers the video if they found casings. The officers spoke with a caller, who stated she heard 7-8 shots but was not sure if they were inside or outside. The officers did not locate any victims or evidence of shots fired.
- 6. On 12/20/2020 at 1:27am officers were dispatched to Retox Martini Lounge, 6901 W. Brown Deer Rd for a Call for Police. The officers observed several groups of people fighting in the parking lot. The officers were able to break up the fights. The officers and security were able to eventually clear the parking lot. The manager was on scene and cooperative.
- 7. On 12/30/2020 at 7:41pm officers conducted a license premise check at Retox Martini Lounge, 6901 W. Brown Deer Rd. The officers spoke with Larry WILLIAMS, who is operating the bar. The officer stated he wanted to speak with security about the procedures they are using at the business. WILLIAMS stated he was hiring a new company and he would rotate the guards to different spots to prevent them from becoming comfortable in one spot. He also stated he has ordered a new camera system. He stated there have been incidents in the parking lot and across the street at Aldi and Wal-Mart, but not inside his business. WILLIAMS also stated that he has security in the parking lot, which has helped keep car break-ins down. He also believes his business is being blamed for issues in the surrounding area.

8. On 01/02/2021 at 2:06am officers were dispatched to an Active shooter at Retox Martini Lounge, 6901 W. Brown Deer Rd. The officers cleared the business but found no evidence of an active shooter or any shots being fired. The officers spoke with Larry WILLIAMs, who stated he is the owner's son. He said there were no shots fired and thinks someone called from the parking lot.

9. On 01/22/21 a Milwaukee Police squad was sent to monitor the address of 6901 W. Brown Deer Road because they did not have a valid Class B Tavern License. The establishment was check throughout the night and was not open for business.

- 10. On 05/21/21 at 7:39pm, Milwaukee Police were tasked to monitor the tavern located at 5901 W. Brown Deer Road because they were not allowed to operate after 8:00pm per their Class B Tavern License. The business appeared to be in compliance with the closing time.
- 11. On 09/03/21 at 8:01pm, Milwaukee Police conducted a license premise check at 5901 W. Brown Deer Road because they were not allowed to operate after 8:00pm per their Class B Tavern License. The business appeared to be in compliance with the closing time.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 01/25/2022 at 02:10 PM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
