This report is written by Police officer Corstan D. COURT, assigned to the License Investigation Unit, Day Shift.

The Milwaukee Police Department's investigation regarding this application revealed the following:

The applicant, LARISSA MC CLAIN, was the licensee of a Class B premises, John's Tap, at 1635 West Wright Street, from 1987 to 1995. Following is her tavern incident and violation record at that premises.

- 1) On 1-8-91, at the Class B premises, John's Tap, 1635 W Wright Street, officers observed a male standing in front of the tavern. When the male saw the squad he ran into the tavern. A check of the tavern resulted in the arrest of three males. All were found with weapons (pistols) on their person and were charged with Carrying Concealed Weapons (guns).
- 2) On 9-11-92, officers conducted a routine check at the tavern, 1635 W Wright Street. They found the front door dead bolted shut. After announcing themselves, the door was unlocked so they could enter, and about 20-30 patrons left. 98 patrons remained on the premises. The capacity is 25 persons. Officers investigation revealed that a 20 year old person was on the premises, with a parent or guardian and the only person on duty in the tavern was an unlicensed bartender.

3) On 4-8-93, officers responded to a report of a shooting at the tavern 1635 W Wright Street. On arrival they determined that a person was shot in the right leg, outside the tavern, and went into the tavern for help.

On 3-13-94, officers responded to a report of underage person on the tavern premises, 1635 West Wright Street. They found a number of underage persons, 7 citations issued for Underage Persons on class B premises. The licensee on the premises told the officers it was the policy of the tavern to admit patrons who appear to be 21 years old. A security guard was at the front door who told officers he "goes by looks", and cards those he feels are underage based on their appearance.

5) On 5-22-94, officers were sent to a report of a fight at the licensed premises, 1635 West Center Street. On arrival they found 2 victims of a cutting. A person sustained a laceration to the forehead, left cheek, and triceps, requiring a total of 19 stitches. A security guard who observed the fight, tried to break it up, and sustained a stab wound to his right triceps. The suspect

fled the scene.

On 6-11-94, officers conducted a tavern check at the premises 1635 West Wright Street, 2:35AM. They looked through the door window and observed 2 bartenders and approximately 20 patrons, but the door was locked. Officers

knocked loudly at the door, and were finally admitted by a security guard, after about a minute. Neither of the bartenders had an explanation for why the door was locked during business hours.

On 12-14-94 LARISSA MC CLAIN filed an application to transfer the Class B license from 1635 West Wright Street to 2678 North 5th Street. During the Utilities and Licenses Committee hearing of February 21, 1995, the transfer application of Larissa Mc Clain was held because of a concern that her "fiancé" might become involved in the operation. A letter was received at the License investigation Unit from Attorney Raymond M Dall'Osto, dated 1-26-95, which states that the applicant's "roommate", Henry Sharkey, is not connected with the licensed tavern business to be operated by Larissa, and had no ownership or investment interest in the business. The application again came before the U & L Committee on 3-14-95, and was Denied, based on "Police Objection". City Tax Assessor's Office records indicate Henry Sharkey purchased this premises 5-1-99.

7) On 4-26-2000, Larissa again filed an application for a Class B Tavern license, for the premises 2678 North 5th Street. Along with the application, the subject filed the required Auxiliary Questionnaire. Question #2 of that form asks the question, "Have you ever been convicted of any felony or misdemeanor (other than traffic) for violation of any federal laws, any Wisconsin laws, any laws of any other states or ordinances of any municipality?" The question was answered with a check in the "No" box. The applicant signed this form, and swore before a Notary Public as to its truthfulness and accuracy.

Based on the 5 convictions listed above for violations of tavern ordinances on 9-11-92, and 3-13-94, the No answer on this Auxiliary Questionnaire was a false statement to an affidavit.

Charge: Truth of Statements and Affidavits (Falsifying) Finding: review date: Court date: sentence: date case: citation:

When she was interviewed, Larissa said she has lived at the same address, 3111A North 34th Street, for 15 years. The owner of the building, Henry Sharkey, dob: 7-15-34, apparently lives with her at that address. He gave the same address on his first application for Class D Bartender license 4-6-94, and has given the same address each time he renewed his license, including the last time, 11-9-98. That bartender license is still valid.

Henry Sharkey has the following conviction record.

1) On 7-24-86, during the early morning hours, a witness observed Henry Sharkey pushing another person out the door of a tavern at 1635 West Wright Street. He was the licensee of the premises at the time. Then the witness saw the subject pull out a handgun and the other person turned and ran into an alley on the north side of 2459 North 17th Street. The witness then observed the subject point the handgun into the alley and fire in the direction of the other person. The other person was then observed to run into a field adjacent to the alley where he fell.

Police officer responding to a shooting in the vicinity of 2459 North 17th Street observed the other person lying in the field and observed that he was deceased.

NOTE: Larissa McClain applied for a

Class B Tavern license for a transfer of a license to 2678 N 5<sup>th</sup> Street on 12-14-94. When it was brought to the attention of the License Investigation Unit, in a letter dated 2-23-95,

was brought to the attention of the License investigation only, in a lottor attent of Henry from then Alderwoman Annette Sherbert, about the concern of the involvement of Henry Sharkey in the business. Henry Sharkey was the owner of the building that this license was being applied for, and was living at the same address as the applicant, at that time.

That license was Denied 3-14-95, by the Common Council, based on the information in the Police Report concerning the investigation of that application.

Subsequent to the Denial of that license, the premises was licensed by Edward Moreland, dob: 10-16-1944, from 1996 until the present. The records of the License Division from 2000 to the present reveals that Larissa McClain held a Class B Manager license for this premises up to the present time, and therefore involved in the operation of the business, even thought she was Denied the license for the premises in 1995.

The most recent information available shows that Henry Sharkey is still the owner of this premises, and his most recent bartender license application, applied for 10-25-02, and still valid, gives his latest address as 3111A North 34<sup>th</sup> Street, the same as the applicant.

8. On 02/24/07 at 1:00 am, Milwaukee police conducted a Tavern check at 2678 N 5<sup>th</sup> Street. Investigation revealed a patron was in possession of a firearm and subsequently arrested. When officers spoke to the manager/bartender, Henry Sharkey, he stated he usually has three security guards at the door to check ID's and do pat downs of customers. Sharkey further stated they don't pat down females because he has only male guards. Sharkey stated to police " I guess they missed one." In regards to gun found on a male patron. Officers also found an underage person inside the bar and cited him for presence of underage. The patron found with the gun was arrested and charged with Felon In Possession of Firearm.

9. On 03/13/07 at 10:59 pm, Milwaukee police responded to a shooting complaint at 2678 N 5<sup>th</sup> Street. Investigation revealed three male subjects tried to gain entry into Ed's Lounge and was denied by security due to their intoxication and loudness. These three subjects attempted for force themselves in and security physically removed them and locked the entrance door to prevent them from gaining entry. Moments later shots were

fired with the class front window shattering and shots being fired into the tavern. One patron, who was inside, was shot in the leg. Two others received injuries from flying glass. All suspects then fled the scene. Officers found many casings in front and to the west of the tavern with broken glass and blood inside the tavern.

10. On 06/03/07 at 3:15 am, Milwaukee police were dispatched to Columbia Hospital for a Battery complaint. Investigation revealed the victim was a patron at Ed's Lounge and while she was dancing with a guy, six unknown females jumped on her. The victim was treated for contusions to her head. Officers conducted follow up Ed's Lounge and interviewed the bartender, Johnnie Coleman, who stated he wasn't aware of any incidents that occurred during the night.

11. On 10/28/07 at 1:21 am, Milwaukee police were dispatched to Sinai Hospital to investigate a Shooting complaint. Officers spoke to the victim who stated he was inside Ed's bar located at 5<sup>th</sup> and Center and was involved in an argument. The victim further stated that numerous people were arguing and fighting inside the tavern with people being shoved out of the tavern. The victim stated he was walking across the street to the parking lot when he was approached by a male with a gun. The victim stated he charged at the suspect and that the suspect fired one shot striking him in the left forearm. Police attempted to make contact with the manager and/or licensee from Ed's Lounge but it was closed. Reports were filed.

12. On 04/18/10 at 9:30 am, Milwaukee police while on patrol observed three subjects on the street with open intoxicants. Police conducted field interviews and all three subjects stated they purchased the alcohol from Ed's Lounge and had to pay extra to have the bartender open the item purchased in order for them to exit the establishment. They further stated that if they wished to stay inside to drink the alcohol, it would have cost them less money. Officers then conducted a license premise check at 2678 N 5<sup>th</sup> Street and spoke with the bartender Hosie Kimbrough who stated he doesn't open any top of anything after 8:00 am. Officers tried to contact the licensee regarding this incident but were not able to reach her. Kimbrough was cited for Special Page 7 Mc Clain, Larissa L

13. On 07/01/10 at 12:10 pm, Milwaukee police conducted field interviews on three subjects who were standing in the lot of Ed's Lounge but upon seeing police, walked into the bar. Officers' investigation found the person bartending, Dovetta Rogers, was not licensed and continued to serve patrons after officers advised her to stop. Two subjects were arrested on warrants and an injunction violation. During the investigation,

the licensee Larissa Mc Clain arrived and she was advised of the incident and cited for Class B Licensee's Responsibility. Rogers was cited for Class D Operator's Liquor License.

- 14. On 07/04/11 at 5:55 am, Milwaukee police were dispatched to 2678 N 5<sup>th</sup> Street for an Entry complaint. Investigation revealed that an entry did occur with a brick being thrown at a door, which shattered the glass. Missing was money from a gaming machine, but unknown to the owner how much was taken. There was video surveillance that captured the incident on tape. A report was filed.
- 15. On 10/25/11 at 1:00 am, Milwaukee police were dispatched to a Shooting at 5th and Center streets. Investigation revealed that a shooting took place in a parking lot across from the bar. A witness stated to police that the victim tried to re-enter the bar after he was shot. Police interviewed Larissa McClain and asked if she or any other employee called for police when the shooting occurred with McClain stating no because police arrived shortly after the shooting occurred. McClain stated she was unaware that the victim was previously in the bar and that there were no disturbances inside her bar that evening. Police spoke with security guard Milton Boyd. Boyd stated that the victim left the bar with a girl and that there were no issues. Boyd stated the victim returned to the bar and when he was patted down, the Boyd noticed the victim was bleeding from his arm. Boyd stated he then ordered the victim to leave and the victim left without incident. Boyd stated he didn't call police because numerous people outside were yelling, "call police" and figured someone had already done so. On 10/19/11, McClain did meet with District 5 personnel to discuss recent trouble the bar was experiencing around her establishment.

16. On 04/18/2019 at 8:47pm officers investigated a homicide at 2660 N. 5<sup>th</sup> St. The officers found a blood trail that may have led to Ed's Lounge, 2678 N. 5<sup>th</sup> St. The officers when to Ed's Lounge and spoke with security and a bartender.

They stated there was a subject in the bar that brought a bottle of liquor into the tavern and was asked to leave. The subject got into an argument with a female just prior to being escorted out. When the subject was outside he was yelling at the bartender stating he was going to come back later, while grabbing his waistband, acting as if he had a gun. The subject then walked off and was not seen again. The bartender could not access the video and he contacted the applicant who arrived on scene and provided the officer with video of the incident. The officers spoke with the applicant about security patting down patrons to see if they had guns. The applicant stated security normally does pat downs but the guard on tonight was new and she would go over procedures with him again.

17. On 04/24/21 at 9:41pm, Milwaukee Police took a report of a theft which occurred at 2678 N. 5<sup>th</sup> Street. Video Surveillance revealed that the victim left her keys and phone on the bar and went to play pool. When her back was turned, the suspect intentionally took her keys. Another suspect assisted in the incident. The bartended was able to identify the one of the suspects as a regular who frequents the establishment.

This license premise report is written by PO David LETTEER, assigned to District 5, Late Power Shift, Squad 5468 Tavern Squad, with PO Russell MACRAE.

On 04-24-21 at 9:41 p.m., we were requested to conduct follow up at Ed's Lounge, located at 2678 N. 5th St., in regards to reviewing video regarding a theft that had occured at the bar.

Upon arrival we made contact with the bartender, Hughie SIMPSON, who allowed us to review the bar video. While at the bar, SIMPSON made contact with the agent SHARKEY and informed her that the police were present and wanted to review the video. We instructed SIMPSON that we would also be filing this report.

As we were reviewing the video, SIMPSON stated he knew the person who had committed the theft as either "Mooney" or "Monk". SIMPSON stated he is a regular at the bar and that he was intoxicated. SIMPSON stated that "Monk" or "Mooney" if he took the keys, that it was an accident. SIMPSON attempted to contact a female that is with "Monk" or "Mooney" at times at the bar and attempted to contact the female, in order to help get the keys back. SIMPSON could not get a hold of the female, who he identified as Tanya, but left her a message about this incident, so that the keys could be returned.

SIMPSON does have a valid Class D Operator's license (232926), which is set to expire 12-31-21.

The following are the observations were observed with accurate time stamps from the cameras:

17:41hrs - Victim arrives at tavern at sits at table in NE corner of bar and puts large-set of keys on table

17:53hrs - Victim is given a beer from Suspect #2

18:00hrs - Victim begins to play pool.

18:03hrs - Victim leaves cell phone on table next to keys

18:15hrs - Victim's phone rings and lights up on camera

18:24hrs - Suspect #2 / Suspect #1 talk together and their attention is directed towards

keys on the table. Suspect #2 appears to watch / wait for Victim's back to be turn while playing pool. Suspect #2 then appears to direct Suspect #1 that Victim's back is turned. Suspect #1 then takes keys off of table with right-hand. Suspect #1 then sits down near table and continues to watch Victim and Suspect #2 play pool.

18:28hrs - Suspect #1 stands up and begins to say goodbye to other patrons prior to walking out front door.

18:29hrs - Suspect #1 walks across N 5th Street to the parking lot of Center Street Liquor located at 509 W Center Street. Suspect #1 gets into an older blue Toyota 4-Runner (unreadable front plate).

18:30hrs - Suspect #1 drives out of parking lot and west on W Center Street.

18:31hrs - Suspect #2 begins to "assist" Victim in searching for keys

18:41hrs - Suspect #2 leaves tavern on foot in unknown direction.

The hearing before the Licenses Committee will take place virtually on 01/25/2022 at 01:15 PM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
