There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 10/22/2021 at 7:46pm officers were dispatched to a Subject with Gun at Wingstop, 7335 W. Good Hope Rd. The officers spoke with the victim, who stated an employee of the restaurant pointed a gun at him while threatening to shoot him. The officers arrested the employee but did not locate a firearm. On 10/29/2021 the officers went to the store to view video of the incident. The video showed the customer in an argument with the victim. The employee is seen with a gun in his hand but did not appear to point it at the victim. The staff was cooperative with the investigation.

#### Narrative (1)

INITIAL INVESTIGATION Rainey, Damian A 029456

10/22/2021

This report is written by P.O. Damian RAINEY, assigned to District Four, Early Power Shift.

On Friday, October 22, 2021 at approximately 7:46 PM, squad 4420 (P.O. Leon WOODS and I) responded to a Subject with Gun complaint at the address of 7335 W Good Hope Rd (WINGSTOP), located in the City and County of Milwaukee. Upon arrival I spoke with Charles HARRIS (b/m 8/23/88), who stated while inside of the above business waiting for his food, a worker by the name of Patrick D. SEAMSTER (b/m 11/23/95), pulled a black firearm off the right side of his waist and pointed it at him stating, "You better get the fuck out my store before I shoot you!" He stated he then exited and called for police because he feared for his safety. SEAMSTER was located on scene, the firearm was not located on scene.

SEAMSTER was then taken into custody by squad 4420 then conveyed to District Four, for booking and processing.

During this investigation all staff members were cooperative with my investigation.

The business has its Food Dealer License 15566-262, which expires on 3/7/22.

The legal name for the business is Good Hope Wings INC.

The license agent is Asif RAJABALI (i/m12/8/67).

On Friday, October 29, 2021 I conducted follow up at Wingstop and spoke with Sonya HUGHS (b/f 6/16/80), who stated she is the District Manager of the business. She stated her cell phone number is 4144919276. She stated she was aware of the incident and stated her boss already downloaded the footage and sent it to her. While on scene I viewed the footage which showed the verbal altercation between HARRIS and the manager Wanda J. LAVENDER (b/f 8/22/81). During the altercation SEAMSTER approached the front counter and presented his firearm and charged his weapon. SEAMSTER then began to tell HARRIS multiple times, "Get the fuck out of her nigga!" SEAMSTER and HARRIS had a brief argument then SEAMSTER walked back to the rear of the store. In the video it did not show that SEAMSTER pointed his firearm at HARRIS. On scene SEAMSTER also told officers that he did not pull his firearm out during this argument.

Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
