The Milwaukee Police Department's investigation regarding this application revealed the following:

- 2. On 11/30/2018, at 8:54pm, officers conducted a license premise check at 340 W Reservoir Ave. The business Lounge 340, was closed at the time of the check.
- 3. On 02/28/2019, 10:18pm, officers investigated a noise complaint at 340 W Reservoir Ave, Lounge 340. The caller did not want to be a complainant, but wanted officers to speak with the business. The caller was concerned because the location wasn't supposed to open until March 1, 2019. Officers arrived at the business and spoke to the agent and manager. The agent informed officers they were conducting a soft opening. The agent stated she didn't want to be known as a bar that causes problems and wanted to work with police. She further stated this was her first bar and wanted to know if they made any mistakes so they could correct the

problems. The officers provided them with their contact information in case they had further questions. No violations were observed.

4. On 04/27/2019 at 11:46pm officers were dispatched to 340 Lounge, 340 W. Reservoir Av, for a Noise Nuisance. The caller stated he could hear music coming from the bar across the street while he was inside his residence. The caller stated his windows were shaking and he would be a complainant for a citation. The officers spoke with Kamesha LEWIS at the bar. She stated she had an ongoing problem with the caller. The officers advised a citation would be issued. On 05/02/2019 the officers went to the bar to issue the citation. They parked down the street and could hear music coming from bar and observed numerous parking violations. They spoke with security about having the autos moved, and security agreed to have the issues resolved. The officers spoke with the applicant about the music and advised her the caller would continue to call if the problem was not resolved.

She stated this has happened before and she would like a citation issued. The officers could hear loud bass coming from the bar from more than 50 feet away. The officers entered the bar and noticed a DJ in the corner. He stated he started at 9:00pm and was playing inside the tavern. The officers spoke with the applicant, who was on scene. The applicant stated she would turn down the music and requested a warning. The officer advised a citation would be issued for Noise Nuisance.

# INITIAL INVESTIGATION

Letteer, David J 016078

This license premise report is written by PO David LETTEER, assigned to District 5, Late Power Shift, Sq. 5468 with PO Russell MACRAE.

On 01-30-21 at 11:35 p.m., we were dispatched to the location of 340 W. Reservoir Ave., 340 Lounge, which is a licensed tavern in the city of Milwaukee.

The CAD read that there was loud music coming from the above location and that the caller was willing to be a complainant.

PO MACRAE and I contacted the caller, who stated she and her husband live across the street from the bar and that at about 8:30 p.m. when they began hearing the music from the bar, while in their bedroom, while attempting to go to sleep. The caller stated a movie was watched around that time, but they could still hear the music from the bar. The call to the police was made when they could not later fall asleep.

While speaking with the caller, I was informed that a citation needed to be issued for the noise violation. I asked the caller if the noise that was heard was the music or the bass from the music. I was informed that it was the bass. I asked the caller if their bedroom windows were open or closed and I was informed they were closed, the bedroom does face the direction of the bar. I was then informed that even while watching the movie, the bass could be heard. The caller stated that they have not been home recently and have not been calling in regards to the bar, but they were home and the bass from the bar was bothering them. The caller stated an attempt to contact the agent of the bar, Partrice DICKERSON was made, in order to inquire about the bass, but the phone number the caller had was not a good number. I informed the caller that we would investigate the noise and get back to them.

PO MACRAE and I drove into an alley just east of the bar and stopped our car and turned it off, with the

windows down. We could hear the bass from the music a half of a block away. The music did get louder when the door opened, but then went down when the door closed. The front door only opened with people were leaving, or coming into the bar.

PO MACRAE and I went into the bar and were met by DICKERSON. I spoke to DICKERSON privately and informed her on why we were there and that the caller wanted a citation issued. DICKERSON stated that she would turn the music down and she asked if I could call the caller and work this incident out with them, so that a citation would not be issued. I informed DICKERSON I would contact the caller and speak to them. DICKERSON was informed that the number that the neighbor called was not in service and asked her for her new number (414-737-2363). DICKERSON stated that we could give the neighbor her new number, so that anything else can be avoided. The bar did have working security at the door and 8 patrons inside of the bar, along with DICKERSON and the bartender Jonathan GLASS (b/m 01-27-56) who does have a valid Class D Operators license (233766), which is set to expire 12-31-21).

PO MACRAE observed that a DJ was set up to play music and spoke to the DJ, Donnell C. CLAIR (b/m 08-17-66) who stated he started began working at the bar at 9:00 p.m. and was playing music inside of the bar.

I checked the posted licenses and found that the bar has a valid Class B license (207955), which is active, but pending a renewal. I also found that the license of the bar is set to expire on 02-19-21 and the tavern is set to serve a 10 day suspension, prior to having their renewal granted.

I then contacted the caller and informed the caller that DICKERSON was asking that a citation not be issued. I also gave the caller DICKERSON's new phone number. The caller stated due to not being able to call DICKERSON, the number being not a working number, as well as the fact of the license meeting on 01 -26-21 with the 10 day suspension, along with other items discussed in the meeting, that they felt a citation for the noise was appropriate.

It should be noted that the distance between the bar and the callers residence is greater than 50 feet, with residences to the south and a church to the north of the bar.

I issued a citation on behalf of the caller for Excessive Noise Violation.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.
