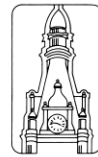

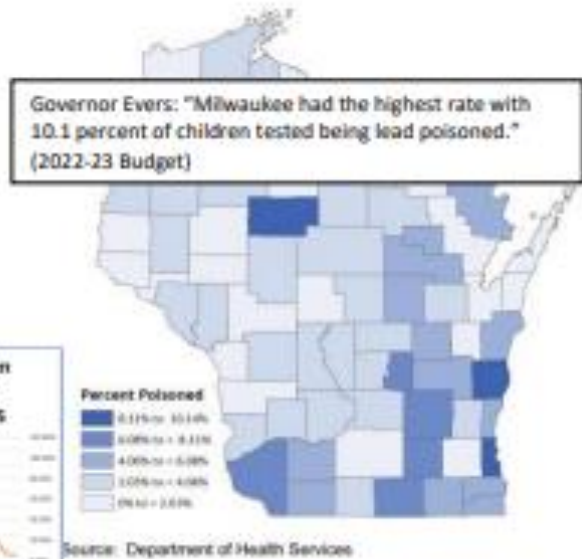

MOU: Sister Cities: Zadar, Croatia – Milwaukee, WI, USA Water Health/Student Cohort Science Initiative

April 22, 2021

Dear Dr. Posley,

The purpose of the Bilingual Water Health/Student Cohort Science Initiative is to introduce international students to hard-to-solve problems, such as the “soup of metals and microbes” in our drinking water at the tap, which appears concentrated at the older parts of the city. In Milwaukee and Zadar, Middle School students would employ investigative STEM methods and simple sensors to diagnose the level of toxicity and generate practical solutions.

WHEREAS

- Both parties want to encourage healthy living
- Both parties want to encourage international cooperation
- Both parties want to encourage student science/STEM participation
- Both parties want to encourage communication via ZOOM technology

WHEREAS

- Several Middle Schools have been identified in Milwaukee and Zadar and nearby Split who have expressed interest in participating in the student STEM programs
- The middle school Golda Meir in Milwaukee is a recognized name internationally and represents an age group that has a high potential for learning
- Students can take the experiment home (sensors, calibration standards, POU filter pitcher, NSF certified standards 42 and 53, notebooks, etc.) and share curriculum with family and neighbors (Table 1)

THEREFORE

- Offer the STEM curriculum to 50 student cohorts, 25 on each side of the Atlantic for 10 weeks beginning September 13, 2021 and ending November 19, 2021
- Hold first virtual ZOOM meeting Tuesday morning Sep. 14<sup>th</sup> 8:30 CST (14:30 GMT) to review concepts and testing protocols, bilingually
- Have ZOOM meetings Tuesday mornings Oct. 5 and Oct. 26 to share experiences
- Hold final virtual meetings Tuesday Nov. 9 and Nov. 16 for student presentations

- Work with the Advisory Council to provide clean water to all 72,000+ (seventy two thousand) homes with lead laterals by providing/installing Point-of-Use filtration, Reverse Osmosis, etc.

# AMERICAN RESCUE PLAN SUMMARY
