Thank you for this, Mike! I took a quick look at your comments and I agree, the highlighted area is much easier said than done. Like the Data Governance Policy, I wrote this at a very high level with the intent of dealing with the granular bits as I worked with specific departments. I think it's definitely something we need to discuss at the Data Governance Committee level after we get the SharePoint and Database surveys completed.

Re the retention labels—I'm not sure if they're available yet either but I do know that it is possible to assign records retention policy on an as-needed basis to specific libraries or folders. Having no confidence that people will do this themselves, though, I am hoping that ITMD will see fit to work with me to provide the off the shelf labels for retention use. I know for sure that I want to do retention through labels rather than through content types—I tried the latter when UWM was doing its own SharePoint rollout and it was an unmitigated disaster from a records retention standpoint.
