This report is typed by P.O. Jeanine See, assigned to CIB-Stolen Vehicle Unit.

On 05/07/2021, I received a call from Rita Harris. Rita told me her dad, Jimmy Harris bought her a vehicle, as a gift, because she recently had a baby, was in school and worked. The vehicle is a 2016 Kia Rio (Vin #KNADM4A31G6670232). Jimmy has been telling Rita, for months, he was going to buy her a vehicle. On 04/24/21, Jimmy called Rita and told her he was buying her a vehicle on 04/26/21. Jimmy was going to drop off the vehicle. Jimmy got a copy of Rita's drivers license, so he could register and title the vehicle in Rita's name. The vehicle was bought at Reo Motors, which is located in the City and County of Milwaukee, WI, at 2777 S 27th St.

On 04/24/21, Rita's grandfather drove the Kia to Rita's house. Jimmy followed the grandpa, to give him a

ride home. Grandpa gave Rita the paperwork and keys to the car. Rita did not go outside because her baby was awake and it was cold out. Paperwork included "Wisconsin Title & License Plate Application" (MV-1), which is the official Wisconsin Department of Transportation form for applying for registration and title for the vehicle and the "Motor Vehicle Purchase Contract" (MVPC). All the information on the MVPC and MV-1 was in Rita's name. Rita emailed me a copy of these documents.

Rita said that as she walked into her home, after receiving the vehicle, and Jimmy started calling and texting her. Jimmy first told Rita he did not want her driving the car, until he was was with her, to make sure she knew how to drive. This caused an argument between Rita and Jimmy. Jimmy then told Rita she was ungrateful (because she did not come outside to personally thank him) and he would never buy her anything again and he was angry.

Rita said after a few text and calls, she no longer responded to avoid further conflict.

Rita said the car started for two days. By 04/29/21, the vehicle would start, but shut off right away. Rita told her grandfather, who told Jimmy. On 05/01/21, Jimmy told Rita he would get a tow truck to pick up the vehicle and take the vehicle back to Reo to get fixed. On 05/03/21, the vehicle was towed, with Rita's permission.

On 05/04/21, Rita received the original title and registration in the mail from DOT.

On 05/04/21, Rita called Reo Motors. Reo told Rita they were fixing the vehicle. On 05/05/21, Rita called Reo. The owner of Reo, Salim Shelleh, told Rita that Jimmy "traded in" the vehicle as money toward the purchase of another vehicle. The other vehicle was a 2015 Dodge Challenger, VIN #2C3CDZBG6FH789392. Rita told Shelleh she had the title to the vehicle and she did not give Jimmy permission to trade-in her vehicle. Shelleh said she could have the Kia back for \$8,000.

It should be noted, Shelleh is the registered owner with WDFI.ORG and Bizpedia, and the registered agent with the City of Milwaukee License Division and Wisconsin Department of Transportation (who regulates the vehicles sales in the state of Wisconsin). Shelleh is responsible for all transactions, regarding all vehicles at his business.

Rita went to a Milwaukee Police Department and was told this was civil matter. Rita heard I dealt with some stolen vehicle investigations, so she called me.

On 05/07/21, I went to Reo. The Sales Manager, Saif Muhsen, was available. Muhsen put me on speaker phone with Shelleh. Muhsen was in the same room with me at Reo and heard the conversations between Shelleh and I. Shelleh told me Rita could buy the Kia for \$8,000. Shelleh told me Jimmy bought the vehicle for \$7,000. Shelleh because of the new mechanical damage (inferred that Rita caused), Rita would have to pay \$8,000. Muhsen gave me a copy of the paperwork regarding Jimmy trading in the Kia, in exchange for the Dodge. Paperwork included Motor Vehicle Purchase Contract, between Reo and Jimmy and a Reo Motor letterhead "Bill of Sale" of the Kia, for trade in for the Dodge, with Jimmy Harris as the listed Purchaser. These documents are dated for 05/04/21. Muhsen told me there was no other paperwork. Muhsen did not give me a copy of a the MV-1 because there this document was not on files, again evidence that Shelleh would not apply for title for Jimmy for the Dodge. The contract and business of the trade in for the Kia, in exchange and money towards the Dodge was conducted on 05/04/21.

Shelleh also told me he "never met Rita" and "I heard Rita give Jimmy permission to sign her name over speaker phone".

Shelleh also told me he would not title Jimmy's Dodge because (I knew there would be a civil lawsuit and I am not releasing any vehicle without more money").

I contacted Wisconsin Department of Transportation Nicholas Denk to ask what violations Shelleh may have committed. Denk told me Jimmy committed a Theft by Fraud.

I called Jimmy. Jimmy told me to fuck off and he was contacting his attorney.

On 05/04/21, Jimmy L Harris (Received), intentionally and without consent, defrauded the victim, Rita C Harris (Harris (Harris)), at 2777 S 27th St (Reo Motors), which is located in the City and County of Milwaukee, WI, when he used the value of property, a vehicle (Kia), in a transaction to obtain another vehicle, without the victim's consent, with the intent to permanently deprive the victim of her property. In the same transaction, the transaction, the owner and agent, who is the person solely responsible for Reo Motors, allowed the illegal transaction.

There is no denial that Rita wanted and requested Jimmy sign her name on the MV-1 and MVPC, however there is question as to weather or not Jimmy could legally sign Rita's name.

I checked Department of Transportation records. As of 05/13/21, the Kia is still registered to Rita. The Dodge is registered to Jimmy, but not titled, with a hold by Reo for "Full Payment Due".

I tried calling Simms. Rita told me she did not want Simms involved because Rita did not want Simms mad at her. I told Rita I was adding Simms to this report because he did drop off/give the vehicle and paperwork to her.

I attached a copy of all related paperwork to the upper left corner of this report under "Attach".

I entered a Suspect Alert for Jimmy.

I forwarded a copy of the reports to the District Attorneys office to review for charging.

On 05/07/2021, I received a call from Rita Harris. Rita told me her dad, Jimmy Harris bought her a vehicle, as a gift, because she recently had a baby, was in school and worked. The vehicle is a 2016 Kia Rio (Vin #KNADM4A31G6670232). Jimmy has been telling Rita, for months, he was going to buy her a vehicle. On 04/24/21, Jimmy called Rita and told her he was buying her a vehicle on 04/26/21. Jimmy was going to drop off the vehicle. Jimmy got a copy of Rita's drivers license, so he could register and title the vehicle in Rita's name. The vehicle was bought at Reo Motors, which is located in the City and County of Milwaukee, WI, at 2777 S 27th St.

Rita said the car started for two days. By 04/29/21, the vehicle would start, but shut off right away. Rita told her grandfather, who told Jimmy. On 05/01/21, Jimmy told Rita he would get a tow truck to pick up the vehicle and take the vehicle back to Reo to get fixed. On 05/03/21, the vehicle was towed, with Rita's permission.

On 05/04/21, Rita received the original title and registration in the mail from DOT.

On 05/04/21, Rita called Reo Motors. Reo told Rita they were fixing the vehicle. On 05/05/21, Rita called Reo. The owner of Reo, Salim Shelleh, told Rita that Jimmy "traded in" the vehicle as money toward the purchase of another vehicle. The other vehicle wAS a 2015 Dodge Challenger, VIN #2C3CDZBG6FH789392. Rita told Shelleh she had the title to the vehicle and she did not give Jimmy permission to trade-in her vehicle. Shelleh said she could have the Kia back for \$8,000.

It should be noted, Shelleh is the registered owner with WDFI.ORG and Bizpedia, and the registered agent with the City of Milwaukee License Division and Wisconsin Department of Transportation (who regulates the vehicles sales in the state of Wisconsin). Shelleh is responsible for all transactions, regarding all vehicles at his business.

On 05/07/21, I went to Reo. The Sales Manager, Saif Muhsen, was available. Muhsen put me on speaker phone with Shelleh. Muhsen was in the same room with me at Reo and heard the conversations

between Shelleh and I. Shelleh told me Rita could buy the Kia for \$8,000. Shelleh told me Jimmy bought the vehicle for \$7,000. Shelleh because of the new mechanical damage (inferred that Rita caused), Rita would have to pay \$8,000. Muhsen gave me a copy of the paperwork regarding Jimmy trading in the Kia, in exchange for the Dodge. Paperwork included Motor Vehicle Purchase Contract, between Reo and Jimmy and a Reo Motor letterhead "Bill of Sale" of the Kia, for trade in for the Dodge, with Jimmy Harris as the listed Purchaser. These documents are dated for 05/04/21. Muhsen told me there was no other paperwork. Muhsen did not give me a copy of a the MV-1 because there this document was not on files, again evidence that Shelleh would not apply for title for Jimmy for the Dodge. The contract and business of the trade in for the Kia, in exchange and money towards the Dodge was conducted on 05/04/21.

Daniel Fonseca is Reo's sales employee who sold the Kia to Jimmy.

Shelleh also told me he would not title Jimmy's Dodge because (I knew there would be a civil lawsuit and I am not releasing any vehicle without more money".

I contacted Wisconsin Department of Transportation Nicholas Denk to ask what violations Shelleh may have committed, which included the non registration of a vehicle for title and accepting the Kia from a person who did not own the vehicle.

I will be contacting the District Attorneys office to ask if they will issue charges for Shelleh. If not, I am considering issuing Shelleh a citation.
