Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 03/14/2020 officers were dispatched to a Stolen Vehicle Recovery at 3520 W. Mill Rd. The officers located a stolen vehicle on the lot. The manager was cooperative and provided the name of the towing company that scrapped the vehicle. The owner was able to recover her auto.

This report is written by P.O. William BILTY, assigned to District 4, Early Power Shift.

On 3/14/2020 I was assigned to squad 4235 with PO Benjamin ADE. We were dressed in our department issued Milwaukee Police Department uniforms with working AXON brand body worn cameras.

On 03/14/2020 we were dispatched to a call of stolen auto located at 3520 W Mill Road. The location is an auto salvage yard. Upon arrival we located a 4 Door Silver Ford Taurus that was reported stolen regarding this incident.

A manager for the location Joeseph W BURKS stated the vehicle was there for at least one week. BURKS stated the vehicle was dropped off by a Towing and Salvage company named "The Sams Towing and Salvage". BURKS stated he knows this company dropped off the vehicle because it had an orange section of spray paint on the front windshield. BURKS stated this indicates that the vehicle was dropped off by his company. BURKS stated there are often vehicles dropped off in their front lot by multiple salvage companies. P.O. ADE and I will follow up with the salvage company in the coming days when able to.

Squad 4227 (P.O. Shane DOUGHTY) later arrived on scene and processed the vehicle. See P.O. DOUGHTY's supplemental report regarding.

The vehicle's owner was the caller and advised officers she observed the vehicle in the lot while driving by the location earlier in the day. She stated she went through the vehicle briefly and found that the battery was missing. She later came back to the location with other subjects who installed a new battery. They later left with the vehicle.

BURKS was very helpful in the investigation and extremely cooperative.

I went over, in length, Chapter 93.

Obvious violations included: video only kept for 30 days, picture of customers identification card (not all transactions had the id card), picture of property bought, video or picture of vehicle that brought in metal/junked vehicles, incomplete Junked Vehicle Bill of Sale and title signatures.

It should be noted, Altar bought this business last year. The beginning of the this year a whole new management team took over.

The hearing before the Licenses Committee will take place virtually on 4/06/2022 at 10:50 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
