This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 02/15/2021 at 12:31pm officers were dispatched to a Theft of gun at Palmer Food Market, 200 E. Center St. the investigation revealed two subject entered the store. One subject distracted the clerk and the second subject went behind the counter and took a pistol from the shelf. The officers were able to recover video of the incident.

2. On 03/07/2021 officers conducted a license premise check at 200 E. Chambers St. The officers spoke with the manager, who signed a standing No Loitering complaint form. The officer provided the manager with a No Loitering sign to display outside.
 3. On 05/18/2021 at 1:14pm officers, along with Wisconsin Department of Revenue agents, conducted a license premise check at Chambers East Food Market, 200 E. Chambers St. The officers spoke with the clerk about invoices for tobacco and liquor. The clerk did not know where they were located but contacted the owner by phone. The owner stated the invoices were at his accountants. The Wisconsin Department of Revenue agent advised the owner to come to the business with the invoices. The clerk did not have a Class D operator's license. Wisconsin Department of Revenue agents removed six boxes of tobacco. The owner signed a standing no loitering complaint and was given a No Loitering sign.

4. On 05/31/2021 at 5:49pm, officers investigated a shooting at N. Palmer St. and E. Chambers St. During the investigation, the officers went to East Chambers Foods to check for video. The manger was cooperative and provided video of the incident to the officers.
5. On 09/19/2021 at 4:44pm, officers were dispatched to a Shooting at 200 E. Chambers St. The officers spoke with the clerks who stated they did not hear a shooting. The officers then located a bullet hole in the front door that went through an interior wall and a cooler door. The officers asked the clerks why they stated they lied and they stated they did not lie because they did not hear the gunshots.

This report is written by PO Dana REBRO assigned to District Five, Early Power Shift, Squad 5265.

On Tuesday, May 18, 2021 at 1:14pm Squad 5264 (PO HARRIS), ATF Agent GeorgeAnn King, and I conducted a License Premise check on East Chambers Food Market located at 200 E Chambers St. PO Nash and PO Young assisted with securing the building while we conducted the investigation. ATF Agent King spoke with the employee Smar Deep SING (W/M 12/26/90). He stated he started a week ago and doesn't know where the invoices are for the purchase of the tobacco and beer they were selling. Agent King requested Smar to call the owner to get clarification on the invoices for the merchandise. The owner stated that the invoices were at the accountant so he could do his taxes. Agent King gave the owner, later identified as Palwinderpal SING (w/m 1/09/91), 30 minutes to get to the store with the invoices.

While waiting for the owner we conducted an inspection with the Department of Neighborhood services. I located a large bucket of Double Bubble filled with change along with an open carton of Newports. There was a sign posted near the cash register with the following message:

Agent King looked over the licenses and asked if Smar had his bartending license. Smar stated he did not. Smar also stated no one else was on the premise that had a license to sell beer either. Agent King continued her investigation and was looking through the cigarette inventory. She located CharBoy and Love Roses glass pipes in a hidden area of the cigarette display. PO Harris located a visa credit card for a Jamal Russel behind the glass on the counter. Smar stated it was left behind last week and no one came back to claim it. PO Harris took it and placed it on safe keeping MPD Inv#21018078. An inquiry of the name revealed that Russel was a victim of a credit card fraud MPD IR 21107030.

The owner of the store Palwinderpal SING came to the store and had some invoices in his hand. Agent King confronted him regarding a re-printed invoice ticket date for 3/23/21 for tobacco from City Depot. The invoices were also not separated for cigars, tobacco, and beer sales. Agent King removed 6 boxes full of tobacco products from the store.

The owner filled out MPD's Standing complaint form 3/07/21 and was issued a District 5 no loitering/no trespassing sign (License Premise report 210660069). The sign was not posted at the time of inspection.

This report is written by PO Dana Rebro assigned to District Five, Early Power Shift, Squad 5265.

On Monday, May 31, 2021 I responded to the intersection of N Palmer St/ E Chambers St for a report of a shooting. When I arrived on scene I spoke with Palwinderpal SINGH (W/M 1/9/81) the manager of East Chambers Food Mart and requested access to their surveillance cameras. SINGH was able to provide me immediate access to the cameras. The camera video was decent quality. There was two exterior cameras that captured part of the incident. One camera showed the initial fight between two woman at the intersection of N Palmer St/ E Chambers St and it continuing southbound on N Palmer St. The second camera was facing eastbound on E Chambers St and captured the victim being shot. Detectives were able to recover the video on a flash drive with no issues.

SINGH was cooperative during the entire investigation and advised me about the on going issues with the neighborhood when it comes to loitering and violence. He stated he didn't witness the incident but heard multiple gun shots. He inspected his property and didn't see any damage from today's incident.

INITIAL INVESTIGATION

This report is written by Police Officer Austin DEITSCH assigned to District 5 Early Power Shift.

On Sunday September 9, 2021 at approximately 4:44PM, Squad 5290 (Myself) wearing full Milwaukee Police Department Uniform and operational body worn camera, was dispatched to 200 E Chambers St to investigate a shooting.

Upon arrival I canvassed the area and asked employees Deep SINGH (W/M,12/26/1990) and Palwinder SINGH (W/M,01/09/1981) if they heard any shooting in the area.

They stated they did not hear any shooting. While on scene they were asked again if they heard any shooting which they stated they did not.

After reviewing Chambers Food Market surveillance video which P SINGH and D. SINGH allowed me to view, a bullet strike was found in the front door of the convenience store.

When D. SINGH was asked about the bullet strikes he stated it was from the current shooting that we were on. D. SINGH then showed us a bullet strike that went through the wall in the back of the store and through a beverage cooler shattering the glass.

When D. SINGH asked why he said he never heard any shooting, D. SINGH stated the Police did not listen to what he said and that he did say he heard gunshots.

D. SINGH and P. SINGH while working at Chambers Food Market failed to report shots fired outside their store which had resulted in a victim shot.

D. SINGH and P. SINGH lied to Police regarding the shooting.

The area of E. CHAMBERS St and N Palmer St is a violent crime area known to have open drug dealing and armed subjects in the streets. 200 E Chambers St (Chambers Food Market) has a large group of subjects that loiter outside which results in multiple shootings and homicides.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 4/06/2022 at 1:45 PM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
