- Quarterly Project and Expenditure Reports
- Annual Recovery Plan Performance Report

Project & Expenditure Report: will report primarily on projects funded, expenditures, and contracts and subawards over \$50,000. Limited programmatic information needed.

Provide information on all ARPA projects:

- project name, project expenditure category, project description, obligations and expenditures, and status of completion
- identify which projects target impacted and disproportionately impacted communities and which specific population is targeted
- provide detailed obligation and expenditure information for any contracts and grants awarded, loans issues, and direct payments greater than \$50,000
- some programmatic information on projects in specific expenditure categories.

 outcomes, and any challenges or opportunities identified during the reporting period.
- Uses of Funds: detailed description of use of funds, including strategies to maximize
 programmatic impact and effective, efficient and equitable outcomes; explain how specific
 communities, populations or individuals are supported; describe how City is promoting the key
 goals of ARPA (public health; economic impacts; services to disproportionately impacted
 communities; premium pay; water, sewer & broadband infrastructure; revenue replacement).
- Promoting Equitable Outcomes: describe efforts to promote equitable outcomes, including how
 projects prioritize racial and economic equity, specific targets to equity results, strategies to
 achieve the targets, and qualitative and quantitative data showing progress against goals,
 describe geographic and demographic distribution of funding and whether it targets
 marginalized communities.
- Community Engagement: description of how the City's use of funds incorporates input that captures diverse feedback from constituents, community-based organizations, and communities.
- Labor Practices: describe workforce practices for infrastructure projects regarding strong labor standards and employment opportunities, including community benefits agreements, prevailing wage requirements, and local hiring.
- Use of Evidence: identify if any ARPA funds are used for evidence-based interventions or if projects are being evaluated through rigorous program evaluations.
- Table of Expenses by Expenditure Category: table listing funds expended within each Expenditure Category
- Project Inventory: List name and brief description of all ARPA projects.
- Performance Report: Key performance indicators for major ARPA projects. Performance
 indicators should include both output and outcome measures. Most measures are at the
 discretion of the City, but there are some required performance indicators and programmatic
 data.
