
Dear Mr. McClain:


We have received your claim in the amount of \$454.08, relating to damage to the front bumper of your vehicle that allegedly occurred during the tow process.

Our investigation reveals that your 2000 Mercury was towed to the City of Milwaukee Tow Lot on September 21, 2010 for being for sale on public property without a permit. The PT-27 Form that was completed prior to the towing of your vehicle noted the front bumper was cracked and loose. Since this damage appears to be pre-existing, the City cannot accept liability and we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
