This is in response to a request from the Menomonee Valley Partners and Sigma Corporation to install the above-captioned parking restrictions.

Our traffic engineering staff has investigated this request and found that motorists using the Sigma Corporations driveways have a difficult time seeing bicyclist on The Hank Aaron State Trail when vehicles park close to these driveways. Therefore, in the interest of public safety, we recommend installing these restrictions to increase sight visibility.
