The Milwaukee Police Department's investigation regarding this application revealed the following convictions:

12. On 03/16/17 at 2:14 am, Milwaukee police were dispatched to 1319 W North Avenue for an Indecent Exposure complaint. Police found the subject and he admitted to urinating on the floor of the business because the clerk would not allow him to use the bathroom. Officers spoke with the clerk, identified as Rajeev Garlapati, and Garlapati stated that he was not able to unlock the bathroom door and asked the subject to please use the restroom elsewhere. Garlapati stated that is when the subject urinated on the floor. A disorderly conduct ticket was issued to the subject.

13.On 08/22/2017 Milwaukee police were dispatched to a theft complaint at 1319 West North Avenue (Shell Food Mart). 15. On 04/29/18 at 2:49am, Milwaukee Police were dispatched to 1319 W. North Avenue for a theft complaint. Upon arrival, officers interviewed the caller/employee who stated that a subject took 2- 1 quart jugs of oil, without paying for them. Police checked the area, found the subject who admitted to taking the oil, and he was cited.

16. On 12/18/19 at 12:05pm, Milwaukee Police were dispatched to 1319 W. North Avenue for an armed robbery complaint. Investigation revealed that an armed robbery occurred on the property of a person that is not an employee of the filling station. The employees were cooperative with the police and provided surveillance footage of the incident.

- 17. On 03/03/20 at 1:39pm, Milwaukee Police were dispatched to 1319 W. North Av for a shot spotter complaint. Officers located casings near pump # 5. Officers spoke with the clerk who was cooperative with the investigation. The store clerk stated that he did not hear any shots fired and let officers review video of the incident. Officers were able to obtain suspect description and vehicle description from the video.
- 18. On 06/03/20 at 4:53am, Milwaukee Police were dispatched to a shot spotter complaint at 1319 W. North Ave. Officers spoke with the store clerk who stated that he initially did not hear any guns shots and only knows what happens inside the store. While officers were checking the parking lot for casings, they heard over the police radio a shooting assignment dispatched. The victim was in his 4dr black vehicle approximately a block away, from officer's current location. Officers re-interviewed the store clerk who stated that he did see a male dressed in all grey discharge a fire arm at the victim. The store clerk then assisted investigators by providing video footage from the business.
- 19. On 03/14/21 at 5:06am, Milwaukee Police were dispatched to a battery cutting complaint at 1319 W. North Ave. Officers outside the location located blood spatter, and a broken Hennessey bottle. Officers spoke with the store clerk who was cooperative and provided video footage from the business. Officers reviewed the video and observed that six suspects attacked the victim. After the incident all the suspects leave the area in a white Infinity Suv.

20. On 04/27/2021at 2:22am, Milwaukee Police were dispatched to 1319 W. North Avenue for a Shotspotter complaint. Investigation revealed that three male subjects engaged in an argument with a female while entering the establishment. One of the male subjects pointed a firearm at the female and she swats the gun away from her face and leaves in her vehicle. The three subjects enter their vehicle and follow the female, discharging their firearm at the female's vehicle while traveling east on W. North Avenue. The business was fully cooperative during the investigation.

- 21. On 06/10/21 at 2:11am, Milwaukee Police were dispatched to 1319 W. North Avenue for a Shotspotter complaint. Investigation reveals that a subject pulls into the filling station, exits his vehicle and discharges a firearm into the air. The subject then enters the store, talks with the attendant, then leaves the store. The subject then re-enters his vehicle, picks up three other subjects, and leaves.
- 22. On 08/27/21 at 2:51am, Milwaukee Police were dispatched to 1319 W. North Avenue for a Shotspotter complaint. Investigation reveals that two subjects got into a verbal altercation in the parking lot of the establishment. The two subjects then exchange gunfire with each other discharging approximately 16 shots between them. Both subjects fled the scene before police arrival and police did not observe any vehicles, buildings, or people that may have been damaged or injured as a result of the incident.
- 23. On 09/16/21 at 2:33pm, Milwaukee Police were dispatched to 1319 W. North Avenue. Officers recovered a firearm and arrested two people who were sleeping in the parking lot of the location.
- 24. On 09/20/21 at 4:30am, Milwaukee Police were dispatched to 1319 W. North Avenue for a Shotspotter complaint. Two casings were recovered from the rear of the location and officers did not find any injured persons or damaged property.
- 25. On 10/13/21 at 12:35am, Milwaukee Police were dispatched to 1319 W. North Avenue for a drug dealing compliant. Upon arrival, officers interviewed the caller who stated he observed drug dealing in front of the filling station and there was a camper in the back where prostitution was occurring. The caller was advised to not stop anyone from leaving the filling station.
- 26. On 11/02/21 at 11:19pm, Milwaukee Police were dispatched to 1319 W. North Avenue for a property damage compliant. Investigation revealed that an intoxicated subject was inside the station throwing property around. The subject was taken to Detox.
- 27. On 11/17/21 at 3:23pm, Milwaukee Police, along with Wisconsin Department of Revenue Agents, conducted a license premise check at 1319 W. North Avenue. Agents seized various tobacco products because the owner could not account for all the invoices. The owner was cooperative with police and agents.
- 28. On 02/19/22 at 2:34am, Milwaukee Police were dispatched to 1319 W. North Avenue for a shooting compliant. Video surveillance reveals two subjects arguing and the victim strikes the suspect, who then leaves and returns with a firearm, shooting the victim fatally. The employee was very cooperative with the investigation.

On Tuesday April 27, 2021 at approximately 2:22am my partner (P.O. SCHLAX) and I were dispatched to 1319 W North Av regarding a Shotspotter Alert (81-577391).

Upon arrival I was able to locate a total of 6 casings, 5 were located in the street between N 13th St and N Teutonia Av, and one was located south of W North Av on N Teutonia Av. P.O. SCHLAX went inside of the gas station to view surveillance footage.

Video of the Incident

Upon viewing the video P.O. SCHLAX observed a silver, 4 door, sedan, possible early 2000 Volkswagen Jetta, pulled into the gas station at approximately 1:58am. The vehicle parks in a parking spot in front of the gas station facing northbound, towards W North Av. At approximately 2:18am Subject 1 and 2 exit the vehicle.

The subjects description

Subject 1- Black male, slim build, medium complexation, white A-shirt, dark in color baggy jeans, blue boxers, black shoes. *Subject with firearm*

Subject 2- Black male, slim build, medium complexation, white A-shirt, light blue baggy jeans, dark blue boxers, red and black shoes.

Subject 3- Black male, slim build, black hat, blue jacket, white T-shirt, light colored pants, white shoes

Subject 4- Black female, heavy build, black hair (Pony tail), black zip up hoodie with yellow lettering on the right sleeve, black pants, black and white shoes

Based on the video surveillance P.O. SCHLAX viewed Subject 1 and Subject 2 attempt to enter the gas station when Subject 4 was leaving the store. Subject 4 pushes past both subjects. The Subjects 1 and 4 appeared to exchange words with each other. Subject 1 and Subject 2 enter the gas station briefly and immediately walk back out of the gas station. Subject 1 approached Subject 4 and pointed a fire arm at the individual (Time stamp 02:19). The individual then swatted the gun away from her face and walked back to her car, appears to be a white Chrysler 300. As the female began to travel in her vehicle exiting the gas station from N Teutonia Av, subjects 1,2,3 got back into their vehicle and exited the gas station from W North Av. Subject 1 was seated in the front passenger seat, sitting on the window. Subject 2 was driving the vehicle and Subject 3 entered the driver side passenger seat. Subject 1 began to discharge the firearm as Subject 4 was traveling east on W North Av from N Teutonia Av.

The business was fully cooperative during our investigation.

On 06/10/2021, my partner (P.O. John DAVIS) and I were dispatched to 1319 W North Ave, which was in the City and County of Milwaukee-WI, regarding a Shot Spotter (Flex No. F81-599383).

Upon arrival, P.O. DAVIS spoke with the fueling station cashier, who requested he stay anonymous due to his reported fear of retaliation from the suspect. However, I was allowed to view footage of the incident. The attendant submitted a vehicle plate number (346-XPM) he believed to be the actual plate number of the suspect's vehicle. The listed plate was not a match of a red newer model Ford Fusion.

Upon viewing the video surveillance P.O. DAVIS observed the Red Ford Fusion enter the parking lot from the north east entrance, and park near the fueling station attendant's window. I observed a black male exit the front driver's, and fired three shots into the air. The same subject reentered his vehicle for a brief moment, and then proceeded into the fueling station interior.

At both times, interior and exterior of the building, it appeared the suspect spoke with the attendant. I asked the attendant if he remembered any of what was stated to him by the suspect, which he replied no.

The subject backed his vehicle away from the building, but was approached by three individuals, who subsequently entered said vehicle with the suspect.

Please be made aware of, one of the three other subjects, appeared to have picked up a casing from the area of the incident and handed it to the suspect.

Two brass 9mm spent casings were recovered from the area of the incident.

P.O. NORWOOD attempted to download video surveillance but was unable to due to error readings

On Friday, August 27, 2021, my partner (P.O. Daniel GONZALES) and I were dispatched to 1319 W. North Ave. for a shotspotter assignment (Flex ID 81-695972), which detected 1 gunshot in the gas station parking lot. There were two additional shotspotters (Flex ID 81-695971 and 81-695969), which detected

3 gunshots on N. Teutonia Ave and 6 gunshots in the gas station parking lot respectfully.

Upon arrival, we were able to locate 16 casings scattered throughout the gas station parking lot and 1 unfired cartridge. There were 10 brass CBC 45 Auto casings, 1 brass GFL 9mm luger casing, 3 FC 9mm luger casings, 1 brass FC 9mm luger casing, 1 brass RP 9mm luger casing, and 1 brass CBC 45 Auto unfired cartridge. All the casings and unfired cartridge were later placed on Milwaukee Police Inventory # 21033013.

I checked video surveillance of the gas station and observed the following. The video surveillance starts at 2:53 am to 2:58 am.

At 2:53 am, I observed a black male, wearing a black Adidas t-shirt, dark colored shorts, and black Adidas sandals with a bald head (suspect #1) speaking with the driver of a black Chevrolet 4 door sedan, which I believe to be a Malibu. Suspect 1 engages the unknown driver in conversation until 2:54:05 am. At this time a black male, wearing a white t-shirt, stone wash jean shorts with designed rips, white tennis shorts and a white baseball hat (suspect #2) exits the black Chevy to continue the conversation. Suspect #1 walks away from suspect #2 and turns his back to him before turning back around to face him holding a handgun in his right hand by his side. Suspect #1 then approaches suspect #2 and gets in his face before reaching for right side of suspect #2. Suspect #2 then attempts to disarm suspect #1 by grabbing his handgun, which causes a short physical altercation between the two of them at approximately 2:54:34 am.

At approximately 2:54:38 am suspect #1 runs out of the video surveillance frame, however suspect #2 appears to discharge a handgun. Suspect #2 then runs east though the parking lot almost getting hit by what appears to be two gunshots that did hit the black Chevy. Suspect #2 then takes cover behind a unknown white 4 door vehicle discharging his handgun multiple times in the direction of suspect #1 at approximately 2:54:49 am. At 2:54:51 am suspect #1 appears back in the view of the video surveillance while taking cover behind the black Chevy, while suspect #2 flees the scene on foot eastbound through the gas station parking lot. Eventually suspect #1 discharges his handgun in the direction of suspect #2 and chases him through the parking lot. Suspect #1 then discharges his handgun multiple times in a southern direction on N. Teutonia Ave by the entrance to the gas station before walking back to a unknown make and model white vehicle parked at pump #5 and fled the gas station.

Through my investigation, I did not observed any vehicles, buildings, or people that may have been damaged or injured as a result of this incident.

The video surveillance was placed on Milwaukee Police Inventory # 21033024,

P.O. GONZALES took 30 photographs at 3:22 am.

NELSON informed him he observed drug dealing in front of the gas station along with a trailer/camper in the rear of the building that he said prostitution was occurring.

It should be noted that NELSON was using his vehicle to stop traffic. NELSON was advised not to continue with such disregard and not stop anyone from leaving the gas station. NELSON stated something along the lines of that he wants to take the city back. SINGH stated all invoices should be in the folder and stated they retain them for approximately 3 years.

On February 19th, 2022 while assigned to Squad 3490, my partner P.O PETERSEN and I, was dispatch to the address of 1319 W North Ave for a shooting incident at the 24/7 Petroleum which gas station in the city of Milwaukee.

Upon arrival, I arrived on scene and assisted with securing the area around the gas station. While on scene, I observed a small blood trail located at the entrance of the establishment. As I entered the establishment, I observed a black male laying on the ground pulseless and not breathing. I also observed, a gun shot wound located on the right side of his stomach of the victim, while the Milwaukee Fire Department was assisting life saving measure to the victim.

The victim was pronounced deceased by the Milwaukee Fire Department. While on scene camera footage was reviewed. What was seen on camera by officers, was the victim and the suspect involved in a verbal argument. The victim then strikes the suspect, who then leaves and returned with a loaded firearm and discharged multiple rounds at the victim striking the victim. The suspect then fled the scene. While on scene there were multiple patrons inside of the store during the incident who witnessed the shooting. During the investigation, CIB responded to the scene to investigative the homicide.

Officers spoke to the clerk by the name of SINGH, SUKHCHAIN who was very cooperative with the investigation by letting the Milwaukee Police department retrieve camera footage regarding the incident.


