There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The agent or attorney for corporate or limited liability applicants must attend. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 01/01/22 at 11:10 pm, Milwaukee police were dispatched to 4231 W. Capitol Dr. for a shooting complaint. Milwaukee Police located three gunshot victims in total related to the incident. One of the victims was inside and two flagged down police outside of the business. All three victims were transported to the hospital by Milwaukee Fire Department medical units. Investigators spoke with an employee of the business who stated that the victims were in line and an argument occurred between the three victims. The employee turned to place the food order to the kitchen staff and heard guns shots fired. The employee was not sure who shot the gun. The business was cooperative with the investigation and allowed police access to video of the incident.

LICENSE PREMISE REPORT

This report is written by P.O. Taylor MOTIFF assigned to District 7 Late Power shift.

On Saturday, January 1, 2022 at 11:10 PM Squad 7440 (P.O. Daryal GOSS and I), while in full duty uniform and equipped with activated Axon body worn cameras, was dispatched to 4231 W Capitol Dr (Chicago Subs), which was located in the City and County of Milwaukee, for a Shooting complaint.

Upon arrival we located a victim, later identified as Deante L JOHNSON (B/M 09-02-1984), in the lobby of the location laying on face down on the floor stating he was shot in the chest. We could not locate a bullet wound on his chest but when MFD removed his jacket and shirt a bullet wound was located on his upper back. JOHNSON was transported to Froedtert Hospital by MFD Med 5 with P.O. GOSS riding along.

A second victim, later identified as Sherronda K POLK (B/F 10-19-1996), was located in the back seat of a Silver Chevrolet Cruze located in front of the business on W Capitol Dr. POLK had bullet wounds in the right shoulder, right abdomen, right buttocks, and left knee. POLK was transported to Froedtert Hospital by MFD Med 13 with P.O. DORSEY of Squad 7230 riding along.

While Squad 7450 (P.O. Donald ARNDT and P.O. Brian BAKER) was arriving on scene they were flagged down at 4327 W Capitol Dr by Erica M DUNCAN (B/F 02-03-1990) regarding a third victim, later identified as Eric L DUNCAN (B/M 10-07-1995), who had received a bullet wound to the left side of his face. ERIC was transported to Froedtert Hospital by MFD Med 16 with P.O. ARNDT riding along.

I spoke with a worker at Chicago Subs, later identified as Cassandra F EDMAN (B/F 02-05-1987), who stated JOHNSON was arguing with POLK by the serving window. EDMAN stated it appeared ERICA stepped between the two as if she was attempting to stop them. EDMAN stated she turned around to give the cooks an order and she heard gunshots. EDMAN stated she did not see who shot the gun.

We were able to review security footage and the video shows JOHNSON arguing with POLK by the serving window. ERICA then approaches JOHNSON and appears to be arguing with him as well. It appears ERIC is attempting to pull ERICA back from JOHNSON. The argument continues and it appears ERIC begins yelling at JOHNSON. JOHNSON produces a firearm and fires at POLK, then fires at ERIC, then fires twice more at POLK. JOHNSON and ERIC began to tussle during which JOHNSON drops the firearm. JOHNSON takes ERIC to the ground and is positioned on top of him. ERICA then grabs the firearm and fires at JOHNSON. JOHNSON rolls off of ERIC and POLK, ERICA, and ERIC leaves the location.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 04/26/2022 at 11:05 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
