This is to inform you that on Tuesday September 14th I woke up at 6:00am for work like I do every day. I noticed that my water pump downstairs kept going off at my property 4345 S 60th st Greenfield WI 53220. Being a little confused I rushed downstairs to see what the issue was. I came down to about a foot of water in my basement. My whole basement was flooded and water kept getting higher. I rushed to wake my daughter up to call Milwaukee waters to request for the water to be shut off. I was under the impression my water pipe broke and it was an internal issue, but I was very wrong. The operator for Milwaukee waters informed me that there has been a pip burst on Milwaukee's side and the workers will be out to fix the issue. I look outside to see the street in front of my home and the streets was flooded as well. I knew I had to act quick due to the water coming up being very dirty. I come outside of my home to my neighbor informing me that she called water works at 5:00am and they still haven't arrived. Both myself and daughter called off of work in order to get the water out. We started off by using a pool water pump, but that didn't help get the water out due to the amount of water coming up at a given time. Once Milwaukee water arrived we had a gentleman by the name of what I remember it to be, Scott, team supervisor, came and informed us that the pipe burst and they will be fixing it and to fill a claim with Milwaukee. That was the only communication I received that day. After I was informed what the issue was I had my daughter go to Home Depot and rent out the submersible pump. This pump was \$46.42 for one day. The water didn't stop till roughly 1:00pm. We later contacted our insurance company and our company was able to send out a cleaning company. Due to the water being dirty we had to act quick in fear our health will suffer because of mold. The cleaning company came cleaned, sanitized and set up fans all around the basement and allowed everything to dry and informed us to allow the fans to stay on for the whole weekend The cleaning company spent two days cleaning out our basement and throwing out things that were damaged. We were informed to stay out of the basement because of the cleaning chemicals and fans. I thought that was the most stressful experience, but little did I know the issues just started.

On September 20st, my daughter and I walked down stairs to check out the situation with our applicants. Since we were told not to go downstairs, we didn't get a chance to check out our washer and dryer until September 20th. We came down stairs to see water again, but this time we had no idea where it was come from. We turned on our washer and realized the water was coming up and realized this was a trend. We flush the toilets or turn the shower on and the water kept coming up. Right away we called Milwaukee water works and let them know of the situation and they informed me that this is not a Milwaukee water problem, but a sewer department issue and transferred me. I told the sewer department my issue and they sent out a gentleman to take a look. The gentleman came right away and knocked on our door and said he can't do anything. That everything looks "fine" on their end. We tried to direct him down stairs to take a look and he stated he is not allowed to do that. He stated that since we had an issue the

week before we will need to deal with Milwaukee water. Once again I called Milwaukee water who sent someone out and informed us to contact our own private plumber. Once again no problem, I followed directions as told. I called the company roto- rotter out, they attempted to put a camera down the sewer and they hit clay and dirty. They told me they can't unclog anything and that its Milwaukee water issue. Once again I called Milwaukee waters and spoke to the same lady, who stated there was nothing they can do. I asked to speak to a manager, because at this point I have called over 8 times and kept being transferred or told they can't do anything. I at one point had the plumbers speak to Milwaukee waters to try and explain the issue they encountered, and Milwaukee Water didn't want to hear it. At this point we weren't using the shower, the toilet and sink in the household. I had then spoken to Tim, the distribution manager at Water works, and once again was direct to do something else. I was instructed to have a more experience plumber come out and fix the issue. I was also introduced to get the problem fixed and to file a claim with Milwaukee. I was informed that Milwaukee water by law cannot do anything since this is in "internal problem." I called a more experience plumber who deals with bigger issues. The plumber stated it will be a job that takes all day and they will need to pull permits. The job was estimated to cost 15k-20k just to open and fix the sewer. After 48 hours of being told do this, do that I was getting frustrated. I was struggling mentally at this point, Depression and anxiety were taking over. I lived and paid taxes ag this property for over 8 years but was told this can't be handled by a city who created the issue. 15-30k out of pocket was not a small amount of money. I knew I was not dealing with the correct people, I spoke to team members who wants to hear and not understand the problem. I took matters into my own hand and took this issue to a higher level since a manager wasn't able to help me. I sent an email to Greenfield Mayor Neitzk and John Laskoskim Superintendent. I also email Joseph J Czanezki details of my problem. My last attempt was to have a plumber come out again and put a camera as far as they could and to mark where the clay hit. Finally, I was able to prove this was a Milwaukee Water problem. I forwarded a photo to Joseph J Czanezki I received a phone call right away from Tim, Milwaukee Waters manager and was told they will be over the next business day and will dig up the hole again to decide what the issue was.

The day finally came September 24th where they reopened the road. It took 10 days to finally confirm it was in fact Milwaukee waters fault. How disappointing is that that I spent that many days trying to provide Milwaukee water was at fault? Right away the same gentlemen who was the supervisor came to my door that morning to apologize and confirm that they did not do the job correctly. With the water pressure being so hard it knocked the sewer pipe out. Not a single worker that day (september14th) thought to look at the sewer pipe. He stated they were looking for the other part of the sewer since it was still missing. I did request to get proof of job competition once it is done so I don't run into problems again trying to prove who is wrong. I was told by Tim that Greenfield's engineering depart will have photos of the job and I can request the photos if needed. If photos are needed for the claim will gladly obtain them. Since that day I have not received any other communication. Very unprofessional experience that I wish to never go through again.

I am currently seeking \$10,498.52 from Milwaukee. All items will be listed with some photos and/or receipts.
