You are hereby notified that the Milwaukee Common Council will hold a hearing on November 23, 2010, commencing at 9:00 a.m., or as soon thereafter as this matter may be heard, in the Common Council chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin to consider the renewal of your Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) license for the premises at 622 N Water Street ("Lady Bug Club/618 Live on Water").

Attached you will find a copy of the Report of the Licenses Committee, which includes its Findings of Fact, Conclusions of Law and Recommendation, recommending renewal of your license with a 20-day suspension based on Items #41, 43, 44, 46, 49, 50 contained in the police report, Milwaukee Police Department and neighborhood testimony. The recommendation is the result of a public hearing before the Committee held on November 8, 2010.

If you file written objections, you or a legal representative may then also appear at the Common Council to make oral arguments supporting your written objections. 
Report on the renewal application of Habib Manjee, Agent for Lady Bug Club, LLC, for Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) renewal applications for the premises located at 622 North Water Street in the City and County of Milwaukee, Wisconsin ("Ladybug Club/618 Live

On Water ").

FINDINGS OF FACT

- 1. Habib Manjee ("Licensee") is the holder of a Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) license for the premises located at 622 North Water Street in the City and County of Milwaukee, Wisconsin ("Ladybug Club/618 Live On Water"). Said license expires at midnight, December 20, 2010.
- Applications to renew said licenses and for change of member were filed with the Office of the City Clerk on October 4, 2010.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On October 29, 2010, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license. There were also claimed objections as follows:

"See also written correspondence, #1-4 received, by the License Division regarding this application. Neighborhood Objections to loitering, littering. Objections loitering, littering [sic], loud music and noise, parking and traffic problems, music and noise, parking and traffic problems [sic], drug and criminal activity, prostitution, trespassing, public urination, and criminal activity, prostitution, trespassing, public urination [sic], fights, shootings, vandalism,



thefts, shootings, vandalism, thefts [sic], past history of licensed location (see finding of fact), operation of the premises in such a manner that it creates a public nuisance of the premises in such a manner that it creates a public nuisance [sic], disturbing the peace, causing the normal flow of traffic on roadways to be impeded, excessive and inappropriate use of police resources, neighborhood problems due to mismanagement, and any other factors which are detrimental to the health, safety, and welfare of the neighborhood."

- 4. On October 27, 2010 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and neighborhood objections and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report and neighborhood objections on November 8, 2010, commencing at 9:45 a.m. in Room 301B of City Hall, 200 East Wells Street, Milwaukee, Wisconsin 53202. At said date, time and place, the Licensee appeared and admitted receipt of notice for the hearing, as well as notice of the objection to renewal of licenses. The Licensee was represented by Attorney David R. Halbrooks, Maistelman & Associates, LLC, 5027 West North Avenue, Milwaukee, WI 53208.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On November 1, 2009 at 2:11 a.m., officers of the Milwaukee Police Department were dispatched to 618 North Water Street for a subject with a gun complaint. Upon arrival, officers observed several subjects in handcuffs next to an auto along with Wisconsin State Patrol officers and security from 618 Club standing in the middle of the street in front of the tavern. Officers also observed several patrons entering and exiting the club screaming and causing a disturbance. Due to the large crowd and lack of additional squad cars, the scene was slow in being controlled. Officers began to speak with the State Patrol who advised them they received a call regarding shots being fired and a description of an auto involved. Upon their arrival, they observed the car and recovered a 9 mm pistol, which was located under the front passenger seat, and placed all occupants in custody. While the State Patrol was attempting to investigate, security from the club interfered with the troopers who were attempting to conduct a high-risk traffic stop. The troopers repeatedly

asked security to stay back and were unable to identify where all the occupants were seated except for the driver, hindering the investigation. Milwaukee officers spoke to Habib Manjee along with security guards for the club to determine what occurred. Manjee was not able to give any accurate details of the incident nor was he able to describe the individuals who were fighting or where the shots came from. Officers spoke to the driver who denied knowledge of a gun being in the car. The driver stated he was at the club to pick up women and that all of a sudden, a large fight erupted and that he ran from the club because he was scared due to being shot in the past. The driver further stated he ran to his car when three males asked for a ride to their auto and got in. The driver stated he began to accelerate when he was stopped and pulled out of the car by security guards and cops. The other occupants were interviewed and denied having any knowledge of the pistol in the auto. No one on scene appeared to be injured or shot and no reports of any gunshot wound victims came in from area hospitals. The gun was placed on inventory.

- B. On February 5, 2010 at 1:43 a.m., officers of the Milwaukee Police Department were dispatched to 622 North Water Street for a fight complaint. Officers observed a fight on the sidewalk and the investigation found that one of the subjects was a patron inside the club prior to the fight.
- C. On February 6, 2010 at 1:43 a.m., officers of the Milwaukee Police Department observed Club 618 security trying to break up a fight in front of the Lady Bug Club. A crowd began to gather and other fights began to break out. Additional officers were called to the scene to help restore order. A total of six patrons were cited for disorderly conduct and fighting. One other subject was arrested on warrants.
- D. On February 21, 2010 at 11:30 p.m., an officer of the Milwaukee Police Department, while on patrol, observed a large amount of vehicular traffic clogging the intersection at Michigan and Broadway. The officer also observed several subjects hanging out of vehicles and heard an unnecessary number of vehicle horns being honked for no apparent reason. The officer also heard the unnecessary revving of vehicles engines and observed a large amount of people standing in the street. Shortly after, the officer then

observed several people fighting while other subjects gathered and cheered on. This incident was captured on video by a citizen and it was placed on police inventory. More squads were called to help with crowd control and several citations were issued for assault and battery. As patrons were observed leaving 618 Live, they would enter the cars and generally drive around in circles around the block. Officers conducted follow up at 618 Live and spoke to Manjee. Manjee was irate when questioned by officers regarding the activity that was occurring in and around the club. A citation was issued to Manjee for disorderly conduct by patrons. Citation was not found in the Municipal Court system.

- E. On July 16, 2010 at 1:10 a.m., officers of the Milwaukee Police Department were flagged down by the manager of 618 Live regarding an auto that was driving around spraying pepper spray at patrons who were leaving the club. Officers were provided a description of the auto, which they located and stopped when they were approached by another auto with the female driver who had an unconscious female in the back seat. Medical personnel were called to the scene and the unconscious female was taken to the hospital. Officers spoke to the driver who stated she and her friend were at 618 Live when a fight broke out inside the club. Security began pushing people out of the club when an unknown male punched her friend in the face causing her friend to fall into some bushes. An unknown female then began hitting her friend in the head with the heel of a shoe until she was unconscious. Police also spoke to the victim who relayed similar events of what occurred only adding she believed she knew who the female was that was hitting her with a shoe. The victim was treated for a fractured nose. Officers viewed video of the interior of the tavern, which shows security removing the victim and a group of friends she was with. No physical altercation was observed on video.
- F. On September 25, 2010 at 12:04 a.m., officers of the Milwaukee Police Department were dispatched to 622 North Water Street for a battery complaint. Upon arrival, officers were met by Habib Manjee and his security staff who had a subject in handcuffs lying on the ground in front of the club. Manjee stated the suspect had been involved in an altercation inside the club and was removed. Once outside, the suspect made threats of returning with a

weapon to do the tavern harm. A citation was issued for disorderly conduct to the suspect. Several calls were received regarding this incident while police were on scene. While officers attempted to investigate this complaint, another fight involving patrons who were leaving the club occurred down the street.

- G. The police report contained 11 incidents (Items 41-51) since November 1, 2009. Regarding the incident described in paragraph A above (Item 41), while there was testimony that indicated that the gun recovered had not been fired that evening, the Committee found that there was substantial evidence that there was a loaded gun found near the licensed premises and that people in the vehicle with the gun had been in the licensed premises.
- H. Five items on the police report (Items 42, 45, 47, 48, and 51) reflect proactive measures taken by the Licensee, are minor incidents, or lack sufficient evidence to attribute conduct to the Licensee or its patrons and therefore those five items are excluded from the Committee's findings.
- I. Milwaukee Police Department Captain Stephen Basting's testimony corroborates the public disorder attributable to the Licensee's patrons that was demonstrated in the items contained in the police report. Captain Basting testified about the amount of police resources that he has to direct to the public disorder on the 600 block of North Water, though he acknowledged that a nearby club has become a growing problem and also contributes to the public disorder at bar time. He testified that he regularly assigns four officers on overtime to the 600 block of North Water and has transferred personnel from the jail to address the public disorder. Captain Basting testified that while the Licensee has been proactive in addressing problems caused by the Licensee's patrons, the conduct of the patrons is beyond the ability of the Licensee to address. He is also uncomfortable with some measures taken by the Licensee including conducting traffic control and the decision to use armed security.
- J. One neighborhood resident, the Executive Director of Business Improvement District No. 21, and a manager of a neighborhood business provided testimony that supports the evidence of public disorder attributable to the Licensee's patrons. The neighborhood resident testified

that the public disorder associated with the Licensee's patrons has not improved despite the Licensee's 60-day suspension last year. The neighborhood resident testified that he has observed loitering, public urination, fights, vandalism, and cars blocking streets, which he attributes to the Licensee's patrons though he cannot say for certain whether these are patrons of the licensed premises or a nearby club, Club Bari.

- K. The Executive Director of BID #21 testified that she has personally witnessed problems in the evening outside the club. She testified that the BID Executive Committee voted unanimously to object to the renewal of this license. She testified that the BID has reached out to Mr. Manjee for years but there is no improvement in the disorder caused by the Licensee's patrons.
- L. The manager of a nearby catering business testified to the public disorder at bar time including observing public urination, unlawful use of the business's parking lot, and harassment of his customers. However, he could not say that these acts were caused by patrons of the licensed premises versus patrons of other clubs in the area. He testified that he is concerned for his staff's safety and has ordered them to leave in pairs at closing.
- M. The Licensee's manager, Nicholas Mercado, testified about the security measures the Licensee has utilized including hiring several new security personnel, conducting a security roll call, use of video ID checker over the previous 18 months, use of outdoor surveillance to detect problem vehicles, and indoor surveillance. Several supporters testified in support of the licensed premises and its security measures. Supporters include patrons, employees, promoters, and the club's landlord.
- N. The Committee finds that the Licensee's proactive security measures are a mitigating factor warranting suspension rather than nonrenewal.

CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the

Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.

- 2. Based upon the above facts found, the Committee finds that the Licensee, Habib Manjee, has not met the criteria of Chapter 125, Wis. Stats. or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) licenses held by him for the premises located at 622 North Water Street in the City and County of Milwaukee, Wisconsin ("Ladybug Club/618 Live On Water ") without undergoing a twenty (20) day suspension of said licenses. The Committee finds the police report and neighborhood objections, as stated above, to be true.
- 3. The Committee recommends that the full Common Council of the City of Milwaukee exercise its judgment to renew the Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) licenses for the licensed premises at 622 North Water Street in the City and County of Milwaukee, Wisconsin ("Ladybug Club/618 Live On Water") with a twenty (20) day suspension of said licenses based upon the danger that his conduct represents to the health, safety and welfare of the citizens of the City of Milwaukee.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, one (1) no, and one (1) excused, recommends that the Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) licenses of Habib Manjee, as agent for Lady Bug Club, LLC, for the premises located at 622 North Water Street in the City and County of Milwaukee, Wisconsin ("Ladybug Club/618 Live On Water"), be renewed with a twenty (20) day suspension.

Said suspension is to be in effect from Midnight, December 20, 2010 and for twenty days thereafter.

Re: Report of the Renewal Application of Elizabeth B. Bates, Agent for Ken Elliot's, Inc., for Class "B" Tavern, Tavern Dance and Videogame Center licenses for the premises located at 150-58-East Juneau Avenue in the City and County of Milwaukee, Wisconsin ("Scooters Pub – Dukes on Water").

FINDINGS OF FACT

1. Elizabeth B. Bates (hereinafter the "Licensee") is the holder of Class "B" Tavern, Tavern Dance and Videogame Center licenses for the premises located at 150-58-East Juneau Avenue in the City and County of Milwaukee, Wisconsin ("Scooters Pub – Dukes on Water"). Said licenses expire at midnight, November 25, 2010.

2. The applications to renew said licenses were timely filed with the Office of the City Clerk on September 1, 2010.

3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a report that could form the basis of non-renewal or suspension of this license on September 2, 2010. The hearing notice also stated that there were neighborhood objections to "loitering, littering, loud music and noise, parking and traffic problems, drug and criminal activity, prostitution, trespassing, public urination, and any other factors which are detrimental to the health, safety, and welfare of the neighborhood."

4. On October 28, 2010, the City Clerk's Office provided notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the

police report that could form the basis for non-renewal or suspension and the neighborhood objections and included a copy of the police report. The matter was scheduled for a hearing on the police report and neighborhood objections on November 9, 2010 at 9:45 a.m. in Room 301B of the third floor of City Hall. At said date, time and place, the licensee did appear and was not represented by counsel.

- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On September 17, 2009 at 12:10 a.m., officers of the Milwaukee Police Department witnessed two male subjects arguing and fighting outside of Dukes bar located at 158 East Juneau. The investigation found the subjects had been playing pool inside Dukes when they began to argue. The argument turned physical with one patron sustaining a broken nose. The incident was captured on video and the suspect was charged with substantial battery.
 - B. On December 13, 2009 at 1:13 a.m., officers of the Milwaukee Police Department were dispatched to 150 East Juneau for a battery. Officers spoke to the victim who stated that a bouncer from Scooters Pub broke a bottle over his head for no reason. Officers spoke with the manager of the tavern and were able to view video both inside and outside of the tavern. The video showed the victim being asked by the bouncers to leave the tavern when several of the victim's friends started to harass the bouncers. These patrons were eventually led outside of the tavern where they continued to cause a disturbance and attempts to reenter the bar were made. It was unclear as to how the victim sustained his head injury since nothing was observed on video regarding it. Citations for disorderly conduct were issued to the patrons.
 - C. On July 30, 2010 at 12:45 a.m. an officer of the Milwaukee Police Department observed a fight in front of Scooters at 154 East Juneau. The fight involved six people which consisted of two bouncers, the bar manager and three patrons. The investigation found a patron tried to exit the door with a glass drink. When he was told he needed to put it in a plastic cup before exiting to the patio, the patron became upset and began hitting one of the bouncers. Additional bouncers came to assist and the patrons' friends

- also began to fight with the bouncers as police arrived. The patrons were cited for disorderly conduct.
- D. The licensee and owner testified that the tavern staff would continue to cooperate with police and provide video evidence as necessary. They indicated that security staff is not permitted to fight, only defend themselves, and would be fired if video surveillance captured staff fighting. The premises are monitored by 24 cameras and staff is aware that they are monitored. The tavern does not utilize an ID scanner system that records patron's identification.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Elizabeth B. Bates, is the holder of Class "B" Tavern, Tavern Dance and Videogame Center licenses for the premises located at 150-58-East Juneau Avenue in the City and County of Milwaukee, Wisconsin ("Scooters Pub Dukes on Water "). The Licensee has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances, together with the police report, to allow renewal of her Class "B" Tavern, Tavern Dance and Videogame Center license for the premises located at 150-58-East Juneau Avenue in the City and County of Milwaukee, Wisconsin ("Scooters Pub Dukes on Water") without undergoing a ten (10) day suspension. The Committee finds the police report as stated above to be true.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern, Tavern Dance and Videogame Center licenses of Elizabeth B. Bates for the premises located at 150-58 East Juneau Avenue in the City and County of Milwaukee, Wisconsin ("Scooters Pub Dukes on Water") with a ten (10) day suspension based upon the police report.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes, zero (0) noes and one (1) abstention, recommends that the Class "B" Tavern, Tavern Dance and Videogame Center license held by Elizabeth B. Bates for the premises located at 150-58 East Juneau Avenue in the City and County of Milwaukee, Wisconsin ("Scooters Pub – Dukes on Water") be renewed with a ten (10) day suspension based upon items #11, 12 and 14 of the police report.

Said suspension is to be in effect between 12:01 a.m., November 26, 2010 and for ten days thereafter if the Common Council adopts the recommendation of the Licenses Committee made on November 9, 2010.

FINDINGS OF FACT

1. Michael A. Batzler (hereinafter the "Licensee") is the holder of a Class "D" Bartender License in the City and County of Milwaukee, Wisconsin. Said license expires at midnight, December 31, 2010.

2. An application to renew said license was timely filed with the Office of the City Clerk on October 12, 2010.

3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On October 13, 2010, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.

4. On November 2, 2010 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on November 9, 2010, commencing at 1:30 p.m. in Room 301B of City Hall. At said date, time and place, the licensee did appear and he was not represented by counsel.

- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
- A. The applicant's driver's license record revealed the following convictions:

11/1/90 Operating While Intoxicated (1st) Sheboygan County Cir. Ct.
3/1/10 Operating While Intoxicated (2nd) Milwaukee County Cir. Ct.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based on the above facts found, the Committee concludes that the Licensee, Michael A. Batzler, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender license without undergoing a ten (10) day suspension of said license based upon the police report.






