
Dear Alderman Hamilton:


A notice was originally filed on June 11, 2010 that failed to list a dollar demand for damage allegedly done to Mr. Sandoval's vehicle during the towing process. Our office denied the matter on July 13, 2010 and the appeal was heard by your committee on September 13, 2010. The committee was unable to rule due to the absence of a dollar demand. The matter was placed on file until or if Mr. Sandoval filed this information. Mr. Sandoval subsequently filed the enclosed damage estimate in the amount of \$817.90.

Our office maintains its original denial of this claim based upon the fact that there is no evidence the City caused any damage to this vehicle. We have included a copy of Mr. Sandoval's original notice and our denial letter dated July 13, 2010 for your reference. Dear Mr. Sandoval:


We have received your claim regarding alleged damage to your vehicle's rear bumper and light. You also alleged there was oil and grease along the edge of the hood and rear of the vehicle.

Our investigation reveals that your 1998 Mitsubishi was towed on June 5, 2010 to the City of Milwaukee Tow Lot due to it being displayed for sale without a permit on public property. Our office reviewed the tow lot intake disc, reviewed the PT-27 form completed prior to the tow and the tow lot intake/exit forms. This review revealed none of the items you are alleging. Since there is no evidence the City caused any damage, it cannot accept liability and we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
