This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 01/02/2022 at 10:13pm officers were dispatched to a Shooting at Burger King, 5120 W. Capitol Dr. The officer's investigation revealed a subject was attempting to rob the restaurant by leaning in the drive-thru window. There was an argument and then several shots were fired. The investigation further revealed a Burger King employee was armed with a handgun and shot at the suspect. During this exchange in gun fire another Burger King employee was struck twice in the chest, causing her death. The manager on duty hid the employee's firearm in the safe and mislead officers during the investigation.
- 2. On 01/11/2022 officers conducted follow up regarding Burger King, 5120 W. Capitol Dr. An officer called the District Manager by phone in regards to corporate policy concerning employees being armed at work. The District Manager stated he could not talk with the officer because he could not verify on the phone if he was in fact an officer. The officer attempted to set up a meeting at the station but the manager stated he would have to speak with company lawyers before having a meeting. The officer called the applicant but there was no answer.

for the Burger King located at 5120 W Capitol Dr, to ask what the company policy is regarding employees carrying firearms on the premises and any other security systems they have in place. This was in response to the shooting that occurred at this location on Sunday, January 2, 2022 (IR 22-002-0127). I reached out to ATKINES at the phone number 215-667-4552. While speaking to ATKINES he advised me that he would not discuss company policy over the phone because he didn't know who he was talking to. I identified myself again, but ATKINES stated that he could not verify that I was a police officer and would not discuss company policy. When I asked ATKINES if he would be willing to meet with me at the District Seven Police Station he originally stated that he would. However, after I gave him the address ATKINES stated that he would have to reach out to the lawyers and seek their counsel. ATKINES stated that he was not sure if he was allowed to talk to me about company policy or not. ATKINES asked for my contact information and stated that he would contact me after he spoke to the lawyers. I gave ATKINES my phone number and concluded the phone call. As of Sunday January 16, 2022 at 12:00PM I have not heard back from ATKINES.

I reached out to the licensee, Adam J Velarde, on Sunday January 16th, 20222. I did not receive an answer, so I left a message asking VELARDE to contact me regarding.

INITIAL INVESTIGATION

Sheets Walker, Tiara S 024300

This report is submitted by PO Tiara SHEETS-WALKER, District Seven, Late Power Shift.

On Sunday, January 02, 2022, my partner P.O. Daryal GOSS and I were assigned to squad 7440.

At approximately 10:13pm, (Squad 7431) P.O. Rafael VILLAGOMEZ and P.O. Julian NAILEN along with my partner PO GOSS and I were dispatched to 5120 W Capitol Drive, Milwaukee, Wisconsin for a Shooting "Call for Service".

Interview of Witness Vincent T ALLEN JR B/M (12/19/1992)

Upon arrival, I was flagged down by witness Vincent T ALLEN JR B/M (12/19/1992) who was located in the Burger King Drive Thru Line. ALLEN stated he observed an unknown suspect stopped in the drive thru window. ALLEN stated that the suspect had his body halfway inside of the Burger King Drive Thru Window and halfway inside of his vehicle. ALLEN stated as he began to video tape the suspect he heard arguing and three gun shots. He then observed the unknown suspect get back into the driver seat of his vehicle and flee southbound from the location.

Interview of victim Niesha N HARRIS-BRAZELL B/F (05/27/2005)

While on scene, my partner P.O. GOSS spoke with victim - Niesha N HARRIS-BRAZELL B/F (05/27/2005) who was a cashier at the Burger KING. HARRIS-BRAZELL stated that a unknown suspect was trying to rob the Burger King and she was shot. P.O. GOSS observed HARRIS-BARAZELL to be shot twice on the right side of her chest.

Interview of witness Tia L CASTLEBERRY B/F (08/11/1983)

P.O. VILLAGOMEZ spoke with Manager - Tia L CASTLEBERRY B/F (08/11/1983) CASTLEBERRY stated at approximately 10:10pm she was washing dishes when she observed anunknown male subject knocking on the drive thru window. CASTLEBERRY stated she had HARRIS-BRAZELL go speak with the customer at the drive thru window. CASTLEBERRY stated as she went back to washing dishes she heard some arguing and a male voice stating give me all the money. CASTLEBERRY stated that she then heard two gun shots near the drive thru window. CASTLEBERRY stated that she ran up to the drive thru window and observed her employee HARRIS-BRAZELL on the floor with a gun shot wound to her rib cage. CASTLEBERRY stated that she contacted the police regarding the incident.

I then spoke with CASTLEBERRY and asked if she was able to provide me with business license/permit.

After further investigation the detectives on scene learned that another employee - Derrick D ELLIS B/M (03/27/1987) was also armed with a firearm and fired off shots inside of the Burger King Restaurant during the shooting incident.

It was later found that CASTLEBERRY hid the firearm in which ELLIS used during this incident inside of the Burger King safe.

ELLIS and CASTLEBERRY were both arrested.

HARRIS-BRAZELL was transported to the hospital where she did succumb to her injuries.

The manager and employees attempted to mislead officers with their initial stories.

The District Manager DAVID was contacted at 215-667-4552 and notified of the incident.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.
