3. On 11-17-05, an officer was dispatched to a report of a Battery, 6449 W Fond du Lac Avenue. The victim told the officer he was punched in the face by the applicant at Fremo's Bar, 6449 West Fond du Lac Avenue. The officer spoke to the applicant, who said he did push the subject (victim) to get him out of the bar because he was causing a disturbance. The incident occurred because the victim wanted money for an accident which occurred a week ago.

The applicant was issued the following citation.

4. On 1-29-06, officers were dispatched to investigate a Battery complaint, 4938 N 66th Street. The victim told officers that he and a friend went to Fremo's Bar, 6449 W Fond du Lac Avenue and 5 patrons in the tavern jumped him and beat him up. The victim stated that the owner of the tavern, Peter Fiumefreddo "purposely got into the fight with him because it was racial". He said he sat next to a white female patron and Mr Fiumefreddo walked between them, knocking into him, and when he called his attention to it, the subject began to fight with him. The victim was loud and appeared to be intoxicated. The officers went to the bar, and spoke to the subject. Mr. Fiumefreddo had a swollen left lower eye, which was turning colors. He said the victim came into the bar and appeared agitated, and started yelling at customers. He said he approached the victim and told him he didn't want any trouble in the establishment, and the victim struck him. The victim's friend and other patrons grabbed the victim and showed him the door. Both subjects were issued citations for Disorderly Conduct.

Subject is on probation until 10-25-06, on The Disorderly Conduct conviction of 8-20-05 (#2). He was sent a notice to provide a letter from his probation officer in connection with this application.

5. On 08/26/06 at 9:35 am, Milwaukee Police were working the tobacco initiative and had a 16 year old enter Fremo's tavern in an attempt to buy some cigarettes from the vending machine inside. The 16 old year old asked the bartender, identified as Lynnetta Braatz, for change to buy some cigarettes. Braatz gave the 16 year old change and he was able to buy a pack of cigarettes. When asked by police, Braatz stated she never asked for any identification. A citation was issued to Braatz for Sale of Tobacco To Person Under 18.

6. On 09/12/06 at 12:37 am, Milwaukee Police were dispatched to 6449 W Fond Du Lac for a fight. Investigation revealed a male patron was fighting with another when he was escorted out of the tavern. This subject returned after being kicked out and punched the glass window breaking it. Officers issued citations for Vandalism and Disorderly Conduct.

 On 01/27/07 at 1:50 am, Milwaukee Police were dispatched to 6449 W Fond Du Lac for a Battery/Cutting complaint. Investigation revealed a patron was struck in the head with a glass mug by another causing a laceration above his left eye down to his cheek. The suspect then fled.

- 8. On 11/15/08 at 1:41 am, Milwaukee police were dispatched to 6449 W Fond Du Lac for a Fight complaint. Investigation a fight started when several patrons began to fight over a woman. Security broke up the fight and all parties were escorted out of the tavern. No violations were found inside.
- 9. On 06/11/09 at 12:21 am, Milwaukee police were dispatched to 6449 W Fond Du Lac for a complaint of Underage Patrons inside Fremo's Tavern. Officers spoke to the bartender Richard W Solney who stated the doorman checks, scans, and records everyone's ID's as they enter the business. He further stated that two patrons attempted to enter with suspicious looking ID's and were denied entry. No underage patrons were found inside the tavern and the call was advised.
- 10. On 06/27/09 at 8:34 am, Milwaukee police were dispatched to 6449 W Fond Du Lac for a Fight complaint. Officers spoke to the bartender Lynnetta Braatz who stated a patron came into the bar and asked for a beer but was short on money to pay for such. Braatz stated she still served the beer when the patron asked for money to play music on the jukebox. Braatz stated she told the patron she was not giving her money for the jukebox and that is when the patron walked behind the bar and attempted to open the cash register. The patron then struck Braatz several times and began to choke her. A customer then pulled the patron off of Braatz and police were called. The suspect was arrested and charged with battery.
- 11. On 08/09/09 at 9:10 am, Milwaukee police went to 6449 W Fond Du Lac to located a subject who was wanted on a felony burglary warrant. Officers found the tavern to be closed but observed two males inside behind the bar. Police spoke to one actor who identified himself as Peter Fiumefreddo, owner of the tavern. Fiumefreddo was shown a picture of the suspect police were looking for and asked if the suspect was there. Fiumefreddo stated he knew the actor but that he wasn't there. Further investigation by police located the suspect inside the building and the suspect was arrested. Fiumefreddo was also arrested and charged with Resisting/Obstructing Police. The charged was amended on 10/21/09 to Disorderly Conduct.

12. On 10/16/10 at 12:30 am, Milwaukee police responded to Hampton and Fond Du Lac for a Shots Fired complaint. Another caller gave an address of 6530 W Medford in rear parking lot. This caller stated a subject was firing a gun. Upon officer arrival, a total of 12 casings in the alley and the yard were found behind 6530 W Medford. Officers also found a bullet hole in one of the windows at the rear of 6449 W Fond Du Lac Avenue. Officers spoke with Peter Fiumefreddo and the bartender Gregory Bostic as well as other employees. Fiumefreddo stated hey did not know that shots had been fired in the alley behind the bar. Fiumefreddo stated Bostic and another former employee were outside and did hear shots being fired in the alley. Fiumefreddo stated he has video surveillance of the outside and would check for a possible shooter. The video did in fact show a subject firing a gun towards the building. Fiumefreddo stated that there had been two subjects that been thrown out of the tavern earlier in the night for causing a disturbance and believed that these subjects could have been involved in the incident. He further stated he would provide officers with copies of the pictures from the ID's of the subjects that were kicked out of the bar.

- 13. On 09/14/2013 Milwaukee police responded to a Shooting complaint at 6449 West Fond du Lac Avenue (Fremo's). Investigation revealed that the victim, Marcus Lee, and some of his friends had been involved in an altercation with another group while inside the business. Bar security broke up the fight and removed all of the parties involved from business. While in the parking lot of the business, gunshots were exchanged and the victim sustained a gunshot wound to the chest.
- 14. On 10/12/2013 Milwaukee police responded to a Shooting/Homicide at 6449 West Fond du Lac Avenue (Fremo's). Investigation revealed that the victim, Larry Gallien, was employed by the business as a security guard. At the end of the night, Gallien was attempting to clear the parking lot of the business when he became involved in an altercation. Gunshots were exchanged between Gallien and a patron. Gallien died as a result of wounds received during this altercation.
- 15. On 04/30/2013 Officers responded to 6449 W. Fond du lac Ave to investigate a shots fired complaint. The investigation revealed that a known regular customer, who was identified as Maurice S. BAINES (b/m, 07/17/1981), had been drinking in the bar since 11:00pm. BAINES was talking with an unknown female throughout the night. At about 1:30am BAINES began to argue with the female. The bartender Jay RAMSEY, who is good friends with BAINES, attempted to calm him down but BAINES punched RAMSEY in the face. RAMSEY had security throw BAINES out. After escorting BAINES out the security officer was walking back inside and heard 3 gunshots. He turned around and observed BAINES holding a black handgun pointing it in the air. The security guard went back inside and heard three more shots. The applicant came down from his living quarters above the bar at about 2:25am unaware of the incident. The applicant provided access to the surveillance cameras. They showed the incident inside the bar but nothing outside. Officers attempted to locate BAINES that night but could not locate him at home. The information on BAINES was obtained from the bar which takes a picture of all the customers ID cards. Incident #13-120-0017 was filed.

16. On 06/01/2014 Milwaukee police responded to an armed robbery complaint at 6449 West Fond du Lac Avenue (Fremo's). Investigation revealed two people were robbed at gunpoint as they were parking their car in the lot of the business. Milwaukee police incident report #141520175 filed.

17. On 09/16/2015 Milwaukee police were dispatched to an injured/sick person at 6449 West Fond du Lac Avenue (Fremo's Bar). Officers observed a subject had collapsed and stopped breathing outside of the business. Milwaukee police incident report #152590155 filed.

- 18. On 11/05/2015 Milwaukee police were dispatched to an armed robbery at 6449 West Fond du Lac Avenue (Fremo's Bar). Investigation revealed the victim was robbed at gunpoint as she exited her car. Milwaukee police incident report #153100010 filed.
- 19. On 11/07/21 at 8:24pm, Milwaukee Police responded to 6449 W. Fond Du Lac Avenue for a fight complaint. Investigation revealed that a subject became hostile inside the tavern and was asked to leave. The subject then started a fight with other unknown subjects and all had left before police arrival.

On Sunday November 7th, 2021, I responded to the address of 6449 W. Fond Du Lac Av. (Fremo's Tavern), which is in the City and County of Milwaukee, regarding a fight complaint.

Employee Statements:

On scene, I spoke with the employee, identified as Martha J. FISHER, f/w, 9-20-1978. FISHER stated she was not working on today's date but observed a male subject (Description Below) inside the bar who became hostile. FISHER stated the subject was asked to leave, which he stated if he had to leave he was going to start a fight. FISHER stated the subject began fighting with other unknown subjects and eventually left the bar. FISHER stated they will be closing the bar down for the night after the incident.

I spoke with another employee on scene, identified as Karyn A. SCHWARTZ, f/w, 2-21-1975. SCHWARTZ stated she was working on today's date as the bartender. SCHWARTZ stated she observed a male subject (Description Below) inside the bar who became hostile. SCHWARTZ stated the subject was asked to leave, which he stated if he had to leave he was going to start a fight. SCHWARTZ stated the subject began fighting with other unknown subjects and eventually left the bar. SCHWARTZ stated they will be closing the bar down for the night after the incident

You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
