The Milwaukee Police Department's investigation regarding this application revealed the following:

#### LICENSE PREMISE REPORT

This report is written by P.O. Andrew DUDLEY, assigned to District 1, Early Shift, Squad 1242.

On Sunday, August 29th, 2021 at 9:36 PM I was dispatched to a battery complaint at the address of 1323 E Brady St (Jack's American Pub), located in the City and County of Milwaukee, State of Wisconsin.

While I was en route to location Squad 1290, P.O. Christopher PETERSON, and Squad 1410, Sgt. David GRANDSARD, had responded to the scene and located an involved subject, later identified as Hector LOZORNIO (m/w, 05/03/94), who was found to be armed with a firearm and was taken into custody.

I spoke with a manager at the location, identified as Andrew JENSEN (m/w, 09/05/89), who stated that LOZORNIO had been asked to leave the location and had been escorted outside. While in front of the location LOZORNIO became loud and boisterous, put his hand on a firearm that was inside of a holster inside his waistband and stated to JENSEN "You're lucky I don't shoot you right now."

This statement, along with the observation that LOZORNIO was armed, caused JENSEN to take the threat as legitimate and contact police for response.

I spoke with the bouncer of the location, identified as Kyle PARTHUM (m/w, 11/04/85), who stated that LOZORNIO had arrived at the location to complain about his debit card being double charged. LOZORNIO requested to speak with a manager and was informed that he would have to come back during the daytime as no one currently working was able to help with credit card charges. LOZORNIO then began pushing past PARTHUM to enter the location, causing PARTHUM to restrain him and push him outside. PARTHUM stated that JENSEN then arrived and began speaking with LOZORNIO on the sidewalk in front of the location while he remained inside.

A loaded firearm was recovered from LOZORNIO by P.O. PETERSON. I placed the firearm on MPD inventory #21033369. I placed 12 unfired .40 S&W cartridges, 1 from the chamber of the firearm and 11 inside of the firearm's magazine, and a black holster that the firearm was inside of on MPD inventory #21033371.

LOZORNIO did not make any statements regarding any threats made and would only speak to us about

the charges on his debit card.

LOZORNIO's actions were done intentionally and without consent.

LOZORNIO was conveyed to Central Booking for processing. LOZORNIO was processed, released and ordered into the DA's office on 10/18/21 at 8:30am.

JENSEN stated that the location had security cameras that should have captured footage of the incident. Sgt. GRANDSARD collected this footage and informed me that it showed LOZORNIO in front of the location speaking with JENSEN and putting his hand on his holstered firearm that was inside of his waistband. I attempted to view the collected footage but it was unable to be played. Follow up will be conducted to collect a working copy of this footage.

I provided JENSEN with a PV-17, Community Contact Card and a PR-3 order in.

All employees that I interacted with at the location were cooperative during the course of the investigation.

#### INITIAL INVESTIGATION

THIS REPORT IS WRITTEN BY POLLAFAYETTE TURMAN ASSIGNED TO DISTRICT ONE, LATE POWER SHIFT.

ON SATURDAY, NOVEMBER 24TH, 2021 I WAS ASSIGNED TO SQUAD 1431 ALONG WITH PO. ROBERT WATTS. WE WERE OPERATING A MARKED BLACK AND WHITE MILWAUKEE POLICE DEPARTMENT CHEVROLET TAHOE (CAR 331) EQUIPED WITH RED/BLUE EMERGENCY LIGHTS AND AUDIBLE SIREN. WE WERE IN FULL MPD UNIFORMS WITH BADGES AND NAMEPLATES AFFIXED TO OUR OUTMOST GARMENTS. WE WERE EQUIPPED WITH BODY WORN CAMERAS, WHICH WERE ACTIVATED AND CAPTURED THIS INCIDENT.

AT APPROXIMATELY 6:37 PM WE WERE DISPATCHED TO A FIGHT COMPLAINT AT APPROXIMATELY6:37 PM AT 1323 E BRADY ST (WHICH IS IN THE CITY, COUNTY AND STATE OF WISCONSIN) WHILE INVESTIGATING I SPOKE TO SUBJECT-1 WHO IDENTIFIED HIM SELF AS ANDREW P JENSEN (W/M 09-05-89) WHO IS THE MANAGER AT JACKS BAR LOCATED AT THE ABOVE ADDRESS (1323 E BRADY ST). WHILE SPEAKING TO JENSEN HE STATED THAT HE WAS CONEING OUT OF THE RESTROOM INSIDE OF JACKS BAR AND A BLACK MALE LATER IDENTIFIED AS DEONTA D GRIFFIN (B/M 01-13-95) ALONG WITH ANOTHER BLACK MALE HAD BUMPED INTO TO HIM. JENSEN STATED THAT THE THREE OF THEM BEGAN TO HAVE A VERBAL ARGUMENT. JENSEN STATED THAT GRIFFIN THEN GOT AGGITATED AND THEN GRABED HIM AROUND THE NECK ALONG WITH GRIFFIN. JENSEN STATED THAT THE FIGHT THEN WENT OUT INTO THE MAIN NORTH ENTRANCE OF THE BAR.

JENSEN STATED THAT ANOTHER EMPLOYEE OF THE BAR WHO WAS LATER IDENTIFIED AS SANTIAGO LONGORIA (W/M 08-20-83) WAS ALREADY OUTSIDE CAME TO JENSEN AID AND TRIED TO GET GRIFFIN OFF OF JENSEN. JENSEN STATED THAT ANOTHER CO-WORKER LATER IDENTIFIED AS AARON J PHILLIPS (W/M 05-24-95) CAME OUT OF THE BAR TO HIS AID. JENSEN STATED GRIFFIN AND HIS FRIEND (NAME UNKOWN) THEN TRIED TO RUN OFF. JENSEN STATED THEY THEN CALLED FOR POLICE AND HELD GRIFFIN UNTILL POLICE ARRIVED.

WHEN I ARRIVED AT THE SCENE I OBSERVED JENSEN ALONG WITH LONGORIA, AND PHILLIPS HAD RELEASED GRIFFIN. GRIFFIN WAS VERY ANIMATED, WAS YELLING AND ACTING IN PROFANE, BOISTEROUS MANNER WHICH CAUSED A DISTUTBANCE. I ASKED GRIFFIN TO CALM DOWN AND HE STATED "THAT'S JUST HOW I TALK". I ASKED GRIFFIN TO EXPLAIN TO ME WHAT HAPPENED AND GRIFFFN STATED THAT HE WAS TRYING TO GO TO THE BATH ROOM AT JACKS BAR ( LOCATED AT THE ABOVE ADDRESS) AND JENSEN PUSHED AND SHOVED HIM FOR NO REASON. GRIFFIN STATED THAT JENSEN THEN TRIED TO THROW HIS FRIEND AND HIMSELF OUT OF THE JACKS BAR AND A PHYSICAL CONFRONTATION BEGAN.

I THEN EXPLAINED TO GRIFFIN THAT HE WOULD BE GETTING A CITATION FOR DISORDERLY CONDUCT FOR WHAT HAD OCCURRED, GRIFFIN WAS THEN RELEASED AT THE SCENE AND FREE TO LEAVE.

I INFORMED THE MANAGER ANDREW P GRIFFEN THAT A TAVERN REPORT REGARDING THIS INCIDENT WOULD BE FILED, ALL INDIVIDUALS ON SCENE WERE COOPERATIVE.

The hearing before the Licenses Committee will take place virtually on 06/06/2022 at 10:55 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
