I have lived in my house on the East Side since 1985. More and more violent acts have been happening as the years go by in our neighborhood including muggings, car jackings and break-ins.

Since late last year, there have been numerous weekly disturbances during music shows at the Miramar location involving large crowds, high traffic congestion outside the theater on Oakland Avenue, fighting both inside and outside the Miramar Theater and reported gun shots in the vicinity of the theater. These incidents have required a constant and weekly presence by the Milwaukee Police Department since January of this year to be sure activity does not become more volatile. It has negatively impacted the neighborhood and the Oakland Avenue commercial district.

Miramar's operator also owned SITE, a nightclub in the Third Ward, which was shut down last year

I have called the District 1 Police Station numerous times to record these complaints, especially as they relate to dangerous driving and car break ins. I have made several calls in the past two weeks. This behavior that is dangerous and disruptive has escalated, and we can not longer treat the symptoms of the problem. Remove the root cause that is the liquor lisence at the Miramar.

I closely monitor the music schedule at Miramar. There are frequent broken car windows on the swail after shows. There is frequent disruptive, intoxicated behavior and noise nuisances that persist well into the night. This is a residential neighborhood. We are caring, involved community members who see this establishment as a problem. Do not renew their license. I also understand that there is an application for a liquor lisence at 2865 N. Murray Ave, on the corner of Murray and Locust. There should not be a hearing of this process until the Murray Hill Community has elected an Alderperson to represent the district.

We write in opposition to the renewal of the class B tavern license for The Miramar Dance Club located at 2844-46 N. Oakland.

We live of The Miramar and over the past year the drunken and boisterous crowds of the tavern's patrons have negatively impacted our already over-parked neighborhood by littering our property and interrupting our sleep. While most of the disruption we've experienced occurs following closing time, on one occasion this winter, gunfire broke out around 9:30 p.m. in front of our son's home located at 2812 N. Oakland Avenue, causing him to grab his 3 year old daughter from her front-bedroom and flee to the rear of his home in fear of her life. Police we contacted in that case and an incident report filed.

The real question that occurs to us is how this business, given its known history, was permitted to locate in an otherwise peaceful neighborhood in the first place?

For the future safety and stability of our neighborhood it is our sincere request that The Miramar's class B license be denied.

This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 02/10/2018 officers responded to The Miramar Theatre for a possible tavern violation. The officer spoke with Aaron OHLSSON who stated for the past 7 years he has run the business for William STACE, who holds the license. OHLSSON stated that STACE fell behind in the rent so he took over paying the rent, and eventually took over the lease after STACE was evicted. OHLSSON stated he did not have a B Managers license. The two subjects who stated they were bartenders did not have Operators licenses. OHLSSON was advised he could not serve alcohol without a licensed bartender on scene. The officer spoke with STACE by phone. He stated he fell behind in the rent and was evicted in July 2017. He stated he removed his occupancy but did not remove the other licenses. STACE stated OHLSSON was operating under his license without permission. On 02/11/2018 officers conducted another tavern check at The Miramar. OHLSSON was on scene and stated he was responsible for another event. There was a licensed bartender on scene. STACE and OHLSSON were cited for Collusive agreement and STACE was cited for responsible Person on Premises.

Charge: Collusive Agreement Prohibited Finding: court date 04/06/2018 Sentence: Date: Case: 6164266 2. On 02/16/2018 an officer responded to The Miramar Theater, 2844 N. Oakland Av, for a tavern check. This check was based on several phone conversations with Attorney David HALBROOKS; who represents William STACE, the agent of The Miramar. HALBROOKS was advised to turn in the liquor license if he wanted the business closed down. When the officer arrived at 10:00pm he spoke with Aaron OHLSSON, who runs the theater but the license is in STACE's name. At 11:50pm the officers returned to do a count of patrons at the sold out show. The officers were positioned at all points of entry/exit and a count was performed as the patrons exited. The total count was 465 and the DNS capacity is 327, leaving the theatre 138 over capacity. OHLSSON did know his capacity but stated he thought he was allowed to include the capacity of the adjoining tavern (Stage Right). Officers will be requesting a meeting with STACE and HALBROOKS at which time STACE will be issued a citation for over capacity.

# 3. On 05/18/2018 a subject in the back stage area of the Miramar Theater, 2844 N. Oakland Av, grabbed a fire extinguisher and sprayed his friend. This caused a disturbance and the subject was cited for Disorderly Conduct.

4. On 02/08/2019 the applicant was charged in Waukesha County with Fish >3 Hooks/Lines (Forfeiture).

- 5. On 06/01/2019 officers were dispatched to a shooting at Miramar Theater, 2844 N. Oakland Av. The officer spoke with the applicant who stated he was having a 17 and over event and had sold 150 tickets. He stated an outside promoter organized the event and provided three unarmed security officers. The officer observed security cameras but the applicant stated they were not operational but he would be installing new ones in the future.
- 6. On 06/03/2019 an officer went to The Miramar Theater for follow up regarding the shooting on 06/01/2019. The officer found the building unlocked but empty. The officer contacted the applicant, who then responded to the scene to secure the building. On 06/05/2019 a meeting was held at the District regarding the shooting. The applicant stated a promoter rented out the space and only expected 40-50 people. He stated 100 people showed up and believes a performer was being targeted. An altercation occurred near the stage and people were escorted outside when shots were fired. The applicant believes pad downs were conducted at the door but was not sure if it occurred. The applicant stated he would not use that promoter anymore, would conduct pad downs at the door, and would purchase an ID scanner and metal detector wand. He also stated new cameras would be installed on 06/07/2019. The Captain requested the applicant have a walk through conducted after the upgrades where completed. On 07/19/2019 an officer went to the business to check on the new cameras but the business was closed. The officer attempted to leave a message for the applicant but his mailbox was full.

- 7. On 07/24/2019 officers conducted follow up at The Miramar Theater to see if they complied with the security plan from the 06/05/2019 meeting. The applicant showed the officer the updated security system with 16 cameras, a portable ID scanner, a metal detection wand and stated two additional cameras would be added outside to monitor the front of the building.
- 8. On 10/31/2019 the applicant was cited in the City of Milwaukee for Noise Nuisance.

10. On 11/12/2021 at 12:04am officers were dispatched to a Subject with Gun at The Miramar Theater, 2844 N. Oakland Av. The officer spoke with security, who stated they had kicked out a patron for climbing on ledges. The subject came back inside and they escorted him out again. He then turned around and had a gun in his hand. The subject racked the slide, pointed the gun at them and stated "Fuck y'all". The subject then fled down the street and got into a car. The officers spoke with the applicant, who stated he was not present during the incident. The applicant did provide officers with video of the incident.

- 11. On 12/01/2021 officers on patrol observed a fight outside the Miramar Theater, 2844 N. Oakland Av. The fight grew to 30-40 people and additional squads had to be called to break up the fight. The officers conducted a license premise check at The Miramar Theater and spoke with the applicant. The applicant stated there were 5 bartenders and 7 security officers. The applicant stated he was charging a \$20 cover and was patting down patrons. The officer asked if they were using an ID scanner and a wand and the applicant replied they were not. The officer observed the business was selling "Hookah" and the applicant confirmed it contained tobacco. The officer also observed there were patrons dancing and that was not listed on the PEP issued to the business. The officer asked where the cover charge was posted and the applicant stated he has never posted a cover charge. The officer issued citations for Cigarette and Tobacco License Required, Tavern Charges to be Posted and Public Entertainment Premise-License Required.

  - 12. On 02/18/2022 at 3:00pm a meeting was held at District 1 regarding The Miramar Theater. The applicant was present and stated he has been hosting R&B nights on Tuesdays. He stated the events have been growing in size and is requesting additional patrols. He stated he has capped the capacity at 250 on these nights and people are upset when they turned away. He has had a subject walk to his car and return with a firearm to threaten security. He now has armed security patrolling 4 blocks around the theater in marked squad cars. The applicant requested additional patrols at closing time on Tuesdays.

On Friday, November 12, 2021 at approximately 12:04 am, Squad 1321 (myself in full-duty uniform equipped with an activated Axon Body-Worn Camera and in a marked squad car) was dispatched to the Miramar Theatre at 2844 N. Oakland Avenue (located in the City and County of Milwaukee) for a Subject with Gun call. Squad 1330 (PO Justin ARREDONDO) was also dispatched.

Upon arrival, I spoke with the two victims of this incident who identified themselves as Dylan R. SCHULTZ (m/w, 03-22-92) and Darien T. LOPEZ (m/h, 12-28-89). SCHULTZ and LOPEZ are employed as security guards for the business. LOPEZ stated that there was a patron who kept climbing onto ledges where he was not allowed. LOPEZ said that he told the patron twice to get down and the third time he climbed up, LOPEZ had to escort him out of the business and stated he was no longer allowed inside. LOPEZ stated that they patron twice to get down and the third time he climbed up, LOPEZ had to escort him out of the business and stated he was no longer allowed inside. LOPEZ stated that the patron left for approximately 2 minutes and then came back inside of the location. LOPEZ and SCHULTZ both stated that they had to grab the subject and took him outside again. SCHULTZ said that when they got outside of the doors, the male had his back turned and when he turned towards them, the subject had produced a handgun. SCHULTZ stated that the subject racked the slide of the handgun back and pointed it at him. LOPEZ said that the subject pointed the handgun at SCHULTZ and himself. At no point were shots fired. LOPEZ stated that the subject only stated "fuck y'all." The subject was described as the following:

Hispanic male, armed with a semi-automatic handgun, 20-22 years old, 5'05", thin build, blond hair pulled back into a ponytail, last seen wearing a yellow hooded pullover sweatshirt.

SCHULTZ stated that the male was last seen going northbound on N. Oakland Avenue. SCHULTZ told me that two other patrons who had witnessed this, but were no longer on scene, saw the subject get into a vehicle. They stated the license plate was either AJF-3434 or AJF-3437. SCHULTZ said that they described the vehicle as a red Mini Cooper. It should be noted that neither of these license plates register to a vehicle even close to that description.

I spoke with the owner of the Miramar Theatre, Aaron R. OHLSSON (m/w, 01-03-90). OHLSSON was not present during the incident but was able to review camera footage. OHLSSON stated that the only camera was able to capture the subject, but the angle was cut off during the actual incident of the subject pulling out the handgun. OHLSSON stated that he would be able to send me the video regardless. I sent OHLSSON an invitation through evidence.com to submit the video. OHLSSON did submit the video and upon reviewing the video, it does show the subject pointing a firearm at the business, but the victims are not in frame. The following is a description of the video:

The camera is located on the west side of the building and points northbound, showing the sidewalk and front entrance of the business. The video begins at 12:00:27 am. It should be noted that the camera is too far away to get a clear view of the suspect's face, however the suspect can be seen based on his clothing description. The subject enters the camera view at 12:00:55 am walking southbound towards the entrance. The suspect enters the business at 12:00:58 am, exits again at 12:01:03 am, and appears to move something from his sweatshirt pocket to the waistband of his pants in the back. The suspect then reenters the business at 12:02:10 am, the suspect exits again with his back to the camera, facing north. He then turns around and lifts up his left arm, pointing the handgun towards the

entrance doors. He then lowers his arm and holds the handgun at his side. At 12:02:14 am, an unknown subject comes out and pushes the suspect away from the building. This unknown subject and the suspect walk away northbound on N. Oakland Avenue and they both leave the camera frame as the video ends at 12:02:23 am.

This case is pending.

I am currently assigned as a patrol officer at District One, Late Shift. I have 10 years of experience with the Milwaukee Police Department. I am a certified Wisconsin Law Enforcement Standards Board (LESB) instructor for the following topics; Standardized Field Sobriety Tests (SFSTs)/Operating While Intoxicated (OWI), Emergency Vehicle Operation and Control (EVOC), Vehicle Contacts, Scenario Instructor, General Law enforcement Instructor, Nark II Pouch Instructor (narcotics identification and testing), and Pursuit Intervention Technique (PIT) Instructor.

I has also received additional training in recognizing characteristics of an armed individual, and advanced roadside impaired driving enforcement (ARIDE) as it relates to OWI related investigations. In my 10 years of service to the City of Milwaukee I have been involved with numerous investigations regarding OWI related offenses, drug related offenses to include distribution of narcotics, and weapons violations which includes robbery or Reckless Use of Weapons violations. I was also assigned as the District Seven License Premise Officer and handled investigations as it related to licensed premises throughout District Seven for approximately 3 years.

On Wednesday, December 1, 2021 I was assigned to Squad 1369 with P.O. Jacob ROECKER and was operating Milwaukee Police Department Squad Car 118. Car 118 is a fully marked squad car equipped with an external emergency light bar, an emergency siren, and an Axon Dash Camera system.

I was in full Milwaukee Police Department Uniform and am equipped with a personal worn Axon Body

While on patrol in the area we noted that there was a vehicle parked blocking the right traffic lane in front of Miramar Theater, located at 2844 N Oakland Av.

We pulled behind the vehicle and prior to being able to take any police action regarding the illegally parked vehicle we noticed a fight between individuals at the front door and security removing people from inside of the bar. The fight consisted of 3 to 4 individuals and security.

Within a matter of seconds the fight grew to an estimated 30 subjects involved and police officers were called into the area to assist in removing the crowd.

I observed one subject seated in the driver's seat of a truck yelling at another individual who was walking towards him. The second individual was a B/M in his early 20's wearing a gray hoodie. I observed this individual lift his shirt slightly and use his right hand to grab something in his waist band. These are indicators of an individual who is armed with a weapon. Another person started to yell "he has a gun". I noted that the subject reaching into his waist band was focused and giving the subject in the truck a "1000 yard stare".

I utilized my flashlight to get his attention and began to yell commands for him not to do it. During this time I transitioned to my firearm and was carrying it in the Sul position, or carried pointed down close to my chest. I had my firearm in this position in the event the actor drew a weapon from his waist band. The subject did not display a weapon and we were unable to see one. The subject retreated back to a vehicle and fled the scene.

Once the crowed dispersed I conducted a tavern investigation check at the Miramar Theater.

I spoke with the owner, Aaron R OHLSSON (W/M, 1/3/90), regarding my concerns and informed him that I would be doing a "Tavern Check". This check is to ensure the businesses compliance with the City of Milwaukee Ordinances regarding the operations of a tavern.

During the investigation OHLSSON informed me that for security they had 7 guards and that they were deployed as follows;

2 stationed at the entrance

1 stationed at the exit

1 at the side door

1 on the stage

1 in VIP

## 1 Roaming

He also informed me that he had 5 bartenders working at the time. The contact information for the 5 bartenders and for the head of security are listed above. It should be noted that all 5 bartenders have valid Class D Bartender's Licenses.

I observed that the license for the business were properly posted, but that they did not have their occupancy limit posted properly. OHLSSON informed me that the frame for the occupancy limit sign broke last week and he was unsure where it was, but would have his employee find it. A short time later a female employee handed him the occupancy limit sign in a wooden frame and when she was asked where it was she informed OHLSSON that it was on his desk under all of his paperwork.

I asked OHLSSON if he was charging a cover charge during the night and he stated that there was a \$20 cover charge at the door. When asked where that was posted OHLSSON stated that it was not posted and that he has never posted his cover charge in the past. I informed OHLSSON that this is a violation of

I asked OHLSSON what his security measures were during the night and he informed me that they do extensive pat downs of all of their customers, and that they have a security wand, but when asked if the wand was in use he stated that it was not as they felt the pat downs were sufficient.

I later spoke with his head of security, Hector M GARCIA JR (B/M, 9/19/84), who informed me that the reason they were not using the security wand is because it is broken. When I looked to OHLSSON for an explanation he stated that he has one in his "Amazon" shopping cart and hopes that it will be here the next day. He did not elaborate why he did not tell me it was broken to begin with.

When asked if they utilize an ID Scanner they stated that they did not. I later was able to review their application for their license and observed that it stated that for security measures they would utilize both a security wand and an ID Scanner.

I also informed OHLSSON that when we came into the business I observed patrons dancing and he acknowledged it. I informed OHLSSON that his posted Public Entertainment Premises (PEP) license does not allow for patrons dancing, and OHLSSON stated that he did not understand as he always has people dancing. I conducted a check in LIRA and confirmed that OHLSSON did not request "Patrons Dancing" on his PEP application.

I also noted during my Tavern Check that OHLSSON was selling Hookahs. I asked OHLSSON if the Hookahs he sold contain any tobacco products and he stated that they do. I asked OHLSSON if he has a Tobacco License to allow for the sale of Tobacco products in the City of Milwaukee and he stated that he does not. This was again confirmed in LIRA.

I informed OHLSSON that I would be speaking with him again in the future regarding this incident.

On Friday, February 18th, 2022, at 3:00PM, while assigned to squad 1264 with P.O. Molly PLUMLEY, a meeting was conducted at 749 W. State St. on the 7th floor with the agent on file OHLSSON, Aaron R. (W/M 01/30/1990) regarding the Miramar Theatre at 2844 N. Oakland Ave. OHLSSON requested this meeting due to concerns of potential gun violence, especially when they turn patrons with guns away. OHLSSON mentioned that he wanted to reach out due to two fights at the location, and a shots fired incident down the street shortly after the location closed for the night.

Present at the meeting was City of Milwaukee Alderman Nik KOVAC, Alderman KOVAC's Legislative Assistant Amanda CERVANTES, City of Milwaukee Attorney Meighan ANGER, Sgt. David GRANDSARD, Sgt. Vincent WOLLER, and Lt. Robert THIEL.

OHLSSON stated late August 2021, the Miramar Theatre began hosting RnB nights on Tuesdays. OHLSSON stated these events are not and have not been advertised by the Miramar Theatre. OHLSSON stated the amount of people attending these Tuesday night events have grown the past 3-4 months and is attracting people now they do not want. OHLSSON stated regular patrons to the bar have stopped attending due to the popularity of this event growing in popularity over time. OHLSSON stated he has capped capacity to 250 occupants, and turns away many people due to this. OHLSSON stated multiple people trying to get into the location have offered money, even \$200 to get into the location, but are turned away. OHLSSON stated they have an issue with people lining up outside the door for an hour, even though they are told they are not going to be able to let them in. OHLSSON stated by 1AM, the location is closed. The cover at the door is \$40 to enter.

OHLSSON stated there was an incident where a suspect walked down the block to his vehicle, obtained a firearm, came back to the location and pointed the firearm at the face of the security guard. This security officer has since quit due to this, per OHLSSON. OHLSSON stated due to his concern with people walking back to their vehicle to obtain firearms, and come back, he has implemented 4 security guards at the entrance to pat down patrons upon entry. The security guards per OHLSSON are equipped with metal detector wands. The security guards are armed with a firearm, wear bulletproof vests, and patrol the neighborhood in a 4 block radius, operating vehicles which look like police cars. Lt. THIEL stated while reviewing an officer's body camera footage on one of our calls for service at the location, he thought the security officers were MPD officers. OHLSSON was asked by PO PLUMLEY if the Milwaukee Police Department was notified of the armed guards making a presence in the area. OHLSSON answered stating some MPD officers were inside the establishment and saw they had armed security.

OHLSSON stated Tuesdays only people 21 years and up in age are allowed into the location. When there are nights where 18 year old are present, OHLSSON stated they differentiate between 21+ and under agers with an X or stamp on the hand and wristbands. OHLSSON indicated that things are peaceful inside the location on Tuesday nights, by saying people are arm in arm singing "Mariah Carey".

OHLSSON requested extra patrol at minimum during closing on Tuesdays' R&B Nights, and also work with the district on the possibility of getting an officer on an overtime assignment. It was suggested by MPD that Community Liaison Officers conduct a security survey of the location.

This concludes my report.

The Miramar Theater located at 2844 N. Oakland Av. PA PELZEK attempted to purchase an alcoholic beverage , but was denied by the bartender, who asked PA PELZEK for identification.

Police Officer MARTINEZ and Police Aide PELZEK asked for a refund of \$40 for the cover charge but were denied by the bouncer.

The Miramar Theater was informed that they have successfully passed on Saturday April 30, 2022 at 6:18 PM the underage tavern enforcement initiative check.
