#### **ADDITIONAL COMMENTS/RECOMMENDATIONS:**

The amount of security that is staffed will depend on the event that is happening. The surveillance cameras are owned and operated by the Wisconsin Center. The plan is to have movable bars that are not permanently built into the building. There was concern about a bar being set up in a hallway to the West of the stage. This bar could be a fire hazard as well as an issue for patrons who might need a wheelchair. This establishment will have events that allow underage patrons however, it will be the responsibility of the bar tender serving patrons to check ID's. The first show for this establishment is booked for the first week in August. This Agent is also working with Planning and Logistics to have an MPD member for the events booked. The Wisconsin Center owns the building and will still have private events held here. PTG Live Events is planning on using the Western entrance and exit on Kilbourn Av as their main point of entry which is where metal detectors will be placed.




# City Concentration Map - 500 W Kilbourn AV


