According to records of the City of Milwaukee, you are the owner and/or operator of the property identified above. This letter is to notify you that the building or structure located on your property is being used to facilitate the delivery, distribution or manufacture of a controlled substance, or is a building or structure where those acts take place, and therefore is a public nuisance pursuant to Wisconsin Statute § 823.113.

Please contact P.O. Michael Ward at 414-935-7198 upon receipt of this letter. Do not disregard this notice. As the owner and or operator of this property, you must take IMMEDIATE action to abate the nuisance activity at this property. If you fail to respond to this notice and/or fail take action to abate subsequent nuisance activity, Wisconsin law permits the City of Milwaukee to seek a court order declaring the property a public nuisance and ordering the property closed and sold with proceeds retained by the City to pay abatement costs, liens, and the remainder split between law enforcement, alcohol and drug abuse assistance programs and community development organizations.

Please review the following nuisance abatement measures that you may employ to prevent the continuance or reoccurrence of drug dealing and other nuisance activity at your property. These suggestions are not exclusive and you may use other nuisance abatement measures that are appropriate in the particular circumstances of your property:

- Participate in a local block watch or neighborhood association.
- Exchange names and telephone numbers with the owners of buildings on each side of your property,
- Attend the monthly crime prevention meetings conducted at your local Milwaukee Police District Station, Information on these meetings may be obtained through the District Community Liaison Office at 414-935-7198.
- Monitor the property for evidence of drug activity. This may include observation of clear corner cut
 baggies strewn about, excessive quantities of plastic sandwich baggies found in odd places, presence of
 numerous weight scales or communication devices and drug paraphernalia such as unusual pipes, blunt
 wrap packaging, burned hollow tubes, etc.
- Installing "No Loitering" signs and "No Trespassing" signs in the front and rear of the exterior of the property.

If the above-referenced property is a residential rental property and the nuisance activity has occurred in a tenant's rental unit or was caused by that tenant on your property, you may use this notice to provide a five day notice to vacate the property pursuant to Wisconsin Statutes § 704.17(1)(c), (2)(c) and (3)(b). In addition to the potential eviction of tenants, other nuisance abatement methods for landlords to consider include:

- Participating in the Department of Neighborhood Services Landlord Training program and make a
 good faith effort to apply the knowledge from the course and attend refresher classes. Information on
 this training program may be obtained by calling 414-286-2954.
- Participating in the local block watch, neighborhood association, landlord compact and property management association.
- Instituting the use of written screening criteria that are provided to each applicant at the time each proposed adult resident receives the written application.
- Conducting background checks on all prospective adult tenants and residents.
- Instituting the use of a written leases for each adult tenant that include provisions relating to disorderly behavior, noise, garbage disposal, use of common areas, illegal activity, tenant responsibility for guest conduct, and the prohibition of subleasing and long-term guests. Timely enforce any lease violations.
- Reviewing the tenancy of any other current residents of the property. This may include the termination
 of tenancies and reapplication by existing tenants for new tenancy.
- Regularly inspecting the interior of the residential rental property to confirm that the residents are your tenants, confirm that the premises are actually used as a residence and determine if the doors or windows have been fortified or the premises outfitted with surveillance or delivery mechanisms.
- Installing a sign with your name and contact information in a common area requesting law enforcement to contact you if they are responding to a call for service at the property.
- Recording with the Department of Neighborhood Services all properties owned or operated by you and
 participate in the e-mail notification system.
- Regularly filing open records requests for Milwaukee Police Department computer aided dispatch system (CADS) reports regarding the property.
- Instituting a standing complaint with the local Milwaukee Police District that would allow the Police Department to remove any individuals loitering on the property.
- Providing the local Milwaukee Police District with updated current tenant lists.

This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 02/13/2004 the Wisconsin Department of Transportation revoked the applicants drivers license for six months for Operating While Intoxicated.
- 2. On 07/24/12, applicant was convicted of OWI in Milwaukee County. His license was revoked for 13 months + 90 days.

3. On 01/01/2015 the applicant was cited at 6541 South 13th Street in the city of Milwaukee for Chronic Nuisance Premises.

- 5. On 05/06/15 at 1:35 am, Milwaukee police responded to 6541 S 13th Street for a Theft of Vehicle complaint. Investigation revealed a customer picked up a prostitute in the area of 12th and Greenfield and brought her back to his room. He went into the bathroom and when he did, heard the door to his room close and when he went out to the room, found his pants and noticed that his keys to his car were gone, as well as his wallet and cash. Officers spoke with the clerk on duty and asked to view surveillance video, but the clerk did not know how to operate the system. Police returned on 05/06/15 and were able to view the surveillance tape. No cameras were where the vehicle was parked.
- 6. On 06/05/2015 at 10:32am officers responded to Econo Lodge, 6541 S. 13th St, for a subject with a gun. The investigation revealed a domestic violence incident where the ex-boyfriend was knocking on the door yelling to open the door or he would kill everyone in the room. No gun was observed and the subject was located walking away. The subject stated he did not have a gun, he just came to get his stuff. The subject was arrested.
- 7. On 08/18/2015 a possible sexual assault occurred at the Econo Lodge, 6541 S. 13th St. The victim reported going to the room with the suspect and waking up alone with her pants off. Officers went to the Econo Lodge to check for a crime scene related to a sexual assault in room #241. The officers arrived and found the room was already cleaned.
- 8. On 09/07/2015 at 1:52pm officers responded to Econo Lodge, 6541 S. 13th St, for a Sudden Death investigation. When the officers arrived they found MFD Engine #14 on scene in room #143 with the deceased, Christopher GARRISON. The investigation revealed GARRISON had a life-long drug addiction and heroin was found in the room. The witness stated for several days he heard people knocking on the window to room #143 and thought GARRISON was selling heroin.
- 9. On 11/08/15 at 4:20 pm, responded to a RES complaint at 6541 S 13th Street. The victim stated that someone had shot a bullet hole into his hotel room and that management refused to call police. The victim came to District 6 to file a complaint. The victim stated he was living at the Econo Lodge with his family for

one month and had been living in another hotel because of threats to his family from a tenant he had to move from that location. The victim stated at 6 am, he woke up and walked into the bathroom to wash up and noticed a large hole through the bathroom mirror and another hole in the side wall. Glass from the mirror had been shattered in the sink and on the floor. The victim believed a bullet had been fired into his room, though he, nor his family, heard the noise. The victim further stated he called the front desk, Pam SINGH, to notify her of what he found and requested she come to his room to inspect what happened. SINGH stated she had a lot of things to do at the time, but would see him later. Ms. SINGH came to the room about 7 am and observed the damage, stating to the victim the damage was minor and that she would have someone come to clean it up. The victim requested that the police be called because he believed it was related to the prior threats to his family from the other hotel. Ms. SINGH refused. The victim stated that the hotel security guard Leslie JOHNS, also came to his room and also inspected the damage, as well as the adjoining room of where the damage occurred. The victim took pictures the damage from the adjoining room when the security guard grabbed the victims phone stating he could not take pictures of the damage and deleted the pictures that were taken. The owner of the hotel, Sanjay PATEL, was called by the security guard who advised him of what occurred. PATEL then spoke with the victim who told PATEL that he wanted police called regarding this matter. PATEL then stated to the victim that if police were called, PATEL would evict him and his family. At approximately 12:00 pm, the victim stated he noticed hotel staff cleaning the adjoining room from where the bullet came from. At 1:35 pm, hotel staff knocked on his room door stating they were there to clean up the damage in the bathroom and that if he didn't let them in, he was going to be evicted. The victim later advised police that he had recorded the conversation with Ms. SINGH refusing to call police. Police later spoke with Ms. SINGH who denied saying she refused to call police and was doing just what the security guard told her to do. Police also spoke with the owner, Sanjay PATEL, who came to the scene. PATEL denied refusing to call for police and stated that no one advised him about bullet holes in any rooms. PATEL further stated that the security guard told him that a mirror had been broken. Supervisors were called to the scene and Ms. SINGH was arrested for Obstructing an Investigation, cited and later released from the station. The security guard was also cited for Obstructing. The owner, Sanjay PATEL, was cited for Chronic Nuisance Premise. An investigative alert was filed for the possible known suspect. Case Pending.

- 10. On 11/09/15 at 9:52 pm, Milwaukee police were dispatched to 6541 S 13th Street for a Soliciting complaint. Police spoke with security officer for the hotel Leslie JOHNS who stated the renter of room #142 may be involved in soliciting because there have been men going in and out of their room all day. Police spoke with the subject in room #142 and identified her as Terry Ann CARRILLO. A wanted check was done and the subject was found to have warrants for her arrest that included Loitering/Soliciting. Another subject in the room was identified as Laquinta YOUNG, also had an outstanding warrant. Both subjects were arrested and advised to not return to the property.
- 11. On 03/10/2016 a meeting was held at District 6 regarding Econo Lodge, 6541 S 13th St. The applicant was at the meeting with his attorney, Vincent BOBOT. Also at the meeting were ACA Nick DeSIATO and Captain Diana ROWE. The applicant gave plans for improving the property which included posting No Loitering signs, installing new cameras, repairing and installing new exterior lighting, repairing the exterior doors to lock from the outside and hiring security. The applicant was advised to have employees monitor the halls for people gathering and soliciting. On 04/09/2016 an officer went to conduct follow up on the presented plan. The officer found signs by several doors but no sign by door #3. There were several exterior lights not working and the cameras appeared to be three different styles, some seemed to be older models. Two of the cameras were facing the ground or at a low angle. The officer found the exterior doors locked but could be opened if pulled hard. Door #3 was not locked at all. There was a SPI car driving through the parking lot. The security guard stated he patrolled several businesses in the area from 7pm to 2am. The front desk is keeping track of vehicle license plates of short term renters and one long term tenant.
- 12. On 03/15/2016 at 5:20pm officers were dispatched to Econo Lodge at 6541 S. 13th St for a trouble with subject. The caller was a resident of the hotel and observed a male and female shooting heroin while seated in a van in the rear parking lot. A check of the registration revealed the van was listed to Best Medical Transport. The owner of the van provided the name of the employee, Tracy CLAYTON. Her room number was located in the hotel and she admitted to police that she and her husband, Kurt CLAYTON, had smoked "crack" and injected heroin in the vehicle. CLAYTON and her husband were cited for Possession of Drug Paraphernalia.

13. On 04/21/2016 officer responded to Econo Lodge, 6541 S 13th St, for a trouble with subject call. The caller was SPI Security guard Thomas JAHNKE. He stated he was told by the clerk to check a room for subjects smoking "crack". He went in the room and found a crack pipe so he called police. JAHNKE took the officers to the room. The officer observed an ashtray with a decorative golf club but no crack pipe. JAHNKE was asked where the crack pipe was and he pointed to the decorative golf club. He was advised it was part of the ashtray and not a crack pipe. The applicant was not on scene and the only number for him is the hotel number.

14. On 09/24/16 at 10:18 pm, Milwaukee police were dispatched to 6541 S 13th Street for a battery complaint. Investigation revealed occupants in the hotel had gotten into an argument. Both subjects were intoxicated and issued disorderly conduct citations. The licensee, Sanjay Patel, was advised of the incident and Patel advised the male subject that he was no longer allowed on the property.

15. On 05/24/19 at 6:30pm, Milwaukee Police were dispatched to 6541 S. 13th Street for a theft complaint. Officers interviewed the caller who stated that a maintenance worker entered her room without knocking, so she went to complaint to the front desk. When she returned, she noticed that there was money missing from her purse. The caller then went to the front desk, told the clerk what happen, and the clerk gave the caller some money. Officers interviewed the front desk clerk who stated that the caller did complaint to her about the maintenance worker (whom she talked to and he stated that he did knock on the door) and she did refund her some money because the caller was yelling and screaming, so she wanted to avoid a disturbance. The clerk also talked with neighboring rooms who confirmed that the maintenance worker did knock on the callers' door. A report was filed.

16.On 07/13/19 at 1:19am, Milwaukee Police were dispatched to 6541 S. 13th Street for a fight complaint. Upon arrival, officer's observed 20 subjects in the lobby upset and arguing with the desk clerk but no active physical fight. The subject in the lobby were complaining that there rooms had bed bugs and wanted a refund, but the front desk clerk refused to give refunds. The clerk was asked to call the manager to see if he could approve refunds to the customers. The manager approved the refund distribution and the clerk gave refunds to the subjects.

17. On 05/15/20 at 10:51pm, Milwaukee Police were dispatched to Econo Lodge, 6541 S. 13th St for a property complaint. Officers spoke with the employee of the hotel, who stated that an unknown black subject entered the location complaining about credit charges. The clerk stated that the subject was upset and irate

regarding the charges. The clerk stated that he initially called for police but the subject then left the location. A short time later the subject returned with a baseball bat to the location and damaged the plastic partition at the front desk. The suspect then entered the employee area and damaged two credit card machines and a printer. The suspect then left the location before police arrival. The business was cooperative with the investigation and provided police video of the incident.

- 18. On 07/10/21 at 4:00pm, Milwaukee Police officers from District 6 held a meeting at Econo Lodge, 6541 S. 13th St. The meeting was conducted regarding police calls for service, and safety/security concerns. The meeting covered from a previous premise check that doors were observed propped open and some doors would not secure properly. Camera concerns regarding placement were addressed. There was no camera placement that covered exits and entrance doors to the building (5) and including the main entrance. The concern stemmed from employees not being able to see who is exiting /entering the building. From the time period of 06/1/19 to 07/7/20 the location had 23 Trouble with subject, 7 Batteries (non DV) and 5 additional calls of service. The mangers were advised the proper hiring of a security company could help deter some calls for police service. The managers were cooperative at the meeting and stated they would addresses the issues covered with the owner of the hotel.
- 19. On 08/10/20 at 4:10pm, Milwaukee Police along with DOC Agent Handrow conducted a wanted check of an offender for a probation violation at the Econo Lodge, 6541 S. 13th St. The hotel was cooperative with Police and notified law enforcement personal when the offender returned to the hotel. The offender was located in a vehicle in the parking lot. The subject was placed in to custody and conveyed to District 6 to be processed.
- 20. On 12/06/20 at 10:11am Milwaukee Police were dispatched to Econo Lodge, 6541 S 13th St, for a trouble with subject complaint. Officers spoke with the manager who requested that a hostile customer be removed. The customer attempted to fight with staff for vacuuming and rolling carts through the hall ways. Officers located the individual and escorted him off the premise.
- 21. On 01/01/21 at 3:42am Milwaukee Police were dispatched to Econo Lodge, 6541 S 13th St, for an overdose complaint. Officers met Milwaukee Fire Department personal in room #251. The Fire Department stated that they had to administer narcan to the female subject, who was unresponsive. The female subject was with her husband and refused to go to the hospital for further medical evaluation. Officers did not locate any narcotics in the room and advised the female subject to seek medical treatment. The female subject still refused and the husband was advised to watch his wife overnight.

- 22. On 01/05/21 at 6:30pm Milwaukee Police officers from District 6 held a Safety Security meeting at Econo Lodge, 6541 S. 13th St. One of the concerns of the meeting was on multiple checks finding doors throughout the hotel propped open and un secured. Officers spoke with management and expressed the continued concerns of propped open doors. The management was advised to continued perimeter checks of the building. Officers discussed the calls for service from 11/01/20 to 01/0/21 the drug overdose call for service was discussed. The management stated that they generate a Do Not Rent List based on the police calls to the hotel. The management was advised officers would be conducting quarterly checks of the hotel and would discuss issues regarding.
- 23. On 01/21/21 at 4:48pm Milwaukee Police were dispatched to Econo Lodge, 6541 S 13th St, for a family trouble complaint. Officers spoke with the caller who stated that his estranged wife keeps harassing him by coming around and knocking at his door. Investigation revealed that a restraining order was activate but since lapsed, and the wife was not located on the premise.
- 24. On 01/24/21 at 8:05pm Milwaukee Police were dispatched to Econo Lodge, 6541 S 13th St, for a call for police. Officers spoke with the front desk that identified a guest who had blood on her fingertips staying in room # 236, but left the location in a vehicle. The officers checked the room and did not observe anyone in the room or any signs of a struggle (no blood damaged items) Officers called back the phone number attached to the assignment serval times with no answer. Officers were unable to determined what occurred and where.
- 25. On 01/27/21 at 4:41am Milwaukee Police were dispatched to Econo Lodge, 6541 S 13th St, for trouble with subject complaint. Officers spoke with the front desk who stated that a subject was causing a disturbance at the hotel. The subject became upset and irate when staff denied giving her a new key card. The staff asked officers to escort the subject out of the hotel prior to check out time, that was 11:00am the same day. Both subjects in the hotel room voluntary complied with officers and left the hotel premise.
- 26. On 02/06/21 at 12:07am Milwaukee Police were dispatched to Econo Lodge, 6541 S 13th St, for a welfare check. Officers spoke with the front desk clerk who stated that other staff heard crying and screaming from room #127. Staff checked on the room but no one answered the door. Officers made contact with the guest who stated that she suffers from chronic migraines and body pain. The subject stated that she heard the door knocked on earlier but was in too much pain to answer. No medical or police services were requested by the subject.

- 27. On 04/29/2021 at 4:09pm officers were dispatched to a Trouble with Subject at Econo Lodge, 6541 S 13th St. The officers spoke with the manager, who stated a customer needed to be removed. The officers located the subject and he left without incident.
- 28. On 04/30/2021 at 6:04pm officers were dispatched to a Trouble with Subject at Econo Lodge, 6541 S 13th St. When the officers arrived they observed a female near the front door, that began walking away when she observed the officers. The officers spoke with the clerk, who stated the female had been kicked out the night before and was not supposed to be on the property. The officers then observed the subject across the street walking away. The clerk was advised to call if she returned.
- 29. On 05/05/2021 at 3:57pm officers were dispatched to a Trouble with Subject at Econo Lodge, 6541 S 13th St. When the officer arrived he advised a female, who was loitering on the property that she had the leave. The subject left without incident.
- 30. On 05/23/2021 at 9:22am officers were dispatched to a Trouble with Subject at Econo Lodge, 6541 S 13th St. The officer interviewed the applicant, who stated a subject rented a room last night. The subject had a guest over and that guest caused a disturbance at the front counter. The subject knocked over items and spilled coffee on the floor. The officers attempted to contact the patron to identify his guest but they did not receive a response.
- 31.On 05/24/2021 at 7:35pm officers were dispatched to a Suspicious Person at Econo Lodge, 6541 S 13th St. The clerk stated she had received complaints of a man handing out candy from his car in the parking lot. The officer did not locate the subject.
- 32. On 05/27/2021 at 9:49pm officers were dispatched to an Overdose at Econo Lodge, 6541 S 13th St. The investigation revealed a subject did overdose in room #212. The clerk was cooperative and provided officers with the name of the subject that rented the room.

At the time of my involvement in regards to this investigation/incident, I was equipped with an operational body worn camera system (issued Taser brand Axon Flex), which captures video and audio. I wear the camera affixed to the left side of my chest. This was done in accordance with the Milwaukee Police Department Standard Operating Procedure regarding Body Worn Cameras.

n Friday, July 23rd, 2021, I was assigned to Squad 6225 along with my partner (P.O. LAWRENCE). At 12:37PM, we were dispatched to the Econolodge, located at the address of 6541 S 13th St, in order to investigate a report of a endangering safety by use of a dangerous weapon. While en route we were informed by dispatch that Oak Creek PD had a subject in custody regarding this case. It should be noted that throughout the duration of this assignment I was equipped with my Axon body worn camera, which was both operational and functional.

Upon arrival, I spoke to P.O. Michael SCHULTZ (Squad 885) of Oak Creek PD via phone. Oak Creek PD officer KENNEDY was on scene at the Econolodge acting as a liaison. P.O. SCHULTZ stated that at 11:23AM on today's date, he received a call of a suspicious male at the address of 6610 S 13th St in the city of Oak Creek. P.O. SCHULTZ informed me that the caller stated that the suspicious male was walking southbound in the 6600 block of S 13th St. The caller initially stated that it appeared as if the male had a gun in his "pocket or waistband."

P.O. SCHULTZ informed me that a stop was conducted at which time the suspect was identified as being Isaiah K SANTIAGO (W/M 02/15/2001). P.O. SCHULTZ stated that SANTIAGO had two firearms in his possession. P.O. SCHULTZ informed me that one of the firearms was a black, Remington 9mm RP9 with serial #RP031024H. P.O. SCHULTZ stated that this firearm was stolen out of the city of Whitewater. P.O. SCHULTZ then informed me that SANTIAGO was arrested for possessing the stolen firearm. Oak Creek's case number for the stolen firearm is 21-015-662.

P.O. SCHULTZ then informed me that he had conducted a QP (Question Prisoner) with SANTIAGO. P.O. SCHULTZ informed me that during that interview SANTIAGO did admit to accidentally firing the Remington RP9 while in room #244 of the Econolodge on today's date. P.O. SCHULTZ stated that the Oak Creek police department then contacted MPD to conduct that portion of the investigation.

The owner of the Econolodge, Chiraag VALAND (W/M 07/31/1980), was on scene. VALAND was able to allow officers access into the surrounding rooms in order to conduct a welfare check and to make sure no patrons of the hotel were injured. Room #144, which is directly beneath room #244, was checked first. VALAND however did inform me that housekeeping had since cleaned the room and removed a possible fired cartridge. See 6130's (P.O. KOBELINSKI) report regarding.

The ceiling on room #144 had a bullet hole that clearly extended outward identifying that the projectile came from the above room. The hole faced slightly toward the north. The hole was toward the center of the room to the north of the sleeping quarters. To the very north side of the room was a wooden desk. On the west side of the desk was a hole that the fired cartridge originally was before being removed by housekeeping. VALAND did inform me that the layout in all the rooms is identical.

Above room #144 is room #244, where SANTIAGO has been staying. VALAND informed me that the room has been rented for three months and stated that SANTIAGO stays there from time to time. I then

examined the floor in room #244. Toward the north of the sleeping quarters (also in the center of the room) was the entry point for the fired cartridge.

Arneisha M BECKWORTH (B/F 12/26/2000) and Lakeyica S YOUNG (B/F 11/11/2001) were on scene in room #244. Both BECKWORTH and YOUNG informed me that they arrived at the hotel in the morning on today's date. Both BECKWORTH and YOUNG also stated that SANTIAGO did accidentally discharge a live cartridge while they were in the hotel room with him. See P.O. LAWRENCE's supplemental report regarding.

I then spoke to the renter of room #244, Amelia CINTRON (W/F 05/03/1985), via phone. CINTRON informed me that SANTIAGO is her little cousin. CINTRON did state that SANTIAGO stayed with her last night and that SANTIAGO, BECKWORTH, YOUNG and two other individuals were in the hotel room when she left this morning at approximately 11:00AM. CINTRON informed me that she was unaware that SANTIAGO had possession of a firearm and that she left before the incident occurred.

While conducting my investigation, I spoke to Thomas J DAHLBERG (W/M 10/29/1964). DAHLBERG resides in room #242, which is directly to the north of room #244. DAHLBERG did inform me that between 10:50AM and 11:00AM on today's date he was awoken by a loud noise that could be consistent with being a gunshot.

The city of Milwaukee did not consent for SANTIAGO to endanger the safety of others by unintentionally discharging one round from a firearm into an unoccupied hotel room due to negligent handling of the firearm. SANTIAGO's actions displayed an utter disregard for human life, especially due to failing to report the incident.

P.O. KOBELINSKI took digital photographs of the scene. P.O. KOBELINSKI then changed locations to the Oak Creek Police Department, located at the address of 301 W Ryan Rd. There, SANTIAGO was then taken into Milwaukee PD's custody for endangering safety by use of a dangerous weapon and conveyed to the District 6 station for processing.

While at the District 6 station SANTIAGO was afforded the opportunity for a mirandized interview. SANTIAGO declined to speak with me regarding and stated that he "just wanted to leave."

The fired cartridge was placed on inventory at the District 6 station as evidence under INV# 21027753.

INITIAL INVESTIGATION

This report is written by P.O. Michael KROHN, assigned to District Six, Early Power Shift.

On March 21, 2022 at 2:45pm I along with Sqd 6140 (P.O. LANGFELDT and P.O. WAGNER) were dispatched to 6541 S 13TH St (Econo Lodge) for a Shots Fired in the City and County of Milwaukee, WI. I was wearing my issued Axon body worn camera which was operational.

Upon arriving at the location I spoke to Amelia CINTRON (w/f, 05-03-85) who stated that she works at the Econo Lodge and lives in Room 244 of the hotel. CINTRON stated she heard loud arguing coming from room 140 in the Econo Lodge. CINTRON stated that her friend and co-worker Stacy W. ATTOCKNIE (w/f, 07-20-75) lives in that room with her boyfriend Iroquois E J REGAZZI (w/m, 05-31-95), a daughter Yaritza M. RIVERA (w/f, 08-19-2004) and RIVERA's boyfriend "Ahman." CINTRON stated that Stacy has already been warned about loud fights and from the hotel and would get kicked out if they knew of this. CINTRON stated she went into the room to try and calm down the loud yelling and arguing. CINTRON stated that Stacy showed up into the room shortly after she went in. CINTRON stated that as the arguing continued REGAZZI became very irritated and began shouting for everyone to get out of the room. CINTRON stated that she began to move to the doorway when REGAZZI pulled out a gun and began waving it in the air yelling for everyone to leave. CINTRON stated she got the door open but was still arguing with REGAZZI as to why he had a gun out, CINTRON stated REGAZZI made a statement that he was "Gonna pop a round off". CINTRON stated that her daughter Eniyah R. MANNING (w/f, 02-15-2007) came to the room and was now standing behind her while she had the door open. CINTRON stated that REGAZZI then put his head down like a pull and began to flail his arms in a circle motion like a windmill as he ran at her. CINTRON stated it was at this time that she heard a bang and realized that REGAZZI shot a round into the room. At the same time when he was flailing his arms in a circle the hand that did not have the gun in it hit CINTRON's daughter MANNING in the right forehead. MANNING stated there was some pain and discomfort. CINTRON stated that she then exited the room and called her boss to call the police.

Stacy ATTOCKNIE stated that she lives in room 140 with her boyfriend REGAZZI, her daughter RIVERA, RIVERA's boyfriend "Ahman" and two younger children. Stacy did state that an argument had occurred in her room. Stacy stated that she kept a gun, an aqua and turquoise 9mm, under the seat of her 1991 red, Toyota Corolla 4dr. Stacy stated that she saw the gun early Monday morning and stated that she keeps the key for the car in the hotel room. Stacy stated that during the argument she observed REGAZZI pull the handgun from his waistband and waive it in the air and then heard the handgun discharge while he was still in the room. Stacy stated that REGAZZI, RIVERA and "Ahman" all left out through the hotel window that leads to the parking lot after the incident.

I then spoke to Chiraag VALAND who is the manager on scene at approximately 5:00 pm, I did notify him that a License Premise Report would be filed on the incident. VALAND stated that he was notified by his employee CINTRON that Iroquois fired a gun off in the room. I asked VALAND if he knew that ATTOCKNIE lives in room 140 with so many people. VALAND stated that he was aware of Stacy and her daughter Yaritza and two younger children all lived in the room. VALAND stated that Iroquois and "Ahman" only stay there sometimes and was not aware that they were living there permanently. VALAND was able to show me surveillance video that same day of the incident which I documented in my report (Case# 22-080-0127) and a copy was retrieved the next day and inventoried.
